Anonymous stated she is still "under the thumb" of an unknown man that sells her, and Anonymous receives no money for it. Anonymous often blacked-out as a child and stated some of her memories are unclear. Anonymous is potentially willing to provide additional information in person. Anonymous noted she was the one to take the photograph of Prince Andrew and [REDACTED] in 2001. Anonymous formally went by the name [REDACTED]"</p>
