During ~~this~~ that time, I have [REDACTED] has worked on a variety of complex investigations involving human trafficking, child sexual exploitation, and international parental kidnappings. I have consistently sought out training and conferences, in order to stay abreast of the ever-changing criminal landscape and environment.

[REDACTED] was trained in Freenet investigations. [REDACTED] was also trained in ICAC Online Ads and ICAC Advanced Undercover Chat Investigations and is familiar with computers and technology and cyber based VCAC investigations. As a member of the NYCEHTTF, [REDACTED] has also initiated and completed several investigations involving violent crimes against children reviewing child sexual abuse material. SA [REDACTED] does not currently have FBI certification as an OCE but is willing to complete OCE certification.

I have [REDACTED] has experience in coordinating and being a liaison with external partners, ~~collaborating~~ working with a multitude of different ~~agencies~~ external partners simultaneously, and have s experience working on extraterritorial investigations. For instance, I was the case agent for the Jeffrey Epstein investigation which was during a high-profile child sex trafficking and sexual exploitation investigation which involved involving international connections, our overseas partners, state department in X. Epstein with the subject traveling frequently travelled overseas, and I regularly SA [REDACTED] coordinated with Customs and Border Protection in ~~his~~ the apprehension and arrest upon of this individual on his return to New York. After he was arrested, multiple search warrants were conducted, both domestically and internationally. I was responsible for planning the search of Epstein's 45,000 square foot home, located on X island. In order for this to be successful, I needed to plan xyz. Kidnapping and Passport Fraud. In addition to working with the Department of State, I also [REDACTED] worked closely in close liaison with NCMEC and New York State Missing Persons Clearinghouse. On another separate IPCKA investigation, the father [REDACTED] took six of his seven children from their mother after she went to work. The children's ages ranged from 2 to 11 years old at the time of the abduction. The father had a Red Notice and the six children had Yellow Notices. I was able to work with INTERPOL and coordinate the return of the six children in March 2022. As a result of the Red Notice, the father was later stopped in X and in December, 2022, I [REDACTED] coordinated with the FBI Legat office in Riyadh and to travel and escorted Alboushari a subject back to the United States to face prosecution.

I have been [REDACTED] was trained and utilize multiple tools and techniques. I am certified to conduct in Freenet investigations and XX. I have also been [REDACTED] was also trained in ICAC Online Ads and ICAC Advanced Undercover Chat Investigations and am familiar with computers and technology and cyber based VCAC investigations.
