I am a Threat Intake Examiner (TIE) at the FBI National Threat Operations Center (NTOC) Unit where we receive information from the public regarding criminal activity and threats to national security. The following information is being forwarded for your situational awareness and any action deemed appropriate.

On 07/27/2023, at 12:50 p.m. Eastern Time, [REDACTED] ([REDACTED]), date of birth [REDACTED] cellular telephone number [REDACTED] called the FBI National Threat Operations Center (NTOC) to report that [REDACTED] ([REDACTED]) plans on filing a lawsuit for \$600 million against the FBI for their mishandling of the Epstein case and that [REDACTED] is lying about being a victim of Epstein.

[REDACTED] provided the following information:

[REDACTED] stated [REDACTED] and other Epstein victims plan on suing the FBI for 600 million for mishandling information related to the Epstein case and is being handled by [REDACTED] attorney Jennifer Freeman (Freeman), telephone number [REDACTED], with Marsh Law. [REDACTED] stated [REDACTED] has publicly claimed that she was a victim of sexual assault by Epstein. However, [REDACTED] has videos and newspaper clippings stating [REDACTED] wasn't the victim of sexual assault and victim blamed the ones that were. [REDACTED] stated [REDACTED] attacks those who question her such as claiming [REDACTED] was a meth head without warning. [REDACTED] stated [REDACTED] posts these videos on her social media accounts and then takes them down but [REDACTED] and others have made copies of these videos. [REDACTED] stated [REDACTED] was hired as an adult by Epstein to paint pedophilic art of Epstein's victims. [REDACTED] stated [REDACTED] blames the FBI for being a victim of Epstein and that is why [REDACTED] is coming after the FBI. [REDACTED] stated she had a point of contact with the FBI, Detective [REDACTED] email address [REDACTED] out of the NY Field Office and has sent this video to him as well. [REDACTED] stated she still has all of these videos and newspaper clippings for the FBI to use.
