██████████, date of birth ██████████ was interviewed over video conference by AUSA ██████████ ██████████, AUSA ██████████ ██████████, Detective ██████████ ██████████ and Special Agent ██████████ ██████████. Also present for this video conference was ██████████ attorneys ██████████ ██████████ and ██████████ ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ starts off by explaining a few incidents that occurred recently that were concerning to her. She states that last week her ██████████ was playing near the canal near her home. When her ██████████ returns home he is crying and states that someone stopped and was taking pictures of him. A few days later he sees that someone is video taping him from the church parking lot across the street from her house.

On another occasion ██████████ saw someone in a vehicle with dark tinted windows taking pictures. She could not see who it was but could hear clicking noises of a camera. On about three occasions ██████████ observed someone taking pictures or filming her kids while they are outside. She has seen white, black and red cars or SUVs. On one occasion she possibly observed a black woman, on another she saw a white man and on another she observed a white woman. A helicopter possibly followed her one time when she went to the store. Her home address is ██████████

██████████ On another occasion she observed a police officer in an SUV parked in the church parking lot and stated they recently did a raid on her neighbors house.

██████████ stated she was the special one to go see the bald guy, who was discussed during ██████████ other interview. GHISLAINE MAXWELL called ██████████ and said that a special friend is flying in and said that he would like ██████████ body type. This massage eventually happened. This was before ██████████ has her first child. ██████████ had been to JEFFREY

EPSTEIN's house many times prior to meeting the bald man. MAXWELL said he was a special man. MAXWELL called ██████████ and said he was a very important client and friend. MAXWELL called ██████████ cell phone and asked for her. She said she would make extra money for giving this man a massage. MAXWELL said her body type would best fit his needs. ██████████ assumed because she was a minor with big breasts. MAXWELL felt ██████████ would be the right girl for the job. ██████████ felt flattered. ██████████ did not know about the intercourse part. She was paid \$800 and was about 15 years old.

██████████ agreed and thought that it may have been that same night that he flew in. ██████████ was to wear make up and look nice. MAXWELL previously sent her a package from New York with Victoria's Secret lingerie in it. It contained white, pink and red bras with different underwear. She always ordered from Victoria's Secret. MAXWELL wanted ██████████ to wear the red bra from this package. Around the next day after the man flew in, ██████████ was picked up in a town car at her home in ██████████. She was living at home with her mother at the time. She had never seen the driver before. He was young and possibly French speaking.

██████████ recalled that she was brought to the West Palm Beach house. The chef was in the kitchen when she arrived and MAXWELL came out of her office. MAXWELL was very nice to ██████████ and she kissed her on the cheek. MAXWELL said that ██████████ was going to make a lot of money and that this man was a real good friend of theirs. MAXWELL said, "It's going to be ok and this will be easy". ██████████ recalled seeing the housekeeper in the house as well.

While in the kitchen area, MAXWELL told ██████████ to go upstairs prior to the massage and get fully nude (as this is what ██████████ normally does when she is there). ██████████ goes upstairs. As she is walking up the stairs MAXWELL tells her, "Make sure our friend has a really good time". ██████████ sets up the massage table and picks out lotion and oil. A man comes out of the steam room only wearing a towel. ██████████ is nude at this point. He drops the towel and gets on the massage table. At first he was on his stomach. ██████████ asked him, "oil or lotion?". The man wanted oil. ██████████ gave him a deep tissue massage on his back and buttocks. At some point MAXWELL walked into the room and asked if everything was ok. She brought the man some water. ██████████ was still naked at this time. At this point, ██████████ was massaging his back. MAXWELL made small talk with him

and asked if everything was ok. MAXWELL told him that [REDACTED] was one of their best.

After MAXWELL left the room the man asked [REDACTED] to climb on the table and massage his chest. Before she knew it they were having sex. After it ended the man said he wanted to see her again. There was \$400 left out in the massage room for [REDACTED] and the man gave her \$400 as a tip inside the massage room. After the massage [REDACTED] goes into the bathroom and scrubs herself with paper towels, gets dressed and goes downstairs. MAXWELL told [REDACTED] she would be hearing from her again soon. MAXWELL gave her \$150 as a tip from the drawer from the computer room/ office. MAXWELL told [REDACTED] that she did good and can massage more of their friends in the future. On a later date [REDACTED] talked on the phone with the man from EPSTEIN's house but [REDACTED] never saw him again.

[REDACTED] recalled this was the 3rd time she was nude in front of MAXWELL. The first and second time was with EPSTEIN. The second time she was nude in front of MAXWELL, MAXWELL fondled [REDACTED] breasts. The first time MAXWELL told [REDACTED] that she had a nice figure. MAXWELL had walked her upstairs and there was girls in the hallway. They went into the sauna in EPSTEIN's bathroom. MAXWELL was replacing lotions and [REDACTED] got naked.

About a month or two later MAXWELL had [REDACTED] massage another man. [REDACTED] did not know his name but he was tall, tan, and athletic. MAXWELL told [REDACTED] not to mention her age and to just give the massage and leave your underwear on. [REDACTED] was confused because she normally gave the massages naked and there was normally a sexual encounter with them. [REDACTED] was upstairs when she went into the massage room. Money was on the table and the man handed [REDACTED] the money. [REDACTED] thought it was about \$600.

There were a couple of pictures of MAXWELL nude and pregnant so [REDACTED] thought EPSTEIN and MAXWELL may have had a kid.

[REDACTED]'s biological father was friends with [REDACTED] [REDACTED]' boyfriend [REDACTED] (known to law enforcement as [REDACTED]) at the time. [REDACTED] met [REDACTED] through her [REDACTED]'s biological father and [REDACTED] as they were friends. One day, [REDACTED], her [REDACTED]'s biological father,

[REDACTED] and [REDACTED] were all smoking together when [REDACTED] asked [REDACTED] if she wanted to make some fast money. [REDACTED] was about 17 at this time.

[REDACTED] was with [REDACTED] the first time she went to the Palm Beach house. They then go there together 1-2 more times and [REDACTED] was in the massage room with [REDACTED]. [REDACTED] didn't really talk about her experiences with MAXWELL and EPSTEIN. The massages with [REDACTED] and EPSTEIN were sexual.

Not all subject matter was discussed during the course of this interview.
