

- [REDACTED] remembered that [REDACTED] last name was [REDACTED], [REDACTED] was about 17 when [REDACTED] met her.
- Before first going to JE's home, [REDACTED] recalls asking [REDACTED] whether she would be with her the whole time
- Maxwell said that [REDACTED] was very pretty when Maxwell first met [REDACTED]
- [REDACTED] told Maxwell [REDACTED] worked with her at a restaurant
- During the first massage at JE's home, [REDACTED] was wearing her underwear but topless
- When JE walked in, he kissed [REDACTED]
- [REDACTED] recalls that the lotions used during massages at JE's were Bath & Body Works
- [REDACTED] remembers that the bills she received for the first massage were 100s
- [REDACTED] started off massaging JE approximately 2 to 3 times per week, at some point increased in frequency to approximately 3 to 5 times per week
- Maxwell called [REDACTED] to schedule massage appointments for [REDACTED] first couple months going to JE's
- [REDACTED] told her mom the calls from JE's employees were about house cleaning
