[REDACTED], date of birth [REDACTED], was interviewed at [REDACTED]. Present for the interview was Assistant United States Attorney [REDACTED] and Special Agent [REDACTED]. After being advised of the identity of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[Agent note: [REDACTED] was shown a photograph of two pictures, which is attached in a 1A.] The smaller photograph [REDACTED] identified herself as being 19 years old. [REDACTED] did not recall the caption on it but advised she was [REDACTED] and brainwashed. This photograph was [REDACTED] she had when she first moved. The larger photograph [REDACTED] identified herself as being 14 years old. [REDACTED] thought this photograph was taken in [REDACTED]. [REDACTED] JEFFREY EPSTEIN paid for that photo [REDACTED]. [REDACTED] recalled this was the first time she had her eyebrows plucked.

When [REDACTED] was asked about [REDACTED], [REDACTED] stated that [REDACTED] extorted her out of money. This was right before [REDACTED]. During this time, there was stuff coming out in the press. [REDACTED]. Essentially, [REDACTED] made it go away. [REDACTED] had a friend who was [REDACTED] who recommended [REDACTED]. [REDACTED] did not know she would need a \$250,000 retainer for [REDACTED]. At the time, [REDACTED]. [REDACTED] was shame ridden. [REDACTED] was told [REDACTED] could make it go away and that [REDACTED] could fend off the media stuff regarding EPSTEIN. [REDACTED] told [REDACTED] to wire her money and she would fly to [REDACTED]. Later, [REDACTED] contacted [REDACTED] friend and said that she had a new bill for [REDACTED] and wanted to talk about ALAN DERSHOWITZ. [REDACTED] said no and [REDACTED] never bothered her again. [REDACTED] gave her [REDACTED], [REDACTED] cash. [REDACTED] middle school [REDACTED] teacher, [REDACTED], was awful to her and would single her out. [REDACTED] was not aware of any interactions either [REDACTED] or [REDACTED] would have had with EPSTEIN.
