

[REDACTED] talks to [REDACTED] regularly but [REDACTED] does not go deep into the case with him. [REDACTED] is suffering. They will not talk about her experiences in depth. When they talk, it's more of [REDACTED] venting. [REDACTED] does not have faith that justice will be served and she feels that others possibly won't be brought to justice.

[REDACTED] discussed with [REDACTED] that he's not sure why the government wants him to testify in this case. [REDACTED] thinks it's because MAXWELL made the sexual comment to [REDACTED].

[REDACTED] and [REDACTED] are on the same page about not discussing details of the case. [REDACTED] and [REDACTED] have not had other substantive conversations.





[REDACTED] was asked about statements he made during a prior interview with the case team. He was asked about making the statement that in 2019 he sent a text to [REDACTED] about MAXWELL or EPSTEIN. [REDACTED] states that he does not specifically remember that. [REDACTED] state that they try not to text about the case and they try to just talk in person or on the phone.

[REDACTED] understanding of [REDACTED] relationship with EPSTEIN and MAXWELL is that EPSTEIN was like a godfather figure to her. MAXWELL was there as a woman as like a buffer of safety. [REDACTED] thinks that MAXWELL was probably EPSTEIN's girlfriend. [REDACTED] always thought that EPSTEIN was weird and eccentric as he dressed down or "looked like he was homeless" but was also rich.

EPSTEIN stayed involved in [REDACTED] life up until about the 2000's. [REDACTED] recalls that EPSTEIN sent [REDACTED] a massage therapist to her house when [REDACTED] was living with her. Soon after that, [REDACTED] got a boyfriend and EPSTEIN faded as far as [REDACTED] recalls.

[REDACTED] never asked [REDACTED] fully what happened and all the details of her abuse.

Ten years ago was when it became real for [REDACTED] but he had still hoped and thought that maybe it didn't happen to [REDACTED].

[REDACTED] knows that [REDACTED] was the one that approached [REDACTED] about EPSTEIN and that's when [REDACTED] broke down and tells her.

[REDACTED] had told [REDACTED] that she was on the plane and that she sat next to PRINCE ANDREW. When EPSTEIN was under house arrest was maybe when they started to

talk about it. To this day [REDACTED] has not explicitly told [REDACTED] details of EPSTEIN.

After the government reached out to talk about the case was when [REDACTED] and [REDACTED] talked about MAXWELL. [REDACTED] refers to her as a monster and she is angry and disgusted with her. MAXWELL's name came up in the last few years but in no gross detail.


