[REDACTED] ([REDACTED]), date of birth (DOB) [REDACTED], was interviewed at One Saint Andrews Plaza, New York, New York. Present for the interview was Assistant United States Attorney [REDACTED] and Special Agent [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] friend [REDACTED] introduced her to GHISLAINE MAXWELL. [REDACTED] visited MAXWELL at her place in [REDACTED]. MAXWELL treated [REDACTED] like they were sisters, "like naughty schoolgirls". MAXWELL was nice to [REDACTED] and seemed interested in her. MAXWELL talked about her boyfriend JEFFREY EPSTEIN. MAXWELL told [REDACTED], "I know how much he's going to like you".

EPSTEIN visited [REDACTED] and MAXWELL called [REDACTED] to drop everything and come to her place. EPSTEIN was in sweatpants and a t-shirt talking on the phone. When EPSTEIN got off the phone, MAXWELL gave EPSTEIN a "résumé" of [REDACTED] attributes, saying things like "she's so pretty and she's so strong," referring to [REDACTED]. MAXWELL told [REDACTED] to massage EPSTEIN's shoulders so she did. EPSTEIN made a comment, "I thought she was just blowing smoke up my ass." MAXWELL said, "Oh, I'll tell you when you come back." MAXWELL asked [REDACTED], "Since you're so strong, I'd appreciate if you could give Jeffrey a massage because he needs a massage everyday...I'd get in trouble." MAXWELL showed [REDACTED] to a room, where EPSTEIN was in a robe. EPSTEIN took off the robe, got on the bed, and [REDACTED] massaged him. EPSTEIN turned over and [REDACTED] saw he had an erection. EPSTEIN stated, "Well that doesn't make you uncomfortable, does it?". EPSTEIN touched [REDACTED] and put her hand on his penis.

EPSTEIN and MAXWELL invited [REDACTED] to Palm Beach, Paris, New York, and the Virgin Islands. EPSTEIN put [REDACTED] in an apartment and told her there were rules. She was not allowed to have men in the apartment. EPSTEIN told

her, "I don't want men where I've been."

Every time [REDACTED] met EPSTEIN, there were varying degrees of sexual behavior. EPSTEIN grabbed her, pulled her to his lap, and would say, "Are you fucking someone; why are you being frosty?". [REDACTED] felt paralyzed like she could not say anything. EPSTEIN would visually shake when he saw [REDACTED] because he wanted to touch her so much.

When EPSTEIN wanted [REDACTED] to do something she did not want to do, MAXWELL would minimize and say things like "don't be silly".

In New York, [REDACTED] massaged EPSTEIN. These massages involved sexual encounters where EPSTEIN groped [REDACTED] and used a "massage thing" on her genitals. [REDACTED] stated, "It was unpleasant."

In Palm Beach, MAXWELL showed [REDACTED] to the room she would be staying in. There was a school girl uniform on the bed. [REDACTED] confronted MAXWELL. MAXWELL told her, "Oh I thought it'd be adorable if you took Jeffrey his tea. Don't be so frigid." [REDACTED] put the outfit on; she did not know what to do. [REDACTED] saw EPSTEIN's martial arts trainer there. EPSTEIN slapped her "ass", reached under under her skirt, and touched her.

[REDACTED] stated, "By the time they get to the sex acts, you have no fight left; they've demoralized you."

EPSTEIN used a "vibrator/massage thing" on her. If [REDACTED] shut down, EPSTEIN would call her frigid. EPSTEIN told her, "If you won't tell me what you like, we'll just have to try things to see what you like."

[REDACTED] knew MAXWELL to be EPSTEIN's girlfriend. EPSTEIN was allowed to fool around but not have sex with others.

[REDACTED] talked about a time where there was a massage table and EPSTEIN pulled her under her skirt. [REDACTED] pushed EPSTEIN away. EPSTEIN grabbed her shoulders, threw her on the bed, and before she knew it EPSTEIN was inside of her. [REDACTED] was crying and she froze. EPSTEIN told her, "That's not my deal with Ghislaine; you've made me cheat on her." The rest of the trip EPSTEIN kept doing the same thing. [REDACTED] "checked out".

In [REDACTED], MAXWELL asked [REDACTED] if she knew anyone who could give EPSTEIN a blowjob because MAXWELL did not feel like giving him one. MAXWELL

told her, "They have to look young at least." [REDACTED] assumed that young meant younger than herself. One day, [REDACTED] went to MAXWELL's and saw a girl there named [REDACTED]. [REDACTED] remembered trying to get [REDACTED] to leave.

EPSTEIN did not like anyone who did drugs. EPSTEIN liked "wholesome young girls"; he liked "pureness". EPSTEIN did not like girls who were damaged.

[REDACTED] described EPSTEIN as being dismissive and then other times he would recognize something she did and it would be nice.

MAXWELL either came to visit [REDACTED] or sent her a gift for her 18th birthday. [REDACTED] described that it was like being in a "weird sick family". MAXWELL was always asking for [REDACTED] help. MAXWELL asked her to bring girls. MAXWELL asked [REDACTED] for sexual favors for EPSTEIN.

When [REDACTED] was approximately 18 or 19 years old, MAXWELL asked her if she knew anyone that could massage EPSTEIN. MAXWELL told her that she knew the ones he liked. MAXWELL would always ask this while in a normal conversation.

When [REDACTED] was in Palm Beach, both MAXWELL and EPSTEIN talked with her separately about having a child. EPSTEIN always insisted on naked sunbathing. EPSTEIN asked [REDACTED] if she wanted children, then told her that they would have to meet his standards. EPSTEIN told her, "I don't want my seed to be diluted." MAXWELL told [REDACTED] that they should find someone for EPSTEIN to have a child with. MAXWELL told [REDACTED], "Well it can't be you because you're getting a bit old."

[REDACTED] stated that a few months after she met MAXWELL, she was given a gift for her 18th birthday. [REDACTED] felt like she was being rewarded for the sexual favors. [REDACTED] was given a really expensive purse.

MAXWELL periodically reached out to [REDACTED], asking if [REDACTED] was available for EPSTEIN. MAXWELL was excited to hear that [REDACTED] [REDACTED]. MAXWELL told her that they'd hire her. They paid for

[REDACTED] trip to the Virgin Islands on the pretense of her being EPSTEIN's massage therapist. The massages with EPSTEIN were always sexual. EPSTEIN would throw \$300 near [REDACTED]. [REDACTED] recalled seeing a young girl on the island, and thought this girl was [REDACTED]. [REDACTED] stated she thought it was [REDACTED] because [REDACTED] told her; [REDACTED] remembered [REDACTED] name. [Agent note: [REDACTED] and [REDACTED] conversed after [REDACTED].] [REDACTED] could not say that it was [REDACTED], but recalled that the girl she saw was young; she looked very young. [REDACTED] described the girl as [REDACTED] looked similar to [REDACTED] but younger.

[REDACTED] was not being treated well by MAXWELL and EPSTEIN. They all went walking on the beach. EPSTEIN was in the middle between [REDACTED] and MAXWELL and stuck his hands down both of their bikinis. It dawned on [REDACTED] that "it was a them thing". When [REDACTED] came back from the trip, she had a nervous breakdown and [REDACTED].

When [REDACTED] was in the room with EPSTEIN, it was just she and him in the room. MAXWELL would be lurking close by. MAXWELL would say things like, "Oh how was it? Is Mr. Epstein happy?". MAXWELL always talked about blow job lessons and blow job parties. MAXWELL said that it needed to be a revolving door. MAXWELL would say, "You know how he is when he's not happy and you know what makes him happy. He has to have sex all the time; he's like a super hero."

One time in Palm Beach when [REDACTED] was maybe 18 or 19 years old, she recalled ALAN DERSHOWITZ being there. [REDACTED] recalled this was during the same trip that MAXWELL wanted her to wear the school girl outfit.

[REDACTED] talked about a time where EPSTEIN was talking with DERSHOWITZ. [REDACTED] was sunbathing topless when EPSTEIN told her to come say hi to his friend. DERSHOWITZ was bragging and laughing with EPSTEIN about getting OJ SIMPSON off. They talked about how people on opposite sides were idiots. [REDACTED] described DERSHOWITZ as creepy; DERSHOWITZ never touched [REDACTED].

[REDACTED] had email exchanges from LESELY (know to law enforcement as LESLEY GROFF). [REDACTED] had a hotmail account from which LESLEY contacted her on to make travel arrangements. [REDACTED] gave those emails to her attorney, [REDACTED]. EPSTEIN had an email, "jesvacation". EPSTEIN asked [REDACTED] for

photographs. [REDACTED], [REDACTED], and another woman made the travel arrangements for [REDACTED].

In Paris, EPSTEIN assaulted [REDACTED] in front of his housekeeper. In New York, [REDACTED] saw EPSTEIN approximately three to four times. EPSTEIN and MAXWELL introduced [REDACTED] to DONALD TRUMP. TRUMP was polite to [REDACTED]. [REDACTED] was approximately 20-22 years old. MAXWELL also introduced [REDACTED] to [REDACTED]. [REDACTED] took [REDACTED] back to the apartment in New York. [REDACTED] woke up and [REDACTED] was there and she thought, "Oh no," because EPSTEIN had said that there were to be no boys at his places with his girls.

MAXWELL would call [REDACTED] and say in a "school girl voice", "Jeffrey wants to see you". MAXWELL asked what [REDACTED] schedule was when [REDACTED] was 17 years old. [REDACTED] [REDACTED] [REDACTED]. MAXWELL came to [REDACTED] 18th birthday party.

[REDACTED] had periodic contact with EPSTEIN and MAXWELL. MAXWELL told [REDACTED] that she had a wealthy high profile boyfriend. MAXWELL wanted [REDACTED] to know that she was not with EPSTEIN.

On or about October 3, 2012, LESLEY emailed [REDACTED] asking her to give EPSTEIN a call. The number was [REDACTED]. [REDACTED] received emails from EPSTEIN; the email account was "jeevacation". [REDACTED] email was [REDACTED].

When [REDACTED] talked with EPSTEIN, he acted like he cared about her life, but as soon as she started talking he would cut her off and ask when she was coming to see him.

[REDACTED] has been working with attorney [REDACTED] for approximately five years. [REDACTED] got in touch with him because she was thinking of coming to Florida to help with a case. [REDACTED] [REDACTED], when a man she did not know called her and told her that she had a beautiful baby girl and told her that she should keep out of anything that is not her business. This man told her that he did not want to make another call like this because the next one wouldn't be so nice. After she received that call, [REDACTED] told [REDACTED] that she could not assist with the case.

[REDACTED] was not sure when she first learned of EPSTEIN's investigation. [REDACTED] knew that he was supposed to be in prison but EPSTEIN sent her an

email while he was supposed to be there. MAXWELL told [REDACTED] that a massage therapist was angry that she was fired. [REDACTED] understood this to be what he was going to prison for.

[REDACTED] feels that MAXWELL is just as responsible as EPSTEIN. MAXWELL was the one responsible for telling girls how to do things and what to say. [REDACTED] stated, "A lot of us were underage; she was responsible for a lot of the grooming." [REDACTED] described MAXWELL as a manipulator who acts sweet.

[REDACTED] felt less afraid now that EPSTEIN was deceased. EPSTEIN did not value human life. [REDACTED]

In the interest of time, not all subject matter was covered during this interview.
