[REDACTED], date of birth (DOB) [REDACTED], was interviewed at the Federal Bureau of Investigation in [REDACTED]. Present for the interview was AUSA [REDACTED], AUSA [REDACTED], and Special Agent [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] was in a group messaging thread that [REDACTED] had started. This messaging thread included multiple victims of JEFFREY EPSTEIN. [REDACTED] removed herself from the group because she felt that she did not want to have to constantly talk or hear about EPSTEIN.

[REDACTED] attended [REDACTED], [REDACTED] 16 to 18-year-olds. [REDACTED] [REDACTED] [REDACTED]. [REDACTED]. [REDACTED]. This would have been on or about November 1993. [REDACTED] [REDACTED] [REDACTED] DOB is [REDACTED].

[REDACTED] met GHISLAINE MAXWELL in early 1994. This was before [REDACTED] turned 17 years old [REDACTED]. The first person she met with MAXWELL was JEFFREY EPSTEIN; she met EPSTEIN within the first couple months of meeting MAXWELL.

When [REDACTED] was approximately 21/22 years old, she went to EPSTEIN's island. She missed her flight when coming back and a random man helped her while she was at the airport, whose name she thought may have been [REDACTED]. This man took her to his home, where his children also resided, until she could get back home. [REDACTED] [REDACTED] best friend, [REDACTED] remembered this time

period and recalled that [REDACTED] came back from the island a different person. [REDACTED] thought that this time with MAXWELL and EPSTEIN just seemed worse. MAXWELL had this finesse about her and was grooming [REDACTED].

MAXWELL would say, "I need you; I need you to fix this." Growing up, [REDACTED] mother would say something similar. Being in therapy, [REDACTED] recognized that MAXWELL would say similar things that her mother would tell her and it made it comfortable for [REDACTED].

[REDACTED] and [REDACTED] had both attended [REDACTED]. The birthday party was held at a club called [REDACTED] [REDACTED] and MAXWELL are approximately the same age. [REDACTED] met [REDACTED] through a modeling agency. [REDACTED] recalled she was in the hotel lobby and was wearing a black velvet catsuit and white platform shoes; [REDACTED] looked really young.

[REDACTED] and [REDACTED] dated on and off for years. [REDACTED]
[REDACTED]. [REDACTED] was disappointed in how he has handled this current situation. [REDACTED] called him and he laughed and said, "Oh, you're famous". [REDACTED] told him that it has been very difficult. [REDACTED] said to her that he did not know EPSTEIN all that well. [REDACTED] stated that this was absolutely untrue, as [REDACTED] did know EPSTEIN. [REDACTED] is currently living in [REDACTED].

[REDACTED] felt that [REDACTED] probably did not want people to know that she was only 16 years old when they dated. [REDACTED] felt that [REDACTED] likely would not want to talk to law enforcement.

[REDACTED] friend [REDACTED] has been very supportive. MAXWELL had introduced [REDACTED] to [REDACTED] in New York. [REDACTED] is currently living in [REDACTED]

[REDACTED] was asked about a few photos that she had sent to her lawyers that had been passed on to law enforcement. In the one photo, where [REDACTED] was holding [REDACTED] she stated that she was approximately 17 years old. This picture was taken in [REDACTED]. In the two photos that were taken from [REDACTED], [REDACTED] stated that she was approximately 17/18 years old. [REDACTED] and her friends would take photos of themselves at [REDACTED]. [Agent note: Photos are attached in a 1A.]

[REDACTED] thought that there were approximately two assaults by EPSTEIN before she started traveling with he and MAXWELL, but was unsure about the exact number. This occurred at MAXWELL's residence [REDACTED].

MAXWELL had acted like a teenager to [REDACTED] saying, "Oh I'm so excited for you to meet him", referring to EPSTEIN. EPSTEIN arrived and ignored [REDACTED]. [REDACTED] felt that it was set up so that she had to prove herself and that MAXWELL's faith in her was justified. MAXWELL told her, "Don't disappoint me; don't let me down". MAXWELL hovered around the first time that [REDACTED] gave EPSTEIN a massage. MAXWELL went upstairs with [REDACTED] showing her where to go, but did not open the door. MAXWELL gave her some oil. EPSTEIN was in a robe. [REDACTED] knew that MAXWELL knew what was going on but MAXWELL was being coy about it, saying, "How did it go? Everyone happy?".

MAXWELL called [REDACTED] after that first time. [REDACTED] thought she had a cell phone at the time. MAXWELL told her, "Well aren't you a clever girl. Jeffrey was very impressed." Then MAXWELL asked when she was free or when could she come again. [REDACTED] felt that there was no chance of getting back to them; it was like she had to do this now.

The first and second time [REDACTED] saw EPSTEIN was within the same trip that EPSTEIN came to [REDACTED] to visit MAXWELL. The second time [REDACTED] went it was the "same kind of thing, just more". On the second visit, MAXWELL said, "Thank God you're here. If it's not you or someone, it all falls to me.". It was in this moment that [REDACTED] knew that MAXWELL knew what was going on and knew that this is what was expected. MAXWELL told [REDACTED] that it was such a relief that she met [REDACTED] and that she was there. [REDACTED] felt that it was like being in a pageant - like being presented. When EPSTEIN was ready, it was like "go". MAXWELL walked up the stairs with

[REDACTED]. MAXWELL opened the door and EPSTEIN was standing there facing them naked. EPSTEIN did not have an erection. MAXWELL told them, "I'll leave you guys to it.". Afterwards, MAXWELL asked [REDACTED] if she had a nice time, then they talked about casual things like what they were doing for the week.

MAXWELL told [REDACTED] that she had to find someone to give EPSTEIN a "blowjob". [REDACTED] did not recall exactly when this conversation took place but recalled that it was in [REDACTED]. MAXWELL never talked like this in front of EPSTEIN.

[REDACTED] recalled receiving a Miu Miu Prada handbag from MAXWELL and EPSTEIN for her 18th birthday. The gift tag said "Love, Jeffrey and Ghislaine". This handbag was sent to her home. [REDACTED] did not recall if they were present for her 18th birthday.

MAXWELL was involved in the sexual contact with [REDACTED] and EPSTEIN on the island.

The first place that [REDACTED] went with MAXWELL was to New York. [REDACTED] thought it was this trip that she met [REDACTED].

[REDACTED] recalled that MAXWELL lived next door to an [REDACTED]. [REDACTED] met him when she was approximately 17/18 years old. MAXWELL made a point to tell [REDACTED] how young [REDACTED] was. [REDACTED] is now deceased.

[REDACTED] recalled MAXWELL and EPSTEIN saying things like "when you grow up". They also talked with [REDACTED] about having a baby. MAXWELL told [REDACTED], "Oh well, soon you'll be too old."

[REDACTED] was asked about emails that she had sent to EPSTEIN. [REDACTED] had a conversation with [REDACTED] about EPSTEIN's first arrest. At the time, [REDACTED] was worried about EPSTEIN, which she now felt was really messed up being worried about him. The premise of the conversation was "poor old Jeffrey...he's in a bit of hot water". At the time, [REDACTED] was not ready to face what had happened to her and was not ready to lose that group of people from her life. At the time, [REDACTED] was still in touch with MAXWELL, as was [REDACTED]. [Agent note: Emails provided by [REDACTED] are attached in a 1A.]

[REDACTED] told [REDACTED], about EPSTEIN and

MAXWELL; this was approximately 13 years ago. [REDACTED] told her this in confidence as a friend. [REDACTED] [REDACTED]. [REDACTED] did not end up working with [REDACTED] [REDACTED] knew EPSTEIN and MAXWELL. Some of [REDACTED] family and friends are still friends with MAXWELL. [REDACTED].

[REDACTED] told [REDACTED], who currently lives in [REDACTED], about EPSTEIN and MAXWELL. [REDACTED] was the one who recognized that something was wrong with [REDACTED] when she had returned from EPSTEIN's island.
