



The day of the hearing where EPSTEIN's charges were dismissed [REDACTED] spoke to [REDACTED] in a limited way. [REDACTED] outlined her experience in a limited way. [REDACTED] also spoke with [REDACTED],

whose last name she could not recall. After the hearing, [REDACTED] and [REDACTED] exchanged a couple phone conversations, along with WhatsApp messages. When [REDACTED] saw things in the news she sometimes reached out to [REDACTED] to tell her she was thinking about her and hoped she was ok.

[REDACTED] was "quite keen" to have [REDACTED] corroborate her on the island and [REDACTED] told [REDACTED] she could not do that because she was not sure. [REDACTED]

[REDACTED] put together a text group and [REDACTED] removed herself from it. Another victim, who was older than [REDACTED], connected with her through [REDACTED] attorneys; the conversation was mostly the victim telling [REDACTED] about her experience.

[REDACTED] talked to [REDACTED] about both EPSTEIN and MAXWELL. This was around 5 years ago.

[REDACTED] talked with [REDACTED]. When [REDACTED] came back from the island at 22/23 years old, [REDACTED] repeatedly asked [REDACTED] what was wrong, what was going on, and why did MAXWELL keep calling her. [REDACTED] would have been around when MAXWELL was calling [REDACTED]. [REDACTED] was [REDACTED] best friend; they spent 60-70% of their time together. At that age, being best friends they told each other everything. [REDACTED] noticed a shift in [REDACTED] demeanor.


[REDACTED] introduced [REDACTED] to MAXWELL. [REDACTED] and [REDACTED] are still in contact. [REDACTED] believed that [REDACTED] went to [REDACTED] with MAXWELL. [REDACTED] did not think that [REDACTED] was aware of what was going on. [REDACTED] thought [REDACTED] was privileged enough not to see what he did not want to see. [REDACTED] stated [REDACTED] is part of a system in [REDACTED] that allows

behavior to continue but was not responsible for it. There is an abuse of power by wealthy and powerful men that kept [REDACTED] going for some time; they would make jokes and make light about it. When EPSTEIN was arrested the first time, [REDACTED] and [REDACTED] talked and [REDACTED] thought it was funny. [REDACTED] felt that she went along with it and she did not feel like she could challenge it. [REDACTED] had email communications with EPSTEIN when he was in prison that seemed like comfort. [REDACTED] is fearful to be presented in a bad light. The first [REDACTED] knew about [REDACTED] experiences was after the hearing in New York where charges were dismissed against EPSTEIN. [REDACTED] was in a lot of press in [REDACTED]. [REDACTED] called [REDACTED] and said, "[REDACTED]." [REDACTED] and [REDACTED] dated on and off for many years.





[REDACTED] never dated DONALD TRUMP. MAXWELL took [REDACTED] to a party in New York. MAXWELL seemed very excited that there would be a lot of great men for [REDACTED] to meet. [REDACTED] felt that MAXWELL presented her and gave a run down of [REDACTED] accolades, similar to a CV. MAXWELL presented [REDACTED] to TRUMP and they had a conversation for approximately 20 minutes. [REDACTED] was invited to MAR-A-LAGO where she was given a tour by TRUMP with EPSTEIN and MAXWELL present. Nothing happened between [REDACTED] and TRUMP. By the things that MAXWELL said, it was made clear that [REDACTED] was available. MAXWELL said things like, "Oh I think he likes you. Aren't you lucky. This is great." There was an article that came out with [REDACTED] and TRUMP. [REDACTED] thought she was around 22 years old. [REDACTED] was given suggestions on things to wear. MAXWELL said things like, "Oh he'll like that. He doesn't like that." It was set up very much like how MAXWELL introduced [REDACTED] to EPSTEIN.

MAXWELL introduced [REDACTED] to [REDACTED]. There was definitely a pretext that this guy was for [REDACTED]. [REDACTED] and [REDACTED] are friends; they dated much later. [REDACTED] described [REDACTED] as a "good guy". [REDACTED] told [REDACTED] that someone from the government had reached out to him.

MAXWELL introduced another man, [REDACTED], to [REDACTED]. [REDACTED] [REDACTED] [REDACTED]. [REDACTED] was much older than [REDACTED]. [REDACTED] [REDACTED], [REDACTED]

MAXWELL's family was very much like [REDACTED]. MAXWELL's father was like [REDACTED]. MAXWELL and [REDACTED] were connected in that way; it was a deep connection. [REDACTED] thought this was why MAXWELL recognized her as suitable for that role she needed.

[REDACTED] has fear around MAXWELL. [REDACTED] described MAXWELL as an extremely dangerous person. [REDACTED] felt the behavior she has witnessed in MAXWELL is "sociopathic". [REDACTED] has a fear if MAXWELL is not convicted.
