

Also present was Assistant United States Attorneys [REDACTED], along with Detective [REDACTED] and Special Agent [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] has talked with friends over the past few months. [REDACTED] also talked with [REDACTED]. All have been contacted by GHISLAINE MAXWELL's (MAXWELL) attorneys. MAXWELL's lawyers showed up to speak to [REDACTED].

MAXWELL introduced [REDACTED] to [REDACTED] ([REDACTED]), who is now deceased. [REDACTED] helped [REDACTED]. [REDACTED] son [REDACTED] lives in [REDACTED]. [REDACTED] is like a [REDACTED] to [REDACTED]. [REDACTED] remembers the day she met him.

[REDACTED] ([REDACTED]) told [REDACTED] that he was not going to speak with her again. MAXWELL had called [REDACTED] at some point and asked if [REDACTED] was going to talk. [REDACTED] felt that [REDACTED] will make it difficult to use.

[REDACTED] felt [REDACTED] ([REDACTED]) was also difficult. [REDACTED] reached out to [REDACTED] asking if she could talk to him. [REDACTED] told her he did not want to talk if it was about MAXWELL. [REDACTED] sent [REDACTED] a message saying, "Friends don't say things to get friends in trouble."


[REDACTED] advised [REDACTED] made up a story of how she tried to stop MAXWELL and how she confronted MAXWELL.



[REDACTED] learned MAXWELL's lawyers had called [REDACTED].

At some point, [REDACTED] wanted [REDACTED] to go to Paris. They stayed at a hotel in [REDACTED]. There were fantastic dinners and fancy parties. There were a lot of drugs and alcohol. The lifestyle was normalized. They were with a group of people and [REDACTED] recalled MAXWELL coming to the lobby of the hotel and she went out with them that night. [REDACTED] recalled wearing a velvet catsuit with white shoes; she weighed around 95lbs at the time. [REDACTED] recalled MAXWELL commenting on how she looked, "You're doing it right." To [REDACTED], MAXWELL was like an old lady. MAXWELL was very charismatic and very reaffirming. [REDACTED] and MAXWELL exchanged numbers.

[REDACTED] advised JEFFREY EPSTEIN (EPSTEIN) had a black book. [REDACTED] also had one that he had laminated and carried around.

A short time after [REDACTED] met MAXWELL and was back in [REDACTED], MAXWELL called her house.

[REDACTED]

[REDACTED] did not remember having a direct conversation with MAXWELL about her age. [REDACTED] age was discussed because with [REDACTED] and other men around, they wanted younger women. MAXWELL told her, "You're only as young as the women you field." [REDACTED] told MAXWELL she lived in [REDACTED]. MAXWELL told [REDACTED] where she lived, and [REDACTED].

When [REDACTED] was around 19/20 years old, [REDACTED] MAXWELL [REDACTED].

[REDACTED] recalled telling MAXWELL [REDACTED].

[REDACTED] did not recall what MAXWELL was wearing, but recalled she had short dark hair. The whole time [REDACTED] knew MAXWELL, MAXWELL had short hair. [REDACTED] remembered thinking AMXWELL was attractive but she needed other

people around her. MAXWELL was smart but not one of the hot girls. [REDACTED] recalled either [REDACTED] or MAXWELL told her that they had went to OXFORD together.

When MAXWELL called [REDACTED] after they first met, MAXWELL invited her over for tea. MAXWELL had a general attitude that she was powerful. [REDACTED] was excited about it. [REDACTED] did not understand why MAXWELL liked her. MAXWELL had a lot going on. MAXWELL was a friend of [REDACTED].

It was frowned upon to ask about people's work and money.

When [REDACTED] had tea with MAXWELL the first time it was just the two of them. MAXWELL talked to [REDACTED] like a schoolgirl. [REDACTED] advised that grown women do not talk about boys, they talk about men. The language MAXWELL used was reminiscent of a schoolgirl. MAXWELL used words like silly, naughty, boys, kissing, and called men's genitalia "willies". MAXWELL almost presented like she was younger than [REDACTED]. [REDACTED] did not talk like that.

[REDACTED] wanted MAXWELL to like her and took her cues from her. MAXWELL asked [REDACTED] about [REDACTED]. At this point, [REDACTED] relationship with [REDACTED] was pretty much over. MAXWELL told [REDACTED], "Well we'll find you someone nice." MAXWELL asked [REDACTED] to tell her about herself and what she liked. MAXWELL commented, "Oh you're so fit, you're so skinny, you're so pretty." [REDACTED] told MAXWELL she liked music. [REDACTED] told MAXWELL that her parents [REDACTED] [REDACTED] told MAXWELL about her family and [REDACTED]. [REDACTED] told her that [REDACTED] [REDACTED] told MAXWELL about the [REDACTED]. [REDACTED] was trying to present to MAXWELL that she was independent and sophisticated.

[REDACTED] could not remember if she went to the apartment first or met [REDACTED] first. [REDACTED] thought that she went to the apartment first because she was around 20 years old when she met [REDACTED]. [REDACTED] spoke with [REDACTED] the day before this interview and asked him if he remembered his age when she met him. As of the date of this interview, [REDACTED].

MAXWELL and [REDACTED] talked about what was going on in [REDACTED] at the time. They talked about if [REDACTED] met anyone nice. They talked about fashion. MAXWELL told [REDACTED] that she had a boyfriend named Jeffrey; MAXWELL did not say his last name at that time. MAXWELL told her he was a philanthropist. MAXWELL told [REDACTED] he would be coming to [REDACTED], and she should meet him. [REDACTED] did not think there was a big time lapse between the time she had tea with MAXWELL and the time she met EPSTEIN. MAXWELL contacted [REDACTED] telling her, "He's coming, you have to come over. I told him about you. It'll be great for you." The only time MAXWELL and [REDACTED] were on the phone together was for MAXWELL to invite [REDACTED] to something.

The first conversation between MAXWELL and [REDACTED], there was nothing overly sexual discussed, but there was an underlying tone. MAXWELL asked, "Oh you dated [REDACTED], is that what you like?" [REDACTED] advised if MAXWELL had said something sexual it would have been inappropriate; [REDACTED] was young and MAXWELL was a much older woman and a stranger to her. [REDACTED]. It would have been abrasive and rude and MAXWELL was not rude. MAXWELL was overly helpful asking if [REDACTED] tea was alright and if there was anything she could get for [REDACTED].

[REDACTED] told her that she met MAXWELL on one occasion but [REDACTED] did not remember that but advised that it was certainly a possibility.

██████████ felt an identification with MAXWELL; ██████████
██████████ MAXWELL talked about her father early on, and a bit later
talked about her brothers.

██████████ was in touch with MAXWELL and EPSTEIN for around 15 years. The last
time ██████████ spoke with MAXWELL was around 10 years ago on the phone. The
last time ██████████ saw EPSTEIN was in Paris and she noticed that MAXWELL was
not as directly involved then.

██████████ described MAXWELL's apartment as having brick on the outside and
there was a pub across the street called "Nags Head". There was a man named
██████████ who owned the pub at the time. Politicians lived on the same street.
Inside, the house was carpeted. There were a lot of picture frames of
MAXWELL and EPSTEIN. There were other pictures of MAXWELL with PRINCE
ANDREW and other famous people. There was a staircase up and it had a
banister. It was carpeted. The carpet was a beige color. There was a
kitchen downstairs; this was where she brought a tray of tea and cookies
from. Upstairs was MAXWELL's room and there was a room upstairs that was
the massage room that had a stack of towels and a robe. There were nice
smelling candles. The massage room was dimly lit with a massage table in
it. MAXWELL gave ██████████ some oil. At one point there were two robes in
the massage room and MAXWELL told ██████████ she could use one; this was the
first time ██████████ massaged EPSTEIN. At the time, ██████████ did not think
anything of MAXWELL offering her a robe.

Since MAXWELL was arrested, ██████████ has two deadbolts on her door and her
██████████.

██████████ recalled getting a threatening phone call a few years back.

██████████ knows MAXWELL like she is someone in her family. ██████████ advised
she knew that if MAXWELL could kill her, she would then go have lunch
afterwards. MAXWELL would do whatever is necessary; she has an obsessive
personality. MAXWELL would do what is required and would not feel bad.

The first two to three years, contact was always initiated by MAXWELL.
Occasionally, scheduling was done through EPSTEIN's secretary. MAXWELL
spent quite a bit of time in the states. MAXWELL would tell ██████████, "Oh,
we'll have to get you over to New York. Or if you're coming to New York

we'll have to get you a place to stay." MAXWELL called ██████████ to check in on her. MAXWELL initiated the phone call, saying, "I need your help." ██████████ was doing quite a bit of ██████████ at the time, and she would tell MAXWELL that. MAXWELL would say to ██████████ that "we'd have to get you over here...want to go on a trip." MAXWELL made everything seem easy and that nothing was out of reach.

Before ██████████ met EPSTEIN, MAXWELL talked about EPSTEIN like he was a god. MAXWELL made EPSTEIN seem like he could do anything, like he was a magic person. MAXWELL told ██████████, "He's going to love you."

MAXWELL said things to ██████████ like, "The massage therapist is not available and I need you and Jeffrey loves you and you have strong hands." MAXWELL almost made it sound like she was irritated. MAXWELL acted like she was irritated that ██████████ was picked over her. MAXWELL said, "Jeffrey is insisting it's you; what am I, chopped liver." MAXWELL acted fake annoyed.

██████████ did not have an ██████████ cell phone. ██████████ was in ██████████ and MAXWELL would always call when she was in ██████████. MAXWELL also called ██████████ when she (MAXWELL) was in New York.

MAXWELL said things that were over the top like, "We just took the plane to the island...just took the helicopter" to some place.

EPSTEIN was a little bit vulgar in everything he said. EPSTEIN talked about money a lot, questioning whether he should buy another island. He said things like that in front of his staff that did not make a lot of money. MAXWELL tiptoed around EPSTEIN; everything was catering to him.

EPSTEIN was direct with his staff. ██████████ did not see him get angry with staff. MAXWELL got mad at the staff when something did not go right. One day, ██████████ heard MAXWELL scream on the phone. ██████████ recalled the subject of muffins; EPSTEIN had to have a certain kind of food. EPSTEIN had to have a certain kind of sweatpants laundered in certain detergent. MAXWELL seemed to be terrified EPSTEIN would leave her. EPSTEIN had a short attention span. MAXWELL had to give EPSTEIN reasons to keep her.

MAXWELL talked about needing young, pretty, blonde girls. MAXWELL told ██████████, "You know what he likes". After the first two times ██████████

massaged EPSTEIN, MAXWELL asked her all the time "who do you know?". MAXWELL told ██████████ that EPSTEIN was high maintenance and demanding, also saying, "one person can't need that much sex". MAXWELL initiated bringing girls. ██████████ remembered seeing ██████████ and felt protective of her.

MAXWELL always called ██████████ direct. EPSTEIN never called ██████████ direct; his secretary LESLEY called and connected EPSTEIN to ██████████. It wasn't until much later that EPSTEIN had direct contact with ██████████.

██████████ traveled to New York, Palm Beach, Paris, and the island to see them. When ██████████ was in Palm Beach, EPSTEIN brought up the subject of having a child. MAXWELL was upset and pissed. ██████████ felt like MAXWELL punished her because of it. ██████████ thought it was humiliating for MAXWELL that EPSTEIN wanted to have a child with her and not MAXWELL. ██████████ felt she looked more like EPSTEIN's type. When MAXWELL left the schoolgirl outfit on the bed, that was one of the worst experiences ██████████ had.

When ██████████ traveled to the island, EPSTEIN's secretary made the arrangements. ██████████ was not sure who made the arrangements for the other places she traveled.

While in the New York apartment, this was around the same time MAXWELL introduced ██████████ to ██████████. This was before ██████████ ██████████ ██████████ ██████████.

██████████ understood that EPSTEIN paid for everything. MAXWELL told ██████████ that EPSTEIN got her the house in New York. ██████████ felt this was almost like MAXWELL showing ██████████ that if EPSTEIN liked her enough this was what she could get. ██████████ knew what had happened with MAXWELL's father so there was no way MAXWELL could be doing stuff on her own. MAXWELL's father lost everything. ██████████ had been to MAXWELL's New York house; this was where she met MAXWELL's brother. ██████████ remembered MAXWELL having the New York house later in the time she knew them.

MAXWELL would say "we" and refer to her and EPSTEIN. MAXWELL said things like, "We can do this. We might get a place in LA."

The last time ██████████ spoke to MAXWELL, MAXWELL told her that she was dating

a wealthy high-profile man.

In the beginning, MAXWELL asked, "What do you want to be when you grow up?".

[REDACTED] thought MAXWELL was torn because she wanted to be enough but knew she could not be enough so she found people so she could keep everything. [REDACTED] was the most like MAXWELL. [REDACTED] thought that on most levels MAXWELL had a genuine connection with MAXWELL. [REDACTED] had the look and age EPSTEIN wanted.

To [REDACTED] recollection, this was after she had massaged EPSTEIN. [REDACTED] was doing things she did not want to do. EPSTEIN touched her. [REDACTED] had flashbacks and would take her [REDACTED] sleeping pills because she could not sleep.

[REDACTED] felt pretty confident she met MAXWELL between the ages of 17-18 years old. [REDACTED]
