[REDACTED], was interviewed in person on 9/2/2021. Present for this interview was [REDACTED] attorneys [REDACTED]. Also present for this interview was Assistant United States Attorney [REDACTED] and Detective [REDACTED]. After being notified of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] she is 95% sure that she met MAXWELL quite a while before she was 18 years old. MAXWELL had known that [REDACTED] was trying to go to [REDACTED] but that implication was that [REDACTED] did not need to go to school because they could give her whatever she wanted.

MAXWELL was at one of [REDACTED] birthdays. She got [REDACTED] a Prada bag with trim on it with a note that said "Love Jeffrey and Ghislaine". [REDACTED] thinks this may have been her 18th birthday.

[REDACTED] is shown a letter turned over to prosecutors from [REDACTED] pertaining to [REDACTED]. [REDACTED] states that she had told MAXWELL that she was going to go to [REDACTED]. [REDACTED]

When [REDACTED] met MAXWELL she told her it was her intention to go to [REDACTED]. [REDACTED]

[REDACTED] told MAXWELL this when she met her. [REDACTED]

[REDACTED] is asked about the black books that she had previously

mentioned. She stated that [REDACTED] had one but it wasn't black. It was just sheets of paper that were constantly updated.

EPSTEIN's secretary would always update his address book and they would call [REDACTED] to get updated information.

[REDACTED] is then shown the address book. She [REDACTED] [REDACTED] She points out her phone number and says that was her number for a long time. She does not know who "moms friend" is. She never saw EPSTEIN's physical book.

[REDACTED] is then shown a photobook and gives the following response to each page as to if she recognizes the person or not:

- 1 No
- 2 Don't recognize but saw a blonde women on the island
- 3 Looks familiar but don't know why
- 4 Looks like one of the girls leaving the New York house
- 5 No
- 6 No
- 7 Yes, that's Jeffrey (cries in shock and states she wasn't ready for that)

[REDACTED] is then shown a photograph of herself nude. [REDACTED] states "that's me" and she thinks it was taken in Palm Beach. She states that she remembers being there and being in the situation and asked to be naked or topless. [REDACTED] is not sure how old she was in this picture.

[REDACTED] talks about the first meeting with MAXWELL for tea that she had. [REDACTED] talked to MAXWELL about her traumatic childhood with her mother. She told MAXWELL that [REDACTED] and she would have to massage her to feel better.

[REDACTED] knew MAXWELL for about 2 months prior to meeting EPSTEIN.

When [REDACTED] met EPSTEIN she tried to dress very professionally. [REDACTED] thought that she was meeting a very important man. She recalls borrowing a skirt and jacket from her mother. When she came into the house MAXWELL told her to be quiet as EPSTEIN was on the phone. MAXWELL was acting very different then the last few times she had seen her. [REDACTED] waited awkwardly for EPSTEIN to get off the phone.

After he get off the phone MAXWELL introduces [REDACTED] to EPSTEIN and says this is the girl I was talking about. MAXWELL talks about [REDACTED] to EPSTEIN. EPSTEIN spoke crude and aggressive to [REDACTED] but was nice and seemed impressed. MAXWELL was encouraging of [REDACTED] to talk more about herself. EPSTEIN seemed to know a lot about everything.

MAXWELL says that [REDACTED] has very strong hands and she tells [REDACTED] to squeeze EPSTEIN's feet to show how strong they are. EPSTEIN is wearing socks. EPSTEIN tells [REDACTED] to move to his shoulders. Then the phone ring and [REDACTED] stops. MAXWELL then tells [REDACTED] that the meeting is over by motioning towards the door to leave.

During this same trip MAXWELL calls [REDACTED] to come to her house to massage EPSTEIN because their massage therapist canceled on them. [REDACTED] gets there and MAXWELL shows her up the stairs. She goes into the massage room where there is a professional massage table and she hands [REDACTED] a bottle of oil. EPSTEIN was in the room wearing a robe. He takes of the robe and is naked. He lies face down on the table. MAXWELL is still in the room when he takes off the robe and then she closes the door.

[REDACTED] massages his neck and back. EPSTEIN encourages her and says she's doing good and gives her direction. At a certain point he turns over. [REDACTED] is wearing a t-shirt and recalls it was warm. EPSTEIN asked her either this massage or the second massage to take her shirt off.

MAXWELL was happy afterwards and asked [REDACTED] how it went. [REDACTED]

said she thinks it went OK. MAXWELL said that [REDACTED] saved her today and you're so great. MAXWELL says well grow to be great friends. [REDACTED] did not get anything for this massage. It was clear that if she wanted to be friends that this was part of the deal.

The second massage MAXWELL brings [REDACTED] upstairs and EPSTEIN is already naked. MAXWELL says "you know the drill... I'll leave you two to it...have a good time". This second massage was more sexualized. EPSTEIN put her hand on his penis and he ejaculated. There was a lot of touching and asking [REDACTED] to be naked. He grabbed her breasts and in-between her legs. [REDACTED] removed her top and was scared.

The first massage EPSTEIN turned over and had an erection and asked if [REDACTED] was uncomfortable with it. EPSTEIN put her hand on his penis and said you don't have to be scared of it. He may have ejaculated. This massage she felt she was being tested as he touched the outside of her legs.

After the second massage he says "good girl". [REDACTED] was so scared and she was having trouble breathing. She sees MAXWELL afterwards as she is outside the door. MAXWELL hugs [REDACTED] and goes into the room. MAXWELL then comes out and gives [REDACTED] a little hug and says "you did a great job". MAXWELL was really excited. [REDACTED] does not recall if she was given anything for this massage.

There were more than 2 massages given in London. MAXWELL would only call [REDACTED] is she needed her after this but would ask if she was dating someone. MAXWELL asked [REDACTED] if she knew anyone that could come over to give EPSTEIN a blow job. She says "Young and pretty like you...you know what he likes". At this point both [REDACTED] and MAXWELL know the massage thing was a ruse. MAXWELL told [REDACTED] that EPSTEIN needed a lot of sexual attention but she needed other people to help so she didn't have to do it all by herself.

In Palm Beach [REDACTED] told EPSTEIN that she no longer wanted to participate in sexual activities.
