██████████, date of birth ██████████, was interviewed over video conference. Present on the video call was ██████████ attorney ██████████. Also present on the call was Assistant United States Attorneys ██████████, ██████████, and ██████████, along with Detective ██████████ and Special Agent ██████████. After being advised of the identity of the above listed individuals and the nature of the interview, ██████████ provided the following information:

██████████ grew up in South Florida, where he attended some college. At the time of this interview, ██████████ worked as a telemarketer and lived in ██████████ Florida.

██████████ met JEFFREY EPSTEIN once. ██████████ went with his girlfriend at the time, ██████████, to EPSTEIN's home in Palm Beach. ██████████ thought this may have been around 2002 when he was a senior in high school. EPSTEIN pulled up to the house in a convertible. ██████████ recalled EPSTEIN put the hood down. ██████████ described EPSTEIN as "flashy".

██████████ and ██████████ shared a phone. ██████████ would answer the call sometimes when EPSTEIN and ██████████ called.

██████████ met ██████████ in approximately 2001/2002 when he was 17 years old and a senior in high school. ██████████ met EPSTEIN through ██████████. ██████████ went to school with ██████████ at ██████████. ██████████ was either a junior or senior when ██████████ met her. ██████████ had a boyfriend, ██████████. ██████████ and ██████████ would smoke pot together. ██████████ had known ██████████ for approximately 3-5 months at the time. ██████████ was asked if his girlfriend would like to make money. When ██████████ asked how much, he was told \$200. ██████████ told ██████████ that she would have to massage an old guy. ██████████ took ██████████ to EPSTEIN's home.

██████████ and ██████████ were at ██████████ and ██████████' apartment. ██████████,

[REDACTED], and [REDACTED] were having a conversation about EPSTEIN. [REDACTED] said EPSTEIN knew famous people then showed a picture and asked [REDACTED] if he knew who was in the photo. [REDACTED] told [REDACTED] that PRINCE ANDREW was in the photo.

When [REDACTED] and [REDACTED] were in the car with [REDACTED] and [REDACTED], EPSTEIN came up in conversation.

[REDACTED] had told [REDACTED] that EPSTEIN was a little pervert and said that [REDACTED] and [REDACTED] might have to massage EPSTEIN topless. [REDACTED] told [REDACTED] this when they were sitting in the car. [REDACTED] told [REDACTED] that EPSTEIN always wanted girls and asked if [REDACTED] knew any that would want to go.

[REDACTED] went to EPSTEIN's home two to three times a week. EPSTEIN told [REDACTED] that she needed to start bringing friends. [REDACTED] lived in a trailer park so he knew girls who needed money. [REDACTED] brought girls to EPSTEIN.

When [REDACTED] and [REDACTED] spent time with [REDACTED] and [REDACTED], [REDACTED] and [REDACTED] would hang out together while [REDACTED] and [REDACTED] hung out together. [REDACTED] did not know what [REDACTED] and [REDACTED] talked about.

[REDACTED] recalled that [REDACTED] was driving the first time he, [REDACTED], [REDACTED], and [REDACTED] all went to EPSTEIN's home. EPSTEIN's house was at the end of El Brillo Way. They parked in front. [REDACTED] and [REDACTED] went up the driveway while [REDACTED] and [REDACTED] stayed in the car and got high. [REDACTED] asked [REDACTED] if [REDACTED] was too young because she was not yet 18. [REDACTED] had said that EPSTEIN was helping her get through school and could help [REDACTED] as well. [REDACTED] and [REDACTED] were paid \$200 cash in hundred dollar bills. [REDACTED] made extra money because they bought extra drugs. [REDACTED] asked [REDACTED] if she could go back to EPSTEIN's home and [REDACTED] told her yes. Approximately a week or two later, EPSTEIN contacted [REDACTED] to get in touch with [REDACTED].

[REDACTED] dealt with a girl named [REDACTED]. [REDACTED] knew her name because he and [REDACTED] shared a phone and he had answered. [REDACTED] would tell [REDACTED] that EPSTEIN wanted [REDACTED] to come out to the house. [REDACTED] did not meet [REDACTED] but thought he did see her in the driveway. [REDACTED] described [REDACTED] as a "good looking [REDACTED] girl". [REDACTED] was professional when she

called. [REDACTED] would ask [REDACTED] if [REDACTED] was available or if she could bring someone with her. [REDACTED] called approximately one to two times a week.

[REDACTED] also recalled another woman, who was European, who called for [REDACTED]. This woman had an accent that was not British. [REDACTED] thought her accent may have been French. [REDACTED] did not meet this woman.

They would pay for the taxi and then [REDACTED] would get an extra \$20 for the cab back home. [REDACTED] would go with [REDACTED] and sit, hang out, and smoke pot. [REDACTED] would wait about an hour for [REDACTED]. When [REDACTED] came out of the house, she always had money with her. [REDACTED] received \$200 for a while, then when she brought girls she started receiving \$300.

[REDACTED] thought [REDACTED] brought the following girls:

- [REDACTED] [REDACTED]
- [REDACTED] [REDACTED]
- [REDACTED] LAST NAME UNKNOWN, who had red hair but is now deceased
- Possibly some friends [REDACTED] knew before she dated [REDACTED]

[REDACTED] also thought [REDACTED] brought [REDACTED] whose last name he did not recall, not [REDACTED] but a different [REDACTED]. [REDACTED] also recalled [REDACTED] bringing [REDACTED], whose last name he did not recall. [REDACTED] recalled parents calling parents and things tumbled down from there. [REDACTED], [REDACTED], [REDACTED], and [REDACTED] all got lawyers when EPSTEIN was arrested. Lawsuits were settled and the girls received money.

[REDACTED] sister, [REDACTED] who was 19 years old, went to EPSTEIN's home. There was a lot of talk about it because [REDACTED] could not go there anymore because she was too old. [REDACTED] told [REDACTED] that EPSTEIN had told her [REDACTED] was not allowed back.

[REDACTED] stopped going to EPSTEIN's home in approximately [REDACTED]. [REDACTED] and [REDACTED] was born [REDACTED] and [REDACTED] had stopped going to EPSTEIN's home when she was pregnant. [REDACTED] and [REDACTED] moved away together. [REDACTED] thought [REDACTED] had started seeing EPSTEIN when she was around 15 years old and stopped seeing EPSTEIN when she was 16 going on 17 years old.

[REDACTED] was arrested [REDACTED] in or around 2008 and was put in the stockade. EPSTEIN was also in the stockade at this time. EPSTEIN saw [REDACTED] and called him over to the fence. EPSTEIN asked [REDACTED] if [REDACTED] remembered him and asked if his lawyers could contact [REDACTED]. EPSTEIN gave [REDACTED] his lawyers' card. [REDACTED] thought this was regarding a lawsuit some of the girls had brought at the time. [REDACTED] later met with EPSTEIN's lawyers at a "Darth Vader building" but did not really say anything.

Sometimes, [REDACTED] interacted with the landscapers at EPSTEIN's home.

[REDACTED] recalled [REDACTED] coming out of EPSTEIN's home and telling him she felt uncomfortable. When [REDACTED] asked her what she meant, [REDACTED] told him there was another girl there and whenever she was there she wanted [REDACTED] to do things. [REDACTED] came to find out this was GHISLAINE MAXWELL. [REDACTED] had described MAXWELL to [REDACTED] as someone who had black hair and was British. [REDACTED] also described MAXWELL as an aggressive, rude, and nasty woman. [REDACTED] remembered [REDACTED] mentioning the name "MAXWELL". [REDACTED] did not want to be there when MAXWELL was there.

MAXWELL was supposed to be a massage therapist and/or teacher. MAXWELL was friends with EPSTEIN. MAXWELL was supposed to show [REDACTED] what EPSTEIN liked. A few times MAXWELL was at EPSTEIN's home and [REDACTED] was uncomfortable. [REDACTED] recalled [REDACTED] saying something like, "this woman is supposed to be teaching me is just mean/rude". [REDACTED] knew [REDACTED] was extremely bothered by MAXWELL. MAXWELL was supposed to be teaching [REDACTED] how to massage EPSTEIN.

[REDACTED] had described [REDACTED] to [REDACTED] as someone he would like.

Sometimes when [REDACTED] went to EPSTEIN's home, she would come out with \$400-\$500. This was when [REDACTED] would have brought a girl. [REDACTED] went up to the room with her girlfriends.

[REDACTED] was "kinda seeing" [REDACTED]. [REDACTED] told [REDACTED] that [REDACTED] was not just doing what [REDACTED] thought and told him it was not just massages that she was doing. When [REDACTED] asked [REDACTED] about it, she told him that EPSTEIN wanted "handjobs" but that she did not do that and that's why she brought girls. [REDACTED] told [REDACTED] that EPSTEIN had a "weird shaped penis" with a "pee hole on the side of his dick".

The money would be sitting there on the table and EPSTEIN would excuse himself to clean up.

[REDACTED] did not know if [REDACTED] massaged anyone else.

For [REDACTED] birthday, EPSTEIN asked her what she wanted. EPSTEIN gave [REDACTED] tickets to see INCUBUS. EPSTEIN had asked [REDACTED] who her favorite singer was and she told him MICHAEL JACKSON. EPSTEIN had JACKSON call [REDACTED] on her birthday. [REDACTED] got off the phone and told [REDACTED] it was JACKSON who called. [REDACTED] and [REDACTED] were living together at this time with her mother. This was when they were living in [REDACTED] together.

EPSTEIN sent [REDACTED] a "cheesy B movie" and lingerie. [REDACTED] recalled seeing the packaging on the lingerie saying it was from Paris. When [REDACTED] said that was strange, [REDACTED] told [REDACTED] that EPSTEIN wanted her to model it for [REDACTED].

When [REDACTED] would call, she would say something like, "This is [REDACTED] from Jeffrey's...is she available...is anyone coming with her...does she need a ride". Sometimes [REDACTED] would hear that EPSTEIN was not in town but was coming on a certain day. [REDACTED] knew EPSTEIN had places in New York, France, and Florida. [REDACTED] had told him that EPSTEIN knew the New York area. [REDACTED] was originally from New York.

When [REDACTED] left, [REDACTED] started going to EPSTEIN's home more. [REDACTED] asked [REDACTED] where [REDACTED] had gone, and he was told that EPSTEIN had sent her to [REDACTED]. [REDACTED] never came back. If [REDACTED] had wanted to pursue what [REDACTED] did, EPSTEIN and [REDACTED] had told her they would help [REDACTED] with whatever she wanted to study.

[REDACTED] did not talk to people about it. [REDACTED] did not talk to the press or law enforcement.

[REDACTED] went from seeing EPSTEIN to working in prostitution. In or

around 2005 when [REDACTED] and [REDACTED] son was around [REDACTED] old, [REDACTED] left.

[REDACTED] told [REDACTED] that when she was in the room with EPSTEIN other girls gave EPSTEIN "handjobs and blowjobs". [REDACTED], [REDACTED], and [REDACTED] would all throw each other under the bus saying it was the other girl who was engaging in sex acts with EPSTEIN. [REDACTED] was [REDACTED] boyfriend so she was not going to tell him what was going on. [REDACTED] knew more was going on. [REDACTED] had been told that [REDACTED] had sex with EPSTEIN.

[REDACTED] told [REDACTED] that EPSTEIN and [REDACTED] knew [REDACTED] was underage because they were trying to help her with school. They wanted to put [REDACTED] in school and help her with massage therapy. [REDACTED] was not going to school at this time as she had dropped out when she was 13 years old.

The first time [REDACTED] went to EPSTEIN's home, [REDACTED] was living across the street from [REDACTED]. They lived on [REDACTED] in West Palm Beach. They moved after they dated for a bit. [REDACTED] stopped going to school and lived with [REDACTED], her mother, and her brothers. They lived in hotels. They moved to [REDACTED].

[REDACTED] and [REDACTED] did not have money at the time. [REDACTED] mother was on drugs. [REDACTED] was working at Wendy's and he would get around \$250 for working for two weeks. The possibility of [REDACTED] making \$200 an hour was a lot. When [REDACTED] asked [REDACTED] if she should do it, he told her that [REDACTED] was doing it and she would not steer [REDACTED] wrong. They would spend the money on alcohol and drugs, including weed, pills, ecstasy. [REDACTED] said it was "play money".

[REDACTED] did not know if pictures were taken of [REDACTED]. [REDACTED] did not think [REDACTED] had a passport.

[REDACTED] went with [REDACTED] one to two times, then on maybe the second time she went [REDACTED] told [REDACTED] that she was going to give EPSTEIN her number so they could call [REDACTED] direct. Approximately a month later, [REDACTED] was gone. [REDACTED] went to EPSTEIN's home every week, approximately two to three times a week. [REDACTED]. [REDACTED] became pregnant and she and [REDACTED] moved away together.
