


- On May 18, 2021, we had a brief phone call with [REDACTED] to discuss testifying at trial and logistics of trial prep; the conversation was not substantive, and it was not an interview
- On November 2, 2021, prepared for trial testimony. [REDACTED] previously undisclosed, clarifying, or different recollections/information below:

- DM knew [REDACTED] and developed a relationship with [REDACTED] told [REDACTED] about family history growing up, [REDACTED]
- At time applying for colleges, subject of finances came up; DM remembers [REDACTED] talking about how she was going to pay for college, searching for scholarships and financial aid; [REDACTED] would talk about certain schools she wanted to go to, certain schools were more expensive
- [REDACTED] and JE went to some kind of show together during trip to NY
- [REDACTED] had first conversation about NY approximately 3 to 4 months after started dating
- [REDACTED] had convo about NM approximately 6 months after started dating
- [REDACTED] spoke about NY trip first; came up in talking about [REDACTED] and [REDACTED] relationship with JE; [REDACTED] was excited that Epstein was opening doors for [REDACTED]
- [REDACTED] that she couldn't bring herself to tell [REDACTED] or anyone else what had happened in New York; she felt confused and awkward because of JE's relationship with [REDACTED] didn't want to ruin it
- [REDACTED] that Ghislaine Maxwell collected [REDACTED] from airport, was host for trip; GM described weekend ahead to [REDACTED]
- [REDACTED] described ranch, big, nice luxurious house; had her own room to stay in during the visit
- [REDACTED] that GM was excited to introduce [REDACTED] to professional massage, that [REDACTED] would get her first massage in NM
- GM explained to [REDACTED] what a massage was like; at some point GM started giving [REDACTED] a massage; cannot recall if JE or GM who touched [REDACTED] breasts, but it was one of the two of them
- Not sure what [REDACTED] was wearing during massage
- Remembers [REDACTED] telling [REDACTED] she was in massage room with GM and massage was underway; [REDACTED] looked up and realized JE was in the room; surprised to see JE in the room

[REDACTED] convo with Annie in [REDACTED] was in [REDACTED]

[REDACTED] told [REDACTED] that JE paid for trip to [REDACTED] before she went on the trip

- [REDACTED] communicates with [REDACTED] about once a month; have spoken about how strange to revisit memories of events, but haven't gone into detail of events
- When other JE news started coming out, had been years since [REDACTED] discussed; [REDACTED] reached out to talk about they how had gone through this together [REDACTED] reflecting as an adult and that he didn't have perspective at time when they were going through it; didn't discuss details
