Please review the attached which is what would be sent to media partners, get posted to FBI New York's website and disseminated via social media. Since we want to draw as much attention as possible, we may send an embargoed version of the press release (they cannot do anything with the release until a FBI set time i.e. the agreed go live date/time) to certain media entities in order to set up interviews in advance of the press release and social media posts going live

Also attached are three potential mockup social media posts to be published on FBI New York social media feeds (X, Facebook, and Instagram).

I would also reach out to my OPA colleagues throughout the bureau in AORs where victims may be located and ask that they post and get the word out as well.

**FBI New York Searches for Possible Victims in Sexual Exploitation Investigation**

*New York, NY* – On April 25, 2023, a federal complaint in the Southern District of New York charged Cameron McEwen with one count of sexual exploitation of a minor and one count of making extortionate interstate communications. The FBI's New York Office believes there may be additional victims in this case.

Investigators say McEwen allegedly used Snapchat to meet individuals whom he would then offer to pay for sexually explicit images and videos. When that individual sent McEwen the requested content, he threatened to leak the images and videos to the individual's family and friends and harm her if she did not find another person to send McEwen sexually explicit material. Investigators say he used several aliases to include a/k/a "X," a/k/a "Cam," a/k/a "dzys.world," a/k/a "itsbeendrippy," a/k/a "fendii," a/k/a "fendii.kashout," a/k/a "ny.cam01," and a/k/a "Dizzyyyy.xo"
