COMPLAINT FOR DAMAGES


Comes now Plaintiff, Michael K. Geilenfeld, and makes this Complaint against Defendants and respectfully show the Court the following:

1.

The Defendant INTERNATIONAL CHILDREN'S RIGHTS ADVOCATES SOCIETY, INC., hereinafter, ICRAS, is a corporation licensed to operate in the State of Georgia, and may be served through its registered agent, Sarah Dirksen, at her address, 1595 CHATTAHOOCHEE RUN DRIVE, SUWANEE, GWINNETT COUNTY, GA, 30024.

2.

The Defendant VALERIE DIRKSEN, INDIVIDUALLY, AND IN HER ROLE AS PRESIDENT OF INTERNATIONAL CHILDREN'S RIGHTS ADVOCATES SOCIETY, INC. is a resident of the State of Georgia. She may be served where she resides in 1595 CHATTAHOOCHEE RUN DRIVE, SUWANEE, GWINNETT COUNTY, GA, 30024.



3.

Defendants are subject to the jurisdiction and venue of this Court by virtue of their status as a joint wrongdoer or joint tortfeasor with the other Defendants.

4.

Venue of this action is proper in this court pursuant to O.C.G.A. § 14-2-510(b)(1) as Defendant corporation maintains its registered office here and Defendant VALERIE DIRKSEN, INDIVIDUALLY, AND IN HER ROLE AS PRESIDENT OF INTERNATIONAL CHILDREN'S RIGHTS ADVOCATES SOCIETY, INC is a resident of Gwinnett County.

BACKGROUND INFORMATION

5.

Plaintiff Michael Geilenfeld, a former Brother with the Missionary Brothers of Charity, is the founder of St. Joseph Family of Haiti, hereinafter "SJF", which operates a network of nonprofit institutions that provide residence, room & board, formal education, and religious training and education to disabled and disadvantaged Haitian children.

6.

In addition to St. Joseph Family of Haiti, Plaintiff Michael Geilenfeld founded Casa De Los Dos Rios in Higuey, Dominican Republic which provides support to disadvantaged adults and children in the Dominican Republic by supplying food, financial, and educational support to the poorest families in the area.

7.

SJF operates St. Joseph Community Outreach Center, Wings of Hope, and Lekòl Sen Trinite. The SJF, which was founded by Michael in 1985 as a refuge for formerly destitute street

children, grew quickly into a residence and school for more than 30 former child slaves, street children, and orphans, and led to subsequent other ministries (Wings of Hope, Lekòl Sen Trinite).

8.

At the Outreach Center, the children received permanent residence, room and board, meals, arts and vocational training, and formal academic education outside the home, among other accommodations.

9.

In or around 2011, a self-proclaimed "journalist" named Paul Kendrick began to publish numerous defamatory statements against Plaintiff Michael Geilenfeld and the above-referenced organizations, falsely claiming Plaintiff sexually abused children.

10.

On or about January 31, 2011, Mr. Kendrick emailed several of the organizations' benefactors, spreading such vile falsehoods that Plaintiff Geilenfeld sexually abused children.

11.

On or about February 1, 2011, Mr. Kendrick admitted to his associate, Bonnie Elam, that he could not and did not verify the veracity of the false statements he spread.

12.

Despite Mr. Kendrick's admission stated in paragraph 11, however, he continued to spread the vile and disgusting allegations to several of the organizations' benefactors.

13.

On or about February 6, 2013, a lawsuit was filed by Hearts with Haiti, Inc. and above-referenced Plaintiff Michael Geilenfeld against Paul Kendrick for defamation, false light, and

tortious economic interference, CA: 2:13-cv-00039-JAW in United State District Court, District in Maine.

14.

On or about February 21, 2014, Defendant Valerie Dirksen was deposed as a nonparty witness in the CA: 2-13-cv-00039-JAW case.

15.

During that deposition, Defendant Valerie Dirksen testified that she heard Plaintiff Geilenfeld could not go to Detroit and Boston, due to the accusations stated above in or around May of 2011.

16.

Defendant Valerie Dirksen testified that she met with Homeland Security Investigators related to the sexual abuse allegations at St. Joseph's Home in or around June 2, 2011.

17.

After the meeting described in paragraph 16, Defendant Valerie Dirksen was told the sexual abuse allegations were old, and that Plaintiff Michael Geilenfeld was innocent.

18.

On July 23, 2015, a 10-person jury in the USDC returned unanimous verdicts in favor of Hearts with Haiti, Inc. and Michael Geilenfeld against Paul Kendrick, finding that Mr. Kendrick negligently defamed Plaintiff Geilenfeld, that Plaintiff Geilenfeld had proven, by clear and convincing evidence, that Mr. Kendrick defamed him knowing the sexual abused statements were false, or with reckless disregard for their truth; that Mr. Kendrick placed Plaintiff Geilenfeld in a false light; and that Mr. Kendrick intentionally interfered with the advantageous economic relations of Plaintiff Geilenfeld.

19.

Defendant Valerie Dirksen was in attendance during the trial described in paragraph 18, including when the jury returned unanimous verdicts in favor of Hearts with Haiti, Inc. and Michael Geilenfeld, vindicating his name of the vile sexual misconduct allegations described above.

20.

On April 27, 2017, the CA: 2-13-cv-00039-JAW case in USDC, District of Maine, was dismissed for lack of subject matter jurisdiction.

21.

Substantially the same complaint was filed in the State of Maine Superior Court, CA: CV-16-313, a copy of which was delivered to Defendant Valerie Dirksen on or about April 19, 2018.

22.

The CA: CV-16-313 case settled on August 27, 2019.

GENERAL ALLEGATIONS

23.

On February 18, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, "This Guy Hunts Down Pedophiles and Beats Them with a Hammer." Within the comments portion of her post, Defendant Valerie Dirksen published, "...That is why I have been advocating for the victims of the serial child abuser Michael Geilenfeld..." See attached screenshot of the post.

24.

On January 8, 2020, Defendant Valerie Dirksen published via Facebook, an article about Plaintiff Michael Geilenfeld, falsely accusing him of sexual abuse. The article is titled, "Michael

Geilenfeld Accused of Sexual Abuse for over 30 years – Stop Sexual Abuse in Haiti,” and the article depicts a picture of Plaintiff Michael Geilenfeld. See attached screenshot of the post.

25.

On January 9, 2020, Defendant Valerie Dirksen published via Facebook, an article tying Jeffrey Epstein and Plaintiff Michael Geilenfeld stating, in pertinent part, “...We the people need to take back the justice system... The same is true for multiple accused pedo with current Arrest warrant and red interpol arrest warrant for rape, sexual aggression and abuse of title. Catholic Archbisoph Gregory was told about this abuse by **Michael Geilenfeld** of orphans in his care in Haiti in 2003!” See attached Facebook post.

26.

On January 24, 2020, Defendant Valerie Dirksen published via Facebook, an article titled “Ocnam Dameus; the Government [Prosecutor] who signed the arrest warrant for multiple accused pedophile Michael Geilenfeld...,” essentially claiming that Plaintiff Michael Geilenfeld was found innocent of the vile allegations because someone had attempted to shield and protect him. See attached Facebook post.

27.

A publisher named “SPEAK Project” had apparently spoken with Defendant Valerie Dirksen, in her role as Président of Defendant ICRAS, where she asked SPEAK Project “to help ensure the safe-keeping of several young people who had testified against accused pedophile mob-boss Michael Geilenfeld...” Such discussion was published on February 16, 2020 by SPEAK Project via the internet on its website, projectspeak.net. See attached article.

28.

Defendant Valerie Dirksen, individually and in her role as President of ICRAS, intentionally and/or negligently caused her discussion with SPEAK Project described in paragraph 27 to be published.

29.

In the article published by SPEAK Project described in paragraph 27, in her role as President of Defendant ICRAS, Defendant Valerie Dirksen encouraged others to donate to the cause and directed viewers to Defendant ICRAS, website, ICRAS8.com.

30.

On or about October 12, 2019, Defendant Valerie Dirksen, individually, and in her role as President of ICRAS, had written and had SPEAK Project publish, an article titled, "Michael Geilenfeld – Accused Serial Pedophile," including a picture of Plaintiff.

31.

At the end of article described in paragraphs 27 and 28, Valerie Dirksen, individually and in her role as President of ICRAS, intentionally and/or negligently caused her article described in paragraph 30 to be published again on February 16, 2020.

32.

On February 18, 2020, Defendant Valerie Dirksen, individually, and in her role as President of ICRAS, published an article she drafted via Facebook. Within that article, Defendant Dirksen stated, "...The Haitian Timoun Foundation is one of several fundraising arms for the multiple accused pedophile, Michael Geilenfeld..." among several statements, tying alleged sexual misconduct, again, to Plaintiff.

33.

On February 18, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, "Shock in Haiti to Learn Burned Church Orphanage had Budget of \$6M." Within her post, Defendant Valerie Dirksen published a comment, stating, "They had the protections of minors from the DCPJ... the same authorities who have testimony from over 20 victims of a serial child abuser, Michael Geilenfeld... See attached Facebook post.

34.

On July 31, 2020, Defendant Valerie Dirksen published a video from Glenn Beck discussing documents that were unsealed in a case involving Jeffrey Epstein. Within her post, Defendant Valerie Dirksen tied Plaintiff to Epstein, and published, "They all think they can get away with this: ThNk God there is an active arrest warrant in Haiti and interpol arrest warrant for Michael Geilenfeld." See attached Facebook post.

35.

Upon information and belief, as of July 31, 2020, however, no "active arrest warrant" existed regarding Plaintiff. Defendant Dirksen was informed that warrant numbered 294 had long been withdrawn.

36.

On July 31, 2020, Defendant Valerie Dirksen published an article titled, "Louisiana Upholds Life Sentence to Black Man for Stealing Hedge Trimmers in 1997." With the article, she posted, "Can't he get a pardon? That is someone who deserves a pardon!" Within the comments of her publication, Defendant Valerie Dirksen commented and published, "... but pedos like Michael Geilenfeld who have red Interpol arrest warrants walks free? Geilenfeld is charged with rape, sexual aggression and abuse of title of the orphans in his case and he was dropped off at JFK

airport by the Dominican police because the Americans would not pick him up. This makes me sick!" See attached Facebook post.

37.

On August 13, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, "Executive Order Blocking the Property of Persons Involved in Serious Human Rights Abuse or Corruption," commenting, "Does that mean they will go after Michael Geilenfeld?" See attached Facebook post.

38.

On August 16, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, "Clergy Sexual Abuse Settlements." Within her publication, Defendant Valerie Dirksen stated, "...Shameful and disgraceful! Archbishop Gregory in DC has known about a serial pedo who associated himself with Mother Teresa's Missionaries of Charities as the first American brother Michael Geilenfeld who has an arrest warrant and red Interpol arrest warrant..." See attached Facebook post

39.

On August 27, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, commenting with her post, "another one... friends with Michael Geilenfeld" and tying the accusatory statements about the priest to Plaintiff. See attached Facebook post.

40.

On December 17, 2020, Defendant Valerie Dirksen published via Facebook, an article titled, "Epstein's "rapist" pal Jean-Luc Brunel arrested for 'sex trafficking models,'" commenting with her post, "Brunel, not his real name was detained. It's a good day. Interesting that the man

wife of multiple accused child abuser of orphans in Haiti, michael geilenfeld, who has active arrest Aggression and abuse of title, is named Brunel too!" See attached Facebook post.

41.

On January 25, 2021, Defendant Valerie Dirksen published via Facebook, a video titled, "Stanley Lucas has done a lot of harm to Haiti, you should listen to how he created an organization to break the ass of Haiti. With her post, Defendant Valerie Dirksen published, "Stanley Lucas with multiple accused American pedophile Michael Geilenfeld in Haiti. He is very aware of the problem with human trafficking in Haiti!" See attached Facebook post.

42.

On January 30, 2021, Defendant Valerie Dirksen published via Facebook, an article titled, "Late Mother Teresa's Order Investigate for Child Trafficking in India." With her post, Defendant Valerie Dirksen published, "Isn't that interesting. She was connected to an American [Michael Geilenfeld] who operated orphanages in Haiti and was accused over 10 times of sexually, physically, and emotionally, abusing orphans and abandoned children in his care. There is an outstanding arrest warrant and red Interpol arrest warrant in Haiti for his arrest. He was dropped off at JFK by Dominican police because the DR and Haiti do not have an extradition agreement. Don't you think the victims deserve justice? Why do people at local churches like Epiphany Lutheran Church support the pedophile but not the victims? Where has everyone gone? What about all that "brother we got your back" crap? More lies? Very sad to think all the churches are involved and so is Rotary International past President Barry Rasin. Rassin was listed as a major donor to Michael Geilenfeld but refused to help the victims. Is everything fake? See attached Facebook post.

43.

On February 4, 2021, Defendant Valerie Dirksen published via Facebook, an article titled, “German nuns ‘rented’ orphaned boys to businessmen for ‘gang bangs & orgies’ – suppressed report seen by media.” With her post, Defendant Valerie Dirksen published, “The report was so gory it was not suitable for public viewing”. Well, there was a nun who worked with Michael Geilenfeld. She took her habit off on weekends to party. She was in a lesbian relationship with one of the directors. Um ok ok. But the thing that made you really pause, was when you heard about the gay couples who would call her to say they would be in Haiti for a week, and needed an 8 year old boy. That really paralysed me. Imagine the poor orphan who would be chosen. I was thinking to myself, did he know? Was he excited at first to think he would have a week of fun and ice cream? This has continued despite the US embassy knowing what is happening in American run orphanages and ibesr the CPS of Haiti and the highest ranking members of government knowing. There is no circling back on this for me. Everyone who turned their back on the children of Haiti are responsible. There are a lot of guilty parties! See attached Facebook post.

44.

On February 23, 2021, Defendant Valerie Dirksen published via Facebook, a video depicting an image of Plaintiff Michael Geilenfeld, with the words, “Sexual Abuse in Haiti. Children trafficking in Haiti’s orphanages.” See attached Facebook post.

45.

On February 24, 2021, Defendant Valerie Dirksen published via Facebook an article, and stated, “You see how these people are fundraising and spreading propaganda through the churches? The ST Joseph home for boys was never full of street kids. It was closed down in 2015 because the founder Michael Geilenfeld and his supporters were involved in sexually, emotionally

and physically abusing the children in the house. There is a \$3.27 bil us business in Haiti. Human trafficking is happening in these orphanages that are unregulated and unlicensed. St Joseph home for boys was not licensed. Does the person on this video from the church not realize there is an arrest warrant and red Interpol arrest warrant out for Geilenfeld? The us embassy knows, the Dominicans know, former chief of police Gideon knows, current chief Leon Charles knows! They all know. How can this woman and her church not know? Is she paid to do this? Who wrote her script? She is welcome to call me to discuss ways to help the victims become survivors!" See attached Facebook post.

COUNT I: LIBEL AND DEFAMATION PER SE

46.

Plaintiff references and incorporates the foregoing paragraphs as if fully set forth and alleged herein.

47.

Defendant Valerie Dirksen's false and malicious statements of Plaintiff Michael Geilenfeld as published to the general public via Facebook and various other publications, as described in General Allegations of this complaint, continue to injure Plaintiff Michael Geilenfeld's reputation and continue to expose him to public hatred, contempt, and ridicule.

48.

Defendant Valerie Dirksen, Individually, and in her role as President of ICRAS, and Defendant ICRAS knew or should have known, by virtue of her discussions with the Homeland Security Investigators and her attendance of the Maine lawsuit, that the vile and disgusting statements she continues to attribute to Plaintiff Michael Geilenfeld are false and will forever injure his reputation and subject him to public hatred, contempt, and ridicule.

49.

Defendant Valerie Dirksen, Individually, and in her role as President of ICRAS's actions and conduct are imputed to Defendant ICRAS.

50.

Pursuant to O.C.G.A. § 51-5-1, such statements constitute libel.

51.

As a direct and proximate result of Defendants' false and malicious statements, Plaintiff has suffered and continues to endure such ridicule from people all over the world and in the United States. Accordingly, Plaintiff is entitled to recover for the actual, consequential, and punitive damages sustained in an amount to be proven at trial.

COUNT II: INTENTIONAL INFLICTION OF EMOTIONAL DISTRESS

52.

Plaintiff references and incorporates the foregoing paragraphs as if fully set forth and alleged herein.

53.

Defendants publications of such vile and false statements amounts to intentional and/or reckless conduct.

54.

Defendants conduct is and continues to be extreme and outrageous.

55.

As a direct and proximate result of Defendants' false and malicious statements and conduct, Plaintiff suffered and continues to suffer emotional distress.

56.

Plaintiff's emotional distress is severe as he cannot ever return to a normal life and will be subject to such ridicule, contempt, and hatred due to the false, vile, and disgusting conduct by Defendants.

COUNT III: ATTORNEY FEES

57.

Plaintiff references and incorporates the foregoing paragraphs as if fully set forth and alleged herein.

58.

In defense of this action, Defendants have acted in bad faith in the underlying transaction. Plaintiff is entitled to an award of attorney fees and expenses of litigation under O.C.G.A. § 13-6-11. Plaintiff specifically prays for such an award.

COUNT IV: PUNITIVE DAMAGES

59.

The actions of Defendants Valerie Dirksen, Individually, and in her role President of ICRAS and ICRAS in this case show willful misconduct, malice, fraud, wantonness, oppression, or that entire want of care which raises the presumption of conscious indifference to the consequences.

60.

Accordingly, Plaintiff Geilenfeld is entitled to an award of punitive damages for which he specifically prays pursuant to O.C.G.A. § 51.12.5.1(d)(1).

Plaintiff is entitled to and prays for an award of punitive damages in an amount to be determined by an enlightened and impartial jury.

WHEREFORE, Plaintiff prays as follows:

- (a) that process issue and the Defendants be served according to law;
- (b) that Plaintiff have a jury trial on all issues raised in this Complaint;
- (c) that Plaintiffs have judgment against Defendants for damages sustained, attorney fees, costs, expenses of litigation, and other damages in the amount of an enlightened and impartial jury;
- (d) that Plaintiff recover punitive damages from Defendants in an amount to be determined by an enlightened and impartial jury.
- (e) that Plaintiff have such other and further relief as may be proper under the circumstances.



Michael Geilenfeld – Accused Serial Pedophile

In orphanages, a Brother-Predator caused Mayhem in Haiti under the guise of goodwill

SPECIAL TO HO—The first American Brother with the Missionaries of Charity claims he devoted his life to helping the poorest of the poor in the poorest country in the Western Hemisphere, Haiti. The stories he shared about life in Haiti with the world could bring even the hardest heart to tears. *"Bring me the street children, the ones no one else wants. We want to teach them they are special and loved,"* he would say. Through the years, boys came and went through the program, some even died in his care. The boys were taught to dance, sing and perform. They were even taught karate so they could fight each other to entertain visitors. Several months a year, the group toured in the United States and Canada to raise funds, thus missing school. He convinced everyone this was "therapy" for the broken boys. The brother's stories always pulled at the heartstrings, and the boys performed their hearts out. One dance, called "the shoe shine," depicted a Haitian man in a purple suit, smoking and refusing to pay the poor boy who was in rags. The police came and threaten to take the boy to jail. The audience always became engaged, and sadly, this is the vision most foreigners now have about Haitians.

The brother claimed he was raising cultural awareness about Haiti. After the show, the brother asked for a freewill donation. Emotional patrons, having just witnessed the greatest underdog-to-success story, were always quick to take out their wallets and checkbooks to put something in the baskets. Some were known to write checks for thousands of dollars, and many \$100 bills made it into the baskets. And, the audience was told: *"100% of every donation goes to the children of Haiti."*

Sadly, life at the homes, really orphanages, is anything but the loving story the brother tells. In fact, throughout the years, different groups of boys have reached out to the authorities for help. They reported

of being sexually, emotionally and physically abused by the self-proclaimed "Ange Michel" – and what an angel! These boys, who are orphaned or abandoned, don't have parents to whom to talk. Due to the control and power that this brother had in a country like Haiti, it was very dangerous for the victims to report anything. Besides that, the brother tells everyone that Haitians are "liars, cheaters and stealers who have learned their tricks on the streets of Haiti and they are just manipulative." In fact, that is a description that could be used to describe the brother himself. Sadly, even neighbors and friends turn on the victims, and accuse them of causing problems. Such is the reality of this dirty secret in Haiti — which is no longer secret.

The victims have shared their stories with priests, pastors, doctors and teachers and even with the U.S. Embassy. Some have made formal accusations to Marie-Carmel Dejean, the former head of *Institut du Bien-être social et Recherches* (French acronym IBESR), a Haitian government organization offering children protective services. Even Catholic Archbishop Wilton Daniel, formerly from Atlanta, now in Washington, responsible for the church sex abuse scandals, has known about this situation since 2003. All these people have done nothing to help the victims seek justice and healing. One victim said, *"After telling 12 visitors what was really happening at the house, and he told me I was lucky to be there, with a roof over my head, I decided to focus on my studies, because no one cared about our*

All told, 10 times, over 30 years, the boys have gone to the authorities with their complaints. Madame Arielle Jeanty Villadrouin, the current IBESR director, conducted an investigation in January 2014, closed the home at Delmas 91 for minors, and refused to license it. Not long after that, Instruction Judge Al Dunel Dimanche ordered that the brother be jailed. In October 2014, he was arrested and spent 237 days in the Port-au-Prince National Penitentiary. You've probably heard about him: **Michael K. Geilenfeld**.

On his release, he went to the United States but by July 2015, he was back in Haiti. In October 2015, the Chief Government Prosecutor, Ocnam Daméus, and Attorney General Jean Roody All issued a search warrant and discovered minors at the home at Delmas 91. Authorities found three minors coming home from school. After interviewing several victims, an arrest warrant was issued. The warrant, signed by Magistrate Judge Abner Emile, led to the issuance of a "Red Interpol alert" arrest warrant for the brother. Rather than face the charges, Geilenfeld fled Haiti and went to Anamuya, north of Punta Cana, in the Dominican Republic, to join his man/wife, Brunel Ezra, who had opened a home for children there sometime after he fled Haiti.

Reportedly, this Brunel Ezra has a long history of trouble with the law. Not only did he stab a minor in the chest but on January 29, 2014, he had shot Haitian rapper O'Gun in the face at the Kinam Hotel in Pétion-Ville and fled to the Dominican Republic. Those at the *Anamuya* home, called *"Casa de los Rios,"* appear to be children of Haitian refugees and the operation is funded by organizations in the U.S. and possibly Canada. Several fundraising websites connected to the brother continue to operate and mention is made to the homes in Haiti, but nothing is said about the brother's legal troubles or his business in the Dominican Republic.

Meanwhile, authorities in the Dominican Republic have reported a major problem of organ trafficking going on in the country, with Haitian refugees being among the prime suspects. Additionally, it should be pointed out that the unlicensed Anamuya orphanage doubles up as a guesthouse. Based on what is known about the visitors to the Haitian homes, one can imagine what's happening at Anamuya.

In April of this year, based on the "Red Interpol Alert," Dominican law enforcement apprehended Michael Geilenfeld in Higuey. Considering that he was in violation of the U.S. Protect Act of 2003, the Dominican officials alerted U.S. law enforcement about his arrest. They waited two weeks for the American authorities to pick him up. Whereupon, Dominican law enforcement escorted him to New York John F. Kennedy International airport where his lawyer was waiting for him. Moreover, the Dominican Republic issued a

"Blue Interpol Alert." Even with two Interpol alerts targeting him, the brother continues with his fundraising activities in the United States.

The US Justice Department is well aware of the brother's dossier, including the twenty sworn testimonies that have been filed at the Office of Protection of Minors, a branch of Haiti's Central Directorate of the Judiciary Police (French acronym DCPJ). Definitely, the wheels of justice have been more than slow on this case.

Haitian and Dominican officials don't want Michael Geilenfeld back on the Island of Hispaniola. Yet, he continues with his fundraising activities, and his homes, or so-called orphanages, are still open for business under the name of St. Joseph family. One always hears about what's wrong with Haiti. But, here is something that is very right about Haiti. In October 2015, the Haitian justice system managed to issue an arrest warrant for rape, sexual aggression and abuse of title against Michael Geilenfeld and it is in force for 10 years, with expiration on October 28, 2025. The young men whose testimonies resulted in this judicial warrant are an inspiration to victims of predators everywhere. Despite several roadblocks, they continued to fight courageously for justice to be done.

Predator Geilenfeld will be looking over his shoulder for the next six years, unless justice nabs him before then. Sadly, he is not the only one preying on Haitian children. As mentioned previously, orphanages double as guesthouses for visiting volunteers. Foreigners love photo ops with the poor. It appeals to their egos. This is missionary tourism and Haiti is full of such tourists and the cases of several of these missionary tourists have reached U.S. courts where some have received stiff prison sentences.

Stories of abuse at orphanages are very common. From Daniel Pye in Jacmel, Father John Duarte of Cap-Haitien and Pétion-Ville, Father Marc Boisvertin Les Cayes, Bob Valerius in Cap-Haitien, Michael Brewer in Tabarre, Father Mathew Andrew Carter in Croix des Bouquets, Father Ron Voss in Port-au-Prince and Doug Perltz in Cap-Haitien, these predators got the message that Haiti was open for business. Many are connected to the North American Man Boy Love Association (NAMBLA), which advocates for lowering the age of consent for consensual sex.

This is a public health crisis throughout the Caribbean. It is multi-generational and has had damaging effects on society. Victims need help to heal from the invisible scars that are as real as scars from a machete blow. In fact, some psychological experts suggest that the invisible scars are even deeper and more painful. Without treatment, they will negatively affect certain individuals during a lifetime.

The victims demand justice. They are protected by Haitian laws and the Haitian Constitution. There should be outrage in the land, the first free Black Republic in the Western Hemisphere and only successful slave revolt in the world! Haitians, your children are being victimized. You should be silent no more. Children, the future of every nation, are especially more vulnerable in a poor country like Haiti. For example, in February 2017, there was a sex trafficking bust at the Kaliko Beach Resort, north of Port-au-Prince. The American predators were allowed to leave without being charged while their Haitian accomplices were arrested. But, nothing has been heard of the case ever since.

A small group of volunteer advocates at the International Children's Rights Advocate's Society has worked tirelessly with Haitian psychologist Wilcox To-yo, MD, to raise awareness and help these victims move from their victim status to that of survivor. *Salon Haitien Santé Men-tale et du Bien-Être* will be holding an "International Scientific Symposium," October 5th and 6th at the Hotel Oasis in Pétion-Ville. The theme this year is "Children, Women and Mental Health in Haiti." For additional information, call (509) 2209- 6838 and 3474-7414 in Haiti or 678-313-8437 in the U.S. We are looking for sponsors to help with this very important national dialogue.

"Injustice anywhere is a threat to justice everywhere," said Martin Luther King Jr., adding, *"We are caught in an*

inescapable network of mutuality, tied in a single garment of destiny. Whatever affects one directly, affects all indirectly." These words are as true today as they were when he wrote them from a jail cell in Birmingham, Alabama, in 1963. We need to continue Dr. King's legacy. We all have a responsibility to help the vulnerable in society, including the young, the elderly and the physically challenged. A dialogue must be opened on the unspeakable problem of sexual victimization going on in so-called orphanages in Haiti. As it is said, if you are not part of the solution, you are part of the problem. Acting on what we believe is right; we should all be part of the solution.

HAITI: IS IT TIME TO ACT YET?

Is there a way to truly understand the depth of the crisis in Haiti and get financial assistance directly to victims?

The island nation that abuts the Dominican Republic is a devastated 'no-man's' land, a haven for sex and drug traffickers and every perverse form of corruption in between. A place where billions of dollars of humanitarian aid never reached the people, where starvation, anarchy and desperation drives kids, teenagers and adults to the streets to fight for survival with homemade weapons and ravenous bellies.

"Haiti was always bad" people are wont to say in decisive tones.

This week, an orphanage located in Fermate, located in south Port-au-Prince, burned down. You may have heard about it. Mainstream reports include “unauthorized orphanage” in the title without explaining that the building in which just under two hundred children were trying to survive, had no electricity, running water or anything in the way of accommodations. The orphanage, one of several inadequate structures operating in deplorable conditions, presented one of very few options for children in need.

Valerie Dirksen, a journalist who has worked diligently over the past several years to

publicize Haiti's plight and elicit help for its citizens, is seemingly fighting a one-woman battle against corruption. In December, Dirksen asked Speak Project to help ensure the safe-keeping of several young people who had testified against accused pedophile mob-boss Michael Gellenfeld. She needed to fund their upkeep for another month, an upkeep that barely covered food and housing much less their safety, and she had completely run dry of funds to do so.



Dirksen reports that one of those whistleblowers lived at the orphanage in Fermate. She clarifies that children on the second floor had lit candles for light, starting the fire. Everyone on the second floor died, with the initial death toll totaling 20 children, not 13 or 15, as is being reported. Many more children were injured and died *en route* or in the clinic, which was also not reported.



"The conditions were squalid and the orphanage was closed down in 2013 but continued to operate. The non-profit reported collecting \$2.5 mil last year and had two airplanes and reportedly received food from USAid to feed the poor," said Dirksen on a call this morning.

Of course none of these funds reached the children.

"This is really a bad situation", Dirksen emphasized.

The injured children have been moved to a clinic at the Baptiste mission which lacks the facilities or caregivers to treat burn victims. At least four of the fire victims are under age six and are burned over 80% of their body.

Dirksen is scrambling to get them transported to a burn facility as soon as possible.





Here is my latest article on the Orphanage Fire. I hope people share this wide and far. This situation is dire for these children.

Unlicensed Orphanage Fire in Fermathe could have been prevented!

By Valerie Dirksen

I have written several articles detailing the unbelievable conditions of orphans and abandoned children in Haiti. The reality is, my efforts have not led to any substantial change despite it being a \$100 million plus dollar "business" in Haiti. Oftentimes, I have thought, "what will it take to get the reform necessary to put an end to children suffering?" Last Thursday night, a fire at a large orphanage in the mountains above Port au Prince, in the community of Fermathe, has hopefully finally gotten the authorities, and international attention.

It took the fire trucks more than 90 minutes to arrive. When they arrived, they found the building, with only one exit door, fully engulfed. \$20 billion in aid, petro caribe money missing, and the \$1.50 per money transfer that was supposed to be used for schools did not seem to help prevent the situation. Where did this money go? As the popular movement in Haiti says, # Kote Kob PetroCaribe A? This is truly something that defies description.

Initially, the reports were that 13 children had died in a fire. Then the report was changed to 15. In fact, there were 20 who were affected by the fire in the orphanage. Two of the children were melted into the mattresses, 13 infants survived the fire, but after being taken to the Baptiste Mission close by, they died as the clinic did not have oxygen tanks they needed to treat their smoke inhalation. Two burn victims were taken to the Bernard Mev Hospital by Luckner Fond Rose, Haitian Timoun Foundation, Haiti Country Director, as there was no ambulance.

This was an orphanage that was unlicensed since 2013, and the 66 children were living in extreme squalid conditions. It has been reported that the fire was ignited by candles that the children had lit in their rooms because the generator and inverter were not working. With no concern for safety, the children were sent to the market to buy candles earlier. This shows the lack of concern for the children given the high instances of kidnapping.

The two story building was in deplorable condition with children sleeping in cramped, dirty bunk beds and filth. The bathrooms did not even have toilet seats! The children were treated like animals, with our pets here in the US receiving better care.

There were only three adults present at the time of the fire. Advocates tried to speak to the American Director, Andrew Perrera, who replied "no comment". Perrera, was previously employed at the Wings of Hope orphanage that was close by, before being relocated to Jacmel. It is believed he was affiliated with the Haitian Timoun Foundation, and visited the homes as a missionary before staying to work in Haiti. The Haitian Timoun Foundation is a NGO that is based in Colorado and recently relocated another office to Ohio. The Haitian Timoun Foundation is one of several fundraising arms for the multiple accused pedophile, Michael Geilenfeld. You may recall, IBESR closed down the St. Joseph Home for Boys in

January 2014 after receiving numerous complaints of sexual abuse and exploitation



agression and abuse of title, along with a Red Interpol Arrest warrant, Geilentfeld walks freely in the US. The DR arrested him last April on the Red Interpol Arrest warrant and returned him to the US because the DR and Haiti do not have an extradition agreement. Didn't the Haitians get Clifford Brandt extradited? So seems like it is possible, unless you are a child abuser? Is this the Haiti the founding fathers dreamed about in 1804 when they were fighting for freedom? I doubt it. This is a disgrace, and shameful. There are so many in high places covering this up. This includes members of the Haitian Diaspora, who should be fighting for the children of Haiti.

The Pennsylvania based NGO, Church of Bible Understanding, founded by the late millionaire evangelical "cult" leader Stewart Trail generates nearly \$7 million per year to operate it's unlicensed orphanages. It also has two airplanes to bring mission trips to the country. No background checks are done on visitors to the orphanages that usually double as guest houses to supplement income to cover expenses. Some of these come as sex tourists, while disguising their intentions as missionaries. This practice of opening orphanages up as guest houses is common in Haiti.

It has been reported that Trail's church was accused of enticing 17 youth out of a shelter in New York with promises of "salvation" in 1983. A New York State court stopped them from transporting youth under the age of 18 without parental permission. This sounds like trafficking, and yet he went to Haiti to run an orphanage? It seems like they have all started a club in Haiti to do their nasty deeds, to the detriment of innocent children who are orphaned or abandoned. These children are told to just, "smile and make it believable" if the "blanc" shows up.

We need immediate action on these crimes of negligence that led to the fire, and those who are responsible need to go to jail! No American in Haiti should be above the law....ever! Advocates have learned that Mr. Osner Fevry, the Haitian Attorney representing the orphanage, who is also working with the government of Jovenel Moise, are working closely with the US Embassy to cover up liability. The US Embassy has known for years about the substandard conditions in Haitian orphanages run by Americans, and turned a blind eye. Perhaps Ambassador Michele Sisson should have been discussed that during her weekly luncheons with Haitian President Jovenel Moise. The Ambassador boasted that she and the president discussed economic development during those meetings. Clearly, based on economic indicators for Haiti, that has not been the case. I believe high school students could do a better job with economic development than these bureaucrats. The orphanage should have insurance that would help cover the cost of the funerals. Child advocates are looking into this further.

With the exception of the IBESR Director Arielle Villadroin's comments on the tragedy, there has been radio silence from the US Embassy, the Haitian Minister of Justice Roody Aly or the NGO in Pennsylvania. Calls made to the NGO's office from the number on their website went to another business. IBESR, claims they do not have enough funding to inspect the 750+ orphanages. They admitted only 35 were licensed. Last year, in a letter from Senator Marco Rubio, of the Senate Appropriations committee, I was informed the Government of Haiti had been given \$24 million to address the human trafficking problem. USAID gave a \$5 million grant to Chemonics. Todate, this money is not to be found, and nothing has been done. I am calling on the Director of IRFSR to step down from her position immediately and get



Does it not seem strange that all these Americans who had no previous experience with child care, all arrive in Haiti ready to operate orphanages? Andrew Perera, the American who was at the orphanage fire, was probably making at a minimum \$1000 per month, excluding room and board. That is three times what a policeman or Haitian medical doctor earns. Is it really helping Haiti to have an American come and operate an orphanage and take a well paying job from a Haitian? This is a huge problem, that needs to be addressed immediately before we write about another catastrophe

ICRAS applauds President Trumps Presidential Decrees on Human Trafficking. This is good to raise awareness about the problem. But what good is another presidential decree or another law if it is not enforced, and creates more "mercenary" aid workers? That is the last thing that will solve this problem. Grace Farm used their grants to build a \$5 million dollar building. \$290 million was given to Thorn to distribute software, Ashton Kutcher's for profit software company developed. Thorn is working with Rotary to raise awareness. No one is talking about the damage done every single day this continues. I have literally been screaming about this since I found out about it in May 2011. I have traveled to speak to anyone who would listen, because to me, every child matters. We can and must do better. A nicely choreographed signing ceremony of the latest Executive Order, turned my stomach. While everyone was doing selfies, children in these orphanages are being neglected and abused. There must be an immediate call to action for these children. This did not happen overnight, and it will not be fixed overnight. Please contact me if you would like to help this cause.

So this is interesting. The IBESR reported 66 children were at the unlicensed orphanage and 15 who had died for lack of oxygen. How could they only pick up 28 children from the NGOs other orphanage? That is only 43. That math does not add up. They had the protections of minors from the DCPJ.... the same authorities who have testimony from over 20 victims of a serial child abuser, Michael Geilenfeld. They also have the arrest warrant and red Interpol arrest warrant.

She should step down immediately. She is negligent and I hold her responsible for the 20 toddlers deaths.

This proves this is part of a much bigger problem for orphaned and abandoned children. They deserve so much better.

Un prêtre catholique américain accusé d'avoir agressé sexuellement un jeune garçon aux Cayes

La victime n'avait que douze ans, à l'époque des faits

Un prêtre catholique américain est accusé d'avoir violé en 2009 un jeune homme haïtien âgé de douze ans à l'époque des faits dans un orphelinat aux Cayes. Le 25 septembre prochain, le père Marc Roméo Boisvert qui vit aux États-Unis doit se présenter devant un tribunal de la juridiction des Cayes pour répondre aux questions de la justice dans le cadre de cette affaire.

Ce énième scandale éclabousse la réputation de l'église catholique à une époque où plusieurs affaires similaires sont portées au-devant de la scène en Haïti (<https://www.loophaiti.com/content/ce-prete-canadien-avoue-avoir-commis-des-delits-sexuels-en-haiti>) et à travers le monde. Une lettre (<https://www.istwanouayisyen.com/second-request-to-bishop-chibly-langlois-of-les-cayes-haiti-alleged-sexual-misconduct-at-pwoje-espwa-sud/>) adressée en 2013 à l'évêque Chibly Langlois et publiée en ligne évoquait cette « allégation d'inconduite sexuelle » au « Pwojè Espwa » dirigé par Boisvert et qui accueillait 600 enfants et jeunes adultes.

« Arrivé comme évêque des Cayes en 2011 dans le diocèse, et n'ayant pas trouvé de dossier à ce sujet, je n'en suis informé que maintenant », explique hier 25 août à Ayibopost le cardinal qui à l'époque, était responsable de tous les prêtres de la région. « Ces genres de cas sont traités de nos jours dans notre institution avec toute la diligence, la rigueur et tout le sérieux requis afin de protéger les mineurs », rajoute le prélat qui invite la victime présumée à s'adresser « à qui de droit » pour que « justice qui lui est due soit rendue, si tel est le cas ».

Un enfant nécessiteux

La mère de Jamesley Valéry est encore vivante quand sa famille pauvre, issue de Saint-Jean, une section communale de Camp-Perrin, le confie au projet Espwa. « Le père Marc m'appréciait beaucoup, il parlait souvent avec moi, explique Valéry. J'allais manger régulièrement chez lui, et je ne consommais pas la même nourriture que les autres enfants. »

Les journées de Valéry se passaient principalement aux côtés du prêtre qui a aujourd'hui pris sa retraite en Floride. « Il a commencé à faire des gestes que je ne comprenais pas, il me touchait les tétons, partage Valéry. Puis, il m'a dit ce qu'il voulait. Si toutefois, j'accepte d'être avec lui, il m'a dit qu'il n'aurait aucun problème à me faire quitter le pays. Et il m'a offert de l'argent. »

Valéry dit avoir refusé ces avances.

Le prêtre n'aurait pas accepté la résistance de l'enfant. « Cela s'est passé en deux fois, se souvient Valéry. La première fois, c'était chez lui. Il m'a poussé sur son lit, a descendu mon pantalon et il m'a violé ». La deuxième fois, Valéry avait dormi chez le père Boisvert. Après l'acte, le prêtre l'a réveillé vers les cinq heures du matin pour qu'il rejoigne l'espace du projet Espwa réservé aux enfants. Et c'est à ce moment-là que le médecin Will Giordano-Perez l'a surpris, sortant de la résidence de Boisvert.

Une réunion intimidante

Will Giordano-Perez travaillait à Espwa depuis 2008 à l'époque des événements.

« Je terminais ma course du matin, écrit-il dans une interview en anglais accordée à Ayibopost. Alors que je retournais à la maison des invités et en passant devant la demeure de père Marc, j'ai vu Jamesley qui quittait la maison du prêtre. C'était tôt le matin et je me souviens avoir pensé qu'il était étrange que Jamesley soit là et pas dans la maison assignée aux autres enfants. Je lui ai demandé ce qu'il faisait là-bas et il m'a dit qu'il y avait passé la nuit. J'ai demandé où il dormait, car je connaissais la maison et ne me rappelais pas qu'il y avait une chambre d'amis. Jamesley m'a dit qu'il a dormi dans le même lit que père Marc. »

Will Giordano-Perez dit avoir rapidement informé Cynthia DeSoi, son supérieur hiérarchique, des révélations de Jamesley Valéry. La responsable des volontaires aurait par la suite demandé au prêtre de ne pas laisser les jeunes garçons dormir dans son lit. « [DeSoi] m'a informé que ces préoccupations avaient été soulevées à plusieurs reprises, y compris au sein du conseil d'administration après que des plaintes similaires aient été faites dans le passé », rapporte Giordano-Perez.

Deux jours après, le médecin est invité à une réunion à la résidence de père Marc Roméo Boisvert, en présence de trois employés, incluant le directeur de l'orphelinat. Sous un interrogatoire intimidant, « le directeur de l'orphelinat a fait pression sur Jamesley pour qu'il déclare avoir plutôt "rêvé" de dormir dans le lit de Marc ». Pressuré, Jamesley emploiera le mot demandé. Et depuis ce jour, plus personne ne l'a vu dans l'orphelinat.

La démission anticipée

« Après le départ de Jamesley, je ne me sentais pas à l'aise de rester à Pwojè Espwa », déclare Will Giordano-Perez. « J'ai pris la décision de mettre fin à mon engagement d'un an là-bas deux mois plus tôt », rajoute le médecin qui précise que « père Marc » lui a personnellement expliqué avant son départ qu'il n'a pas dormi dans le même lit que Jamesley Valéry.

Onze ans après les faits, Jamesley Valéry se remémore cette réunion éprouvante. Il raconte qu'il ne se sentait plus à l'aise dans l'espace de l'orphelinat parce qu'il craignait les moqueries des autres enfants au cas où ils apprenaient ce qui s'était passé.

Aussi, le père Boisvert traitait Jamesley Valéry différemment depuis l'incident. L'enfant voulait quitter le pays. Une fois, il a demandé des comptes au père Boisvert sur ce qu'il lui avait promis s'il acceptait d'avoir des rapports sexuels avec lui. Mais, « [l'homme de Dieu] ne m'a pas donné de réponse tout simplement. Il m'a méprisé, puis est monté dans sa voiture. Il a monté sa vitre et il est parti ».

Deux enquêtes internes

À sa naissance en 1998, le projet Espwa ressemblait aux multitudes œuvres charitables menées par des citoyens étrangers en Haïti. « On a loué une petite maison et on l'a rempli avec des garçons trouvés dans les rues », écrit (<https://www.blogger.com/profile/02286660603499771437>) père Marc Roméo Boisvert sur son profil Blogger.

Rapidement, le projet financé et administré principalement par l'ONG Free The Kids prendra de l'ampleur. En 2009, plusieurs bâtiments étaient déjà construits, y compris des fermes, des écoles, une clinique, une chapelle, et même des jardins potagers.

Une première enquête commanditée par Free the Kids tentera en vain d'éclaircir l'affaire « Marc Roméo Boisvert » en 2013. Les investigateurs venus des États-Unis ont plié bagage sans avoir pu recueillir les témoignages du garçon qui avait disparu.

Après l'échec de cette première tentative, Free of the Kids USA engage les services d'Edward R. Kirby & Associates qui produit un rapport le 22 janvier 2015. Dans ce document dont Ayibopost a obtenu une copie, père Marc Roméo Boisvert nie les allégations faisant croire que « Jamesley, ou tout autre jeune a dormi chez lui ou avec lui cette nuit-là ou toute autre nuit ».

Des inconsistances dans le témoignage

Pourtant, ce même rapport révèle que faute de place dans l'ancien emplacement de l'orphelinat, « les garçons dormaient dans tout l'établissement, y compris dans la chambre du père Boisvert, mais pas dans son lit ». Ces déclarations sont attribuées à Dre Cynthia DeSoi, supérieure hiérarchique du docteur Will Giordano-Perez.

Les enquêteurs ont aussi retrouvé un ancien résident ayant déclaré avoir dormi dans le lit de père Boisvert. Cependant, ce résident affirme que le religieux ne l'a pas touché.

Edward R. Kirby & Associates ont par ailleurs trouvé un autre jeune homme âgé entre 21 et 22 ans qui a séjourné durant dix-huit mois dans la résidence de père Boisvert, si bien que la rumeur d'une relation homosexuelle consentante entre adultes avait circulé.

Sans les témoignages de Jamesley Valéry et du médecin Will Giordano-Perez, les enquêteurs ont conclu qu'il n'existait « aucune preuve physique ou photographique connue que le père Marc Boisvert s'est livré à des activités sexuelles avec des mineurs pendant son mandat à Pwojè Espwa ». De surcroît, il n'y avait aucune déclaration de première main d'une victime indiquant avoir été agressée sexuellement.

La victime resurgit

La situation n'est plus la même aujourd'hui. Jamesley Valéry poursuit formellement son agresseur présumé devant la justice. Il

raconte avec émotion comment il s'est réfugié après sa fuite de l'orphelinat à l'Institut du Bien-Être social et de la Recherche (IBESR) sans toutefois rien dire aux techniciens de l'institution.

Après le séisme, Valéry a disparu dans la nature. Il explique avoir vécu seul, dans les rues aux Cayes. Ensuite, il a roulé sa bosse jusqu'à Port-au-Prince. « Pour le moment, je vis une vie vraiment stressante. J'ai peur pour ma vie, parce que j'ai décidé de rechercher justice », déclare Jamesley Valéry.

Après le mandat de comparution déjà émis contre Marc Roméo Boisvert, l'avocat du jeune homme, Me Édouard Cassamajor, rapporte que le juge a demandé d'entendre Méridien Bertrand du bureau de l'IBESR dans le Sud et Jean Robert St Louis, un responsable régional de la Brigade protection des mineurs. L'avocat impute la lenteur du dossier aux différentes crises sociopolitiques qui ont frappé le pays en 2019 et le Coronavirus en 2020.

« Nous devons protéger nos enfants »

Depuis juin dernier, Free The Kids a remis le leadership du projet Espwa à Ouverture internationale, une ONG. Espwa qui n'est plus un orphelinat héberge provisoirement 30 enfants, jusqu'à leur prise en charge par l'IBESR. Méridien Bertrand assure que l'institution compte enlever tous les enfants à Espwa pour les replacer dans leurs familles.

Un vent nouveau souffle à Pwojè Espwa. La nouvelle stratégie de la mission consiste au « développement de l'enfant et la préservation de la famille ». Le père Boisvert accusé de pédophilie n'est plus de la partie. « Il a été séparé de l'organisation en 2018 et n'a aucune autorité ni responsabilité dans l'organisation », déclare Milou L'hérissou, le nouveau directeur général d'Espwa.

Ayibopost a tenté en vain d'entrer en contact avec Père Marc Roméo Boisvert. Rien n'indique s'il comparaitra effectivement devant la justice haïtienne.

À son départ à la retraite, Père Boisvert avait donné son aval au changement de leadership. « Non seulement nous devons protéger nos enfants, mais il est essentiel de protéger l'institution, la structure créée pour répondre à leurs besoins, tout en étant de bons gestionnaires de nos ressources limitées », avait-il déclaré selon une note de presse de Free The Kids.




