Director [REDACTED] to Testify Before Senate Judiciary
[Politico](#) (09/09, Fuchs) and [Just the News](#) (09/09, Severi) reported that Director [REDACTED] is scheduled to testify before the Senate Judiciary Committee on Tuesday, Sept. 16, at 9 a.m. in the Hart Senate Office Building as part of the panel's oversight of the bureau. According to the article, Director [REDACTED] will also appear before the House Judiciary Committee the following day, Sept. 17, as the Trump administration faces bipartisan scrutiny over its handling of the Jeffrey Epstein case. The article noted that the Senate committee's notice did not specify the exact reason for the hearing, but that House Republicans recently released files related to Epstein, including a birthday book the White House has denied contained a message from President Trump.
