I was home all day yesterday and today waiting for your call, I did not expect you to call me back at 5.16pm on a Friday, but thank you for leaving a message.

I don't see any sense of urgency in your behaviour given the magnitude of the crimes I discovered affecting the entire Country, I hope this is not a second **SHAM investigation** just like the fake investigation of the SDNY U.S. Marshall last year who FAILED to take any action to protect me and to stop the enslavement of

America by A.I. in our Courts of Law, violating my whistleblower's rights and allowing the technocratic enslavement of 340 million fellow U.S. citizens to this day, confirming they all belong to the same pedo-satanist cult that infiltrated the SDNY.

Since I made these 3 shocking discoveries that started on January 2023, with the last Jeffrey Epstein sham trials evidence filed on Aug 27, 2025, the surveillance , stalking, harassment and intimidation against me because of my SDNY case has increased exponentially (even after they unsuccessfully tried to close my case based on fraud 2 times with 2 orders written by Generative Artificial Intelligence, instead of **SIGNING** my default judgement- doc.91).

I reported this STALKING many times to the SDNY from day one but the FBI, DOJ, SDNY US MARSHALS and the

Judges [REDACTED], Chief [REDACTED] have been **ignoring** all my requests of help because of my A.I. discovery, **the enslavement of America, the worst crime against Humanity.** Am I correct NY FBI DIRECTOR Christopher G. Raia, US Marshal Director [REDACTED], US Attorney [REDACTED], SDNY Esquire-anti-Judge [REDACTED] and Chief [REDACTED] [REDACTED]?

I contacted MANY times the NYPD of every Precinct in Manhattan from June to September 2024 to report this crime against Humanity by the SDNY judges using A.I. against Sovereign US Citizens, but nobody EVER contacted me, the corruption is beyond mind blowing... I filed all these emails in federal court.

This morning at 10:20 am my stalker - AS ALWAYS - was waiting for me in front of Blue Mercury 2477 Broadway, the corner of my building, so I told him to stop taking orders from pedophiles and that he is a pedophile himself and that I have already reported him to the Court, he called a "fucking bitch" and I think he was filming me, so if you play with the video changing my words, you now I am already AWARE of your A.I. games more than anybody on the planet, as you tried this sick game before with the 2 fake NYPD officers last year, everything is in my docket. Of course my stalkers are always in black SUV Cadillac or Chevrolet with black windows, clearly **FBI** or some other federal agency.
