



Report to The Federal Bureau of Investigation

Francesco Cascio handwriting regarding his family. Francesco Cascio was a child traveler, personal assistant and business manager to Michael Jackson. Francesco was a person of interest in the trial and a person who covered up for Michael Jackson for many years.

To provide assistance to the Federal Bureau of Investigation, I have obtained video, audio, images, documents over the last 20 years. In hand paper documents as well as a digital folder with a significant amount of information. All information was obtained legally and can be proved with a video of an audio recorded phone call. 
██████████ – Jeffrey Epstein’s Painter Suing the FBI for \$600 Million
