- * At this time, we have no information to suggest she is a co-conspirator.
- * DOB is [REDACTED]

- * She frequently traveled with Epstein and uses his addresses as her own.
- * She is known to have been associated with Epstein for approximately five years.
- * She last departed the US on 6/14/2019, using her [REDACTED] passport, and was traveling from Teterboro airport in New Jersey to Paris, France via Epstein's plane.

After her telephone number was identified as the number called by Epstein, we reached out to set up an interview. She requested we speak to her attorney. SDNY has been in contact with the attorney and she is tentatively scheduled to be interviewed on Friday.
