Pursuant to a federal investigation regarding the sexual exploitation of minors, [REDACTED] was interviewed by the Federal Bureau of Investigation (FBI). After being advised of the identity of the interviewing agents and purpose of the interview, [REDACTED] voluntarily provided the following information:

[REDACTED] met Jeffrey Epstein when she was 14 or 15 years old. [REDACTED] repeated eighth grade several times and was attending Jeaga Middle School during the time period she met Epstein. She estimated that she went to Epstein's residence approximately 25 times from the age of 14 or 15 until the age of 16 or 17. [REDACTED] was introduced to Epstein by her friend [REDACTED]. [REDACTED] met [REDACTED] at a middle school in Jupiter, Florida, but they did not become friends until later when they lived near each other in West Palm Beach, Florida. While talking to each other at the Sticks and Stones Bar, now known as Victory Billiards, [REDACTED] asked [REDACTED] if she wanted to give a guy a massage and make easy money. [REDACTED] declined [REDACTED] initial invitation but later went to Epstein's Palm Beach residence with [REDACTED]. [REDACTED] told [REDACTED] that she would have to get naked during the massage and that Epstein would touch her.

[REDACTED] first visited Epstein's residence by traveling there by taxi cab with [REDACTED]. [REDACTED] believed they went to Epstein's residence during the summer. [REDACTED] and [REDACTED] were led by [REDACTED] Last Name Unknown (LNU), upstairs, through a bedroom and into an area that had two showers. There were nude pictures throughout the residence. [REDACTED] noticed there were no faces shown on the nude pictures at the residence. Epstein walked into the room a short time later wearing a towel. [REDACTED] began removing her clothes and Epstein told [REDACTED], "You can undress." [REDACTED] and [REDACTED] were both naked and began massaging Epstein together. [REDACTED] later left the room and Epstein gave her \$200.00. [REDACTED] stated that when [REDACTED] left the room it seemed planned. [REDACTED] believed [REDACTED] was given the money because she brought [REDACTED] to Epstein. When [REDACTED] was alone with Epstein, he requested her to rub his chest and squeeze his nipples as he masturbated to ejaculation. Epstein touched [REDACTED] chest and stomach area as he masturbated. Epstein got

in the shower after he ejaculated. [REDACTED] was paid \$200.00 by Epstein and he told her he had fun. Epstein asked for her telephone number and she wrote it down on a notepad that had his name printed on it.

During their conversation, Epstein asked [REDACTED] who she lived with, if she had a boyfriend and he asked her age. [REDACTED] silently mouthed to [REDACTED], "don't lie," when Epstein asked [REDACTED] age. [REDACTED] told Epstein her true age which she believed was 14 or 15. At a later contact, Epstein asked [REDACTED] about her birthday. [REDACTED] told Epstein she was 16, which was about a year older than her true age. Epstein replied by telling her it was ok and he did not care how old she was. Epstein told [REDACTED] that he did not like girls that were older than 18 years old.

Epstein told [REDACTED] that when he first saw [REDACTED] he really liked her and that he "fucked her." Epstein told [REDACTED] that he no longer wanted [REDACTED] to come to his residence because she was pregnant. [REDACTED] brought many other girls to Epstein including [REDACTED] cousin, [REDACTED]. [REDACTED] went to Epstein's residence once when she was approximately 20 years old. Epstein did not like her and did not want her brought again. [REDACTED] added that [REDACTED] was a heavy drug user. [REDACTED] also introduced [REDACTED] Last Name Unknown (LNU), aka Jenny to Epstein. [REDACTED] LNU was younger than [REDACTED] and visited Epstein's residence one time. [REDACTED] LNU had a Spanish last name and was described as short with long brown hair, freckles and light colored eyes. [REDACTED] LNU attended Okeeheelee Middle School. [REDACTED] LNU went to Epstein's residence prior to [REDACTED] first contact with him. During one of their conversations, Epstein asked [REDACTED], "Do you know that girl Jenny that [REDACTED] brought?" At the conclusion of the interview, [REDACTED] directed the interviewing agents to [REDACTED] LNU's residence, 2319 Avenue Barcelona Este, located in the Tavares Cove trailer park.

[REDACTED] was usually paid \$200.00 to \$300.00 for the sessions with Epstein. She was given \$100.00 one time for no reason. [REDACTED] was usually contacted telephonically by [REDACTED] LNU to make arrangements to go to Epstein's residence. [REDACTED] LNU would call a day or two ahead of their scheduled arrival in Palm Beach. Epstein also called [REDACTED] occasionally from his Palm Beach residence. Another female, named [REDACTED], [REDACTED] or [REDACTED] LNU, who was described as tall with straight brown hair

and having an unknown accent, also set appointments for _____ to be with Epstein. Sometimes Epstein's massage equipment was already in place when _____ arrived at Epstein's residence and other times she had to get the massage table out of a closet and lotions out of a dresser drawer.

During one of _____ visits to Epstein's residence, Epstein offered to pay her \$400.00 for oral sex or \$500 to \$600 for sexual intercourse, _____ declined both. _____ also declined a later request by Epstein to have sexual intercourse. Epstein masturbated all but one or two of the occasions _____ was with him.

_____ did not engage in oral sex or sexual intercourse with Epstein. _____ advised that Epstein had fondled her breasts and legs and digitally penetrated her vagina. Epstein also used a white vibrating device directly on her vagina during one of her visits. Epstein asked _____ if she liked it when he touched her. _____ has touched Epstein's penis and described it as bigger at the top than at the bottom. _____ also stated Epstein has a hairy chest.

_____ traveled to Epstein's residence by herself after her first meeting with Epstein. She primarily traveled to the residence by taxi. Epstein, _____ LNU or the aforementioned girl with the unknown accent paid _____ taxi cab fares.

_____ was aware that her friend, _____, had been to Epstein's residence. _____ previously lived with _____ at _____ grandmother's house. _____ went to Epstein's residence prior to _____ first contact with him. _____ was also friends with _____. _____ advised that she met with private investigators (pis) for Epstein's attorneys and that the same investigators had contacted _____. The PIS inquired about _____ age when she was with Epstein and how much money she was paid by Epstein. The PIS also asked _____ about her drug use. The PIS revisited _____ a few months ago and she asked them to leave. _____ has also observed the PIS driving by her residence in a sport utility vehicle.

_____ was a marijuana user but she did not use drugs during her visits to Epstein's residence. _____ did not use Panax and cocaine until later. At age 17, _____ crashed her grandmother's car and her grandmother pressed charges. _____ was ordered to a drug program at Milton Girls Juvenile

Residential Facility in Milton, Florida. [REDACTED] stated she was in the drug program for 5 months, one week and 3 days.

Epstein offered to pay an extra \$100.00 to [REDACTED] if she brought additional girls to him. Epstein asked [REDACTED] to provide a massage to [REDACTED] LNU but the massage never took place.

[REDACTED] believes Epstein should be prosecuted for his actions.
