

Hey, no problem on the race! [REDACTED] and I are still planning on walking, one of my friends and her daughter will be joining us. But we will miss you and we will have to plan another get together since I won't be working with you for at least the next sixty days. I don't know if you have heard but I am on loan to PB-1 for a 60 day TDY. [REDACTED] assures me that it is only temporary. I guess the Mortgage Fraud business is booming and not near enough personnel assigned to handle all the cases. I half-way volunteered, we r down to five agents([REDACTED] and [REDACTED] r out of the country and [REDACTED] just had a baby) and I feared our poor [REDACTED] being low man, seniority wise, might get stuck. It's one case and only sixty days, sooooo I'm jumping in with a positive attitude, (it's really all i got since i have never even sniff at working this type of violation:) I have not heard anything re the [REDACTED] case. I am assuming with the objections from the SAO we r not going to pursue. If I'm wrong let me know, maybe I could do both. [REDACTED] gets back the 2nd week of FEB and I'm sure she could handle it.

One last thing, [REDACTED] has called me re several of Epstein's victims. I guess she talked to a couple of them and to [REDACTED]. There has been a questionnaire provided to several of them that they have been advised to fill out. I guess one of the questions starts offand how long have you been prostituting. So needless to say the victims r upset with one victim wanting to come to the FBI office to fill it out. [REDACTED] will sit with her but provide no advice. [REDACTED] said at least four victims have relapse because of this. I hope their attorneys are taking care of them. [REDACTED] told [REDACTED] that she was given the questionnaire and asked to return with it completed in 24 hours. Just thought I would let you know.
