Witness : Perry Celani - Moonta - Cloud 9 Hypnotherapy - 8a George Street, Moonta SA 5558
Victim was a previous client of Perry Celani receiving Hypnotherapy treatment and Raki
Cleansing for traumas associated with the continual targeting that had occurred over a 40 year
period of her life and spoke in detail of the abuse and trauma of which she had suffered.

Following the treatment Perry Celani and the victim ██████████ ██████████ had remained in contact to
discuss professional matters of treatment and professional matters of the victims new business
venture development ISPY.SUPPORT, which Perry Celani agreed to become a support member
of in 2023.

During the discussions of professional meetings involving ISPY.SUPPORT and the Criminal and
corruption aspects of which people in the location of the Copper Triangle were encountering or
suffering Perry Celani and the victim discussed a matter of which Perry Celani, the witness had
encountered while owning a Pizza shop in the location of Moonta, involving the Kadina Council
Office and John Olsen. Perry Celani, the witness informed the victim, ██████████ ██████████ that the
Kadina Council office and John Olsen were involved in Criminal corrupt activity involving the real
estate of the shop he was renting, the criminal activity and corruption occurring following a fire in
the shop which closed the shops doors. The criminal and corrupt activity involved a break and
enter of the premise by the two parties involved and the shop land registration being changed
without notice to the rental agreement participant, Perry Celani, from commercial to residential
prior to his rental agreement contract, which he had not been informed of when signing the rental
agreement.

Perry Celani, the witness following being informed of this information when reporting the fire for
insurance and encountering the break and enter by the two parties involved, the Kadina Council
office and John Olsen commenced reporting the criminal activity to the authorities.

Following commencing reporting of the criminal activity involving these matters Perry Celani
became a targeted victim of the two parties, which involved being targeted in his residential
address, which continued over a long period of time, the family became targets of the two parties
involving threatening behaviour, damages to his property and the family pet, a dog had been a
victim of the attack and suffered psychological and physical trauma.

Following Perry Celani, the witness informing the victim, ██████████ ██████████ of this information the
victim, ██████████ ██████████ Identified the local member of Government Fraser Ellis MP and his
family the Ellis Family as involved sources in the targeting and criminal network that had targeted
her, and continued to target her while residing in the location of Kadina 2019-2024.

Following the victim identifying the sources involving the Ellis family, and involving Psychologist Shannon Reid's involvement in the targeted criminal activity the victim, [REDACTED] [REDACTED] informed Perry Celani, who worked in the same building as Shannon Reid that she had identified the two parties as involved in the targeted Criminal activity that had targeted her and informed him not to associate with Shannon Reid or inform her of any more information involving ISPY.SUPPORT.

Following informing Perry Celani, the witness of this information Perry Celani, the witness informed the victim, [REDACTED] [REDACTED] that the Ellis family were closely involved with John Olsen MP, Kadina, Liberal party, and stated the initials JO (John Olsen) "the initials of a terrible person we have spoken of" when the victim, [REDACTED] [REDACTED] asked "Can I ask..who is JO?" This conversation is recorded in text message on both parties mobile phones, the witness Perry Celani and the targeted victim, [REDACTED] [REDACTED]

Recorded as evidence of the conversation shared between both parties during a professional meeting involving the business development of the targeted victim, [REDACTED] [REDACTED] involving [REDACTED] and verifies the Ellis Family connected and identified as involved to a Australian Government source identified as involved in the targeting of the victim, John Olsen MP, Kadina, Liberal Party, the targeting commencing in Kadina, the victim [REDACTED] [REDACTED] aged 14 years of age, and of who has been identified as a Direct target of Epstein and Maxwell and involves a targeted Sex Abuse Ring.





COMMENCEMENT OF MANIPULATING THE VICTIM - GROOMING THE VICTIM FOR SEXUAL PURPOSES - SEXUALLY TARGETING THE VICTIM - ELLIS FAMILY - FRASER ELLIS MP AND GILES ELLIS %20 - INVOLVED IN SEXUALLY TARGETING THE VICTIM 2021-2024

Prior to the victims first contact with Fraser Ellis MP, Kadina the victim approached Michael Ellis, Country Times, Kadina seeking media coverage and assistance to the targeting, and asked Michael Ellis for his advise, when Michael Ellis stated "that he could not assist"

Michael Ellis did not advise the victim to seek assistance from his son Fraser Ellis MP and proceeded to advise the victim that he could not assist her in anyway.

Michael Ellis had the exact same stance while sitting in the meeting with the victim as his son Fraser Ellis MP - Michael Ellis had the exact same look in his eyes, held his eyes in the exact same manner as his son Fraser Ellis MP . Michael Ellis had the exact same demeanour as his son Fraser Ellis MP, when engaged with the victim in person - Eyes portraying a person that was watching a person privately sexually engaged in her own privacy / masturbation / eyes held in a stare and open as if watching on a screen at something that was enticing and couldn't take their eyes off of it

Michael Ellis was involved in a media announcement in the Country Times involving the corporation TELCO, Identified as the corporation involved in Criminal activity targeting of the victim Public announcement connect Identified Australian Government member Rowan Ramsay, Port Pirie, Kadina to the Criminal Corporation of Telco - The victim in 2023 received verification in a letter from Fraser Ellis MP, Kadina that Fraser Ellis MP is also connected to the criminal activity of TELCO and connected to Rowan Ramsay - Both sources identified as involved - Michael Ellis involved in Conspired cover up of his family and the government parties involved in criminal network targeting of the victim involving sex crimes connected to Epstein and Maxwell / public media releases of TELCO and Government sources connected to the corporation in the location of Kadina and Port Pirie

Michael Ellis - Continuous public media releases in the Country Times of Identified involved members of the █████ family, Identified as Source and involvement in source and co-conspirators of targeting █████, the victim and co-conspirators in sex crimes in Australia involving Epstein and Maxwell, █████ █████ and █████ █████, and █████ █████ █████ community achievements involving business achievements / no longer functional in the community and bowling achievements of the parents

Trish Stringer - Local author - Michael Ellis - Continuous media releases of the local author Trish Stringer in the Country Times, including front page headlines on publishing achievements Trish Stringer identified as having access to shared surveillance of the Privacy of the targeted victims own home, who is also a published author and has multiple manuscripts in development Identified by the targeted victim as Trish Stringer, a community member of Kadina involved in Intellectual Property theft directly from the targeted victims home - Targeted victim, a published author stated in the privacy of her own home "I am going to release limited edition copies of my novels signed by the author to create the Reality series into a unique style of marketing" Novels published by Trish Stringer were released signed in the local book store of Kadina - Newly opened book store , Kadina One More Page, 17 Hallett Street, Kadina SA 5554

Trish Stringer Identifies as a community member involved in Destruction of career for sex demand for a sex abuse ring / Intellectual Property theft - Involved individual as a co-conspirator in sex crimes in Australia , namely Kadina

In line with the report, Shannon Reid, Psychologist Identified as being involved and having access to shared illegal surveillance of the Privacy of the targeted victims home and stating the words that were only spoken in the privacy of the victims home - "Abandonment"

Suggests: Multiple parties involved in the location of the Copper Triangle and having access to shared Illegal Surveillance of the targeted victims Privacy and involved in multiple counts of illegal activity against the targeted victim as Co-conspirators in Sex crimes in Australia - Gaining access from Fraser Ellis MP in this location, Identified as Government source involved

Michael Ellis, Kadina Identified as involved in the targeting of an individual and co-conspirator of sex crimes in Australia involving Epstein and Maxell - Sex Abuse Ring

11th April 2021 - Fraser Ellis MP - First contact - First meeting - Targeted victim

On the advice of ██████████ ██████████ ██████████, not Identified as involved during this period 2019-2021, while ██████████, the victim resided in the home of her parents and cared for them while unwell with terminal cancer and a heart condition the targeted victim contacted Fraser Ellis MP to discuss gaining his assistance in the targeting / strongly advised by ██████████ ██████████

First Meeting / First appointment - Office of Fraser Ellis MP

The targeted victim was greeted by Fraser Ellis MP as "Mate" - which struck the targeted victim as "ODD" for a client of a MP, a woman in particular to be addressed as "Mate" by a Government figure and Professional

The targeted victim and Fraser Ellis MP had not up until this point at anytime during their lives met one another or knew one another in anyway, personally or professionally

Fraser Ellis MP led the targeted victim down a short hallway to the back section of the main office of Fraser Ellis MP, located at the back of the reception area and not into a separate clientele Office of usual conducted professional meetings with clientele - Suspected to be the desk of Fraser Ellis MP

Fraser Ellis MP Blushed heavily in both cheeks upon first sitting at the desk across from the targeted victim and his disposition seemed very nervous in the presence of the targeted victim. Fraser Ellis MP seemed almost breathless and could not speak in the first moments while in the targeted victims presence. The targeted victim watched closely, and was slightly suspicious of the disposition of Fraser Ellis MP, a Government figure, a Professional that seemed nervous and unable to speak, due to being a target of criminal activity and having witnessed involved individuals disposition in her presence, which had also involved blushing and nervousness. Fraser Ellis MP cleared his throat before speaking. The targeted victim, at the time believing in his innocence, as the Ellis Family have a credible and good reputation in this community, and the targeted victim unknowing that the Ellis Family were involved individuals in the targeting spoke to Fraser Ellis MP about the evidence in her possession involving corruption in multiple Government Departments and has also been Identified as corruption in the Government Department I.C.A.C/OPI in 2016-2017 during the targeted victims dealings with I.C.A.C/ OPI , who denied any corrupt activity was involved in the targeting during that period. The targeted victim supplied a USB and information to Fraser Ellis MP to this effect - Australian Tax Office / Fraudulent debt created , Housing SA / Fraudulent Debt created and multiple counts of other Fraudulent activity involved in the targeting / Identified as connected to TELCO, a corporation involved in multiple counts of Illegal activity against the targeted victim, and Identified as connected to Fraser Ellis MP in 2023 - The targeted victim supplied the information to Fraser Ellis MP to assist in his endeavour to prove his innocence in the I.C.A.C / OPI enquiry and court hearings involving Fraser Ellis MP. Deception and multiple other allegations believing at the time, due to ██████████ ██████████ and ██████████ ██████████ information regarding the Ellis family that they were honest, and reputable community members

Illegal use of RF / Radio Frequency Transmissions - Targeted victim is a sensitive and susceptible to certain frequencies, only heard by those individuals who are susceptible - Frequencies heard by a sensitive are similar to certain frequencies heard by animals, mainly dogs that can not be heard by a human - Targeted victim first encountered RF Transmissions in her parents home at age 15 years old / Commencement of targeting first recorded at age 14 years of age

RF Transmissions - Fraser Ellis MP involvement - Stated by Fraser Ellis MP to the targeted victim RF transmissions do not change the tone or punctuation of the person using the illegal technology

First heard in 2019 RF Transmissions - "Welcome back beautiful" - Transmitted in Woolworths, Kadina - Suspected to be Fraser Ellis MP due to later statements of calling the targeted victim "Beautiful"

RF Transmissions following the targeted victims First Meeting with Fraser Ellis MP - In Office meeting

"I don't know what to do" -Fraser Ellis MP

"Because I'm the Government" - Fraser Ellis MP

Second Meeting - In Office appointment - Fraser Ellis MP, Kadina

The targeted victim was greeted by Fraser Ellis, MP as "Mate" again and led to a single separate office at the side of the main office, a clientele office.

During this meeting Fraser Ellis MP sat very close across the table to the targeted victim, leaning forward towards the targeted victim across the table, placing his elbows and forearms on the table and leaning inwards towards her sitting across from him on the other side of the table, and looked into her eyes unusually. **The targeted victim thought his disposition was unusual for a Professional of this stature and nature - Government figure MP but continued due to her mothers advice and information regarding the Ellis family as being reputable**

The targeted victim proceeded, on [REDACTED] advise, [REDACTED] [REDACTED] to discuss the aspects of her issue, the targeting and criminal activity, and was seeking the assistance of Fraser Ellis MP. During this meeting the targeted victim mentioned one aspect of the targeting of her whole family in Port Pirie which involved the suspected rape by a human of her family pet, dog, Ruby.

Fraser Ellis MP when hearing this information sat back in his chair away from the targeted victim, crossed his arms, which is a defensive stance of knowledge or guilt or involvement, crossed one leg over the other and acted disgusted, but seemed faceless, emotionless to the victim having witnessed other criminals involved in the targeting act in certain unusual manners when in her presence, facial expressions did not change to match the words stated, eyes stayed emotionless, face stayed emotionless but the words were empathetic

Fraser Ellis MP from the sitting position of sitting back away from the targeted victim at the information regarding the targeted dogs suspected rape then sat forward, uncrossed his legs, placed one elbow on his knee, and leant forward again towards the targeted victim before moving forward again across the desk as first sat in the meeting - **Exact same disposition and sitting position as the targeted victim witnessed when speaking to his [REDACTED] Michael Ellis, Identified as involved**

Fraser Ellis disposition in the targeted victims presence was as if the targeted victim was well known to him even though the targeted victim had never met him before

Fraser Ellis MP eyes stared in an unusual look as if looking into a computer screen at something or someone enticing and sexually attractive to him - **The targeted victim 2 days prior to this meeting had in her own privacy of her own bedroom in her parents home masturbated and was only known to her that she had sexually pleased herself - Exact same look in the eyes of Fraser Ellis MP as she had encountered with his [REDACTED] Michael Ellis, Identified as involved**

The targeted victim asked Fraser Ellis MP if he could assist her with reporting the targeting to the correct authorities and assist her in the required help that she required in order to stop the targeted activity - Fraser Ellis MP stated **"I will see what I can do"**

The targeted victim submitted USBs to Fraser Ellis MP containing the constructed Criminal files of the illegal targeted activity, Stage 1, 2,3,4 incomplete at this time, but contained Stage 2 Fraudulent activity, the Intellectual Property theft of the Medical Business Plan and [REDACTED], Stage 4 Multiple Intellectual Property developments of the targeted victim 2003-2021, and in Possession, Stage 2 Sexual Targeting, Stage 3 Police targeting, involving Conspired Attempted murder Constructed Evidence files did not contain at this stage the evidence and Identified involvement of Epstein and Maxwell

RF Transmissions - Fraser Ellis MP involvement - Stated by Fraser Ellis MP to the targeted victim Following the second meeting - In office

"Don't you dare flirt with that man" - Community member in a furniture store who was being friendly to the targeted victim - As if I belonged to Fraser Ellis MP / him

"I won't stop until you're in my arms" - Targeted victim standing across from office of Fraser Ellis MP at the Commonwealth Bank ATM machine

"Truth was in my eyes" - Stated to the victim in the privacy of her own home - bedroom

Continuous RF Transmissions continued in the Privacy of the targeted victims home involving Fraser Ellis MP - **Commencement of Manipulation, grooming and sexual targeting by the Ellis Family**

First comment - Fraser Ellis MP - "I would never cheat on my wife" - 2021 following second Meeting involving relationships

Following the second meeting with Fraser Ellis MP the targeted victim during interactions with the RF Transmissions in her home began to talk about her interactions with **ADAM**, email online friendship, at the time unknowing ADAM was Epstein and Maxwell, and began to talk about the heartbreak she felt when she ended the friendship with Adam (Epstein and Maxwell)

RF transmissions were stating "I was ADAM" - Fraser Ellis MP

Suspicious of Fraser Ellis MP involvement in RF transmissions in her home and suspicious of his involvement in the targeting, Commencement of her suspicions the targeted victim stated "if you were Adam say a word so I know it was you during our next meeting"

Adam was the targeted victims secret and had not told anyone in her life except for [REDACTED] about their friendship or email interactions as the targeted victim had been told by Adam that he was a married man and their friendship needed to stay a secret. The targeted victim was naive at this time in her life and unknowing about the world having left a isolated secluded lifestyle with an abusive husband of 17 years that had controlled her movements and had isolated her in the marriage in the home, and had not allowed her to have friendships or outside the home contact apart from taking the children to school and shopping for the home - 17 years emotionally neglected, physically and psychologically abused - isolated from society with no online presence / was not allowed to use the computer - Separated from husband on 31st March 2007

Third meeting - In Office appointment - Fraser Ellis MP, Kadina

The targeted victim was greeted by Fraser Ellis MP as "Mate" and led to a different Clientele office this time asked by Fraser Ellis MP "Do you mind if my assistant sits in on this meeting and assists" I agreed to his assistant being present during the meeting and was introduced to Sarah, the assistant of Fraser Ellis MP. The targeted victim was placed at a large round table, a conference room office. The targeted victim had made the meeting involving submitting community projects and community ideas involving reasons of cancer ratio in the area of Kadina and what was entailed in the high number ratio of cancer in the area, also multiple medical projects and ideas, as the targeted victim had knowledge of Fraser Ellis MP involvement in the medical industry involving the Wallaroo Hospital, which involved recruiting doctors and a constructed system for rural areas, Retirement recruiting systems, computer programs for hospitals and the submission of Government projects and a NDA involving the government projects to be considered by a Government source for support and funding

During this meeting Fraser Ellis MP following the targeted victim talking about ADAM in the privacy of her home and asking Fraser Ellis MP who had stated he was ADAM through RF Transmissions in her home to say a word that only she would know was the truth of his involvement in being ADAM, stated the word "Secret" to the targeted victims face / presence - The word the targeted victim had used when speaking of her friendship with ADAM, later Identified as being Epstein and Maxwell

This word "SECRET" suspected of being a Confession by Fraser Ellis MP of his connection to Epstein and Maxwell and his involvement in the targeting involving Sex Abuse Rings and Sex Crimes in Australia and connects Fraser Ellis MP to the sign received via email from ADAM / Epstein and Maxwell involving the design of the M.S.I.C Logo involving Epstein and Maxwell containing the sign %20 as was the Government Department NEIS and Fraser Ellis MP [REDACTED] Giles Ellis / Contained within the file 4 / 4B Giles Ellis %20

Direct Online targeting of the targeted victim involving Epstein and Maxwell commencing 2006 and ceased by the targeted victim in 2013

Following the second meeting with Fraser Ellis MP the commencement of a Pattern of Behaviour conducted by the Ellis Family began in the home of the targeted victim through RF Transmissions Commencement of Grooming, manipulation and Sexual Targeting commenced - Commencing with Fraser Ellis MP, Kadina

Pattern of Behaviour :

- Gaining trust
- Forming an emotional trust and bond with the targeted victim by telling her personal things about their lives - Fraser Ellis being conceived at the parents age of 17 years of age, Fraser Ellis personal life from a child, mischievous child, watching movies together on Netflix, staying awake and talking all night, Fraser Ellis always wanted to be a member of the Government, stated his wife would not allow him to masturbate, stated he preferred to spend time with me than his wife
- Michael Ellis , Involved in the grooming and manipulation of the targeted victim stated to the targeted victim "My son is in love with you" - Commencement of Conspired Sexual targeting by Fraser Ellis MP and Family involvement in Grooming and manipulating the targeted victim for sexual purposes of a sex abuse ring

Prior to the commencement of the Manipulation, grooming and sexual targeting of the Ellis Family the targeted victim, as stated in a cover letter to the FBI , Criminal Division and ██████████, Victim co-ordinator in 2021-2023 had isolated herself from society for her own protection from Sexual targeting and was stating in the privacy of her own home "I do not want a relationship" "I do not want to be touched" - and remained vigilant in the isolation, no friendships in the community, no relationships in the community and remained in hiding in isolation in her parents home constructing the evidence into constructed criminal files for the FBI involved in the case of Epstein and Maxwell

- Michael Ellis , Involved in the grooming and manipulation of the targeted victim stated to the targeted victim "Shut down your business or they will never stop coming for you"
- Michael Ellis, Involved in the grooming and manipulation of the targeted victim stated to the targeted victim "Walk away from the evidence" "We will protect you"

During this period of commencement of Manipulation, grooming and Conspired Sexual Targeting of the victim the targeted victim due to the information she was given by ██████████, ██████████ involving the Ellis Family being reputable became manipulated into believing the Ellis family were protecting her in Kadina and were forming a relationship with Fraser Ellis MP, who she had been manipulated into believing she could trust - **Manipulated trust had been formed**

The Constructed evidence of Constructed criminal files Stage1,2,3,4 contain constructed evidence of this manipulation and claim Fraser Ellis MP, Kadina is innocent and not involved in the targeting - This construction of the evidence is wrong and incorrect and was later Identified in 2023-2024 that the Ellis family, and involving Fraser Ellis MP are Identified as a Primal Source of the targeting and were connected to two other Primal sources of the targeting involving a Sex crime involving Epstein and Maxwell co-conspirators in Kadina, Port Pirie - John Olsen, Kadina, Liberal Party and the ██████████ Family, ██████████ ██████████, and all parties are involved in the targeting of the targeted victim involving a Sex Crime in Australia

**CONTINUOUS RF TRANSMISSIONS - ELLIS FAMILY - MANIPULATED TRUST FORMED
MANIPULATED CONSPIRED SEXUAL TARGETING FORMED / PORTRAYED RELATIONSHIP
2022**

- Michael Ellis - Stating his son wanted to take care of the targeted victim and to be a housewife and give her a easier life stating "So I can feel like I am taking care of you" "That's what a man needs to feel when in a relationship " - Referring to the targeted victim not gaining employment and stop building a career

During this period of manipulation, gaining trust RF Transmissions involved multiple people involved in psychologically abusing the targeted victim calling her a "Prostitute" and portrayed a GOOD COP / BAD COP scenario - Conspired confusion and manipulation of the targeted victim to be Conspired into a Conspired act of Sexual Targeting

RF Transmissions contained 24 hour Defamatory language and vicious harassment towards the targeted victim - targeting her confidence, self image, sexuality, lifestyle, image, identity

- Continuous manipulation continued involving all family members, Fraser Ellis MP, Michael Ellis , Teresa Ellis and Giles Ellis

RF Transmissions commenced stating that the Ellis brothers Fraser Ellis and Giles Ellis were rival brothers fighting for the targeted victims hand in a relationship

2022 - The targeted victim on continual persuasion of ██████████ ██████████ ██████████ agreed to the Covid 19 vaccination although against her best judgement knowing she had severely reacted to vaccines in the past and should not have it administered. The targeted victim took precautions and obtained referrals from 2 GP's for testing to vaccine reactions prior to agreeing to have the Covid 19 vaccine administered - No testing was performed from either Allergists involving the referrals and the targeted victim was advised by both Allergists to proceed with the vaccine, Resulting in a Near fatal Acute allergy reaction to the vaccine - Suspected to be a Conspired Attempt on the targeted victims life - 5th Attempt

During the Acute Allergy reaction to the Covid 19 vaccine Fraser Ellis MP stated through RF Transmissions in the home of the targeted victim ["Im in love with Frankenstein" - Referring to the swollen disfigurement, and skin lesions of the targeted victim face](#)

Forth meeting - In Office appointment - Fraser Ellis MP, Kadina

The targeted victim was greeted by Fraser Ellis MP as "Mate" and led to the conference room accompanied by Fraser Ellis MP assistant, personal assistant, Sarah - During this meeting the targeted victim asked for assistance to a medical claim of Medical negligence involving the Covid 19 vaccine Acute Allergy reaction and the Medical negligence involving the Wallaroo Hospital

Fraser Ellis MP during this meeting sat very close to the targeted victim at her side and leant in close when addressing her, the targeted victim could smell Fraser Ellis MP cologne due to the fact that he sat in very close proximity to the targeted victim at the table and leant towards her, presenting himself as if speaking to her in private.

During this meeting Fraser Ellis MP stated the word, when talking about Government projects "Labor"

Fraser Ellis MP also stated the words :

- ["How did that feel?"](#) - Identified as words stated to the targeted victim in 2015 during Extreme Targeting involving Conspired isolation of the victim, Extreme Sexual targeting of the victim and Conspired attempted murder by lethal injection of the victim, and stated to the victims face by Identified individual involved 2014-2015 Conspired Sexual Targeting involving [Paul Gardner](#), Port Germain, Queensland, and connected to Police sources involved, Motorcycle gang members involved and the targeted victims Business Advisor of a Intellectual Property Theft, [Michael Fetherstonhaugh](#), 2006-2012 Medical Business Plan and M.S.I.C, connected to the Direct targeting of Epstein and Maxwell (ADAM) and a Sex Abuse Ring targeting the targeted victim

- "Criticism" - Word that would suggest Fraser ellis MP Involved in the constant and Continuous psychological abuse, vicious harassment of the targeted victim in her home conducted through RF Transmissions

Both these statements were not pertained to any other form of the interaction involving the meeting of a medical claim and gaining assistance and were spoken completely out of context by Fraser Ellis MP, Kadina and suspiciously suspect of being personal

Comment "How Did that feel? Made by Fraser Ellis MP - Identified as Involved and present during the 2013-2017 Conspired Attempted murder of the targeted victim by lethal injection, the Conspired Extreme Sexual targeting of the targeted victim, Extreme Fraudulent activity involving Money laundering from the targeted victim, Conspired Police targeting of the targeted victim, and Multiple Intellectual Property Theft, including the development of the Reality series manuscripts of the targeted victim

During this meeting Fraser Ellis MP Personal assistant GLARED at the targeted victim as if jealous or a distaste or disliking for the targeted victim

Sarah, Personal Assistant of Fraser Ellis MP was Identified as relaying messages for Fraser Ellis MP while he was at work entailing "Tell her I love her" -which Sarah was relaying to the targeted victim for Fraser Ellis MP through RF Transmissions

Fraser Ellis MP, Kadina Government source Identified as Involved in the targeting of the targeted victim and targeted Sex Crimes in Australia involving Epstein and Maxwell

Fraser Ellis MP, Kadina and Sarah informed the targeted victim during this meeting that it was advisable for the targeted victim to write the claims herself for the medical negligence and did not assist the targeted victim in anyway involving the medical negligence claims, including the medical negligence of the Wallaroo Hospital.

Following this meeting RF Transmissions involving the manipulation, grooming and Conspired sexual targeting of the targeted victim involving the Ellis Family continued. During this period the targeted victim suspicious of what the Ellis Family were saying was untrue, but instead believed that they were trying to protect her from the targeting. **The targeted victim kept stating "I don't believe you because there is no personal contact between us"**

The targeted victim was then contacted directly by Giles Ellis, Manager of the Kadina Sports and Leisure Centre - Who then proceeded to become involved in the manipulation, grooming of the victim and Conspired Sexual targeting of the victim. - Email evidence / Refer to File 4 / 4B Giles Ellis %20

Pattern of Behaviour following this point - Manipulation - Grooming - Conspired Sexual Targeting

- Fraser Ellis MP - Manipulating the targeted victim into becoming a house wife and getting pregnant - having a child
- Giles Ellis - Portraying a jealous ██████ who was fighting for the targeted victims hand in a relationship
- Giles Ellis - masturbating with the targeted victim through RF Transmissions
- Giles Ellis stating he was the son in love with her
- Michael Ellis - Stating Giles was the son in love with her
- Teressa Ellis - Stating Giles was the son in love with her
- Manipulation of marriage
- Manipulation to change the targeted victim image to a wholesome house wife and ██████ image
- Fraser Ellis MP—Stating "Trust Me"
- Fraser Ellis MP - Stating "I did it because I care"
- Fraser Ellis MP - Stating "Please Stay"
- Fraser Ellis MP - Stating "This will never happen again" "I give you my word"
- Fraser Ellis MP - Stating "I will never let you go"
- Fraser Ellis— Stating "I won't stop until I have a ring on that finger"
- Fraser Ellis - Stating "Everyone loves you here"
- Fraser Ellis MP - "You don't know how beautiful you are"

During this period both parents Michael and Teressa Ellis are acting in support of the relationship with their sons - Both parties supporting each son separately -Teressa supporting Giles Ellis and Michael Ellis supporting Fraser Ellis MP

At this point the targeted victim was still in progress of constructing the Constructed criminal case files and had identified the involvement of Epstein and Maxwell and had suffered horrendous shock following discovering that she was a targeted victim involving child sex predators and a sex abuse ring and suffered horrendous fear, and began to research the FBI divisions involved in the Epstein and Maxwell case, and had submitted the Evidence to I.C.A.C/OPI.

RF Transmissions in the home of the targeted victim remained extremely abusive, psychologically.

Giles Ellis - Teressa Ellis - Involvement in Manipulating, Grooming and Sexually targeting the victim

Giles Ellis who the targeted victim had now been manipulated into believing was the son she was going to be in a relationship with and had manipulated the targeted victim during the psychological shock of identifying the involvement of Epstein and Maxwell stated through RF Transmissions "Hazel tried to kiss me" - Stating that an employee identified as an employee of Giles Ellis at the Kadina Sports and Leisure Centre (Gym) had tried to kiss him at a work show stating "she threw herself at me" - Commencement of grooming the targeted victim - Pattern of Behaviour - Betrayal Psychological, emotion grooming of the targeted victim to create vulnerability and breaking down the victim emotionally and psychologically enforce the targeted victim to act in an act of her own Betrayal - Run into the arms of another man in an act of betrayal - namely his ██████ Fraser Ellis MP / acting as if he is in love with the targeted victim and is fighting for the targeted victims hand in a relationship

The targeted victim did not react in an act of betrayal but became very distressed while still under the shock of the realisation of a Sex abuse ring involvement and the continuous Psychological abuse that was occurring in the home through RF Transmissions

Following this event Hazel, Giles Ellis employee accused by Giles Ellis as "throwing herself at him and trying to kiss him" entered the home through RF Transmissions and portrayed a rival woman fighting for Giles Ellis to have a relationship with him. Hazel began to argue continuously with the targeted victim over Giles Ellis and stated "He slept with me" "He has a large penis"

Following Hazel introduction into the home of the targeted victim through RF Transmissions the targeted victim while in the Sports and Leisure Centre standing at the lockers in the Gym section of the centre near the entry to the gym, one of the instructors walked past in an intimidating, angry stance, a disposition of jaded towards the toilets located outside the gym entry door, straight in front and past the targeted victim. At the exact moment the instructor walked past the targeted victim, Giles Ellis stated through RF Transmissions "Oh no Hazel"

Both parties Giles Ellis and Hazel / Employee of Giles Ellis and the Kadina Sports and Leisure Centre involved in manipulation, grooming for sexual purposes and the Conspired sexual targeting of the Ellis family, Fraser Ellis MP and Giles Ellis - All parties involved in Co-conspirators of sex crimes in Australia and targeting of the targeted victim

At this point the targeted victim was still stating in the privacy of her own home, her bedroom interacting with RF transmissions Fraser Ellis MP and the Whole Ellis family, now including the grandfather, Teressa Ellis ██████ :

- "I do not want a relationship"
- I do not want to be touched"
- "I am saving myself for marriage" - "I will not have sexual relations outside of marriage" - "I will not have sexual relations with a partner before the wedding night" stated "I want a traditional value' - moral values of the targeted victim
- "I will not get into a relationship without a career" - targeted victim was aware of the detail in the constructed evidence files stating Destruction of career for sex demand of a sex abuse ring - Targeted victim was terrified of being the target of another conspired sexual assault of the targeted activity involving a sex abuse ring

The targeted victim remained isolated from society 2019-2024

RF Transmissions remained psychologically abusive 24 hours a day during this period of the Ellis family manipulation, grooming and sexually targeting the targeted victim, while the targeted victim remained entrapped in her parents home, now Identified as the Primal source and involvement as co-conspirators of sex crimes in Australia, and Family members, the [REDACTED] family targeting a member of their own family, the victim, [REDACTED]

Illegal Conduct in a Public Office - [REDACTED] [REDACTED], Identified as a family member involved - Fraser Ellis MP, Identified as a Australian Government source involved

Following the parents, [REDACTED] [REDACTED] and [REDACTED] [REDACTED] doctors appointment with Dr Richard Daehn, Kadina Medical associates [REDACTED] and [REDACTED] [REDACTED] went to the office of Fraser Ellis MP, Kadina and asked for an appointment.

At this point Fraser Ellis MP was refusing to have appointments with the targeted victim due to in house arguments through RF Transmissions between the targeted victim and Fraser Ellis MP, Fraser Ellis MP manipulating the targeted victim to have a relationship with his [REDACTED] Giles Ellis and the targeted victim refusing to have relationships. The targeted victim was also trying to rebuild her career, JC INNOVATIONS which Fraser Ellis MP had blocked all email contact to his office from the targeted victim to discuss rebuilding her career in the location of Kadina during the period of manipulating, grooming and sexually targeting the targeted victim.

At this point Giles Ellis was stating through RF Transmissions to the targeted victim "Please" Terressa Ellis was stating through RF Transmissions "Please give Giles a chance"

[REDACTED] [REDACTED] and [REDACTED] [REDACTED] - Office of Fraser Ellis MP

Upon [REDACTED] and [REDACTED] [REDACTED] requesting an appointment with Fraser Ellis MP the request was met and an appointment was made for half an hour time from the time they entered the office. During this appointment [REDACTED] [REDACTED] and Fraser Ellis MP discussed the targeted victim, [REDACTED] [REDACTED] [REDACTED] medical condition regarding the Covid 19 vaccine Acute allergy reaction without the targeted victims knowledge or consent, and [REDACTED] [REDACTED] provided medical information involving [REDACTED] to Fraser Ellis MP .

[REDACTED] [REDACTED] informed the targeted victim, [REDACTED] [REDACTED] of this event when the parents returned to the family home, and provided all details of what the appointment entailed - the targeted victims own private and confidential medical information without her knowledge or consent - the targeted victim scolded [REDACTED], [REDACTED] [REDACTED] and told her never do that again.

Fraser Ellis MP involved in Illegal conduct in a public office and obtaining medical information regarding a third party without consent of the third party or knowledge of the third party

[REDACTED] [REDACTED] involved in illegal conduct in a public office with a Identified Australian Government source involved in the targeting

This conduct in line with 2017 Conspired Attempted murder of the targeted victim by lethal injection and the detail contained within the evidence concerning hospital records of the illegal detainment of the targeted victim - Dehlia Guy [REDACTED]

This detail Identifies that [REDACTED] of the targeted victim, [REDACTED] [REDACTED] was involved in Conspiring with sources involved in the targeting of her own family member, the targeted victim as a co-conspirator in the 2017 Attempted murder of a family member, the targeted victim [REDACTED] involving medical sources involved

Following this event RF Tansmissions - Continuous - Vicious harassment - abusive harassment - Manipulating - Grooming and sexual targeting of the targeted victim continued involving the Ellis family

Targeted victim now manipulated into believing the relationship was with Giles Ellis and not Fraser Ellis MP - Both brothers still acting as if rivals

Rf Transmissions stating :

- "Stay here with me so I can keep you safe" - Fraser Ellis
- "That's my girl" - Grandfather of the Ellis Family
- "Don't restart your career" "I want you to be a house wife so I can take care of you" -Giles Ellis
- "I want you to have a baby" -Giles Ellis
- "Kiss" - Giles Ellis - Portraying a man that was thinking of his partner while at work
- "Don't speak to my [REDACTED]" -Giles Ellis
- "Stop" - Giles Ellis portraying a partner that is becoming emotional at work while the targeted victim is interacting with the RF Transmissions - Manipulating the victim into believing he had emotional feelings for her
- "Don't worry about your children anymore, we'll take care of them" - Ellis family
- "No" "Say no to my [REDACTED]" - Giles Ellis - "Don't speak to him"
- "I have a large penis" - Giles Ellis - Sexual overtones

Following these RF Transmissions of manipulating the targeted victim, grooming and sexually targeting the victim into believing she was going to have a relationship with a respectable family in the community Giles Ellis, Teressa Ellis and Michael Ellis stated to the victim through RF Transmissions

"The relationship with Giles is an arrangement so you can have a secret sexual arrangement and relationship with Fraser because he is in the Government but is in love with you"

The targeted victim reacted very frightened to this event and the first thought she had was "You are a cult or involved in religion" The targeted victim stated "No, absolutely not" and began to detach from the Ellis Family emotionally and refused to talk to them or associate with them in any way. The targeted victim was horrified and very scared and remained isolated in her bedroom for long periods of time refusing to speak to anyone.

Following this event the Ellis family manipulated the victim into believing that they were just testing her loyalties to Giles Ellis and testing that she was not attracted to Fraser Ellis MP his [REDACTED]. Targeted victim was manipulated to believe what the Ellis family were telling her as they had become very supportive, very understanding of her anger at being targeted and spent long lengthy amounts of time with her talking to her or watching movies and told her "you are family" The Ellis family and the targeted victim would state "Mwah" to each other, a sign they were family All family members involved- Emotionally breaking down the victim

The RF transmissions remained abusive, psychologically abusive continuously, and Fraser Ellis MP became aggressive verbally towards the targeted victim 24 hours a day The targeted victim was becoming a victim of the break down of the targeting manipulation by this point and becoming very exhausted and began to struggle psychologically The targeted victim began to have suicidal thoughts to escape the targeting and the abuse

Prior to the fifth meeting with Fraser Ellis MP the targeted victim through RF transmission interaction heard Sarah, Fraser Ellis MP Personal Assistant state "Here comes our little superstar, the little show off" - Mocking the targeted victim in what seemed a jealous statement

Fifth Appointment - Fraser Ellis Office - the targeted victim

The targeted victim was greeted by Fraser Ellis MP stating "Mate" and was led into the conference room with Fraser Ellis MP and Sarah, Fraser Ellis MP Personal Assistant During this meeting Fraser Ellis MP sat very close to the targeted victim. The meeting entailed the submission of community issues and medical claim reports. The targeted victim showed Fraser Ellis MP photographs on her mobile phone of drainage issues at the end of her parents street. Fraser Ellis MP then showed the targeted victim photographs of what he stated was his home and the drainage issues on his street around his home - the home was a yellow prefab home, average in size - The home looked similar to the home the targeted victim had been denied financial assistance in the community to purchase as her own housing so she could leave her parents home were she was entrapped in a bedroom - The targeted victim was constantly denied housing rental and purchase in the location of the Copper Triangle - Conspired Entrapment in her parents home, Identified as a primal source and involved, [REDACTED] and [REDACTED] during the manipulation, grooming and sexual targeting conducted by the Ellis Family

During this period the targeted victim had become very emotionally and psychologically fragile and had failing health due to ongoing complications of acute allergy reactions.

The targeting had become fatal to the victim and the targeted victim felt as if there was no escape from the ongoing continuous vicious verbal harassment and abuse being conducted through RF Transmissions and had become suicidal in thoughts

Following this meeting the targeted victim was manipulated by the Ellis family to believe she was no longer able to attend meetings with Fraser Ellis MP in his office and was told not to go to his office anymore as she was family and now personally involved with the Ellis family and in a relationship with Giles Ellis, who did not want her to interact with his [REDACTED] because he was jealous, and stated numerous times through RF transmissions in the targeted victims home "My [REDACTED] is attracted to you" " I don't want you to go near him or speak to him at all"

The targeted victim manipulated into believing the Ellis family because they were reputable in the community did not attend anymore appointments in the office of Fraser Ellis MP.

Interaction continued through RF transmissions in the home of the targeted victims home while the targeted victim remained entrapped in Kadina because of lack of employment opportunities, closed career, manipulated into believing she was going to have a relationship with Giles Ellis and she was not to gain employment and to become a house wife

The targeted victim determined to stop the targeting continued to report the targeted activity to the FBI, American Criminal division before shutting down the evidence construction on the advice of Michael Ellis and the Ellis Family, who had stated that she was going to get married to Giles Ellis and the targeting would no longer exist, that she would be safe with them and they would protect her.

Michael Ellis - Stated when the targeted victim spoke about the marriage and where she would keep the evidence so it would be safe "You can keep it at our house" -Manipulating the targeted victim into gaining access to the evidence suspected as going to be destroyed by the Ellis Family so the targeted victim remained a targeted victim and a victim of the Sex abuse ring for life

RF Transmissions continued involving the Ellis family, Fraser Ellis MP and Giles Ellis portraying brothers who were in rival with each other fighting over a woman, the targeted victim

RF Transmissions in the home of the targeted victim - Ellis Family

- "I'm trying to protect you, I'm trying to protect you" - Fraser Ellis MP
- "If you marry my [REDACTED] you will be protected for life and we can be together" - Fraser Ellis MP
- "If you leave the house again and go to the pub I will send the police after you to drag you out of there and take you home" - Exchange Hotel - Targeted victim having a drink with a friend to talk about the stresses in her life - Fraser Ellis MP - 2 police officers entered the Exchange Hotel following this statement when the targeted victim met a friend for a drink following this warning by Fraser Ellis MP - a Male and a female police officer - Evidence the targeted victim is being watched by Fraser Ellis MP through illegal surveillance and RF transmissions
- "Richard is your enemy, don't talk to him" - Fraser Ellis MP - Targeted victim unsure who Richard was and not informed by the Ellis family who Richard was who was also involved in RF Transmissions in the home of the targeted victim
- Grandfather of Ellis Family - Portraying support of the relationship with Giles Ellis and portraying supporting the targeted victim during the vicious assault of abusive verbal psychological assault in the home of the targeted victim that was occurring 24 hours a day - Involved in the manipulation, grooming and sexual targeting of the victim by his grand children and the Ellis family
- Fraser Ellis MP and Giles Ellis both parties talking to the victim through RF transmissions while she is self pleasuring herself / masturbation - Fraser Ellis MP stating he wanted to place the head of his penis in her anus while she had sex with Giles Ellis his [REDACTED]

- "Kill yourself bitch" and laughing at the targeted victim - Fraser Ellis MP - targeted victim close to suicide / suicidal thoughts commencing during the psychological assault of the manipulation, grooming and sexual targeting of the Ellis family and the constant and continual RF transmissions of multiple people in the house involving abusive and vicious harassment and assault - Breaking down the victim psychologically so she will submit to the arranged marriage
- "I'm at the hospital" - Fraser Ellis MP - During this interaction following this statement : "I'm back at the hotel now, do you want to masturbate" then spoke to the victim all night - Fraser Ellis MP
- "You don't know how beautiful you are" -Fraser Ellis MP
- "Your incredible" - Fraser Ellis MP
- "I'm your husband" - Fraser Ellis MP
- "I'm putting a condom on in the bathroom"

Fraser Ellis MP portrayed a relationship with the targeted victim through RF Transmissions and in office meetings continuously and portrayed a man that was in rival with his [REDACTED] Giles Ellis as the form of manipulating, grooming, sexually targeting the victim and creating confusion in the victims mind

The targeted victim repeatedly told Fraser Ellis MP "I'm not a shameless hussy, I do not fool around with married men" and continued to interact with Giles Ellis, his [REDACTED] who had informed her that he was going through a divorce with his ex wife Sarah.

Giles Ellis - [REDACTED] of Fraser Ellis MP portrayed himself as a man that was interested in dating the targeted victim and was in the **Exact location at the Exact moment the targeted victim was in that location on multiple occasions in the front foyer, café and front desk of the Sports and Leisure Centre when the targeted victim was in the Sports Centre during the duration of the Sports and Leisure Centre membership contract during the early morning hours / targeted victim exercising at the gym**

The targeted victim repeated kept stating in her home interacting with Giles Ellis regarding the relationship he wanted with her "I don't know you" "I have never met you"

The manipulation , grooming and sexual targeting conducted by the Ellis family continued daily. The Ellis family following the targeted victim becoming scared of being told that the relationship arrangement with Giles Ellis for his [REDACTED] Fraser Ellis MP was only a tactic to test the targeted victims loyalty to Giles Ellis and continued to emotionally and psychologically break down the victim

The targeted victim continued to talk to Giles Ellis and Fraser Ellis MP, but remained cautious and suspicious of the information they were providing concerning their support and the relationship

Giles Ellis continued to ask the targeted victim advice concerning his divorce with Sarah, his ex wife and began to introduce the targeted victim to his children through RF Transmissions, Rebecca (Becky) and Taylor and commenced portraying a family setting of a marriage situation in the home of the targeted victim, while entrapped in [REDACTED] [REDACTED] and [REDACTED] [REDACTED] home, bedroom - The targeted victim has an estranged relationship with [REDACTED] due to the history of the family, [REDACTED] sexual molestation and the abandonment of the family at age 14 years of age when the targeted victim, [REDACTED] informed [REDACTED], [REDACTED] [REDACTED] of the sexual molestation of [REDACTED], [REDACTED] [REDACTED] at age 11 years of age until she was 14 years of age and knowledge that [REDACTED], [REDACTED] [REDACTED] has always been jealous of her since she was a child and did not like [REDACTED], the targeted victim interacting with [REDACTED], [REDACTED] [REDACTED]

The Ellis family manipulated the victim into believing that the arranged marriage with Giles Ellis is for her own protection from the targeted activity and that they were trying to help her and protect her.

The targeted victim unsure of the situation involving the brothers Fraser Ellis and Giles Ellis asked Michael Ellis, [REDACTED] of the two brothers through interaction of RF transmissions "Which son is in love with me, please tell me the truth" Michael Ellis, [REDACTED] of Fraser Ellis MP and Giles Ellis stated "It's Giles"

Giles Ellis continued to portray a family setting every weekend with the targeted victim through RF transmissions and informed the targeted victim that she needed to get to know the children because they would be a part of her life. The targeted victim interacted with the children of Giles Ellis continuously on the weekends, doing gardening with them, watching children's movies with them and creating a weekend family setting - Giles Ellis had told the targeted victim that he had the children on the weekends but his ex wife Sarah had full custody of the children and they resided in Adelaide

During this period of the manipulation, grooming and sexual targeting of the victim Fraser Ellis MP continued to distract the targeted victims attention towards himself and was stating information about his [REDACTED] behind his brothers back, undermining the trust of the targeted victim towards his own [REDACTED] and the portrayed conspired relationship that the targeted victim had been manipulated to believe - The targeted victim believed Fraser Ellis MP and continuously spoke to him through RF Transmissions and trusted Fraser Ellis MP to be telling the truth as the targeted victim had questioned Giles Ellis honesty on numerous occasions and had noticed a Pattern of Behaviour of deceit and betrayal in Giles Ellis , but remained manipulated and confused, but suspicious of both parties and by both parties and interacted with both parties on a relationship level, and including the family, Michael, Teressa and the grandfather of the Ellis family.

Following Giles Ellis portraying a relationship with the targeted victim and forming trust Fraser Ellis MP informed the targeted victim through RF Transmissions that his [REDACTED] Giles Ellis had slept with another woman in an act of betrayal of the forming relationship. The targeted victim was informed that the other woman was Patricia Lava / Betts (Pip Lava), Kadina, connected to Vincent Bulone/ 2018-2019 Sexual Targeting of the targeted victim / Identified as involved / Sex Abuse Ring, through employment, Natalie Betts, Adelaide University, Employee of Vincent Bulone , married to Patricia Lava, Betts [REDACTED], Nicholas Betts
Giles Ellis strongly denied this event had taken place and stated "My [REDACTED] is a bastard" "He is lying to you"

Fraser Ellis stated behind his brothers back in secret through RF Transmissions "My [REDACTED] slept with both those women" -Both women referring to Hazel and Patricia Lava / Betts

Giles Ellis strongly denied the accusation of his [REDACTED] and continued to manipulate the targeted victim - Pattern of Behaviour forming - Grooming the victim - **Refer to all Patterns of Behaviour in Stage 2, Sexual Targeting**

Fraser Ellis MP continued to manipulate the targeted victim into believing the relationship was with him and not with his [REDACTED] Giles Ellis - The targeted victim detached from Giles Ellis and continued to interact with Fraser Ellis MP believing Giles Ellis was dishonest and not worthy of her for a relationship - Acts of betrayal with other women / Pattern of Behaviour

On the 1st of March 2023 the targeted victim manipulated by the Ellis family submitted USB's of her business development JC INNOVATIONS to the office of Fraser Ellis MP believing that through the RF Transmissions of a family involvement and a relationship with Fraser Ellis MP that Fraser Ellis MP would assist her in the development and establishment of her business JC INNOVATIONS in the community of Kadina and commenced the restart of rebuilding her career

Following the submission of the USBs to the office of Fraser Ellis MP the targeted victim received an email stating that he could not assist her with the business developments as he did not have the time due to his pregnant wife - Refer to File 4 / 4A Michael and Fraser Ellis MP/ email dated 1st March 2023

The reply received from Fraser Ellis MP to the targeted victim states in an obvious form that this reply was of a personal nature and the MP's wife who was pregnant was not restricting his duties of his office but was informing the targeted victim on a personal level of his pregnant wife and that he was in a relationship, married

Evidence : the interactions involving manipulation, grooming and sexual targeting of the targeted victim in the home of the targeted victim and office through RF transmissions contained within this report and the evidence of the emails received from Fraser Ellis MP had taken place and are true and correct - Fraser Ellis MP involved in Co-conspirators of Sex Crimes in Australia and involved every member of the Ellis family

Following the targeted victim receiving this email from Fraser Ellis MP Giles Ellis his [REDACTED] continued to pursue the targeted victim and reformed trust with the targeted victim stating referring to the outcome , the email received involving Fraser Ellis MP being married and his wife being pregnant "See, I told you my [REDACTED] was lying and I was telling you the truth" "I did not sleep with anyone, and have not slept with anyone for 2 years" "I've been waiting for you" "I knew from the moment I first saw you that I wanted to marry you" "I am going to buy you a ring and marry you"

The targeted victim detached from Fraser Ellis MP and stopped talking to him, no longer trusting what he was saying - The targeted victim at this point had been manipulated by the Ellis family and was now vulnerable to the conspired attack of the manipulation, grooming and sexual targeting of the Ellis Family, but still remained cautious and suspicious and paid attention to the Pattern of behaviour that she recognised and found similar and familiar to previous forms of Patterns of Behaviour involving Conspired Sexual targeting individuals involved

The targeted victim again attached to Giles Ellis in a manipulation of believing they were entering a relationship and forming one through the interactions of RF transmissions in the home.

At this point : Patricia Lava / Betts (Pip Lava, Betts) entered the home through RF Transmissions and portrayed a woman that had been rejected by Giles Ellis and was fighting with the targeted victim as a rival to be in a relationship with Giles Ellis, in the same Pattern of Behaviour as previous woman that had entered the house, Giles Ellis employee Hazel, Instructor of the Sports and Leisure Centre

Patricia Lava, Betts made the Exact same statement as Hazel had stated "He has a large penis"

Following a period of time of the targeted victim being viciously attacked and insulted and assaulted involving the portrayed rival of Patricia Lava, Betts, Patricia Lava, Betts left the home though RF Transmissions for a short period of time

During this time, point in time Giles Ellis and the targeted victim staying united in the portrayed relationship , the targeted victim manipulated but still questioning the situation with the Ellis family, detaching then reattaching to the family due to the suspicious Patterns of behaviour the targeted victim was recognising, continued to question Giles regarding his interactions with Patricia Lava, Betts - Giles Ellis Strongly denied that he had slept with her and firmly continuously stated "my [REDACTED] lied to you"

At this point Giles Ellis introduced his ex wife Sarah to the targeted victim in the targeted victims home through RF Transmissions - The targeted victim was suspicious of Sarah, Giles ex Wife who seemed manipulative and deceitful to the targeted victim

The targeted victim spoke continuously to Giles Ellis about his interactions with his ex wife, who she was informed by Fraser Ellis MP who remained in the home through RF Transmissions and continuously portraying a man who was rivalling his [REDACTED] for the woman, the targeted victim, but had now stated he was the [REDACTED] in law and her friend, that Giles Ellis his [REDACTED] was in constant contact with his ex wife - His ex wife at this point stated "your not to watch horror movies when the children go to bed in the home when they are there on the weekends"

This statement made by the ex wife of Giles Ellis seemed very unusual to the targeted victim, that the ex wife thought she could control the activity of the new relationship in the home of her and Giles Ellis if they were to get married or have a relationship.

The targeted victim questioned Sarah and Giles Ellis relationship following their divorce and the constant contact involving Sarah's knowledge of personal details of the targeted victim and the portrayed relationship with Giles Ellis. Sarah portrayed the jealous ex wife and argued with the targeted victim in the targeted victims home through RF Transmissions.

Giles Ellis portrayed a ex partner that was still in support of his ex wife and started to lie to the targeted victim through RF transmissions and disappearing on the weekends, and Fraser Ellis MP portraying his [REDACTED] and interacting with the targeted victim as his [REDACTED] Giles Ellis in the relationship as a family setting on the weekends.

The targeted victim suspicious kept questioning this activity and instinctively knew she had been lied to

Giles Ellis portraying a relationship with the manipulated targeted victim stated "I had to take Sarah to the hospital and that's why I was not here on the weekend"

"I was invited to a birthday party with Sarah and that's why I wasn't here on the weekend"

"I was scared of how you would react if I told you the truth about being with Sarah" - placing the blame back onto the targeted victim for his actions and lies

"Sarah asked me for money to pay her rent"

The targeted victim manipulated to believe they were forming a relationship stated "you need to break free of Sarah, she's manipulating you" - Giles Ellis agreed and informed the targeted victim that he was a victim of abuse by Sarah and she had been abusing him, and that he suffered from depression throughout the entirety of their marriage - Giles Ellis gained sympathy of the targeted victim knowing she had been a victim of abuse in her own marriage to Darren Mc Diarmid 1996-2007 .

Giles Ellis portrayed himself as an abuse victim and a man that was now telling all his truths to the targeted victim. Giles Ellis admitted he had slept with Patricia Lava, Betts and stated that it was "A payback" for her being attracted to his [REDACTED] Fraser Ellis MP and placed the blame back onto the victim - Guilt tripping the victim / a form of manipulation and that he did it because the targeted victim broke his heart and he felt betrayed

Giles Ellis following this point stated continuously that he was exhausted and needed time to himself and would be quite through RF transmissions - seemed not present in the home of the targeted victim stating "I need time to myself"

The targeted victim continued to interact with Giles Ellis through the RF transmissions in the home of the targeted victim and stated that she wanted to go to Melbourne to see her children and called it a road trip. Giles Ellis convinced her she should not go alone and convinced her that they would go together with the children Rebecca(Becky) and Taylor on the school holidays

As time continued to increase the targeted victim began to question suspiciously the lack of personal face to face contact they were not having and only interacting through RF transmissions in the home of the targeted victim and repeatedly stated "I don't know you" "I've never met you" And stated "I need to know you are genuine" "If you are telling me the truth and are genuine that we are forming a relationship met me at the Sports and Leisure Centre and say hello"

The next morning following this statement made by the targeted victim through RF transmissions the targeted victim entered the Kadina Sports and Leisure Centre and walked towards the front counter in the foyer. Giles Ellis sat at the front counter in the foyer as discussed the previous night before concerning the road trip to see her children in Melbourne and him being genuine and the relationship was not a lie. Giles Ellis stated to the targeted victim concerning her Gym membership account "Just a minute, I was on the other screen" "there is a problem with your account but I'm sure it will sort it self out" - Giles Ellis portraying the conspired manipulation of the victim in an act of Conspired Sexual targeting in person to convince the targeted victim that what was hap-

Following meeting Giles Ellis in person at the front desk of the Kadina Sports and Leisure Centre that evening through RF transmissions the targeted victim stated to Giles Ellis met me outside at the Sports and Leisure Centre and I'll give you some of the scallops in sauce that I made - Giles Ellis had stated that he wanted to try some of the scallop recipe she was having for dinner - access to Illegal surveillance of the targeted victims home

The targeted victim arranged to meet Giles Ellis who she was manipulated into believing she was forming a relationship with outside of the sports centre the next morning with a bowl of the scallops she had made for dinner the night before as they had discussed through RF Transmissions. The next morning the targeted victim sat on a bench outside the sports and leisure centre waiting for Giles Ellis as arranged the evening prior. Giles Ellis did not show and left the targeted victim sitting there alone for thirty minutes - An act to humiliate the targeted victim - **Conspired manipulated humiliation of the targeted victim to break her down emotionally**

RF Transmissions - Giles Ellis

Following not meeting with the targeted victim as arranged Giles Ellis stated through RF transmissions "I could not take the risk because of my professional position as manager of the sports centre and you being a customer" "It would be unprofessional" "I need you to cancel your gym membership so we can be in a relationship" "I can't date a customer" "I need you to go to Pilates in Moonta"

"I swear to you that I am telling you the truth" "I give you my word" "I am genuine"

**The manipulated targeted victim stated "I understand" "I believe you"
The targeted victim began to cancel her gym membership at this point**

Following the targeted victim meeting Giles Ellis in person at the front desk of the Kadina Sports and Leisure centre Fraser Ellis MP was in the Exact location at the Exact moment the targeted victim was in that location with his wife and baby in a pram - One page more Book shop, Hallett street Kadina - The targeted victim was standing on the footpath with a friend Carol Burford, Moonta

Following this event the Ellis family continued to manipulate , groom and sexually target the victim through RF Transmissions

RF Transmissions : targeted victim at this point stated she wanted to gain a law degree to feel safe and regain legal power and protection because of the targeting - The targeted victim was developing ISPY.SUPPORT further at this point

- "I swear to you, you will not need a law degree " - Fraser Ellis MP
- "I need this to work between you and Giles" - Michael Ellis
- " Giles is very kind" - Fraser Ellis MP
- "You'll be safe with Giles" - Michael Ellis
- "Don't move to Port Lincoln, there is a police officer there who wants to kill you" "you will not be safe" "Giles is genuine, he wants a relationship with you" - Fraser Ellis MP
- "Destroy the evidence" - Fraser Ellis MP - Targeted victim replied "NO, I will never destroy the evidence, the evidence is my protection"
- "Don't give Giles a headjob on your wedding night, let him take the lead" - Fraser Ellis MP
- "You're so beautiful" - Fraser Ellis MP

During this period the targeted victim was introduced to a man named Alistair who proceeded to talk to the targeted victim through RF Transmissions and stated "she deserved better than Giles Ellis" and started to try to convince the targeted victim to detach from the portrayed relationship with Giles Ellis and the Ellis family and have a relationship with him. The targeted victim suspicious of this activity immediately stated "No" "I do not want a relationship" "I do not want to be touched" and became aggressive towards any man who entered the house through RF Transmissions in order to protect herself from any forms of criminal or Sexual targeting activity - The targeted victim remained vigilant and suspicious of any forms of sexual targeting in the house through RF transmissions or in the township of Kadina at all times and did not engage with society and remained unapproachable and aggressive to protect herself

Continuous RF Transmissions - Ellis Family

- "Dad said no at first " - Fraser Ellis MP
- "Give her time" - Michael Ellis
- "This is therapy" -Fraser Ellis
- " Start your books' "I will help you with the editing, publication and marketing sweetie" - Michael Ellis
- "I can't wait to finger you" - Fraser Ellis MP
- "Please Stop" - Giles Ellis

During this period of the targeted victim remaining suspicious and not submitting to any forms of manipulated relationships with society continuous abusive RF transmissions remained in the home of the targeted victim and was developing a pattern of behaviour - The targeted victim questioned the recognised pattern of the RF Transmissions abusive nature . Fraser Ellis Mp stated "this is therapy" "this is to help you, so you and Giles can have a relationship" The targeted victim stated "No, this is against the law and done without my consent, you do not have my consent, I do not trust Psychologists" - 2017 Conspired attempted murder of the targeted victim involved a falsified diagnosis involving a Forensic mental Health Psychologist Dr Hoa Nuy-gun

The targeted victim cancelled the gym membership as manipulated by Giles Ellis and commenced Pilates in Moonta. During the Pilates the instructor of Pilates stated through RF transmissions "Giles is worried about your shoulder" "Giles is really nice" - Pilates Kara instructor Identified as involved Co-conspirator in sex crimes in Australia and involved in the manipulation, grooming and sexual targeting of the targeted victim involving the Ellis Family, namely Giles Ellis

Alistair / Identified as involved in Sex crimes in Australia, Sexually targeting the targeted victim through RF Transmissions in her home, having access to illegal surveillance of the targeted victims home and Conspiring as a co-conspirator with the Ellis family involving manipulating, grooming and sexually targeting of the targeted victim involving the Ellis family continued to sexually target the targeted victim while attending Pilates through RF Transmissions at the exact same time as Giles Ellis, Fraser Ellis MP and the Ellis family were involved in Manipulation of the targeted victim, grooming and sexually targeting the targeted victim,

At this point the targeted victim repeatedly kept stating "But there is no contact, I don't believe you anymore" and kept detaching from the Ellis family and becoming aggressive towards them so they would not come near her and continued to develop ISPY.SUPPORT and began to detach permanently from the Ellis family

RF transmissions of a vicious abusive nature continued 24 hours a day. Fraser Ellis Mp repeatedly stated "We are trying to help you" "It is Therapy"

In this period the targeted victim started to network for the new business venture ISPY.SUPPORT and seeking professionals to become part of the support network of the business

The targeted victim contacted Shannon Reid on the advice of Perry Celani, who stated Shannon Reid was interested in becoming a support member. The targeted victim held a meeting with Shannon Reid, Psychologist and recognised the unusual first one word that Shannon Reid stated upon first meeting with her as she picked up a notebook as if the meeting was a client psychologist meeting session and not a professional meeting regarding ISPY.SUPPORT as arranged Shannon Reid stated to the victim a word that had only been stated by the victim in the privacy of her own home when interacting with [RF Transmissions](#) and speaking about her family and her brothers sexual molestation and the [abandonment](#) that followed by her family members - [Shannon Reid](#) stated "[Abandonment](#)"

The targeted victim noticed the word and knew Shannon Reid was involved in the targeting of the targeted victim, that it was not a coincidence, that Shannon Reid was involved in what Fraser Ellis MP had stated was therapy, and Shannon Reid had access to illegal surveillance of the targeted victims home and illegal access to Rf Transmissions in the targeted victim s home

[Shannon Reid Identified as Involved as a co-conspirator in conspired manipulation, grooming and sexual targeting of the targeted victim involving the Ellis Family - Shannon Reid Identified as involved as a co-conspirator in Sex crimes in Australia involving Epstein and Maxwell](#)

Following the targeted victim Identifying Shannon Reid, Psychologist as being involved in Illegal surveillance and illegal RF transmissions in her home and the suspected abusive nature of the RF transmissions being conducted to break down the victim slowly, grooming of the victim and Identifying the word "abandonment" used by Shannon Reid, Psychologist the the targeted victim confronted Shannon Reid in her home through RF transmissions and threatened to report her and have her prosecuted Shannon Reid replied through RF Transmissions " I was asked to do this by Fraser Ellis Mp" "I'm trying to desensitise you" Shannon Reid claimed she was desensitising the targeted victims complex PTSD. The nature of the abuse through RF Transmissions involved calling the targeted victim a filthy whore, a prostitute, just a hooker 24 hours a day.

Shannon Reid identified involvement and confession involvement connected to Ellis family, Fraser Ellis MP during the period of the Ellis family Conspired manipulation, grooming and sexual targeting of the targeted victim in the privacy of her own home through RF transmissions and the use of shared illegal access to illegal surveillance of the privacy of the targeted victims home - All parties Identified as involved co-Conspirators in sex crimes in Australia involving Epstein and Maxwell and targeting the victim in the location of Kadina, and the Copper Triangle

Continued RF Transmissions : Ellis Family

- Teresa Ellis defending Giles relationship of Giles and Sarah following their divorce and ganging up on the targeted victim
- "Shhh, don't tell anyone, don't repeat this to anyone " " My marriage is an arrangement but I'm in love with you" "the relationship with Giles, my [REDACTED] is an arrangement so that I can have an affair with you and the baby will be looked after in the marriage" "This is the truth" Fraser Ellis MP - Arranged marriage with Giles so Fraser Ellis MP could have sex with the targeted victim
- "Shhh, don't talk to these people, don't talk to anyone" - Fraser Ellis MP
- "I've got a surprise for you" - Giles Ellis
- "I've got a surprise for you" - Fraser Ellis MP
- "I'm addicted to you" - Fraser Ellis MP

Following Giles Ellis confession he had slept with Patricia lava, Betts the targeted victim through RF transmissions stated "You do know that Patricia Lava, Betts is connected to Vincent Bulone, the man who was involved in Conspired sexual targeting and is involved in the crime that was committed against me" - warning the Ellis family that they are now connected to Patricia lava, Betts and the crime committed against the targeted victim, sexual targeting

RF Transmissions - Ellis Family

- "Get rid of Pip Lava mate " - Fraser Ellis MP
- "We are no longer in contact with Pip Lava, Betts, we told her to leave Giles alone and reported her to the police for stalking Giles" - Fraser Ellis MP
- "I've Just had a baby" - Patricia Lava, Betts
- "I only masturbated with her" - Giles Ellis
- "Love you sweetie" - Michael and Teresa Ellis
- "I'm in love with you" -Fraser Ellis MP - repeatedly
- "I'm in love with you too" - Giles Ellis - Repeatedly
- "It is Fraser that is in love with you" - Michael Ellis
- "My baby's name is Lydia" - Fraser Ellis MP
- "Darling" - Fraser Ellis and Giles Ellis
- "Shhh mate" - Fraser Ellis MP
- "Shhh Beautiful" - Fraser Ellis MP

At this point, following a 2 year period of manipulation, grooming and sexual targeting involving the Ellis family the targeted victim became very suspicious of their involvement in the targeting and detached permanently from the Ellis family and the manipulation and stated through RF transmissions repeatedly "I don't believe you, I don't want anything to do with you, leave me alone" The targeted victim did not interact with the Ellis family anymore past this point, in person or through RF Transmissions in the targeted victims home. Fraser Ellis MP remained in the home of the targeted victim and continued to persuade the targeted victim to speak to him through RF Transmissions

During the targeted attack involving the Ellis family the targeted victim was manipulated into giving the Ellis Family material items, which the targeted victim was informed by Michael Ellis to bring to the Country Times depot and leave them with the receptionist to give to him, these material items included :

- Oranges from the targeted victims parents orange tree
- Pumpkins from the targeted victims garden
- Perfume / Chanel no5 - targeted victim has a acute allergy to salicylates and can not use perfume
- Tomatoes from the targeted victim garden - and a note for Giles Ellis containing the targeted victims phone number

Following the targeted victim detaching from the Ellis family Fraser Ellis MP was in the Exact location at the Exact moment the targeted victim is in that location on 2 occasions ;

- Walking past the Commonwealth bank while the targeted victim is standing in line in the bank
- Walking outside from his office with his wife and baby at the exact moment the targeted victim is walking past the doorway to his office

Fraser Ellis MP stalking the targeted victim in her home through Illegal surveillance and in public locations in the township of Kadina following conspired manipulation, grooming and sexually targeting the victim through RF transmissions, in office contact and involving all family members of the Ellis family - Endangerment of the targeted victim of an Identified Co-conspirator involved in sex crimes in Australia and a Primal source of the targeting of the targeted victim

Following the targeted victim detaching permanently from any form of contact with the Ellis Family Continuous RF Transmissions involving Fraser Ellis MP:

- "I'm serious" - Referring to prostitution of the targeted victim - targeting
- "I'm the Government"
- "You were only an opportunity"
- "Your ugly"
- "You don't know how beautiful you are"
- "Fuck you"
- "Too late beautiful" - This statement followed the completed development of future projections of ISPY.SUPPORT and submitted to the Premier of SA for review under an NDA - Contained within the evidence - Following this statement by Fraser Ellis MP a Mental Health Centre opened in the location of Kadina - Contained within the future projections of the development ISPY.SUPPORT submitted to the Premier of SA for review of support by the Government is a Mental Health Unit, the cover letter to the Premier of this development states the targeted victim wants to establish the development in the township of Kadina
- "Don't know what to do with her" - Fraser Ellis MP
- "I pushed her too far" - Fraser Ellis MP
- "I went too far" -Fraser Ellis MP
- "It's all over" - Fraser Ellis MP - Stated RF transmissions as the targeted victim walked past the office of Fraser Ellis MP

Pattern of targeting :

"It's too late" - RF Transmissions - Stated following every count of Destruction of career for sexual purposes involving Intellectual Property Theft
