



Country Health SA launches Inpatient Dashboards for Port Augusta and Mount Gambier

* Residents of Port Augusta and Mount Gambier will now be able to access up-to-date information about the amount of people being treated in their local public hospitals. *


* The Country Health SA Local Health Network (CHSALHN) launched inpatient dashboards for Port Augusta and Mount Gambier Hospitals following the successful release of the metropolitan data earlier this year. *

* Professor Belinda Moyes, Chief Executive Officer CHSA LHN said the inpatient dashboards provide country residents with an opportunity to learn more about how their hospitals are managed. *

* "The inpatient dashboard provides detailed information on the number of inpatients at each hospital at any one time," Professor Moyes said.

* "South Australia was the first state in the country to make this level of information available to the public and we are excited to extend this technology to country residents. *

"Through the dashboard the general public can gain a better understanding about how patient flow is managed in our busy hospital environments."



How to interpret this chart

This table shows a summary of the status of all inpatient beds in the Port Augusta Hospital (PAHS).

In an online environment, you can click on the chosen hospital in the table and the whole dashboard will update to show data specific to that hospital.

The dashboard displays occupancy per hospital split across 'general' beds and 'all' beds, breakdown of inpatients, the length of stay, and much more.

Professor Moyes said the dashboard, which is available online, will be updated every 30 minutes to provide real-time information about bed occupancy, average length of stay and inpatient flows.

"The dashboard also includes information specific to each hospital about the number of patients currently within each area or clinical unit at the hospital," Professor Moyes said.

"It allows people to easily see all of the different 'streams' of inpatient care that each hospital provides, such as surgical or pediatrics, and the status of each of these areas.

"Staff already use the dashboard, along with a range of other tools, to help monitor and manage capacity and ensure that patient safety is maintained.

"By releasing this data publicly we are continuing to make our health system more transparent."



ISPY.SUPPORT is a non for profit organisation that is designed for the collective collaboration of evidence collected from society of Professional or personal positions in the form of Fraudulent activity, Police targeting, Government targeting, Intellectual Property Theft, Sexual targeting and predatory activity, Stalking, Cheating spouses and partners, Corruption, Suspicious activity, Professional corruption and dissatisfaction,

Suspicious activity involving organisations or personal experiences, Dating site predatory suspicions, Social media predatory suspicions, Child predatory suspicions or predatory activity involving churches, religion schooling and religious sectors, such as churches, scientology, catholic schools for example, Police sexual targeting, Police fraudulent activity - involving stalking, fraudulent utility bills, fraudulent fines, fraudulent and illegal arrests, professional misconduct involving lawyers, judges and authority figures, illegal incarceration in Mental Health Facilities and Jail systems, corrupt Health Departments, Professional Integrity and anonymous reporting of Professional positions involved in Corruption (Whistle blowers), fraudulent activity or other illegal activity (Guaranteed Protection of identity, profession information and personal information).

and members of the public who join and attend the support group meetings on a monthly basis.

FUTURE DEVELOPMENT AND DEVELOPMENT PROJECTIONS

The business ISPY.SUPPORT future development and development projections consist of developing the NON For Profit support group meetings into a Trauma Centre, involving developing the business concept into a central hub, and establishing the development in specific areas commencing in Regional South Australia, the Yorke Peninsula, Kadina and developing further to be established in other regional areas of Australia and metropolitan areas of Australia. The central hub, ISPY.SUPPORT Trauma Centre will consist of an advisory service involving Consultants consisting of appointments with clients in order to report issues involving legal issues, criminal issues, corruption, mental health, medical issues, issues concerning trauma and abuse, or to be assisted with any social and public issue that requires the expertise of a consultant that can recognise the issue and direct them towards the correct department or service required to resolve and address the issue. ISPY.SUPPORT consultants will have the legal rights to report their clients issues to the conjoined and congealed services connected to ISPY.SUPPORT and make appointments for their clients with the correct departments, services, Government officials offices in order to provide the correct assistance to their client. ISPY.SUPPORT is a central hub that will streamline the system for the public, and the public will be directed and assisted in the correct perspective and direction in order to be assisted and gain the resolution for their particular issue. The business ISPY.SUPPORT bridges the gap between the public and the Government system and services in their local areas so people, members of the public are no longer slipping through the cracks and remaining unassisted, which in turn results in helplessness, frustration, further trauma and grief and suicide. The business ISPY.SUPPORT streamlines every service and system into a central hub and advances the systems and services for the public and bridges all gaps of services available to the public and communication within the systems involved in public services.

The business ISPY.SUPPORT will incorporate an advanced communication system and digital appointment system, M.H.S.I.C, Mental Health Services and Information Centre, in order to digitally communicate with the conjoined Government departments, services and public services systems, and including legal systems and Government Officials Offices in order to report their clients issues to the correct departments, communicate information between services and departments involving the reported issues, extending to medical services connected to ISPY.SUPPORT and M.H.S.I.C so all information of communication involving the clients of ISPY.SUPPORT are bridged and information is supported by M.H.S.I.C between all parties involved, streamlining the information and communication between all systems and involved parties. The business ISPY.SUPPORT involving the communication system M.H.S.I.C incorporates a Digital appointment system that allows ISPY.SUPPORT to digitally make appointments for their clients with the correct department, system or service required to address the recognised and reported issue of their client and the conjoined Government system, service required, or Government officials offices in order to direct their client to the correct department or service required to have their issue addressed and resolved. The communication and digital system of ISPY.SUPPORT M.H.S.I.C will advance all communication systems in the Government System, Medical System, Legal Systems and public services available to the public and bridge all gaps of communication between the systems and the public alleviating frustration, lack of knowledge and information and helplessness for the public and professionals involved in the system in order to stay abreast of all issue involved in the public

sector and between the systems conjoined to ISPY.SUPPORT M.H.S.I.C system.

The business ISPY.SUPPORT Trauma Centre will consist of a central hub providing services to the public consisting of provided services of treatment rooms and legal consultant rooms for victims of crime, victims of trauma, abuse and grief, medical abuse or trauma involving psychological trauma, physical trauma, emotional trauma and mental health conditions. ISPY.SUPPORT is a central hub for conjoined professionals and specialists in the area and region of the established business ISPY.SUPPORT involved in the treatment of trauma victims involving trauma, abuse, grief and mental health conditions to diagnose and treat clients of ISPY.SUPPORT involving the support group meetings or the public in one location, and treating members of the public who are slipping through the cracks of the system, or do not know where to seek assistance or are trying to break through red tape of the system to be treated.

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer. [129] These and several similar lawsuits were dismissed. [130]

All other lawsuits have been settled by Epstein out of court. [131] Epstein made many out-of-court settlements with alleged victims. [130]

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [redacted] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [redacted] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case. [132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein. [133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement. [134][135] A document filed in court alleges that Epstein ran a "sexual abuse ring" and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders". [136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights. [137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [redacted] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record. [134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court. [138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be. [139]

[redacted] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit, [140] [redacted] (then known as [redacted]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew [141] and retired Harvard Law professor Alan Dershowitz. [8][142] [redacted] also claimed that Epstein, Maxwell and others had physically and sexually abused her. [143] She alleged that the FBI may have been involved in a cover-up. [144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls. [145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [redacted]. Dershowitz took legal action over the allegations. [146][147][148] [redacted] filed a defamation suit against Dershowitz,

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.^[22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be [REDACTED], who was previously known as [REDACTED] met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when [REDACTED] was a 16-year-old spa attendant.^[22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".^{[22][63]}

Maxwell has repeatedly denied any involvement in Epstein's crimes.^[51] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".^{[58][64]}

[REDACTED] asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. [REDACTED] sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in [REDACTED] favour,^[65] with Maxwell paying [REDACTED] "millions".^[66]

In 2017, [REDACTED] filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[9][48][67][68]}

On 16 April 2019, [REDACTED] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, [REDACTED] had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [REDACTED] affidavit was filed in support of a defamation suit by [REDACTED] against Alan Dershowitz.^[69] According to the affidavit, [REDACTED] had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.^{[70][71]} [REDACTED] reported the incident to the New York Police Department and the FBI.^{[52][72]} Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, [REDACTED] to his New Mexico property where he and Maxwell molested her on a massage table.^{[73][74]}

[REDACTED] was interviewed for *CBS This Morning* in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.^[75]







SCENE OF COMMENCEMENT OF GOVERNMENT TARGETING 1988

John Wayne Olsen, Liberal Party Premier of South Australia (1996-2001), served two years in the Senate from 7 May 1990, when he filled a casual vacancy caused by the resignation of Senator Tony Messner.

JOHN WAYNE OLSEN - KADINA - SOURCE
A colourful backgrounder in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen.

Born in Kadina in rural South Australia on 7 June 1945, Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, nee Heath. He was educated at Kadina Memorial High School, studied accountancy at the South Australian School of Business Studies, spent a period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as president of South Australia's Rural Youth (1970) and later as a Kadina town councillor from 1971, and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter.

In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River; following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1985 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on urban and rural communities, and referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. *For service to the SA Parliament, particularly in the areas of economic development and reform, and through promoting business, infrastructure and investment opportunities. Olsen was Australian Consul-General in

*He was appointed Deputy Chairman and CEO of the American Australian Association in 2010. In 2014 he became an advisor with the Bespoke Approach lobbying firm. [6]

After the election, Marshall continued to lead the Liberals in opposition.^[20] Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.^[21] Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.^[22]

2018 state election

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.^[23] The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.^{[24][25][26]} At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election. → GOV SOURCES INVOLVED

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.^{[27][28][29][30]} Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.^[31]

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.^[32] The full ministry was sworn in on 22 March.^[33] In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.^[34]



- Anna - North Terrace University Campus - Telling her that he would pick her up in the red car (newly purchased Holden Astra for me) - Anna then contacted him telling him that she "missed him" and he replied that he was having drinks with the girls at the university and that she should come join him - he stated in another text message "No regrets"
- Marianne - Meeting her for lunch in Melbourne
- Sarah - Meeting her in the city for morning coffee regularly - FRASER ELLIS MP OFFICE
- Ashlee - Meeting her in the city
- Karam - Meeting for a nightcap - Travelling / business hotels
- Kerry - France - "Owe you a nice lunch"
- Racheal - Travelling for work / hotels - Lending her computer cords in the middle of the night and meeting in the lounge, airport lounges - "waiting in front of Charles Hawker"



Told me that he had bought her a present - a silk scarf - he had also bought a silk scarf for me when we first starting dating - I told him that it was inappropriate and personal and as he had bought one for me does he do that with all the women and I said it was now nothing special and had no special meaning and that I would not now ever wear it. He denied that he was doing anything wrong.

I went to a university conference, Robbie Davies was there, I walked up to join Vincent's PA who was standing with her talking, I was visible to Robbie Davies. She would not look at me and held her head down towards the floor and rushed away quickly, did not say hello or acknowledge me in anyway.

Michelle - Adelaide University - employee

Michelle kept messaging Vincent day and night through personal messaging apps with her personal issues. Contacted Vincent once at 4am in the morning with her personal issues while he was away from the university travelling in the US - He got out of bed to address and support her personal issues.

This went on for months

Would not fire her even though she was submitting wrong results and incompetent at her job - he was letting everyone else go when the grant money ran out but extended her contract.

I told him to back this personal contact off and as her boss his relationship at work should be professional and he was acting inappropriately in a relationship (ours) which was damaging and disrespectful towards me. He denied that he was doing anything wrong. This behaviour stopped.

Annie - Adelaide University - Colleague

Kept getting sms messages at the same time every night when he got home from work - was acting strangely and suspiciously - He never spoke about Annie to me or mentioned her name. I found his behaviour odd and suspicious and relating to previous behaviour so I checked his sms messages on his tablet that were connected to his phone. I found numerous messages to Annie - meeting her for lunch constantly - lots of interaction - picking her up from another location of campus in my red car that he had bought for me and telling her that he missed her - I felt Betrayed. - NO REGRETS

I confronted him and told him that I had read the messages on his tablet - He said that it was a joke - seemed nervous and defensive - we argued - told him he was lying to me, hiding things and it was inappropriate behaviour in a relationship, that he was hurting me.

He denied that he was doing anything wrong and blamed me for not trusting him.

Pattern forming - Behavioural - I was aware

He disconnected his phone from the tablet so no sms messages could be seen on it and changed his password when he travelled next.

Saw the messages to Annie saying he was drinking with the girls and she should come and join him - Denied he was drinking at work and I was being paranoid - he was doing this after he had asked me to stop drinking - I quit for nearly a year - He also asked me to quit cigarettes - I did for nearly 7 months - he was doing this at work while I sat alone at home waiting for him to come home at the end of everyday.

→ Natalie Betts - Adelaide University - employee

I met her at a university lunch for Christmas - seemed very comfortable and friendly with Vincent - playful - sat down inbetween me and Vincent as we sat next to each other on a long wooden bench at the table, nearly in Vincent's lap - I saw it as a rival behaviour and odd and disrespectful to a couple and their relationship.

Vincent was receiving constant messages from her while we were together and still messaging as soon as he got home from work while ignoring me and played with her - playful messages, laughing and giggling - sided with each other playfully against a company - told Natalie the way that this company had treated him which he had not spoke to me about or even mentioned - spoke about her constantly.



Targeted victim was approached by a woman in a clothing store located in the Kadina district while shopping with her mother, Cynthia [redacted] and asked if she would be interested in doing modelling as a Kmart catalogue model in Kmart catalogues.

The targeted victim replied "I will have to ask my mother", and proceeded to walk towards her mother while the unknown woman waited for her to return.

The targeted victim approached her mother and informed her mother of what the woman had proposed regarding becoming a model for Kmart catalogues.

The targeted victims mother informed her daughter, [redacted] (targeted victim) that she could not allow her daughter to do modelling due to financial reasons and that she was raising a family of four children and could not support her daughter by accompanying her to modelling shoots, which would be necessary as she was a minor of 14 years of age.

The targeted victim returned to the woman who stood waiting for her and informed her that she would have to decline the offer of doing modelling.

The woman smiled at the targeted victim before leaving the clothing store.

The woman was unknown to the targeted victim and was not sighted in the Kadina district again following this incident by the targeted victim.

Katrina Rawson, Kadina on his sister's, the targeted victim [REDACTED] [REDACTED] bed in her bedroom while she was hiding in the bedroom cupboard and terrified and not knowing what to do to help her friend Threatening the targeted victim, his sister [REDACTED] [REDACTED] with a loaded diving spear gun when she tried to defend and protect her friend from being sexually molested by her brother, Shaun [REDACTED] [REDACTED], the targeted victim, the sister [REDACTED] [REDACTED] aged 15 years of age following the event of her informing her mother of the sexual molestation of her brother - The mother, Cynthia [REDACTED] [REDACTED] sighted this event of the daughter, the targeted victim [REDACTED] [REDACTED] being threatened by her brother

- Refusing to support the daughters carer choices and schooling - Stating to her daughter "No you can not go to college"(age 14 years of age, Medical scientist following the high school Kadina memorial High Schools teachers recommendations of her daughter advanced academic achievements and academic directions following conducting Work experience in the high school science lab) - "No you can not do modelling, you will be nothing but a housewife and a mother like me" (age 14 years of age) - Mother, Cynthia [REDACTED] [REDACTED] commenced employment, Prices bakery as a nightshift packer when the daughter, the targeted victim [REDACTED] [REDACTED] was aged 14 years of age and following informing her of the brothers sexual molestation and made the daughter, the targeted victim [REDACTED] [REDACTED] take care of the family home and the family following denying her modelling (nothing but a housewife and a mother like me)
- Carer choices of the targeted victim, the daughter Jacqueline Pearce denied support by the mother, Cynthia Pearce following being informed by the daughter of the brother, Shaun Pearce sexual molestation at age 14 years of age claimed she did not support her daughters carer choices at the age of 14 years of age because of lack of finances (money) when the daughter continuously confronted her with the subject when an adult up until the age of 52 years of age (currently entrapped in the family home with the mother, Cynthia Pearce 2016-2023) following being encouraged and pressured by the mother, Cynthia Pearce in 2017 to move back to Kadina to reside in the family home All claims since the age of 14 years of age of this nature have contradicted with the mother, Cynthia Pearce's original statements made when the daughter was 14 years of age
