... Epstein a message". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[129]</sup>

... a similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

On December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [redacted] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [redacted] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring" and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement. On the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [redacted] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[138]</sup> Judge Marra made no ruling as to whether claims by [redacted] are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that [redacted] may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

[redacted] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit.<sup>[140]</sup> [redacted] (then known as [redacted]) alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[142]</sup> [redacted] also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with [redacted]. Dershowitz took a defamation suit against Dershowitz.

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein. [22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be Virginia Giuffre, who was previously known as [redacted] met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when [redacted] was a 16-year-old spa attendant. [22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex". [22][63]

Maxwell has repeatedly denied any involvement in Epstein's crimes. [54] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims". [58][64]

[redacted] asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. [redacted] sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in [redacted] favour, [65] with Maxwell paying [redacted] "millions". [66]

In 2017, [redacted] filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms. [9][48][67][68]

On 16 April 2019, [redacted] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, [redacted] had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [redacted] affidavit was filed in support of a defamation suit by [redacted] against Alan Dershowitz. [69] According to the affidavit, [redacted] had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein. [70][71] [redacted] reported the incident to the New York Police Department and the FBI. [52][72] Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, [redacted] to his New Mexico property where he and Maxwell molested her on a massage table. [73][74]

[redacted] was interviewed for *CBS This Morning* in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault. [75]



Thank you sincerely for taking the time to visit me in my office on two occasions and for sharing material which you say shows multiple instances of intellectual property theft. # Trial delayed for Liberal MP Fraser Ellis over alleged fraudulent claims for Country Members Accommodation Allowance

The trial of a South Australian Liberal MP accused of making fraudulent travel claims has been delayed by more than seven months, until after the state election.

Fraser Ellis was due to stand trial in November, charged with 23 counts of deception.

The Member for Narungga is accused of making 78 fraudulent claims for the Country Members Accommodation Allowance — totalling more than \$18,000 — between May 2018 and June 2020.

His charges arose as a result of an investigation by the state's Independent Commissioner Against Corruption (ICAC).

However, the Adelaide Magistrates Court was told that the original trial date should be vacated until after a High Court judgement has been made on a separate but similar case.

Independent South Australian MP Troy Bell has been granted special leave to appeal to the High Court in December, almost five years after he was first charged following an ICAC investigation.

Mr Bell has pleaded not guilty to misappropriating \$2 million in public funds while working for an independent learning centre before he entered parliament.

### Key points:

- Mr Ellis is now expected to stand trial next June

Mr Ellis will now stand trial in June next year, but the court was told that could be changed again if it clashed with a parliamentary sitting week.

Mr Ellis suspended his own Liberal Party membership in the wake of being charged but, in a statement issued after the court hearing, said he would ask the party to back him or sack him.

"As this matter will now not be resolved prior to the state election, I will write to the State Executive of the Liberal Party inviting them to confirm that I remain the endorsed Liberal Party candidate for the seat of Narungga," Mr Ellis said.

\* CLAIMED HE WAS INNOCENT TO TARGETED VICTIM IN OFFICE MEETING.

"Given I am presumed innocent I hope that the Party will confirm my endorsement and allow me to stand as a Liberal candidate at the election.

"If the Liberal Party, despite the presumption of innocence, and despite my record in achieving outcomes for the people of Narungga, and despite the overwhelming support that I have received from my community, choose to remove my endorsement then I will nominate as an independent candidate and seek the support of my community directly."

The Liberal Party state executive said a decision regarding Mr Ellis's candidacy was "yet to be determined".

On Wednesday, Mr Ellis's lawyer, Anthony Allen QC, made an application to vacate his client's trial date until after a judgement had been made in Mr Bell's case.

"So far as defence is concerned, [the Bell case] is likely to have an impact, or potentially could have an impact, on this trial," Mr Allen told the court.

"There are matters being considered by the High Court that are relevant to these proceedings; the interpretation of the ICAC Act is certainly something that will occupy focus in the High Court.

"Some guidance in the form of a judgement in the High Court would likely resolve any potential issues that might have an adverse impact on these proceedings."

Prosecutor Ryan Williams did not oppose setting a new trial date for Mr Ellis but warned the High Court matter may be delayed and not heard until January or February next year.

Mr Williams also asked the Adelaide Magistrates Court to appoint an apolitical Magistrate to Mr Ellis's matter.

"It's important that, whoever hears this trial, neither have any affiliation with any of the major political parties nor must they have had any affiliation with the major political parties in the past, given the highly politically sensitive nature of the allegations," he said.



First-term South Australian Liberal MP Fraser Ellis has been charged with making more than \$18,000 in fraudulent expenses claims, after a probe by the state's anti-corruption watchdog.

The Independent Commissioner Against Corruption (ICAC) Ann Vanstone QC, said it would be alleged Mr Ellis made 78 fraudulent claims for the Country Members' Accommodation Allowance.

The probe was sparked by a series of exclusive stories by the ABC that raised questions about the use of the scheme by several MPs.

The system allows regional MPs who live more than 75 kilometres from Adelaide to claim up to \$234 a night when they are in the city on official business.

- The charges arose from a recent ICAC investigation
- Mr Ellis has maintained his innocence, and says he will "vigorously defend" the allegations

"It will be alleged that Mr Ellis claimed the allowance for nights he did not spend in Adelaide," Ms Vanstone said in a public statement.

She said Mr Ellis had been charged with 23 counts of deception — allegations the MP strenuously denies.

## Government 'in chaos'

Opposition Leader Peter Malinauskas said it was a "stunning revelation".

"People are also rather alarmed about the fact that he'd informed the Premier and the Premier has said absolutely nothing about it, despite having opportunity to do so," Mr Malinauskas said.

"This speaks to a degree of secrecy that ... I think South Australians are alarmed about.

"We now have a Marshall Liberal Government that was elected with a majority and has lost it and that has sent the government into chaos at the very time South Australians are looking for stability in leadership."

Premier Steven Marshall said today he was told "late yesterday" about the charges being laid against Mr Ellis.

"I'm focused on one thing — the people of South Australia," Mr Marshall said.

He said the pre-selection for Narungga occurred last year and that Mr Ellis could not be a candidate for the Liberal Party if he was not a member.

"It is a matter for the state executive," he said.

Mr Marshall said he had written confirmation from Mr Ellis that he would continue to support the State Government on confidence motions and supply.

## How did the expenses scandal begin?

The Country Members' Accommodation Allowance came into focus when an ABC investigation raised questions about long-serving Liberal MP Terry Stephens's use of the scheme.

Mr Stephens maintained he had done nothing wrong, but the ABC investigation prompted State Parliament to release 10 years' of allowance claims.

Immediately before those details were published, Mr Ellis announced he would repay money claimed while staying in Adelaide with Mr Stephens.

Ministers Stephan Knoll and Tim Whetstone also repaid thousands of dollars, while maintaining they had done nothing deliberately wrong.

The pair later resigned from their ministerial portfolios.

The ABC's stories prompted ICAC to begin investigating several MPs, including Mr Ellis, Mr Stephens and Adrian Pederick.

The Office of Public Integrity also examined the allowance claims of other regional MPs, but later cleared them.

Veteran Liberal MP Mr Pederick also repaid money while maintaining his innocence, before stepping down from his role as Government whip.

Mr Stephens stepped down as president of the Upper House while continuing to maintain he had done nothing wrong.

In her most recent statement, ICAC commissioner Ann Vanstone QC confirmed that her "investigation into claims by other Members continues".

At the end of a marathon late-night sitting where Parliament passed a contentious abortion bill, Mr Ellis rose to his feet after 2:00am to reveal he had been charged with offences arising from an investigation by the ICAC.

"I'd like to take this rather unconventional time to inform the House that yesterday I was charged with alleged offences arising from the recent ICAC investigation into the Country Members' Accommodation Allowance," Mr Ellis said.

"I am completely innocent and I will be vigorously defending these allegations to the full extent of my resources and the law.

"These charges are mere allegations, not proof of what is alleged against me."

"I make this statement now, Mr Speaker, knowing that there has been no public statements from the ICAC or the Department of Public Prosecutions because I have nothing to hide, my conscience is clear."

Mr Ellis was one of several State Government MPs investigated by the corruption watchdog over their use of the Country Members' Accommodation Allowance.

Mr Ellis has repeatedly maintained his innocence, but repaid \$42,130 he had claimed under the scheme while staying at the Adelaide residence of a parliamentary colleague.

\*"I've never acted dishonestly," Mr Ellis told Parliament. - DISHONEST + MANIPULATIVE

"Any error in a claim form completed by a relatively inexperienced member was simply that, an error.

"There is a significant difference between an error and any proof beyond reasonable doubt of a crime in a court of law.

"These were the result of genuine errors by a new member for which I've already apologised."

Mr Ellis told Parliament that he informed the Premier Steven Marshall about the charges yesterday.

He said he had suspended his Liberal Party membership and would move to the crossbench while the case against him proceeded.

His move to the crossbench means the Liberal Government now holds just 23 seats in the 47 seat Parliament.

John Wayne Olsen, Liberal Party Premier of South Australia 1996-2001, served two years in the Senate from 7 May 1990, when he filled a casual vacancy caused by the resignation of Senator Tony Messner.

A colourful background in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen.

Born in Kadina in rural South Australia on 7 June 1945, Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, nee Heath. He was educated at Kadina Memorial High School; studied accountancy at the South Australian School of Business Studies, spent a period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as president of South Australia's Rural Youth (1970) and later as Kadina town councillor from 1971, and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter.

In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River; following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1986 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2] An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at national' contributions to debate. He spoke often on the state of the economy, particularly its effect on referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. The citation for his appointment as an Officer of the Order of Australia in January 2007 reads in part: - 2007

For service to the SA Parliament, particularly in the areas of economic development and reform, and through promoting business, infrastructure and investment opportunities. Olsen was Australian Consul-General in

Los Angeles (2002-06) and then in New York (2006-09), and initiated the G'Day LA and G'Day USA programs.

He was appointed Deputy Chairman and CEO of the American Australian Association in 2010. In 2014 he became an advisor with the Bespoke Approach lobbying firm. [6]

After the election, Marshall continued to lead the Liberals in opposition.<sup>[20]</sup> Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.<sup>[21]</sup> Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.<sup>[22]</sup>

2018 state election

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.<sup>[23]</sup> The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.<sup>[24][25][26]</sup> At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election. → GOV SOURCES INVOLVED

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two - the first time the Liberals had won a state election since Olsen's victory in 1997.<sup>[27][28][29][30]</sup> Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.<sup>[31]</sup>

Premier of South Australia

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.<sup>[32]</sup> The full ministry was sworn in on 22 March.<sup>[33]</sup> In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.<sup>[34]</sup>
