Mag Winters dating history with [REDACTED] Targeted victims father  
Relationship ended as a result of fathers betrayal with targeted victims [REDACTED]

[REDACTED] targeted victims [REDACTED] betrayed the relationship between [REDACTED] and Mag Winters by seeking a relationship with [REDACTED] while dating Mag Winters.

Targeted victims father [REDACTED] described Mag Winters as "a very nice girl".

Targeted victims [REDACTED] explained that following the betrayal of the relationship, her stealing Mag Winters boyfriend, [REDACTED] Mag Winters attacked her physically on the netball court with her friends in the netball team playing against the targeted victims netball team. **Not the behaviour of a very nice girl.**

The attack against [REDACTED] by Mag Winters on the netball court escalated into another physical attack (Personal town feud) with the friends of [REDACTED], who then attacked Mag Winters in their friends defence.

Kadina - Township History - Tight nit community - Township Structure

Kadina SA is a township community that is segregated into tight nit groups of association which discriminate against one another within the circles of association. Kadina is a township of group followers associating with only the tight nit members of the association, known as "Clicks". Any person not agreeing with the set mind or activities of the "Clicks" are out cast within the township and are discriminated against any opportunities regardless of qualifications or abilities and are made to feel they must leave the township, made to feel not welcome. Narrow mind set of the township, "Your not a local" rotates within the tight nit click associations (groups) who portray themselves as being above everyone else in the township and are associated in religious groups, Rotary Clubs, Council offices, Local Government Offices, Car industries, Farm industries, Industries, Police services and Medical Industry.

Police officer of the Kadina Police Department married targeted victims childhood friend, Nicole Oliver. Dissolution of the marriage resulted in the estranged partner of the marriage Nicole Oliver being targeted by the estranged husband (police officer) who included other members of the Kadina Police Department in his personal affairs of the dissolution of the marriage, who proceeded to target Nicole Oliver continuously for 2 years following the end of the marriage with continuous harassment and victimisation.

Mind set of the tight knit click associations - Township mind set - made to feel unwelcomed and victimised until the targeted victim moves from the township.

→ **First incident** : Targeted victim was followed along the Adelaide highway heading towards Kadina by a police vehicle following travelling to Adelaide to take her father who is suffering from Terminal cancer to Adelaide for treatment. Police vehicle turned towards the Kadina Police Station.

→ **Second Incident** ; Targeted victim was followed into Woolworths Super market by two police officers, a male and a female. The male officer stopped at the end of an aisle as the targeted victim entered the aisle and portrayed a polite figure by stepping aside and ushering the targeted victim into the aisle politely with his hand and stated "Mam" - Afternoon hours - 2 weeks prior to further stalking of the targeted victim of further police vehicles in **Exact location at the exact moment the targeted victim is in that location (Government and Police Illegal Surveillance of the targeted victim recorded since first incident of Intellectual Property Theft in 1993, from the Privacy of the targeted victims own home, Willamulka SA)**

**Third Incident**: 20th November 2021

→ 65 Stirling Terrace Kadina - parents home - Police vehicle driving past the family home in the evening hours while the targeted victim sat on the front veranda of the home

**Fifth Incident**: 21st November 2021

Targeted victim and Fraser Ellis, MP Kadina have not met in person before the first meeting while targeted victim resided in Kadina as a child or following relocation to Kadina from Port Pirie in 2017.

First meeting conducted in office of Fraser Ellis, MP Kadina :

Targeted victim supplied documented evidence of Corruption within the Australian tax Office involving Altered BAS Statements, creating Fraudulent debts and missing funds during electronic transfers from Statewide Super, super funds release application reported to the targeted victim by Statewide super as the missing funds being a result of the Australian Tax Office. Targeted victim supplied the information to Fraser Ellis, MP, Kadina following the ICAC investigation allegations and believing in his innocence and to review in his defence.

The targeted victim received a letter of acknowledgement and appreciation following this meeting.

Second meeting conducted in office of Fraser Ellis, MP Kadina

Seeking State Government assistance for the targeted criminal activity that had continued while residing in Kadina - Request of targeted victim - Contact Federal Law and the Prime Minister Fraser Ellis, MP, Kadina agreed to assist the targeted victim during this meeting anyway he could assist, if he was able to and appeared to be very concerned about the illegal activity that was being reported to him.

Targeted victim received a written letter following this meeting acknowledging the meeting and his offer to assist. Fraser Ellis, MP, Kadina only Senator between the years of 2016-2022 to agree to assist the targeted victim.

Targeted victim Submitted Business developments and medical Industry information to be addressed by the Government and encouraged Fraser Ellis, MP to pursue the information. Fraser Ellis, MP pursued the information provided which involved the medical Industry in regional locations and the results were publicised in the public - Student loans being paid for by the Government and ongoing infrastructure of the Medical industry in regional locations - Currently being addressed by Fraser Ellis, MP in the State elections as his campaign.

Targeted victim did not receive a written letter of appreciation or acknowledgement of the business developments submission from Fraser Ellis, MP Kadina - Suspected a result of Mail - WRONG - interception and blocked contact to only senator to assist targeted victim - Targeted victim received all previous correspondence prior to this event upon each meeting or submission

Email contact for appointment purposes - Blocked contact

29th January 2022 - Targeted victim proceeded to contact the office of Fraser Ellis, MP Kadina by email services to make an appointment to discuss the submitted Business developments and Medical Industry information provided by the targeted victim. Targeted victim encountered blocked passage / blocked contact to a Senators office, Fraser Ellis, MP Kadina

██████████ Marshall and Vickie Chapman have been confirmed as Government Sources involved and connected in the act of Government and Police targeting of an Individual, and confirmed as Conspiring against the targeted victim in 2020.

Career for Sexual Demand - [REDACTED] denied her [REDACTED] doing modelling and stated  
"You will be nothing more than I am, a wife and [REDACTED] which the [REDACTED] [REDACTED]  
[REDACTED] denied as the reason upon further questioning and referring to the event in her  
adult years and stated continuously to her [REDACTED] as an adult the reason for denying  
her any form of carer was a lack of money - Financial reasons - Both parents of the  
targeted victim were working during this period of age 14 years of age, owned their own  
home and later supported their 2 sons, one being [REDACTED] [REDACTED] the son that molested  
the [REDACTED] in Technical Engineering school and business ownership

Outspoken [REDACTED] / the targeted victim of [REDACTED] would not stop seeking justice concerning the childhood sexual molestation by her [REDACTED] in the family and would not stop talking about it and fighting for her justice within the family structure for over a 20 year period, seeking their admission and confession following informing her [REDACTED] in front of her [REDACTED], [REDACTED] who had sexually molested her commencing age 11 years of age in the family home, his sisters bedroom at age 14 years of age and all parties of the family denying it had occurred and the [REDACTED], [REDACTED] telling all other family members, including her friends in the community of Kadina that her [REDACTED], the targeted victim, [REDACTED] was :

- Making it up
- Seeking attention
- Is a little bitch for causing trouble in the family and making things up about her [REDACTED]

Following the event of the [REDACTED], targeted victim [REDACTED] telling her [REDACTED] about her [REDACTED] sexually molesting her at age 14 years of age, sexually molestation commencing 11 years of age and continuing until the age of 14 years of age and all parties of the family denying that it occurred no member of the family, including both parents, [REDACTED] and [REDACTED] talked to their [REDACTED] or [REDACTED] about the sexual molestation or asked their [REDACTED] any details about what had occurred, where it had occurred, when it had occurred and the [REDACTED] / targeted victim was sent to her bedroom alone away from all other family members and spent the next 3 years alone in her bedroom outed by the rest of her family and made to feel unwelcomed in the family and the family home and locked herself away in her bedroom in the family home to avoid contact with all other family members until she left the family home at age 17 years of age and relocated to Adelaide - Basically ran away from the family home when she was legally able to and had her own transport and employment of which she had spent the previous 3 years of her life alone in her bedroom planning on doing to escape the family

Age 14 years of age - Accompanied by her [REDACTED] - Local doctor of Kadina - Following this event of informing her [REDACTED] of her brothers sexual molestation and receiving no family support, family admission and being isolated in her bedroom the [REDACTED], the targeted victim, [REDACTED] spoke out to the local doctor, Dr Materne or Dr Bettes (unsure which doctor due to memory) what had happened in the family home

The targeted victims [REDACTED] stated to the doctor that "her [REDACTED] was having some emotional problems due to becoming a teenager" and the doctor referred her [REDACTED], the targeted victim to a Psychologist

The [REDACTED], targeted victim, [REDACTED] attended 2 appointments with the Psychologist at the Wallaroo Hospital by herself but did not continue due to feeling the Psychologist did not understand what she was saying and was trying to paint her as having emotional and psychological troubles and would not believe her that her [REDACTED] had sexually molested her

Suspected : Her [REDACTED] had lied to the Psychologist leading to the appointments about her [REDACTED] and the event of the sexual molestation by the [REDACTED] to cover up the family secret and protect her own superficial public image as a [REDACTED] and that of the families public image

Following the event of the targeted victim at age 14 years of age telling the local family doctor of the event of her [REDACTED] sexually molesting her at age 11 years until 14 years of age the following occurred within the family and was conducted by the [REDACTED] of the targeted victim, [REDACTED]:

- The [REDACTED] / targeted victim, [REDACTED] was abandoned by all family members, the father, and 2 brothers, [REDACTED] (perpetrator) and [REDACTED] (youngest [REDACTED]) but remained in contact with her eldest [REDACTED] who was adopted and did not get told about the event by the [REDACTED] and was the targeted victims best friend (close relationship within the family structure) and did not like his [REDACTED] [REDACTED] (the perpetrator)
- The [REDACTED], the targeted victim, [REDACTED] was segregated from all family members, which included; 2 brothers, father and mothers side of the family, targeted victims relatives, aunts, uncles, cousins and grand parents, who were told that the [REDACTED] was causing trouble in the family, seeking attention and lying about her [REDACTED]
- Targeted victim, the [REDACTED] [REDACTED] only family contact that had remained intact was her cousin [REDACTED], the [REDACTED] of her mothers [REDACTED] who had remained in contact with the targeted victim and did not abandon her due to her knowledge that the targeted victim, [REDACTED] was telling the truth about her [REDACTED], [REDACTED] and that [REDACTED] did in fact sexually molest his own [REDACTED] as he had tried to sexually molest his cousin, [REDACTED] in the same manner - [REDACTED] did not speak up in the targeted victims defence to any parents involved, including her own or the targeted victims parents, her brothers and sisters or her aunty and uncle, the targeted victims parents [REDACTED] and [REDACTED] concerning this event but remained in contact with the targeted victim and they constantly spoke of this event over a period of years with each other in private

Previous Attempted Sexual Molestation of the [REDACTED] / the targeted victim, [REDACTED] - Age 8 years of age - In the family home Keith Edwards - Paedophile - of an older age - 60 years of age and over The [REDACTED] targeted victim, [REDACTED] informed her [REDACTED] and father, [REDACTED] and [REDACTED] that the family friend that was constantly coming to the family home during day hours and evening hours and was spending time alone with her outside in the garden and in the family home, including saying goodnight to her in her bedroom was kissing her with an open mouth and placing his tongue in her mouth (French kissing), asking her if her could come in the toilet with her and was trying to put his hands under her dress by placing his hand on her bare knees and sliding his hand up to the hem of her dress at the top of her thighs

Following their [REDACTED], the targeted victim [REDACTED] [REDACTED], aged 8 years of age informing them about this sexual activity of Keith Edwards her parents believed her and asked questions about what was happening and reassured her that they would "take care of it, and not to worry anymore", that Uncle Keith was a bad man that would not be allowed to come to the family home anymore

Following this event Uncle Keith (Keith Edwards) was removed from the family home and

I was contacted on the 21st may 2021 by Officer Leong, stating that she was from Services SA on the phone number : 0422 370 133. During this phone contact I was informed that the phone call was being Recorded and the information given was not to be shared with a third party during the recorded phone call. Officer Leong (woman) informed me of the issue of suspected Identity Theft (my Identity) which involved numerous bank accounts being opened in my Identity and being used for illegal purposes of Drug Trafficking, Money Laundering, Money Transfers to a corporation, Fraudulent Activity and were operating in numerous locations, from recalled memory being Queensland, ANZ, NAB; as some of the numerous accounts, and involved over 1 million dollars illegally rotating through the bank accounts. I was informed that my Tax file number was being illegally misused in Australia and that my bank accounts and tax file number would be suspended.

I was asked to provide the details of my banking institutions and the balances of the bank accounts in my name. I informed Officer Leong that I held 3 bank accounts with the Commonwealth Bank, 2 personal accounts and 1 business accounts, balances being \$530.00, Goal Saver account, \$10.00 - \$15.00 in the business account and \$15.00 - \$20.00 in the personal account. I informed Officer Leong that the accounts were set up by the Commonwealth Bank Manager, Paul Flavel, Kadina and could be confirmed by Paul Flavel, Manager.

Following providing my bank account details I informed Officer Leong that this was a case of Identity Theft. Officer Leong agreed with me on the case of Identity Theft and informed me that the case would be referred to Federal Agencies - Federal Police - Legal Investigation.

Officer Leong then informed me that my bank accounts and Tax file number would not be subjected to a suspension and the case would be referred to the Federal agencies for a thorough investigation and I was not instigated in the illegal activity that had occurred because of the Identity Theft - Legal Investigation. I was informed by Officer Leong that the details would be sent to me via email services. I have not received an email from Officer Leong concerning this matter and contact.

# Discussing homelessness and community housing across YP

FEDERAL Assistant Minister for Community Housing, Homelessness and Community Services Luke Howarth and Member for Grey Rowan Ramsey visited Kadina on Tuesday, September 29. The pair met with Copper Coast Council mayor Roslyn Talbot, YP Community Transport general manager McDonald and Copper Coast Salvation Army Captain Karen Armstrong to talk about community housing, mental health and homelessness on Yorke Peninsula.

"Everyone needs to understand a lot of homelessness in the area is situational and if we give people the required help when they need it, they can

"Salvation Army will also contribute \$5m and build more community housing," he said.

"We know homelessness is more hidden in regions and a lot of people either couch surf or live with other people causing severe overcrowding."

"I love to see this government money come into regions — being here (in regions) is a great way to talk to community groups and service providers to better work together."

Mrs Talbot said the visit was an opportunity to highlight for affordable housing in the area.

"While it (homelessness) isn't a core function of council, he (Mr Howarth) has given us some suggestions of ways to advocate for solutions for our area," she said.

"We are a growth area and we are trying to encourage more people here but affordable housing is a real issue."

I also highlighted the need for accessible information for people, to have more Copper Coast-specific connections." Mrs Armstrong said she wanted the assistant minister to know the region had a lack of

- 2022-2023 The [REDACTED], [REDACTED]; [REDACTED] following the targeted victim, the [REDACTED] [REDACTED] continuously developing the evidence and receiving confirmed reports that she was a target of Organised Crime suddenly started to receive scams to her mobile phone impersonating that she was now a targeted victim of the targeting - Sources connected and involved impersonating the same form of targeting to persuade the [REDACTED] that the activity was not targeting her but the family in order to Cover up the mothers and families involvement in the crime of targeting that the family had commenced against her [REDACTED] from the age of 14 years of age when the targeted victim, the [REDACTED], [REDACTED] had revealed the Family Secret to a local doctor and spoke out of the family home as warned by the [REDACTED] to the [REDACTED] at age 14 years of age "We don't speak about family business outside of the family"
- 2017-2023 The targeted victim, the [REDACTED], [REDACTED]; [REDACTED] constantly and continuously cared for her parents during their illnesses, the father [REDACTED] diagnosed with Terminal cancer and the [REDACTED], [REDACTED] a Heart condition involving appointments and treatments in hospitals on a continuous basis and moved back to the family home in 2019—2023 and commenced to renovate the family home continuously without any help from other family members and as the parents career while also transporting them using her own vehicle to any treatments required in metropolitan locations or outside the Kadina region on a regular basis and when needed of which the [REDACTED] proceeded to assist her [REDACTED] financially when needed - The [REDACTED], the targeted victim [REDACTED] during this period quit smoking cigarettes and no longer required the financial assistance of the [REDACTED] resulting in the [REDACTED] continuously wanting to know the daughters financial affairs and both parents the [REDACTED] and [REDACTED] stating to the [REDACTED] continuously complaining that she was not doing enough for them in the house, including complaining about dishes on the sink and her father stating "You can't put everything on your [REDACTED]" - [REDACTED], the targeted victim no longer financially dependent on the [REDACTED] or father and the loss of control over their [REDACTED] - Loss of control - Financial referring to the [REDACTED] comment stated to her [REDACTED] during the Conspired Sexual Targeting of Vincent Bulone the [REDACTED] stating "use him for money" - The [REDACTED] encouraging her [REDACTED], the targeted victim [REDACTED] to use men for money - Suspected a reference of the [REDACTED] applying a tactic of prostitution grooming

Following discovering this detail and the thought remaining on the [REDACTED], the targeted victim [REDACTED] mind and shoulders of having let this doctor down and completing the deal of the photographs by not attending the third and last appointment for the doctor to take the last of the photographs the [REDACTED], the targeted victim [REDACTED] informed her [REDACTED] [REDACTED] that she had finally found the doctor, Dr Harries who had performed that operation in 2001 and how excited she was to finally be able to explain to the doctor what had actually happened and why she was unable to complete the deal they had formed in 2001 - the [REDACTED] [REDACTED] then replied that she knew and had heard of a Dr Harries that operated at the Wallaroo Hospital

THE TARGETED VICTIM, THE [REDACTED] [REDACTED] [REDACTED] RECEIVED THE DESIGNED BUSINESS LOGO OF M.S.I.C FROM ADAM GURGLY / EPSTEIN AND MAXWELL VIA EMAIL IN THE FORMAT CONTAINING %20 - THE EXACT SAME FORMAT RECEIVED BY THE TARGETED VICTIM, THE [REDACTED] [REDACTED] [REDACTED] FROM A AUSTRALIAN GOVERNMENT DEPARTMENT [REDACTED] - NEW ENTERPRISE INCENTIVE SCHEME FOR BUSINESS DEVELOPMENT AND RECEIVED AS %20

2008 The [redacted] following a 20 year battle with her [redacted] the targeted victim [redacted] following her [redacted] not backing down or being a part of the family and the constant and continuous arguments with her [redacted] over getting her family to admit what had happened to her concerning her [redacted] and the sexual molestation that had occurred at age 11 until 14 years of age and cutting of all contact and interaction with all family members including her parents, and the [redacted] [redacted] finally convinced her [redacted] the targeted victim [redacted] to forgive the family by confessing that her [redacted] [redacted] who had denied the sexual molestation of his [redacted] since his sisters age of 14 when she had revealed the sexual abuse in the family home to her parents had finally admitted that he had in fact sexually molested his [redacted] to his [redacted] and that the [redacted] [redacted] believes her [redacted] the targeted victim [redacted] that she was in fact sexually molested by her [redacted] [redacted] [redacted]

Following this confession by her [redacted] to her [redacted] as stated by the [redacted] [redacted] the targeted victim, the [redacted] and [redacted] began to associate with family once more. The incident was never discussed by any family member following reuniting with the family, the [redacted] [redacted] did not apologise to his [redacted] and the [redacted] the targeted victim did not receive an apology from anyone within the family involved in the segregation and remained segregated from all relatives except [redacted] [redacted] and remained in contact with her Aunt, her mothers [redacted] Lyn Morgan / Wickstein

The original form of the event that occurred at age 14 years of age is still current and present at age 52 years old, and the targeted victim, the [redacted] is now currently as a result of the continuous targeting entrapped in the family home with the perpetrators of the targeting the family members the [redacted] [redacted] and Father [redacted] and the brothers that regularly visit the family home and their parents [redacted] and Matthew [redacted]

Prior to this event in 1996 while pregnant with her third child and still refusing to associate with her family, namely her [redacted] [redacted] [redacted] who she knew was the one not admitting it had happened and had caused all the segregation of herself from the family was contacted by her mothers [redacted] her aunt, Lyn Wickstein, Arno Bay via a written letter sent to her Melbourne address. Contained within the written letter was the details of her Aunties belief that the sexual molestation by her [redacted] [redacted] [redacted] had actually occurred and she believed her that it had occurred and the reason she believed her was that she had in fact been a victim of sexual molestation by her [redacted] in her family and so had 2 of her sisters, the [redacted] [redacted] sisters and her [redacted] [redacted] knew of this event happening in the family, Lyn Wickstein revealed the victims of this sexual molestation in their family, the [redacted] [redacted] family, their [redacted] Sylvia Philips family (grandmother of the [redacted] the targeted victim [redacted]) and described how they had been affected by it. The names of the sisters of the sexual molestation of the family, the [redacted] [redacted] sisters were the same sisters the [redacted] [redacted] had been jealous of while the targeted victim, the [redacted] [redacted] was a child and had been told numerous multiple times by her [redacted] [redacted] that those sisters had mental health issues and were bitches and ran them down to people behind their backs within the community, it was the same sisters that had informed the targeted victim, the [redacted] [redacted] [redacted] that her [redacted] [redacted] [redacted] had said the same thing to them behind her back following 2017 detainment. The targeted victim, the [redacted] [redacted] [redacted] was aware as a teenager of her mothers jealousy of her sisters, these in particular sisters who had been sexually molested by the [redacted] Norm Phillips, and her jealousy of them going any where near her husband, the father [redacted] [redacted] and did not associate with those members of the Phillips family regularly and only spoke to them when necessary of at family reunions or gatherings, and was always physically comparing herself to her sisters in photographs in the family home in her

the targeted victim presence

Lyn Wickstein could only obtain this information regarding the sexual molestation of her [redacted] in the family home from the [redacted] she had a close relationship with the [redacted] - Who according to the written letter from Lyn Wickstein to her niece, the targeted victim, the [redacted] and [redacted] of [redacted] knew that in fact the sexual molestation of the [redacted] in the family that was denied in the family and resulted in the family conspiring against the family member had in fact occurred and the [redacted] had confessed in confidence to her [redacted] Lyn Wickstein that the event had actually occurred in the family and her son [redacted] was in fact guilty of Sexually Molesting his [redacted] in the family home and the [redacted] the targeted victim

- did not make it up
- was not seeking attention
- or causing trouble in the family by making up things about her [redacted]

which is what all family members segregated from the [redacted] / [redacted] were told and informed by the [redacted] [redacted] at age 14 years of age and why the segregation of her from all members of the family and relatives had occurred

Following the marriages and during their marriages the [redacted] [redacted] stated that during a family gathering at [redacted] [redacted] house Marlene [redacted] drank to much alcohol and ran away from the party and that the father [redacted] [redacted] chased after her to make sure she was alright and that Marlene [redacted] [redacted] cornered [redacted] [redacted] and kissed him, which [redacted] [redacted] walked in on and sighted [redacted] [redacted] This event caused severe extreme jealousy of the [redacted] [redacted] against her [redacted] [redacted] Marlene [redacted] and her husband the father [redacted] [redacted] and remained an issue in their marriage, to the point of the father, husband [redacted] [redacted] threatening to walk out on the marriage

- The [redacted] [redacted] [redacted] stated to the [redacted] the targeted victim [redacted] [redacted] when questioned by her [redacted] "Why haven't you got any baby photo's of me, but have got baby photo's of my brothers " (all 3 brothers)  
The [redacted] [redacted] [redacted] replied that the reason she did not have baby photo's of her [redacted] the targeted victim [redacted] [redacted] was because they did not have enough money at the time - the exact same reason given to every reason why the parents did not support their daughters carer or schooling choices but did support the sons of the family - Denied their [redacted] any recognition or support in the family from her birth

- The [REDACTED] following being informed of the event of the targeted victim, the [REDACTED] being sexually molested by the son [REDACTED] brought into the family home a man involved in what the [REDACTED] had been informed by the [REDACTED] Insurance. The insurance man only came to the family home when the father [REDACTED] was at work (ETSA Kadina Electricity Company) and the [REDACTED], the targeted victim [REDACTED] was present in the family home or when she had come home to the family home and sighted him sitting in the kitchen sharing a cup of coffee / tea and something to eat with each other, and was multiple times and on a regular basis. The targeted victim, the [REDACTED] informed her [REDACTED] that the insurance man made her feel very uncomfortable and uneasy around him as he always looked her up and down as if he was taking her clothes off with his eyes ( having awareness because of Keith Edwards at age 8 and her [REDACTED] at age 11-14 years of age of predators behaviour and warning signs of their behaviour) - The insurance man always left the home as soon as the father [REDACTED] arrived home from his employment, but stayed just long enough to say hello to the father [REDACTED] and then left  
 The [REDACTED] told her [REDACTED], the targeted victim [REDACTED] that she must have been mistaken and don't be silly - Refused to believe her [REDACTED] and denied the behaviour of the insurance man around her [REDACTED]

- Suspicious Death - Suspected Conspired involving the Family Members and a Criminal Network - [REDACTED] - Adopted eldest son of the [REDACTED] and father [REDACTED] and [REDACTED] and close family relationship to the targeted victim, the [REDACTED] - and not involved or had knowledge of his [REDACTED] Sexually molesting his [REDACTED] - a family member who did not like his sibling [REDACTED] A family member [REDACTED] that the [REDACTED] stated was jealous of his [REDACTED], the perpetrator of Sexual Molestation of his [REDACTED] at age 11-14 years of age

- [REDACTED] Jeffery [REDACTED] - Kadina - Died age 32 years of age - Between Bute and Kadina - Road accident - Driving home from his place of employment - Qualified Engineer - Township of Kadina closed for his funeral and all community members attended his funeral - Well known - popular member of the community - much loved and admired by all of the community of Kadina - and best friend to his [REDACTED], the targeted victim, the [REDACTED] and [REDACTED] - Friends with a police officer, Kadina - Only [REDACTED] the [REDACTED], [REDACTED] and targeted victim [REDACTED] would allow to be around her twin baby sons born 1993 and had just turned 1 year old - 1993 First recorded event of Intellectual Property Theft of the targeted victim / Infant Sleep Positioner / American Government involvement / John Olsen, Kadina Mayor and Liberal Government member and involved in a political position in New York in 2006-2009, the exact years 2006 that the [REDACTED], the targeted victim [REDACTED] was directly targeted by Epstein and Maxwell under the Fake identity of Adam Gurgly, and the second event of Intellectual Property Theft / The Medical Business Plan (Specialist Centre) and connected to Steven Marshall, Premier of SA involved in Conspiring against the targeted victim with Vickie Chapman, Attorney General of SA and Ex Prime Minister of Australia Julia Gillard - Vickie Chapman Connected and involved in 2017 illegal detainment with Roger Kirchner, Police Targeting and Rowan Ramsay in Port Pirie conspired following the targeted victim contesting Intellectual Property Theft of the medical business plan and M.S.I.C in 2013 and was illegally detained in 2017 following obtaining evidence of involvement in the business development and discovered the illegal targeted activity in her life / all accounts and commenced reporting the activity and seeking assistance

██████████ died at the age 32 years of age from a motor vehicle accident while driving on the road between Bute and Kadina, heading back to his place of residence, Kadina and lost control of his vehicle on a straight stretch of road with no obstacles, just skids on the road indicating that he braked and swerved and skidded in an 180 on the road and smashed into a tree on the opposite side of the road on the side of the vehicle and was reported by the people that found him slumped in the vehicle and called for help that the accident had broken his neck and had already passed away by the time he had been found

Prior to this accident occurring 3—5 after the targeted victim, the ██████████ the ██████████ twin sons first birthday ██████████ the targeted victims ██████████ and close family relationship was involved in regular association and still a close relationship with his ██████████, the targeted victim ██████████ and her first born children twin sons, and the only immediate family member that did not segregate from his ██████████ following the event of the family being informed about the ██████████ ██████████ sexually molesting his ██████████ age 11—14 years old and assumed did not know what his sibling ██████████ had done to his ██████████ and the targeted victim, the ██████████ the ██████████ had not revealed this information as she knew her ██████████ ██████████ would hurt him ██████████ physically for abusing her

Accident and death of ██████████ ██████████ occurred in September 1994 following the first intellectual Property Theft of the targeted victim, the ██████████ ██████████ ██████████ resulting in the Destruction of a carer for sexual demand in Willamulka SA, located between Bute and Kadina SA. Intellectual Property Theft in the possession of the American Government and SIDS Australia

Behaviour of ██████████ ██████████ following the death of her son ██████████ ██████████:

- ██████████ ██████████ pushed her ██████████ away from her when her ██████████ went to hug her and console her mothers what was perceived as grieving for the loss of her eldest son and grabbed her son ██████████ ██████████ and hugged him Displaying disdain for her only ██████████
- The ██████████ ██████████ blamed ██████████ ██████████ friends for his death, stating that they had spiked his drink during having drinks after work and that's what caused the accident and his death
- The ██████████ ██████████ blamed the police officer who was friends with her son ██████████ ██████████ for his death stating that if the police officer had have stopped him from drink driving along time before this event he would still be alive
- The ██████████ ██████████ then stated that her son ██████████ ██████████ had a medical condition / a heart blockage and that is what caused his death
- The ██████████ ██████████ stated following the event of her sons death that she was going to have tubal ligation reversal performed to have another child to replace the death of her adopted child
- Both parents ██████████ and ██████████ quit smoking following the death of their son ██████████ ██████████ and during directly following his death and in what was perceived as deep grief - image portrayed in the community to gain sympathy from community members - Quit smoking as if not under any emotional stress

2013-2020 Targeted victim, the [REDACTED] [REDACTED] [REDACTED] carer development Author of her first novel "Reality" - Received a publishing contract with Austin Macauley Publishers in 2018 prior to the Conspired Sexual Targeting of Vincent Bulone in July 2018

Publishing contract for the first novel "Reality" involved part payment for publishing with the publishing house from the Author, Holly Jackson, the targeted victim The [REDACTED] [REDACTED] of \$6,000 - [REDACTED] [REDACTED] and [REDACTED] [REDACTED] refused to financially assist the targeted victim the daughters publishing contract - Continual denied support of carer and schooling choices of the targeted victim the [REDACTED] [REDACTED] / Destruction of carer for sexual demand of a sexual abuse ring involving government sources, a criminal network and connected to Epstein and Maxwell / convicted child sexual predators who were involved in directly targeting the targeted victim the [REDACTED] [REDACTED] in the location of Port Pirie in 2006-2013

The first novel of the targeted victim the [REDACTED] [REDACTED] [REDACTED] contained a fictionalised account of the emotional and psychological abuse suffered by the victim following being a target of sexual molestation by her [REDACTED], which was a fictionalised account of her own experience in the family home and contained a fictionalised account of having an online lover (Epstein and Maxwell / Adam Gurgly) and the emotional and psychological effects of living an abusive life from a young age and the [REDACTED] [REDACTED] [REDACTED] had knowledge of the content of the first novel written by her [REDACTED], the author Holly Jackson, the targeted victim [REDACTED] [REDACTED] which the novel publication Reality released by the publishing house Austin Macauley Publishers resulted in sabotage of the sales of the published novel through sabotaged marketing of the published novel and Breach of the publishing contract by the publishing house Austin Macauley Publishers, resulting in Sabotage of the targeted victims, the [REDACTED] [REDACTED] [REDACTED] carer again
