The mother, [REDACTED] [REDACTED] suspected of being sexually active in the community of Kadina as a teenager involving sexual interaction with the government officials involved in Kadina John Olsen, Kadina and Rowan Ramsay, Kadina / Port Pirie and the government officials knowledge of this sexual activity and manipulated by the mother [REDACTED] [REDACTED] to assist in the family secret cover up under the act of the motive of their own personal secrets of having been sexually active with the mother [REDACTED] [REDACTED] as a teenager Suspected black mail tactic applied by the mother [REDACTED] [REDACTED] against the government officials involved in the Criminal Network targeting of the targeted victim, the daughter [REDACTED] [REDACTED] to sexually discredit her and sexually abuse her by grooming her for a sexual abuse ring and government sources involved in a criminal network of Paedophilia and Prostitution, as threatened by Paul Gardner, Queensland in 2015

The mother [REDACTED] had stolen [REDACTED] from another woman at age 14 years of age from a relationship he was in with Mag Winters (Chapman married name)

History of how the relationship began between [REDACTED] and [REDACTED] 19 years of age at the time of the commencement of their relationship Contradicts her claim to the father [REDACTED] stating that she was a virgin when they had first met due to the history of having dated his brother prior to the relationship and being skills at stealing a man from another woman Mag Winters, and the sexual history of her sexual behaviour in the family home in front of her daughter, the targeted victim [REDACTED] and the involvement of Government sources John Olsen and Rowan Ramsay covering up their own sexual secrets involving the perpetrator the mother [REDACTED]

Sexual behaviour and enticement towards the brother [REDACTED] following being informed of the brother [REDACTED] sexually molesting the sister, the daughter Jacqueline [REDACTED] indicates that the mother [REDACTED] and the son [REDACTED] are covering up a family secret of being sexually active with each other and the sexual behaviour of the son [REDACTED] towards the sister, the targeted victim [REDACTED] and also her friends was learnt sexual behaviour within the family home conducted and taught by the mother who was sexually molesting or sexually raping her own son [REDACTED] from a young age and was jealous of the sons sexual interest in the daughter, sister the targeted victim [REDACTED] - Mother [REDACTED] jealous of the daughter from birth / Pattern of behaviour towards the daughter from birth and following the event of the sons sexual interest in the daughter / sister

Pattern of behaviour of other son Matthew [REDACTED] who sided with all other family members against the sister, the targeted victim and daughter and had a close relationship with his sister, the targeted victim [REDACTED] prior to the event of the mother [REDACTED] being informed of the sexual molestation of the sister, the daughter the targeted victim [REDACTED] and segregated from his sister at age 14 years of age following the mother [REDACTED] stating lies about the daughter to segregate her from the family and activate the targeting to keep her secrets of the family sexual molestation and the sexual molestation and involvement with her son [REDACTED] and sexual history within the township of Kadina with Government officials John Olsen and Rowan Ramsay Son of the mother [REDACTED] - Matthew [REDACTED] suffers OCD and other Mental

Health disorders of anxiety, arrogance, abusing women by running them down / narcissistic behaviour similar to the mother and wet the bed / bladder problems un til 18 years of age and displays an unusual protectiveness of the mother towards the sister , the daughter the targeted victim [REDACTED] [REDACTED] which indicative of some form of sexual behaviour occurring between mother and son at a young age and his knowledge of the sexual behaviour between his older brother [REDACTED] [REDACTED] and the mother [REDACTED] [REDACTED]

The mother [REDACTED] [REDACTED] indicative of suffering from a Sexual Mental Health Disorder, narcissistic behaviour , well developed skills of manipulation, lying and manipulating community members by lying to them and displaying a superficial public image and dislikes people who are not vulnerable or easily lied to or manipulated to / strong characters and seems to target easy targets within the community to sell her superficial public image which is not displayed within the family home with her family, especially her daughter, the targeted victim [REDACTED] [REDACTED] and Conspired against the daughter to protect the Family Secrets and placed her in a position of severe endangerment, entrapment, sexual abuse and abuse resulting in Destruction of carer, death threats, criminal network targeting, falsified diagnosis of a delusional condition, PTSD / near death experience, Conspired Attempted murder b y lethal injection to appear as suicide and Compromised the Australian Government System and Australian Systems and individuals lives in an act of manipulated Conspired attack of her daughter to cover up the family secret involving Government officials of the community of Kadina and Compromised the Community Image of Kadina and the members of the community



- Physical abuse - Return attack by friends of the woman who betrayed the relationship resulting in the loss of the relationship - Vindictive
- Portrayed herself as a very nice girl - Turned vicious and physically attacked the woman who betrayed the relationship and took her boyfriend

1989 - 16 years of age

Kelvin Ahrns - Muddy lane Moonta SA

Mignon Ahrns - Muddy Lane Moonta SA - Sister

Engaged to Chapman 1989

Fathers name - Kevin Ahrns

Targeted victim was introduced to Kelvin Ahrns by his sister Mignon Ahrns who was dating the targeted victims brother, ██████████ ██████████

Pattern of Behaviour - Kelvin Ahrns

- Deceitful
- Disrespectful
- Physically abusive
- Psychologically abusive - All members of the family towards the targeted victim
- Betrayal - Womanising - Cheated on the relationship with his own best friends Girlfriend
- Very jealous and possessive
- Cheating resulted in the end of the relationship

Kelvin Ahrns following this relationship married a woman, surname Pridham, Wallaroo and had 1 child, a daughter.

Kelvin Ahrns as a result of this relationship was detained in a Mental Health Institution

Suspected to be First count of Conspired Sexual Targeting of the targeted victim
Individuals involved and connected - Government and Police targeting of an Individual

1991 - 19 years of age

Christopher McGinley - 22 Monmouth Street Moonta Bay

Victoria McGinley - Sister - Involved in kidnapping of the targeted victim - Involved in the Medical Industry - Nurse, Moonta Hospital

Targeted victim formed a medical condition PTSD as a result of the extreme violence and abuse of this relationship

Pattern of Behaviour - Christopher McGinley

- Deceitful
- Disrespectful
- Extremely violent - Extreme physical abuse - Choking, suffocating, assaulting
- Extreme psychological and emotional abuse
- Violent rape
- Womanising
- Betrayal - Had sexual intercourse with another young woman and made the victim watch as he betrayed her
- Extreme violence involving holding the victim at knife point
- Violent rape while his friends watched clapping - humiliation of the victim
- Humiliation
- Kidnapping from the family home - Parents home - assisted by his sister Victoria

- Segregation from family and friends - isolation
- Blocked contact from family and friends - Isolated from using telephone services
- Entrapment in the domestic home of his parents - Family home
- Locked in rooms - made to sit in corner of the room while being spat on, attacked by his dog, denied food and water and shower facilities
- Harassed while showering - clothing of the day thrown in the shower and victim made to wear the wet clothes resulting in irritated skin and rashes
- Knives held to the victims throat while sleeping - upon waking, nicks of the blade cutting the skin under the victims chin
- Victim suffocated by pillows while she slept
- Unpredictability of the perpetrator - violent and constant mood swings
- Entrapped in the relationship and domestic family home of Christopher McGinley for a 12 month period resulting in the victims constant escapes - Resulting in being kidnapped from her families home and returned to the entrapment by Christopher and his sister

Last entrapment following being kidnapped resulted in the victim escaping again and hiding in her brothers house, where Christopher McGinley did not know the address. The targeted victim hid behind the lounge of her brothers lounge room when the brother left the house for work and would not enter the house during that time in fear of her life. 7am - 6pm for 3 days
 Brother - Steven [REDACTED] - Kadina - Deceased

Following 3 days of the victim hiding in her brothers house the victims mother entered the brothers house and informed her daughter she had been contacted by Christopher McGinley who insisted the victim return to the domestic family home in Moonta (his parents home where she had been entrapped) and collect her belongings. The victim argued with her mother and refused to collect her belongings, the mother insisted and accompanied the victim back to the Moonta home of Christopher McGinley. The victim knocked on the front door of the home, her parents standing behind her. Christopher McGinley opened the front door, grabbed the victim by the scruff of her neck and pulled her into the house, holding the divers knife to her throat and stated "Today you die" The victim struggled and broke loose from the perpetrator and knife point to her throat and ran to the kitchen, running around the kitchen table trying to escape, while being viciously yelled at stating "If I can't have you no one can", while waving the knife at her. The victim became trapped again by Christopher McGinley at knife point to her throat, when a knock at the front door, yelling "it's the police" was heard, summoned by the victims parents. The police officer talked Christopher McGinley into approaching with the victim the front window of the house where he was standing. Christopher McGinley walked the victim to the front window of the house while holding the knife into her back. Christopher McGinley on request of the police officer slid the front window open a little with the victim standing in front of him facing the window. When the window slid open the police officer rushed at the window slid it open fast and reached for the victim, pulling her out of the house through the open window. The police officer stated to the victims parents "she's like a puppet, I can move her anywhere" - Obvious severe shock of the victim - Resulting in PTSD

The victim and her parents accompanied the police officer to the police station and gave a formal statement, including the previous 12 months of extreme violence and abuse and entrapment. The victim gave the statement and pressed charges against Christopher McGinley. The police officer was a witness to the endangerment of the victim at knife point and the entrapment. Christopher McGinley was only issued a Restraining order based on this report, police witness and account of entrapment and extreme violence of endangerment to the victim.

Targeted victim - married to Darren McDiarmid - 4 children - Residing in Port Pirie
Targeted victim 35 years of age

First Incident:

Targeted victim while residing in Port Pirie, married and at age 35, while standing with her husband at the Port Pirie park watching her youngest son Corey perform at his school play was approached by Christopher McGinley, who came behind her in that location and stood behind her staring at her. The targeted victim told her husband Darren McDiarmid who then turned around to stand facing Christopher McGinley in an Intimidating stance protecting his wife. Christopher McGinley was standing with a toddler in a pram. Christopher McGinley walked away.

Exact location at the exact moment the targeted victim is in that location (Government and Police Illegal Surveillance of the targeted victim recorded since first incident of Intellectual Property Theft in 1993, from the Privacy of the targeted victims own home, Willamulka SA)

Second Incident:

Targeted victim was standing in the Port Pirie Ellen street watching the Christmas parade with her son when approached by Christopher McGinley who stood on the opposite side of the road, directly opposite her position and stared at her, trying to intimidate her. The targeted victim left with her son to protect her son from any occurrence that may occur from the incident.

Exact location at the exact moment the targeted victim is in that location (Government and Police Illegal Surveillance of the targeted victim recorded since first incident of Intellectual Property Theft in 1993, from the Privacy of the targeted victims own home, Willamulka SA)

Confirmation of individual involved and connected - Commencement of targeting of an individual 1988 Kadina - Connected to Mag Winters, John Olsen and Ellis Family.

- Teddy Rowe - Targeted child known to the targeted victims childhood friend
- Leon Jolly - Targeted victims childhood friend
- Keith Edwards - Targeted the family included targeted victim as a child, 8 years of age

Suspected pattern of attack against the woman's daughter, who betrayed her relationship with the targeted victims father, the targeted victims mother

Mag Winters - Involved and connected to Government sources and Prominent families in Kadina and Moonta

Betrayal and emotional abuse targeted at the daughter of the mother who betrayed the relationship and attacked her with her friends - Woman's vindictiveness / Payback
Targeted conspired attack to destroy the parents of the targeted victim who betrayed her during the relationship by targeting the daughter and discrediting the family's reputation

Sons of the father of the targeted victim were not subjected to targeting.

Daughter of the mother , who betrayed the woman's relationship - Daughter was targeted
Targeted victim, daughter was not born during this event and is an innocent victim of Payback on a personal level of an individual connected to prominent families and Government sources.

1996 - 2001 - Senate 1990

1996 Premier of SA - State Politian of South Australia

→ Born in Kadina SA 1945 - Three years following the birth of the targeted victims mother, ████████ a Phillips (maiden name), born in Kadina in 1942 - Similar in age
Both parties known to one another and both parties born in the same location of Kadina.

→ John Olsen, MP Kadina became politically engaged in 1970 and became Kadina town councillor in 1971 - The birth year of the targeted victim

→ John Olsen, MP Kadina became town Mayor of Kadina in 1974-1977 - The targeted victim a child residing in Kadina

→ 1988 - Targeted victims first recall of first event of an Unusual disturbance in the family home at the age of 15 years old - night hours, alone in her bedroom

First recorded event of EMF and RF transmissions

→ First recorded event of commencement of targeting in the Privacy of own home of the targeted victim, discovered as Government and Police Illegal Surveillance, followed by the first event of Sexual advances by a police officer, In Exact location at the exact moment the targeted victim is in that location at the age of 16 years of age, located in Wallaroo.

→ 1992 - John Olsen, MP Kadina returned to State politics of South Australia

→ 1993 - First recorded event of Intellectual Property Theft of the targeted victim from the Privacy of own home, Willamulka SA, an isolated farmhouse on the outskirts of Kadina, following giving birth to her first two children, twin sons, and engaged to be married to the children's father

Intellectual Property Theft - Infant Sleep positioned

In the possession of the American Academy / American Government followed by 1994 SIDS Australia

→ John Olsen, MP Kadina was Australia Consul-General in Los Angeles in 2002

American Government Connections

* Born in Kadina in rural South Australia on 7 June 1945, Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, née Heath. He was educated at

* Kadina Memorial High School; studied accountancy at the South Australian School of Business Studies, spent a

period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as *

* president of South Australia's Rural Youth (1970) and later as a Kadina town councillor from 1971 and mayor of -1971

* Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter.

* In 1976 Olsen was elected president of the South Australian division of the Liberal Party; an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River; following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. ██████ Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1985 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of

* Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament *
 * on 7 May 1990; he was sworn in the Senate on the following day.[1]

* Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

“ ... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on small business and rural communities, and referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. The citation for his appointment as an Officer of the Order of Australia in January 2007 reads in part: - 2007

* For service to the SA Parliament, particularly in the areas of economic development and reform, and through promoting business, infrastructure and investment opportunities. * Olsen was Australian Consul-General in * Los Angeles (2002–06) and then in New York (2006–09), and initiated the G'Day LA and G'Day USA programs. * He was appointed Deputy Chairman and CEO of the American Australian Association in 2010. In 2014 he became an advisor with the Bespoke Approach lobbying firm. [6]

After the election, Marshall continued to lead the Liberals in opposition.^[20] Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.^[21] Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.^[22]

2018 state election

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.^[23] The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.^{[24][25][26]} At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election. → GOV SOURCES INVOLVED

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.^{[27][28][29][30]} Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.^[31]

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.^[32] The full ministry was sworn in on 22 March.^[33] In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.^[34]



A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States* (2014)

SEXUAL ABUSE RING
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 ([REDACTED]) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [REDACTED] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [REDACTED] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

[REDACTED] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] [REDACTED] (then known as [REDACTED]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} [REDACTED] also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [REDACTED]. Dershowitz took legal action over the allegations.^{[146][147][148]} [REDACTED] filed a defamation suit against Dershowitz,



Bloom asserted that the woman had received threats. The suit was dropped on November 4, 2016. Trump attorney Alan Garten denied the allegations, while Epstein declined to comment. [156][157][158][159][160]

v. Epstein and Maxwell (2017)

In 2017, [REDACTED] filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms. [161][162]



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

Bradley Edwards' defamation v. Epstein (2018)

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential. [163][164]

v. Epstein and Maxwell (2019)

TARGETED VICTIM - FIRST SEXUAL TARGETING - POLICE OFFICER - 16 YRS OLD - KADINA

On April 16, 2019, [REDACTED] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, [REDACTED] had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [REDACTED] met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted. [164] Farmer reported the incident to the New York City Police Department and the FBI. [165]

[REDACTED] affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table. [166]

v. Epstein and Maxwell (2019)

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by [REDACTED]. [167] She stated that an associate for Epstein had recruited her outside [REDACTED] at age 14 and she was gradually groomed for over a year before Epstein raped her in his New York City mansion when she was 15. [168] [REDACTED] filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place. [169] In October 2019, [REDACTED] amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and [REDACTED] as enablers. [170]

Jeffrey Epstein - PROSTITUTION - MODELING

Jeffrey Edward Epstein (/ˈɛpstiːn/ *EP-steen*;^[2] January 20, 1953 – August 10, 2019) was an American financier and convicted sex offender.^[3]^[4] Epstein, who was born and raised in Brooklyn, New York City, began his professional life by teaching at the Dalton School in Manhattan, despite lacking a college degree. After his dismissal from the school, he entered the banking and finance sector, working at Bear Stearns in various roles; he eventually started his own firm. Epstein developed an elite social circle and procured many women and children; he and some of his associates then sexually abused them.^[5]^[4]^[6]^[7]

In 2005, police in Palm Beach, Florida, began investigating Epstein after a parent complained that he had sexually abused her 14-year-old daughter.^[8] Epstein pleaded guilty and was convicted in 2008 by a Florida state court of procuring a child for prostitution and of soliciting a prostitute.^[5]^[9] He served almost 13 months in custody, but with extensive work release. He was convicted of only these two crimes as part of a controversial plea deal: federal officials had identified 36 girls, some as young as 14 years old, whom Epstein had allegedly sexually abused.^[1]^[10]

Epstein was arrested again on July 6, 2019, on federal charges for the sex trafficking of minors in Florida and New York.^[11]^[12] He died in his jail cell on August 10, 2019.^[13] The medical examiner ruled the death a suicide.^[14] Epstein's lawyers have disputed the ruling, and there has been significant public skepticism about the true cause of his death, resulting in numerous conspiracy theories.^[15]^[16] Since Epstein's death precluded the possibility of pursuing criminal charges against him, a judge dismissed all criminal charges on August 29, 2019.^[17]^[18] Epstein had a decades-long association with the British socialite Ghislaine Maxwell, leading to her 2021 conviction on U.S. federal charges of sex trafficking and conspiracy for helping him procure girls, including a 14-year-old, for child sexual abuse and prostitution.^[19]^[20]^[21]^[22] Epstein also maintained long-term relationships with various high-profile individuals, including Donald Trump, Leslie Wexner, Bill Clinton, Alan Dershowitz, and Prince Andrew, Duke of York.^[23]

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year" ^[110] It resulted in a 53-page indictment in June 2007. ^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate, ^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed potential co-conspirators. According to the Miami Herald, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The Miami Herald said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims." ^[1]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone" ^{[52][53][112]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI. ^{[1][89]} The plea deal was later described as a "sweetheart deal". ^[113]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience" ^{[114][115]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement. ^[116]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18, ^[117] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours. ^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koeppel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking


Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.^[92] She had allegedly undressed, but left the encounter wearing her underwear.^[93]

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.^{[71][94]} During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.^[92]

The Federal Bureau of Investigation (FBI) then became involved. Subsequently, the police alleged that Epstein had paid several girls to perform sexual acts with him.^[89] Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.^{[95][96]} The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.^[93] [REDACTED] a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.^[97] The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Recarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude – Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*^[98]

A former employee told the police that Epstein would receive massages three times a day.^[93] Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.^[99] Julie Brown's 2018 exposés in the Miami Herald identified about 80 victims and located about 60 of them.^{[1][71][100]} She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."^[1] Details from the investigation included allegations that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.^{[95][101][102]}

INDICATING UNDERAGE OR YOUNG.

In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.^{[93][103]} On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.^{[5][9][104][105]} State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,^[106] to which Epstein pleaded not guilty in August 2006.^[107]

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.^{[92][108]} Linguist Steven Pinker also assisted.^[109]

Targeted victim was approached by a woman in a clothing store located in the Kadina district while shopping with her mother, [REDACTED] and asked if she would be interested in doing modelling as a Kmart catalogue model in Kmart catalogues.

The targeted victim replied "I will have to ask my mother", and proceeded to walk towards her mother while the unknown woman waited for her to return.

The targeted victim approached her mother and informed her mother of what the woman had proposed regarding becoming a model for Kmart catalogues.

The targeted victims mother informed her daughter, [REDACTED] (targeted victim) that she could not allow her daughter to do modelling due to financial reasons and that she was raising a family of four children and could not support her daughter by accompanying her to modelling shoots, which would be necessary as she was a minor of 14 years of age.

The targeted victim returned to the woman who stood waiting for her and informed her that she would have to decline the offer of doing modelling.

The woman smiled at the targeted victim before leaving the clothing store.

The woman was unknown to the targeted victim and was not sighted in the Kadina district again following this incident by the targeted victim.

In 2015, the Israeli newspaper Haaretz reported that Epstein invested in the startup Reporty Homeland Security (rebranded as Carbyne in 2018).^{[76][77][78]} The startup is connected with Israel's defense industry. It is headed by former Israeli Prime Minister Ehud Barak, who was also at one time the defense minister, and chief of staff of the Israeli Defense Forces (IDF). The CEO of the company is Amir Elihai who was a special forces officer, and Pinchas Bukhris, who is a director of the company, was at one time the defense ministry director general and commander of the IDF cyber unit 8200.^[79] Epstein and Barak, the head of Carbyne, were close, and Epstein often offered him lodging at one of his apartment units at 301 East 66th Street in Manhattan.^{[80][81]} Epstein had past experience with Israel's research and military sector.^[82] In April 2008, he went to Israel and met with a number of research scientists and visited different Israeli military bases.^[82] During this trip, he thought about staying in Israel in order to avoid trial, and possible jail, for charges he was facing for sex crimes; however, he opted to return to the United States.^[83]

Video recordings

Epstein installed concealed cameras in numerous places on his properties to allegedly record sexual activity with underage girls by prominent people for criminal purposes such as blackmail.^[84] Ghislaine Maxwell, Epstein's close companion, told a friend that Epstein's private island in the Virgin Islands was completely wired for video and the friend believed that Maxwell and Epstein were videotaping everyone on the island as an insurance policy.^[85] When police raided his Palm Beach residence in 2006, two hidden pinhole cameras were discovered in his home.^[86] It was also reported that Epstein's mansion in New York was wired extensively with a video surveillance system.^[87]

[REDACTED] an artist who worked for Epstein in 1996, noted that Epstein showed her a media room in the New York mansion where there were individuals monitoring the pinhole cameras throughout the house. The media room was accessed through a hidden door. She stated that in the media room "there were men sitting here. And I looked on the cameras, and I saw toilet, toilet, bed, bed, toilet, bed." She added that "It was very obvious that they were, like, monitoring private moments."^[88]

Epstein allegedly "lent" girls to powerful people to ingratiate himself with them and also to gain possible blackmail information.^[89] According to the Department of Justice, he kept compact discs locked in his safe in his New York mansion with handwritten labels that included the description: "young-[name] + [name]".^[90] Epstein implied that he had blackmail material when he told a New York Times reporter in 2018, off the record, that he had dirt on powerful people, including information about their sexual proclivities and recreational drug use.^[91]

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse.^[181] The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.^[181]

Jane Does v. Epstein estate (2020)

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.^[182]

Jane Doe v. Epstein estate (2020)

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.^[183]

Jane Doe v. Epstein estate (2021)

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.^[184]

Trafficking charges

On July 6, 2019, Epstein was arrested by the FBI-NYPD Crimes Against Children Task Force at Teterboro Airport in New Jersey on sex trafficking charges.^{[27][185][186][187]} He was jailed at the Metropolitan Correctional Center in New York City, which has held prisoners such as John Gotti, Joaquin "El Chapo" Guzman, and Paul Manafort.^{[188][189]}

According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds - and perhaps thousands - of sexually suggestive photographs of fully - or partially - nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: (Young) [Name] + [Name], "Misc nudes 1", and "Girl pics nude".^[90] Also found in the safe were \$70,000 in cash, 48 diamonds,^[190] and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. The passport showed his place of



The next day suspecting something was happening in my home / being watched or listened to I said in the privacy of my own home , not shared with a third party - "Ok then, send your man down the beach so we can spend the day together"

I then left my place of residence and went to the beach location where I had met the man the previous day. The man appeared at the beach forefront and parked next to me within minutes of my arrival / white Futura car.

The man got into my vehicle and we spoke for a while and he made sexual advances towards me. He was smoking marijuana in my vehicle. I found this to be unusual and suspicious and said that I had to leave. I left and returned to my place of residence.

The following week I saw the same man at the front of Cheap as Chips store in Port Pirie. He stopped me to talk as I was about to enter the store and wanted to give me his phone number and informed me that he was accompanied at that moment by his ex partner and child, who walked out of the entrance of the store. I refused to accept his phone number and said I did not want to see him again.
