I am contacting you to inform you and raise an urgent matter of importance of your awareness involving a criminal matter of State Government Corruption that has been occurring in the life of a member of your community over a 27 year period, and is still current, active and present in that persons life in the present year of 2021.

In 2006 - 2012 I constructed and developed 2 Medical Business Plans, designed to enhance the medical services available to the public, assist in the publics access to medical services and to assist Medical Professionals in the services they could provide for their patients, while residing in the region of Port Pirie. In my assistance of these developments I registered with the Regional Development Board, Port Pirie and continued to develop the business plans under the guidance and assistance of Business Advisors Michael Fetherstonhaugh and Terry Reichelt.

Following numerous attempts of applying for funding and Government Funding, of which was continuously denied I placed the Business plans on hold and commenced the construction and development of my own fashion design business J Monequic, as I continued to seek funding for the previous medical business plan developments. In 2013 I discovered that the Medical Business Plans had been a target of Intellectual Property Theft and I had been experiencing numerous cases of targeted Fraudulent Activity, Sexual targeting and Police Targeting, which were affecting my ability to establish my career as a Professional Business owner, Sources of Funding and my personal life.

I am qualified in Business Management, Business Administration, a Published Author with Austin Macaulay Publishers, London and was accepted into the Venture Dorm Program with the Flinders University by Dee Edwards in 2020. I also became a part of the Eventbrite, Women in Business Association in 2019, when I re-located to Kadina from Adelaide, following the diagnosis of my father, David [REDACTED] suffering from Terminal Cancer, and the discovery that my partner at the time, having met him in 2018, an employee of the Adelaide University, Director of Research, Professor Vincent Bulone was involved in the targeted illegal activity that had affected my life causing untold damage while residing in the region of Port Pirie and following re-locating to Kadina.

In 2013 following the discovery of the Intellectual Property Theft of the 2 Medical Business Plans I contacted a Intellectual Property Lawyer seeking Legal Assistance and Legal Advice - Johnson Lawyers. I was advised to collect documented evidence regarding the people's involvement in the Medical Business Plans development and seeking funding.

In 2013 I obtained a Letter of involvement, Roger Kirchner, Director of the Port Pirie Hospital and Secret

Administration of SA Health. In 2016 I obtained a Letter of Involvement from the Regional Development Board, listing the Business advisors involved and submitted both Letters of Involvement to the Intellectual Property Lawyer, Johnson Lawyers, John James, who then denied the involvement of Roger Kirchner in the Medical Business Plans development. This denial alerted me to Suspicious Activity occurring involving the Intellectual Property Theft of the business plan (Cover up), and the illegal activity that had been targeting numerous accounts resulting in missing monies (Source of income and funding) and Fraudulent Activity.

* In 2015 - 2017 I commenced reporting the Fraudulent activity and targeted illegal activity to numerous sources seeking investigations and assistance, which included :

- Utility Companies
- Telecommunication Companies
- Government Departments
- Legal Services
- * • I.C.A.C - Corruption Commissioner *

Following the numerous reports submitted I was denied all investigations, assistance and that the activity was occurring.

Following the period of contesting and reporting of this activity I began to experience extreme Police Targeting in the region of Port Pirie between the periods of 2014 - 2016, which resulted in :

- Fraudulent fines and charges
- Police brutality, resulting in permanent injury
- Illegal Representation of a lawyer - Connected to Roger Kirchner's Executive Assistant
- Falsified Diagnosis - Local Doctor
- Illegally obtained falsified diagnosis (medical records) without authority, under the act of Illegal Representation, which was submitted in the Port Pirie Court House
- Illegally court ordered Mental Health Evaluation, based on the illegally submitted and obtained medical records - Judge A. Grasso
- Court Ordered Mental Health Evaluation conducted without Legal Representation, which resulted in my detainment into Glenside mental Health Facility, under the act of a falsified diagnosis
- Denied release from Glenside Mental Health Facility by SACAT, which resulted in another falsified diagnosis of Schizophrenia and ordered onto prescribed medication administered by monthly injections over a 16 month period, which carried the side affects of causing self harm to oneself (Suicide) - Attempted Murder to Appear as Suicide (Cover up)

* In 2017 following my release from Glenside Mental Health Facility I contacted I.C.A.C, Corruption Commissioner seeking assistance and investigation into the Intellectual Property Theft and Targeted Illegal Activity, which had resulted in numerous forms of Fraudulent Activity, and submitted documented evidence to support my claim, which included:

- * • Intellectual property Theft - 2 Medical Business Plans
- Fraudulent Activity - Missing funds - Excessive rise in Utilities and Telecommunication Systems, which also resulted in blocked and altered phone messages and contact, resulting in Isolation from family and friends - Submitted 2016 Origin Electricity bill / Excessive rise in utilities resulting in Police involvement / Corruption - CC Parking Fines, Townsville, Queensland (barcode scanned result)
- Sexual Targeting - Individuals connected and involved in the targeting
- Illegal conduct of Lawyers, doctors, police and judges involved in illegal activity

* I was denied an investigation, assistance and that the illegal activity was occurring or was a case for the Corruption Commissioner.

In 2018, following re-locating to Kadina from Port Pirie I met Vincent Bulone, Professor of KTH Sweden University and Director of Research, Adelaide University and formed a defacto relationship with this man, and re-located to Norwood, Adelaide.

In 2018 I obtained a publishing contract of my first novel with Austin Macauley Publishers, London and continued to develop and write 2 more novels / books to be included and published as part of a 4 part series

Of the book series, the second book under contract with the same publishing house in February 2020. In 2019 I commenced the development of my own business JC INNOVATIONS, involving a 5 Stage business development of business concepts (Businesses), products, Government developments, Medical and Scientific developments. JC INNOVATIONS registered in 2019.

Following discovering the involvement of my partner Vincent Bulone in the targeted illegal activity of Intellectual Property Theft and Sexual Targeting at the end of 2019, and while my father was under treatment for terminal cancer I disconnected from Vincent Bulone and re-located back to Kadina, as a carer for my terminally ill father, and then my mother Cynthia [REDACTED] who suffered a heart condition which required a Triple Bypass operation to be proceeded, and continued to develop my business JC INNOVATIONS and develop my book series, under contract with Austin Macauley Publishers, London. The first novel of the book series was published and released in October 2020.

Following the construction of JC INNOVATIONS 5 Stage Business Strategy I applied for funding with MADEC, Employment Department (Government Department) and submitted the business concepts for review for funding under the act of the Government Departments Intellectual Property Laws. This Government funding was denied and I was referred to the NEIS Program for funding. I was also denied assistance and funding by the NEIS Program.

Following the applied funding JC INNOVATIONS encountered Multiple Intellectual Property Theft between the years of 2020 - 2021, and the Illegal activity of Targeted accounts, Fraudulent Activity Continued, which also included the Australian Taxation Office, 2020 Altered BAS Statements resulting in denied rebates without requesting Proof of claim. - Grant Brodie

The publication of my first novel "Reality" encountered numerous forms of blocked marketing on Social Media Websites, which impinged on the sales of the book, professional writing career prospects, exposure to the public and the investment return of the publishing house.

In 2019 - 2020 following this continued activity and the awareness of Vincent Bulone's involvement I reported the activity seeking assistance and investigation into the illegal activity of:

- Intellectual Property Theft
- Sexual Targeting
- Police Targeting
- Targeting
- Fraudulent Activity

- Fraudulent Activity - Including the 2016 Origin Electricity bill - Excessive rise in utilities - Queensland police involvement
- Sexual Targeting - including connections to individuals involved in the medical business plans development and police sources of involvement

Multiple Intellectual Property Theft and Illegal Activity has been occurring under the act of Government Targeting / Illegal Government Surveillance of Privacy of own home, place of residence and has been occurring for 27 years, first recorded occurrence 1993 and continued until currently 2021, in every location of Australia, and including re-location or location, public and residence.

Documented evidence of this activity occurring over a 27 year period is in my possession and is currently being constructed to form a Legal Case against the Government Departments, Government figures, individuals involved, including employees of departments and companies, and all connections involved in the Sexual Targeting, Police Targeting, Falsified diagnosis's (medical positions), Legal Positions and seeking the representation of Peter Gordon, Gordon Legal Law Firm, Melbourne.

* This illegal activity is still current, active and present, which has resulted in a Restricted Lifestyle to protect myself from :

- * Sexual Targeting - Restricted interaction and forming relationships
- Intellectual Property Theft - No construction of businesses or business developments
- Fraudulent Activity - Residing with parents - No access to utility accounts / rental agreements
- Police Targeting - Isolation at place of residence
- Illegal activity - Isolation at place of residence

Restricted Lifestyle will remain in place until I have completed the construction of the evidence and have sought the Legal Representation of Peter Gordon, Gordon Legal Law Firm, Melbourne and commenced Legal Action for conviction / prosecution against the individuals involved.

I was informed by the Media Sources that due to Media Legislation the issue must first become a Legal Case matter before they can act on publishing the Illegal Activity, Targeting and endangerment of my safety to the public.

As this Illegal Activity appears to be a case of State Government Corruption Specifically Targeting an Individual over a 27 year period, and involving a Corruption Syndicate of individuals involved, including Police Corruption I advise you to contact and inform the Federal Government of this activity, to be recognised, addressed and conduct a full investigation into this matter and the evidence supplied to you.

* I have contacted you in the interest that this information may assist you in your current development of Taxation Fraud and the Legal Case that you are currently involved in, involving the State Government Taxation Fraud claims that have been laid against you, which I believe is connected to this activity reported in this letter and evidence provided. Dear Fraser Ellis MP,

* In addition to our previous contact and discussion concerning seeking assistance to report targeted activity of an individual to the Federal Agencies and Federal Government I have provided additional information, which includes Local Government involvement, Rowan Ramsey and a copy of the postal documentation and receipts of registered mail sent to the provided list of the Federal Agencies and Federal Government.
The packages contain a documented report and a USB, containing the documented evidence to support the report and my claim to seek an investigation into the targeted activity, files of which I provided to you via the USB, personally delivered to your office and given to you by me during our appointment on the 25th June 2021.

On this date of our appointment, 25th June 2021, following the appointment I contacted your office by phone to inform you that the USB containing the documented evidence and Federal Government and Federal agencies files, of which you were concerned may pose a risk to your computer because of the reported malware discovered on my computer. I informed your office administration to inform you that the USB does not contain any malware and was constructed on a computer that is not connected to any internet source or is infected by malware, so will not pose a risk to any computer. The first USB of documented reports and files provided to you prior to this second appointment was also constructed from the same Computer, not connected to any internet source or infected by malware, and also posed no risk to any computer.

I am contacting you to provide my direct phone number for direct contact concerning the matters that we have discussed. Ph # 0499 882 865

* Your office administration (older woman) had contacted my mother the day prior to our scheduled appointment on the 25th June 2021 to reschedule the appointment for a half an hour later. My mother reported to me that your office administration employee claimed to not have my phone number and had rang my mother instead to contact me about the appointment. I was unclear as to how your office administration had assumed that I was the daughter of Cynthia [REDACTED], as I do not know this woman or have entered your office at any time with my mother. This woman is unknown to my family and numerous relatives of mine with the surname [REDACTED] reside in Kadina.
My mother has been instructed to not provide my phone number to any source because of the targeted Activity, of which she is aware of. The message of the rescheduled appointment was relayed to me via my mother.

I am also informing you that I had provided a envelope containing the documented report of the Telstra Head office findings of the Remote Access to servers, accounts and computer hardware by Government and Police Sources to the same office administration employee of your office (older woman) approximately 3 weeks ago, who confirmed that she would pass the envelope onto to you for me.

I had provided this report during our meeting on the 25th June 2021, of which you took great interest in and proceeded to read closely, as if you had not read that report before, and questioned in my mind wether you had actually received it when I had provided it to your office 3 weeks prior, and as I had not received a reply from you regarding this information.

* Concerning your assistance to contact the Federal Agencies and Federal Government to assist me in *
seeking an investigation into the targeted activity, which has been recognised by numerous companies and
sources, I greatly appreciate your assistance and aid in my endeavour to seek assistance in stopping the
illegal targeted activity and seeking justice of the illegal activity which has caused tremendous damage in
my personal and professional life over the course of the 27 year history of the targeted illegal activity.



I am contacting you to submit Community developments and Government business developments, which I thought may be of interest to you and you could implement and place into the right hands for further development and opportunity.

*As submitted in previous contact in your office, the suggestions of community developments involving the development of KFC, Millers Clothing store and a Spend less Shoes store, which I believe would be beneficial to this area as a growing commodity of conveniences and further employment in the region I would like to discuss these potential interests further.

In reference to the development of the KFC store I would like to suggest the location of the establishment as being developed on the corner of the Aldi Supermarket carpark, next to the round about, across from Cheap as Chips, as a potential growing commodity for this region.

As you know the region statistically is made of an older generation who regularly travel to Port Pirie for the conveniences of KFC, Millers clothing store and Spend less shoes, which takes the money (spending) from our region and reduces our economic growth. Within the older generation there is also the inconvenience of travel arrangements to travel to these regions, which to me would make perfect sense to provide such conveniences to this region to not only sustain the populations spending habits but also to assist in economic growth and creating employment in this region, which would greatly be beneficial as a whole.

* In 2007 - 2009 I conducted a Statistical overview into Professionals in various rural regions, their spending habits and the reasons as to why these regions do not attract Professionals to the areas or remain in these areas past their contracted dates. Discovered within the Statistical Overview were the reasons.

- * • Lack of conveniences - Shopping
- * • Lack of employment for their families

These two points of interest were high on that list, which prompts you to address these issues and find solutions.

In reference to the Millers Clothing store and Spend Less Shoes I would like to suggest the location of the proposed developments as being in the vacant commercial buildings situated across from the Commonwealth Bank. In reference to this commercial building, these two developments could be the start of a small shopping mall of specialised shops established, that could grow as time proceeded and further specialised shops were attracted to this region. In turn this would also address the Statistical Overview results of convenience and employment and also assist in the economic growth of Kadina. Establishing these conveniences in this region would also ensure that the spending habits of this community remained here in Kadina and they were no longer travelling to Port Pirie, where the wealth of our community is being spent. From my analysis of talking with the local people of this community these shopping conveniences have been recognised as being high on the list of their reasons to travel to Port Pirie.

I would like to now address the further developments submitted, Government developments addressing the issues of Cross contamination of Microbial Infections, which is a project I have written in an Executive Summary of the concept only, but have not completed past that point. Within this development I have included the issue of the current Coronavirus, which you know is a cross contamination of contact which is reducing economic growth, health risks to the public, employment and numerous other issues here in Australia. I am aware of the Immunisation Scheme which is appearing to be affective but is also still incurring some hurdles and problems through the fear of the public, and infections are still ongoing and current and creating the problem of loss of employment, closed borders, restricted travel and numerous other problems. The development that I have submitted is designed to work in conjunction with the Immunisation Scheme, which will assist in reducing the cross contamination within the hotspots of the sites of cross infection (contamination) within public locations. The implementation of this development in conjunction with the Immunisation Scheme should greatly reduce the current issues that are ongoing and reoccurring constantly and enable Australia to contain the issue by addressing the hotspots of the contamination within the public sectors, and enable the process of containing this issue to increase rapidly. The project has been addressed as the target market of the Australian Pharmaceutical Company as the developer and supplier of the implemented application of the development, which would also greatly benefit Australia's economic growth within an Australian Company. I encourage you to read the concept carefully for consideration and implement your contacts within the Government to consider this development further.

The second Government development that I have submitted addresses the issue of food wastage in farming and supermarkets and Government spending (overheads) for public establishments, which include Prisons, Public Hospitals, Rehabilitation Centres, Detention Centres, just to list a few. As with the first development of the cross contamination project this project has been written into an Executive Summary of the concept only and will require further development. I have listed the advantages for the Government, the potential of the development, benefits to the population and environmental factors, which I feel addresses some very important current issues. The development is designed to be established in Metropolitan areas and produce to be collected from Metropolitan areas and regional areas and delivered to the Distribution Centre for sorting and distribution of the produce to the addressed locations listed as an example. The establishment of the Distribution Centre not only addresses the issue of food wastage, Government overheads (spending in the public sector), Public consumption, environmental factors of landfill but also creates numerous employment opportunities, which in turn also decreases Government spending for Centrelink recipients, and boasts the Governments economic growth. I encourage you to read the concept carefully for consideration and implement your contacts within the Government to consider this development further.

I am currently not available for consultation and discussion concerning these submitted business developments as I am caring for my father who is currently undergoing cancer treatment once more, but will be available to conduct a meeting with you to discuss these projects after the 30th September 2021. 




I am contacting you to request your Legal Assistance and Legal Representation concerning a case of Specific Targeting of an Individual, between the years of 2007 - 2021.

The Legal Case consists of :

- Intellectual Property Theft - 2006 - 2012 Medical Business Plan, M.S.I.C, communication tool - In the possession of SA Health, SA Government
- Sexual Targeting / 2007 - 2018 - In connection with motorcycle gang members, Police Sources, Medical Industry and Government position sources - All individuals involved in Sexual Targeting of the victim are connected to one another or the named sources
- Fraudulent Activity / 2008 - 2021 - Consisting of Money laundering / skimming of victims personal income involving Government Departments, Banking Institutions, Real Estate Agents - Creating Fraudulent debts consisting of Excessive rise in utility accounts, Excessive rise in Telecommunication Systems accounts, Government Departments involving Real Estate Agents
- Isolation of the targeted victim through the use of Remote Access to Telecommunication Servers consisting of Blocked contact to family, friends and victims children residing in Melbourne, altered text messages to friends, family members and victims children residing in Melbourne resulting in severed relationships, blocked contact to legal assistance assistance resulting in the entrapment of the victim in the targeting - Illegal activity resulted in an altered restricted lifestyle of the victim

Following the submitted evidence to I.C.A.C, Corruption Commissioner and requesting an investigation into Police and Government Targeted Corruption and assistance the Liberal Government passed a bill to deny I.C.A.C, Corruption Commissioner the right to conduct investigations into Government officials and Government corruption and their involvement.

2017 Government Funding Denied for I.C.A.C Investigation

In 2017 I contacted I.C.A.C, Corruption Commissioner and submitted in person documented evidence of Intellectual Property Theft, Medical Business Plan and M.S.I.C, and the targeted illegal activity and requested an investigation and assistance into this activity. I was denied an investigation and assistance in this instance. This occurred following my release from the illegal detainment into Glenside Mental Health Facility, detained as a result of Police Targeting, Port Pirie Police Department, Illegal Representation connected to Roger Kirchner, SA Health and falsified diagnosis of Dr Kajani, Port Pirie, DR Nguyen and SACAT. The falsified diagnosis involved was Schizophrenia (a delusional condition). While detained in Glenside an act of Intellectual Property Theft occurred, which involved the development of Student and University college students accommodation, that resulted in being in the possession of SA Government, and was constructed and established for the Adelaide University. This business development constructed while detained in January 2017 - February 2017 was submitted to the Manager of Glenside for review but was denied support and remained in my possession only. This development written in the detainment of Glenside Mental Health Facility, while claiming I was suffering from a delusional condition of Schizophrenia remained in hand written form only and has never been installed on a computer of submitted into the possession of a third party.

The illegal detainment occurred as a result of a court ordered Mental Health Evaluation under the act of Illegal Representation and was conducted by Dr Nguyen, which resulted in a falsified diagnosis being the act of which I was then detained 1 hour following the evaluation. The Ellis family are well known members of this community and are held in high regard of being respectable and honest people, who will assist members of their community.

Kadina - Illegal Targeted Activity Recognition

I have obtained all verification, confirmation of the targeted illegal activity that occurred in the district of Port Pirie and continued in 2017 - 2021, following relocation to Kadina from Port Pirie, from Kadina sources who have supported me and reported the illegal activity to higher authorities.

Following contact with Mr Ellis, father of Fraser Ellis, MP, Local Government I discussed in the Privacy of my parents home with my parents the issue of seeking assistance for the targeted illegal activity. My mother, Cynthia [REDACTED] advised me to contact Fraser Ellis, MP, local Government to seek this assistance.

Prior to Completion and Contact:

During the construction of the reports and documented evidence for Fraser Ellis, MP I.C.A.C., Corruption Commissioner announced alleged allegations of an investigation conducted into the activity of Fraser Ellis, MP involving his involvement in Fraudulent corrupt activity involving the Australian Tax Office claims, which is currently being conducted and contested by Fraser Ellis, MP in a court of law.

Ellis releases plan for regional health

14 Dec 2021

Member for Narungga Fraser Ellis has today released his Regional Health Plan, which outlines a number of solutions to South Australia's regional health crisis.

"As I have publicly stated many times, regional health care is the biggest issue facing the Narungga electorate--and all country South Australians--and it was an issue long before the pandemic and will continue to be one long after it is finished," Mr Ellis said.

"Over the last 3 ½ years I am proud to have played a part in securing local improvements such as the new surgical unit at Yorketown, afterhours x rays and a salaried doctors model for Wallaroo Hospital under a new Rural Health Workforce Plan, and decentralising local health network boards. But problems still exist, and it is clear the status quo can't remain.

"I welcome the Federal Government's announcement last week of the incentive to pay HELP debts of graduating doctors and nurses who commit to working in regional areas, but I believe more still needs to be done.

"Today I present a plan for Regional Health Care.

"Over the past months I have consulted with rural health professionals from across the State, shared ideas with the Minister for Health and chatted to constituents about improvements they'd like to see in their local health services.

"The critical issue is the shortage of doctors themselves. There are a large number of carrots in place to encourage doctors to work in the country, but few are working. It is time to get a stick out.

"I believe as a priority we need the discerning allocation of Medicare Provider numbers by the Federal Government to ensure efficient distribution of GPs across the State, and for State Government to appoint an Assistant Minister for Regional Health.

Firstly I would like to thank you for acting on the information I provided regarding the medical services in the rural regional areas and sectors, and congratulate you on a job well done.

I overheard the public announcement regarding medical students receiving Government support on loan repayments concerning continuing their doctorates in rural regions. I do believe this is a step in the right direction and will encourage further medical students to consider their options and relocate to rural regions, which will greatly benefit those areas.

I have been addressing this issue since 2007 and it was of great satisfaction to finally get a result following submitting the information to you, a Government official who regarded the information as a serious issue and acted.

I was impressed and will endeavour to support your position and Government campaigns in anyway I can.

On another note, I have not heard of the outcome of your court proceedings regarding the ICAC investigation but do hope you can prove your innocence and all goes well for you, as I do still believe in your innocence and understand the distress this must have caused you.

Dear Health and Community services Complaints Commissioner,

→ I am contacting you to bring to your attention a concerning Medical and Health issue I experienced while requiring emergency medical treatment for Acute Allergy Oedema that I developed following the administration of the Covid19 vaccine, Pfizer on the 8th February 2022, and my admission to the Wallaroo Hospital Emergency Clinic.

On first presentation to the Wallaroo Hospital Emergency Clinic 8 days following the administration of the Covid19 Pfizer vaccine and presenting multiple symptoms, which included a hive like rash covering the regions of my face, neck, chest, arms and legs, commencement of swelling in my facial and nasal regions, severe sneezing and congestion in my sinus passages, a severe feeling of unwellness and commencement, of tightening of the chest (lungs) I informed the Triage nurse of my Medical History of previous Acute Allergy reactions to vaccines and multiple medications, and that the Covid19 vaccine Pfizer, 1st dose, had been administered 8 days prior to my presentation at the emergency clinic.

I was then admitted to the emergency clinic to be assessed by a doctor and to receive medical treatment for the presented symptoms. I was then examined and assessed by a younger doctor, who introduced himself as Tim. Following examination by this doctor I was diagnosed with suffering from a Viral Infection and was prescribed Phenergan for the itchiness of the hive like rash, and was discharged from the emergency clinic.

The diagnosis of a Viral Infection following the administration of the Covid19 vaccine Pfizer and my previous prior medical history of acute allergy reactions to vaccines and multiple medications was an obvious misdiagnosis of an inexperienced doctor of allergy reactions or inexperienced as a whole in this clinic.

Two days following this diagnosis I presented myself again at the Wallaroo Hospital Emergency Clinic for the second time presenting extremely escalated symptoms, which now included the hive like rash covering the regions of my facial, neck, chest, legs and arms appearing now as skin lesions and had severely spread to cover all regions of the facial, neck and chest regions, the commencement of previous swelling to my facial region had escalated to severe swelling and spreading into the area of my head, which felt like internal swelling of my brain not external swelling of my scalp, the symptoms had also escalated into my Respiratory system and I was now suffering from compromised breathing and escalated Allergy Asthma, an original Respiratory condition that had began following the administration of the ADT vaccine, a Respiratory allergy reaction to the vaccine, and was now struggling to breath and catch my breath.

Following presenting myself with these severe symptoms which was now endangering my life as a result of the breathing difficulties at the front desk of the Wallaroo Hospital Emergency Clinic, and following the initial misdiagnosis of a Viral Infection by the doctor on site at my first presentation at the clinic I was then admitted to the examination room to wait for a doctor to examine me, and to receive the now urgent medical treatment and care I required, due to the severe breathing difficulties.

Following being admitted to an examination room within the Emergency clinic by a Triage nurse at the front desk I was then left to wait in the examination room, struggling to breath and beginning to panic for a period of 2 hours. Following waiting for a period of 2 hours and now feeling very panicky due to my compromised breathing I began to suffer from chest pains and proceeded to address the nurse with this medical urgency.

I was informed by the nurse that the doctors were changing shifts and I would have to continue to wait. I continued to wait a further 30 minutes while listening to the new shift of doctors address the other patients in the emergency ward who had already received medical treatment and care from the previous shift of doctors. The other patients, which numbered three or four were now informing the new doctors on shift that the pain in their feet had dissipated or the back pain had now gone, but not one of these patients who had received prior medical treatment from the previous shift of doctors complained of suffering from breathing difficulties, which would require urgent medical treatment, as a Triage nurse should know and prioritise accordingly as first priority as in my case.

Feeling very disgusted at the lack of medical care and urgency I was being treated with and now feeling very panicky because of my breathing difficulties and feeling as if I was being ignored by the doctors and Triage nurse, including medical staff of the emergency clinic I discharged myself in the hope that if I called an ambulance, which would have cost me \$1000 when I returned home in Kadina I would actually receive the urgent medical treatment that I required.

Once I arrived at my place of residence in Kadina following discharging myself from the Emergency clinic I laid down on my bed exhausted and struggling to breath and passed out, and didn't wake until early the next morning.

The next morning when I awoke the severe and acute symptoms I had presented myself with at the Wallaroo Hospital Emergency Clinic the evening before had now escalated even further and I was now suffering from shooting pains across all areas of my head, which still felt like internal brain swelling, I was in extreme pain from acute swelling of my facial regions and the skin lesion type rash had now covered every region of my body, my sinuses had completely swelled and congested and could not breath through my nasal passages, the compromised breathing and triggered allergy asthma had escalated to rapid breathing and the chest pain was increasing. Suffering from these severe symptoms, which had now overnight escalated to rapid breathing indicating a heart failure related condition I once again presented myself at the Wallaroo Hospital Emergency Clinic, accompanied by my parents, Cynthia and David [REDACTED], as I was unable to drive.

When I approached the front desk and being addressed by the Triage nurse and a younger doctor on site and informing them of the medical urgency of the situation, and that it was the third time I had been seeking urgent medical treatment in the clinic because of the severity of the condition and symptoms, and that I had been ignored for 2 hours the previous evening while suffering from extreme breathing difficulties we were met with an arrogant, distasteful attitude and was blamed with being abusive towards them, which as a Qualified Professional Business Manager, and Qualified Business Administration, Business Development and a Published Author under contract with a publishing house in London, I can assure you I do know about correct behaviour in public offices, and we were at no time abusive or aggressive towards the staff of this Emergency Clinic.

Following presenting myself for the third time at the Wallaroo Hospital Emergency Clinic requiring Emergency urgent medical treatment because of escalated compromised respiratory system that had remained untreated the evening before, and was now presenting symptoms of a threatened

Heart condition, chest pains and rapid breathing, due to the lack medical treatment urgency the evening before I was immediately placed in the examination room and my obs addressed by the Triage nurse, who had addressed me at the front desk with a distasteful attitude.

During this procedure of having my obs assessed by the Triage nurse I was once again addressed with a very negative, distasteful attitude and she proceeded to berate me for discharging myself the evening before, blaming me , the patient for the medical negligence of the emergency clinic and the doctors of which had not assisted me and address the urgency of my Respiratory distress and compromised breathing on my second presentation to the clinic.

I was immediately examined by an experienced doctor on site, Dr Birss, who immediately diagnosed me with Acute Allergy Oedema as a result of an Allergy reaction to the administered Covid19 Pfizer vaccine, administered on the 8th February 2022, and prescribed a medical treatment plan of Predisolone, and due to the severity of the allergy reaction required two courses of the prescribed medical treatment plan, followed by a continual medical treatment plan of Phenergan for ongoing symptoms, prescribed by a GP of the Kadina Medical Association Clinic. I was informed by Dr Birss while receiving the urgent medical treatment I required that the next step of treatment that would have been required urgently would be a Tracheostomy to treat my compromised Respiratory system and rapid breathing with chest pain (heart) because of the severity of my condition, that was not treated the evening before.

The untreated severity of my condition could have resulted in the loss of my life and severely endangered my life by being left untreated with Compromised respiratory system of breathing difficulties and the acute allergy reaction to the vaccine, which was misdiagnosed initially.

I am contacting you to inform you of the severe medical issue I experienced as a result of the Medical Negligence and attitudes towards patients of the doctors and Triage nurses of the Wallaroo Hospital emergency Clinic, and the inexperience and poor management of this department of the Wallaroo Hospital, which resulted in a severe threat to my life, and could have resulted in my death, and urgently needs to be acknowledged and addressed.

I am contacting you to place a complaint against the Wallaroo Hospital Emergency Clinic and am requesting urgent attention to this medical issue involving :

- Medical Negligence of the Triage nurse upon second presentation at the emergency clinic
- Medical Malpractice of the doctor upon first presentation of diagnosis of a Viral Infection
- Medical Negligence of the Emergency Clinic of the doctors and staff for failure to treat an urgent medical condition of a Acute Compromised respiratory system that could have resulted in the patients death upon second presentation of the patient to the emergency Clinic
- Abusive and aggressive behaviour towards a patient conducted by the Triage nurse upon third presentation to the emergency clinic while the patient was suffering from rapid Breathing / threat of heart failure and severe compromised respiratory system for the medical negligence of the emergency clinic and doctors that had occurred the evening before / second presentation

Following experiencing the medical negligence of this department of the Wallaroo Hospital I submitted a written detailed account of this event and medical negligence of the staff in this department and the medical negligence of the department to the head nurse of the Wallaroo Hospital, Sue Watkins informing her in detail of my experience and received no acknowledgement or reply to this complaint.

I am contacting you to place a complaint against the Wallaroo Hospital Head Nurse, Sue Watkins for failure to address a critical patient complaint of endangerment to the patients life due to the medical Negligence of the staff of the Emergency Clinic and request urgent attention to this medical issue of the Wallaroo Hospital.

I have provided this information to the local MP, Fraser Ellis, Graves Street , Kadina and advise you to contact Fraser Ellis, MP to discuss these continual medical issues that are occurring in the Wallaroo Hospital and this region in the medical sector, which is endangering the community

members lives and address these important medical issues in this region.

I have provided a detailed account of the medical urgency I suffered during the medical symptoms of the Acute Allergy Oedema, including photographic evidence of how I presented myself at the Wallaroo Hospital Emergency Clinic, and a copy of the written detailed account I submitted to the head nurse of the Wallaroo Hospital, Sue Watkins, which also contained the detailed account of the event, including photographic evidence, of which I received no acknowledgement or reply, dated 3rd May 2022.

I am requesting your urgent attention and immediate action concerning this written complaint against the Wallaroo Hospital and Wallaroo Hospital Emergency Clinic.

I am contacting you to supply you with the report that I submitted dated 16th August 2022, concerning the Medical Negligence of the Wallaroo Hospital, as discussed during our meeting and the contact details of the Complaints Commissioner that your office supplied.

As discussed the report contains all details of the Medical Negligence, which include the Triage nurse issue, misdiagnosis upon first presentation at the Emergency Clinic, which in turn resulted in a life threatening situation, the attitude of the staff, the negligence of not treating a patient with compromised breathing, which involved the Triage nurse not prioritising urgency of the patients, and also as discussed the lack of recognition from the Head nurse of the hospital when supplied with a written report of the emergency situation and extreme negligence of the staff involved.

The report supplied is self explanatory and I do now hope that this issue involving the Wallaroo Hospital will become recognised and urgently addressed to reform the ongoing medical issues within this system and improve the Medical Care of this community.

Regarding the further issues discussed I supplied contact details via email regarding the medical infrastructure developments I supplied previously and a point of contact on which to start to discuss the implementation of the reformed infrastructure, in order to improve and facilitate the current issues this community has and is facing at this current time concerning the medical treatment and conduct of the Wallaroo Hospital.

I am still currently in further negotiations with the medical claim of the Medical Negligence concerning the Acute Allergy Oedema reaction that I suffered as a result of the Covid19 Vaccine, and as I expected they are playing ball at the moment with trying to direct me to claim the Government Compensation Claim for reactions to the Covid19 vaccine, but as I explained to them the acute reaction was not pertained specifically to the Covid19 vaccination, but a case of Medical Negligence and Medical Malpractice of the Medical Professionals involved due to my Medical History of previous acute allergy reactions to previous vaccines and several medications, which placed me in a high risk bracket and the Medical professionals involved failed to conduct testing for an allergy reaction according to the referral by Dr Daehn, Kadina Medical Association. I am submitting a Medical Compensation claim regarding this case of \$25,000 for the claim of Medical Malpractice and Medical Negligence cases of the Wallaroo Hospital and Wallaroo Hospital Emergency Clinic.

I am requesting that this report and claim of Medical Negligence and Medical Malpractice of the Wallaroo Hospital Emergency Clinic and Wallaroo Hospital be submitted to the correct department to commence the procedure of the compensation claim. I am requesting that all documentation submitted with the complaint, dated 16th August 2022 be submitted with the claim of compensation to the correct department as documented evidence to support the claim.

Community member (daughter) was denied all access to her police file or reports in 2016 under the Freedom of Information Act by SAPOL





A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

*DESTRUCTION OF CAREER FOR SEX DEMAND - SEXUAL ABUSE RING AMERICA
Victims' rights: Jane Does v. United States (2014) *SEXUAL ABUSE RING - AUSTRALIA
PROMINENT POSITIONS GOV

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 [REDACTED] and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [REDACTED] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [REDACTED] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

[REDACTED] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] [REDACTED] (then known as [REDACTED]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} [REDACTED] also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [REDACTED]. Dershowitz took legal action over the allegations.^{[146][147][148]} [REDACTED] filed a defamation suit against Dershowitz,

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.^[22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be ██████████, who was previously known as ██████████. ██████████ met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when ██████████ was a 16-year-old spa attendant.^[22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".^{[22][63]}

Maxwell has repeatedly denied any involvement in Epstein's crimes.^[51] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".^{[58][64]}

██████████ asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. ██████████ sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in ██████████ favour,^[65] with Maxwell paying Giuffre "millions".^[66]

SEXUAL DEMANDS - SEXUAL ABUSE RING - TARGETING
██████████ v Epstein and Maxwell (2017) - MAXWELL DESTRUCTION OF CAREER PROSPECTS - COMPLY.

In 2017, ██████████ filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[9][48][67][68]}

Affidavit filed by ██████████ (2019)

On 16 April 2019, ██████████ went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, ██████████, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. ██████████ affidavit was filed in support of a defamation suit by ██████████ against Alan Dershowitz.^[69] According to the affidavit, ██████████ had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.^{[70][71]} ██████████ reported the incident to the New York Police Department and the FBI.^{[52][72]} Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, ██████████, to his New Mexico property where he and Maxwell molested her on a massage table.^{[73][74]}

██████████ was interviewed for CBS This Morning in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.^[75]

██████████ v Epstein's estate, Maxwell, and Jane Does 1-3 (2019)

INTELLECTUAL PROPERTY THEFT - AMERICA INVOLVEMENT IN POSSESSION - MULTIPLE

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress ██████████ was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

Liquid Funding was initially 40 percent owned by Bear Stearns. Through the help of the credit rating agencies – Standard & Poor's, Fitch Ratings and Moody's Investors Service – the new bundled securities were able to be created for companies so that they got a gold-plated AAA rating. The implosion of such complex securities, because of their inaccurate ratings, led to the collapse of Bear Stearns in March 2008 and set in motion the financial crisis of 2007–2008 and the subsequent Great Recession. If Liquid Funding were left holding large amounts of such securities as collateral, it could have lost large amounts of money.^{[65][67]}


Investments

Hedge funds

Between 2002 and 2005, Epstein invested \$80 million in the D.B. Zwirn Special Opportunities Fund, a hedge fund that invested in illiquid debt securities.^{[68][69]} In November 2006, Epstein attempted to redeem his investment after he was informed of accounting irregularities in the fund.^[70] By this time, his investment had grown to \$140 million. The D.B. Zwirn fund refused to redeem the investment. Hedge funds that invest in illiquid securities typically have years-long "lockups" on their capital for all investors and require redemption requests to be made in writing 60 to 90 days in advance.^[68] The fund was closed in 2008, and its remaining assets of approximately \$2 billion, including Epstein's investment, were transferred to Fortress Investment Group when that firm bought the assets in 2009.^{[68][69]} Epstein later went to arbitration with Fortress over his redemption attempt. The outcome of that arbitration is not publicly known.^[68]

MEDICAL BUSINESS PLAN 2006 - 2009 - INTELLECTUAL PROPERTY THEFT
In August 2006, Epstein, a month after the federal COMMENCEMENT SEXUAL TARGETING 2007 investigation of him began,^[71] invested \$57 million in the Bear Stearns High-Grade Structured Credit Strategies Enhanced Leverage hedge fund.^{[68][72]} This fund was highly leveraged in mortgage-backed collateralized debt obligations (CDOs).^[72]

On April 18, 2007, an investor in the fund, who had \$57 million invested, discussed redeeming his investment.^[73] At this time, the fund had a leverage ratio of 17:1, which meant for every dollar invested there were seventeen dollars of borrowed funds; therefore, the redemption of this investment would have been equivalent to removing \$1 billion from the thinly traded CDO market.^[74] The selling of CDO assets to meet the redemptions that month began a repricing process and general freeze in the CDO market. The repricing of the CDO assets caused the collapse of the fund three months later in July, and the eventual collapse of Bear Stearns in March 2008. It is likely Epstein lost most of this investment, but it is not known how much was his.^{[73][72]}




The government began negotiation with Epstein for a plea agreement in mid-2007, as the hedge fund began to collapse.


By the time that the Bear Stearns fund began to fail in May 2007, Epstein had begun to negotiate a plea deal with the U.S. Attorney's Office concerning imminent charges for sex with minors.^{[68][71]} In August 2007, a month after the fund collapsed, the U.S. attorney in Miami, Alexander Acosta, entered into direct discussions about the plea agreement.^[71] Acosta brokered a lenient deal, according to him, because he had been ordered by higher government officials, who told him that Epstein was an individual of importance to the government.^{[52][53]} As part of the negotiations, according to the *Miami Herald*, Epstein provided "unspecified information" to the Florida federal prosecutors for a more lenient sentence and was supposedly an unnamed key witness for the New York federal prosecutors in their unsuccessful June 2008 criminal case against the two managers



Early development

The story and development of the Yorke Peninsula Country Times over the last 150 years follows a web of newspapers threaded together since the first Yorke Peninsula newspaper appeared as the Wallaroo Times and Mining Journal in 1865.

This first paper was the product of Andrew and David Taylor, who came to Australia from Invercargill, New Zealand, in the same year.

This paper flourished at Elizabeth Street, Wallaroo, until in 1888, due to pressure by Kadina traders, the establishment moved the business to 25 Taylor Street, Kadina. In January 2008 the business then moved to its current modern facilities at 31 Goyder Street with the building being officially opened by Senator Alan Ferguson in November of that year.

The paper was then called the Kadina and Wallaroo Times in deference to the gentlemen traders who probably suggested that they would withdraw patronage if this did not occur.

In 1891 Andrew died, and David continued until his death when Mrs Furner-Taylor headed the business. In 1910 Andrew's son, William F Taylor and James H Pengelley, both of Kadina, entered into a partnership which lasted for 25 years until 1935 when Mr Pengelley died. His son Fred then became a partner.

When William Taylor died in 1945, Fred took control, with Mrs Agnes Taylor maintaining a financial interest until 1962, when the family finally relinquished a 92 year connection with the "Times".

Competition

During these years the Times suffered competition from two other papers, the Plain Dealer and its offshoot the Copper Age, produced by John Southwood and George Spring who found it hard going during the depression years.

Fred Pengelley's long association with the newspaper ended in 1963 when Moonta newspaper proprietors, C.J.G and T.F. Ellis, who ran the People's Weekly, purchased the Kadina business. The Ellises continued to print both newspapers (one in each town) until 1966, when the Moonta paper was incorporated in the Times to become the Kadina, Wallaroo and Moonta Times.

Two years later a further change took place when The South Australian [REDACTED] another Kadina-based newspaper, owned by Mr and Mrs H.W. Tossell of Adelaide, merged with the Times. As a result the newspaper was named the Yorke Peninsula Country Times, with the first edition on September 4, 1968.

In 1970 the publishers purchased the rights to the S.Y.P. News Pictorial, published in Yorketown, which was an amalgamation of the Maitland Watch and the S.Y.P. Pioneer.

The Times Today

The Ellis family still own the Yorke Peninsula Country Times. Michael Ellis is the Managing Editor.

From that first issue in 1968 the Yorke Peninsula Country Times has gone from strength to strength - from a newspaper of 16 pages, to one that gradually increased, with strong support, to a paper which regularly publishes 60 plus pages growing to nearly 100 in the busy Christmas period.

From a small beginning, the print run has steadily forged ahead until more than 8,000 copies stream from the Goss Community press situated at the new premises at 31 Goyder Street, Kadina.

* John Wayne Olsen, Liberal Party Premier of South Australia, 1996–2001 served two years in the Senate from 7 May 1990, when he filled a casual vacancy caused by the resignation of Senator Tony Messner.

* JOHN WAYNE OLSEN - KADINA - SOURCE

A colourful backgrounder in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen. CONNECTED TO AMERICA AND

STEVEN MARSHALL, PREMIER OF SA

→ Born in Kadina in rural South Australia on 7 June 1945. Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, nee Heath. He was educated at Kadina Memorial High School, studied accountancy at the South Australian School of Business Studies, spent a period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as president of South Australia's Rural Youth (1970) and later as Kadina town councillor from 1971 and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter. ← 1971

→ In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River, following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1985 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

* Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

“ ... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on small business and rural communities, and referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. The citation for his appointment as an Officer of the Order of Australia in January 2007 reads in part: - 200-
