

Paul Gardner - Paul Gardner showed me on numerous occasions how he could break into my home using a credit card / health care card or plastic card from his wallet, 7 meadow Crescent, Port Pirie. Paul knew how to break into my home and on numerous occasions when returning to my home I discovered doors left unlocked and my person effects tampered with.

Val Stevens , my next door neighbour and friend - Val Stevens noticed numerous sightings of different vehicles coming and going from my home in short succession whilst I was absent and in the company of Paul Gardner at his Port Germain address.

My youngest child, Corey and his friend Jason Colliver were home at the time, both children were loners and had limited friends.

Unusual suspicious activity

Kane Gardner - Kane (Paul Gardner's son) had mentioned that the Port Pirie Police Department had come to the house situated at Port Germain in the early hours of the morning whilst I lay asleep with Paul in his bedroom. Paul told me that he had been instructed by the police to pick up a warrant for his arrest from the local police station of Port Pirie. I escorted him there in my vehicle to pick up this warrant. Paul had lost his licence at the time for Excessive alcohol and wreckless driving.

Vickie Ann Chapman (born 21 June 1957) is an Australian politician, representing the South Australian House of Assembly seat of Bragg for the South Australian Division of the Liberal Party of Australia since the 2002 election. Chapman served as the Deputy Premier of South Australia and Attorney-General between 19 March 2018 and 22 November 2021 in the Marshall government.^[1] She was the first woman to hold either post.

Chapman has previously served as deputy leader of the Liberal Party from 2006 to 2009, and became deputy leader again in 2013. In that capacity, she served as Deputy Leader of the Opposition between 30 March 2006 and 4 July 2009, and again between 4 February 2013 and 19 March 2018. She was also the Shadow Attorney-General and Shadow Minister for State Development, having gained the extra portfolio of State Development in a cabinet reshuffle on 13 January 2016.

Early life

Chapman was born on Kangaroo Island. One of seven children, Chapman attended the Kangaroo Island Parndana Area School, and following the death of her mother at age 12 she later attended Pembroke School in Adelaide. She studied a law degree at the University of Adelaide and graduated in 1979 as a barrister.

Chapman's father, Ted, was a member of the Liberal and Country League and then the South Australian Division of the Liberal Party of Australia in the South Australian House of Assembly. A Liberal moderate, Ted was a member of the Steele Hall-led Liberal Movement faction in the 1970s and




SUSPECTED CONSPIRED AMBUSH OF TARGETED VICTIM
Premier Stephen Marshall and Deputy Premier Vickie Chapman on Sunday afternoon toured the Kangaroo Island fire ground.

Officials including the Kangaroo Island mayor Michael Pengilly and Greg Georgopoulos visited the command post at Parndana, water bomber replenishing point at Turkey Lane. They also visited parts of the fire ground.

The CFS website shows the Duncan fire has now extended over the entire 13,000 hectare north coast fire warning area.

The scrub fire is uncontrolled and is burning in a northerly direction towards the coast between Middle River and Snug Cove. Conditions are continually changing.

SA Police will be undertaking assessments of damaged properties around Western River and Western River Cove today. Assessments of properties around Middle River cannot commence until fire conditions moderate



 The Menzies fire to the east has been downgraded to Advice level and is no longer immediately threatening the north coast or Emu Bay.

"We visited KI Base at Parndana where they received a comprehensive brief from Terry May and incident management team.

"No TV or news teams were made aware of the KI visit deliberately. Then the Premier and I went to air support at Turkey Lane where a briefing was given.

"Local SES are doing the aircraft loading out there. Vickie Chapman went to the fire ground at Middle River and west with the council CEO accompanying her.

"On the way to the Menzies fire ground I requested from Stephen Marshall that the government supply a recovery coordinator. He agreed.

"Hoping to call a small recovery group meeting either later today or Monday to kick things off. Anyone that needs assistance including financial household grants, these are available through Government already.

"Many of our community including mainland assistance are still flat out on fire grounds. It is my intention to get a brief out to councillors Monday.

"Considerable council resources and staff are on the fire grounds helping. Anyone who wishes can ring me on 0419 030 564 as necessary. Thank you all for your ongoing efforts."

State Member visits

State Member for Mawson Leon Bignell on Saturday visited the Kangaroo Island command post for a briefing. "There is still plenty of work to be done to put out the fires on Kangaroo Island's north coast," he posted online.

* Crews on Sunday afternoon, December 22 are continuing to work on the Coopers Road, Duncan fire on Kangaroo Island where 13,000 hectares have been burnt.

Overnight back burning has secured part of the western edge of the Duncan fire, however the area between Snug Cove on the coast and Snug Cove Road approximately 2km south of the coast remains unsecured at this time.

The CFS is implementing its plans to secure the western edge of the fire using a retardant line, but due to smoke causing poor visibility this is proving to be difficult.

Plans are also being made to secure the southern edge of the fire, north of the Playford Highway.

Two teams of firefighters from the mainland are working with local crews, private farm firefighting units, the forestry industry and crews from the Department of Environment and Water.

To ensure your safety, and that of firefighters and other emergency personnel, please do not enter the area unless necessary. Hazards may include reduced visibility due to smoke, fallen trees blocking roads and emergency vehicles operating in the area.

Residents in the area are advised to remain vigilant and to continue checking and following your Bushfire Survival Plan.



I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint.

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling [redacted] or [redacted]


I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament. Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for raising your concerns with me.



short her courses in Adelaide in 1982, and moved to Melbourne to work with the Australian Union of Students.^[20] In 1983, she became the second woman to lead the Australian Union of Students, serving until the organisation's discontinuation in 1984. She was also the secretary of the left-wing organisation Socialist Forum.^{[21][22]} Having transferred her studies to the University of Melbourne, Gillard graduated with a Bachelor of Laws degree in 1986 and a Bachelor of Arts degree in 1989.^[23] In 1987, she joined the law firm Slater & Gordon in Werribee, Victoria, working in industrial law.^[11] In 1990, she was admitted as a partner; at the age of 29, she was the youngest partner within the firm, and one of the first women to hold the position.^{[24][25]}

Early political involvement

From 1985 to 1989, Gillard served as President of the Carlton branch of the Labor Party.^[6] She stood for Labor preselection in the Division of Melbourne prior to the 1993 federal election, but was defeated by Lindsay Tanner.^[26] At the 1996 federal election, Gillard won the third position on Labor's Senate ticket in Victoria, behind Robert Ray and Barney Cooney.^{[27][28]} However, on the final distribution of preferences she was defeated by Lyn Allison of the Australian Democrats.^{[29][30]}

In 1996, Gillard resigned from her position with Slater & Gordon to serve as chief of staff to John Brumby, at that time the Leader of the Opposition in Victoria.^{[6][30][31]} She was responsible for drafting the affirmative-action rules within the Labor Party in Victoria that set the target of preselecting women for 35 per cent of "winnable seats". She also played a role in the foundation of EMILY's List, the pro-choice fund-raising and support network for Labor women.^[32]

Gillard has cited Welsh Labour politician Aneurin Bevan as one of her political heroes.^[24]

Member of Parliament (1998–2007)

Gillard was first elected to the House of Representatives at the 1998 federal election representing Labor, a safe Labor seat near Melbourne, replacing Barry Jones who retired. She made her maiden speech to the House on 11 November 1998.^[33] Gillard was a member of the standing committee for Employment, Education and Workplace Relations from 8 December 1998 to 8 December 2001, in addition to Aboriginal and Torres Strait Islander Affairs from 20 March 2003 to 18 August 2003. Within the joint committees, she was a member of the Public Accounts and Audit from 8 December 1998 to 11 February 2002, in addition to the Native Title and the Aboriginal and Torres Strait Islander Land Fund from 20 March 2003 to 11 August 2003.^[6]

Shadow Minister (2001–2007)

After Labor's defeat at the 2001 federal election, Gillard was elected to the Shadow Cabinet under then-Labor Leader Simon Crean, where she was given responsibility for Population and Immigration. In February 2003, she was given additional responsibilities for Reconciliation and Indigenous Affairs.^[34] In these roles, in the wake of the Tampa and Children Overboard affairs, which were partly credited with Labor's 2001 election loss, Gillard developed a new immigration policy for the Labor Party.^[13]

Gillard was later promoted to the position of Shadow Minister for Health and Deputy Manager of Opposition Business in the House (to Mark Latham) on 2 July 2003.^{[25][35]} During this time, she shadowed Tony Abbott, with the rivalry between the two often attracting attention from the media.^[36] She was later given additional responsibility for managing opposition business in the House of Representatives by Latham, who had succeeded Beazley as Labor Party leader.^[37]
