A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

DESTRUCTION OF CAREER FOR SEX DEMAND - SEXUAL ABUSE RING AMERICA
Victims' rights: Jane Does v. United States (2014) * SEXUAL ABUSE RING - AUSTRALIA

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 ([REDACTED]) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add [REDACTED] (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim [REDACTED] against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by [REDACTED] are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

[REDACTED] v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] [REDACTED] (then known as [REDACTED]), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} [REDACTED] also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with [REDACTED]. Dershowitz took legal action over the allegations.^{[146][147][148]} [REDACTED] filed a defamation suit against Dershowitz,

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein. [22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be [REDACTED], who was previously known as [REDACTED]. [REDACTED] met Maxwell at Donald Trump's *Mar-a-Lago Club* in Palm Beach, Florida, when [REDACTED] was a 16-year-old spa attendant. [22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex". [22][63]

Maxwell has repeatedly denied any involvement in Epstein's crimes. [51] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims". [58][64]

[REDACTED] asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. [REDACTED] sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in [REDACTED] favour, [65] with Maxwell paying [REDACTED] "millions". [66]

SEXUAL DEMANDS - SEXUAL ABUSE RING - TARGETING

In 2017, [REDACTED] filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms. [9][48][67][68]

Affidavit filed by [REDACTED] (2019)

On 16 April 2019, [REDACTED] went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister [REDACTED], had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. [REDACTED] affidavit was filed in support of a defamation suit by [REDACTED] against Alan Dershowitz. [69] According to the affidavit, [REDACTED] had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein. [70][71] [REDACTED] reported the incident to the New York Police Department and the FBI. [52][72] Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, [REDACTED], to his New Mexico property where he and Maxwell molested her on a massage table. [73][74]

[REDACTED] was interviewed for *CBS This Morning* in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault. [75]

[REDACTED] v Epstein's estate, Maxwell, and Jane Does 1-3 (2019)

INTELLECTUAL PROPERTY THEFT - AMERICA INVOLVEMENT IN POSSESSION - MULTIPLE

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koeppel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress ██████████ was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

Liquid Funding was initially 40 percent owned by Bear Stearns. Through the help of the credit rating agencies – Standard & Poor's, Fitch Ratings and Moody's Investors Service – the new bundled securities were able to be created for companies so that they got a gold-plated AAA rating. The implosion of such complex securities, because of their inaccurate ratings, led to the collapse of Bear Stearns in March 2008 and set in motion the financial crisis of 2007–2008 and the subsequent Great Recession. If Liquid Funding were left holding large amounts of such securities as collateral, it could have lost large amounts of money.^{[65][67]}


Investments

Hedge funds

Between 2002 and 2005, Epstein invested \$80 million in the D.B. Zwirn Special Opportunities Fund, a hedge fund that invested in illiquid debt securities.^{[68][69]} In November 2006, Epstein attempted to redeem his investment after he was informed of accounting irregularities in the fund.^[70] By this time, his investment had grown to \$140 million. The D.B. Zwirn fund refused to redeem the investment. Hedge funds that invest in illiquid securities typically have years-long "lockups" on their capital for all investors and require redemption requests to be made in writing 60 to 90 days in advance.^[68] The fund was closed in 2008, and its remaining assets of approximately \$2 billion, including Epstein's investment, were transferred to Fortress Investment Group when that firm bought the assets in 2009.^{[68][69]} Epstein later went to arbitration with Fortress over his redemption attempt. The outcome of that arbitration is not publicly known.^[68]

MEDICAL BUSINESS PLAN 2006 - 2009 - INTELLECTUAL PROPERTY THEFT
In August 2006, Epstein, a month after the federal COMMENCEMENT SEXUAL
investigation of him began,^[71] invested \$57 million in the Bear TARGETING 2007
Stearns High-Grade Structured Credit Strategies Enhanced
Leverage hedge fund.^{[68][72]} This fund was highly leveraged in
mortgage-backed collateralized debt obligations (CDOs).^[72]

On April 18, 2007, an investor in the fund, who had \$57 million invested, discussed redeeming his investment.^[73] At this time, the fund had a leverage ratio of 17:1, which meant for every dollar invested there were seventeen dollars of borrowed funds; therefore, the redemption of this investment would have been equivalent to removing \$1 billion from the thinly traded CDO market.^[74] The selling of CDO assets to meet the redemptions that month began a repricing process and general freeze in the CDO market. The repricing of the CDO assets caused the collapse of the fund three months later in July, and the eventual collapse of Bear Stearns in March 2008. It is likely Epstein lost most of this investment, but it is not known how much was his.^{[73][72]}



The government began negotiation with Epstein for a plea agreement in mid-2007, as the hedge fund began to collapse.

By the time that the Bear Stearns fund began to fail in May 2007, Epstein had begun to negotiate a plea deal with the U.S. Attorney's Office concerning imminent charges for sex with minors.^{[68][71]} In August 2007, a month after the fund collapsed, the U.S. attorney in Miami, Alexander Acosta, entered into direct discussions about the plea agreement.^[71] Acosta brokered a lenient deal, according to him, because he had been ordered by higher government officials, who told him that Epstein was an individual of importance to the government.^{[52][53]} As part of the negotiations, according to the *Miami Herald*, Epstein provided "unspecified information" to the Florida federal prosecutors for a more lenient sentence and was supposedly an unnamed key witness for the New York federal prosecutors in their unsuccessful June 2008 criminal case against the two managers







* John Wayne Olsen, Liberal Party Premier of South Australia 1996-2001, served two years in the Senate from 7 May 1990, when he filled a casual vacancy caused by the resignation of Senator Tony Messner.

* JOHN WAYNE OLSEN - KADINA - SOURCE

A colourfull backgrounder in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen.

* STEVEN MARSHALL, PREMIER OF SA

→ Born in Kadina in rural South Australia on 7 June 1945. Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, née Heath. He was educated at Kadina Memorial High School, studied accountancy at the South Australian School of Business Studies, spent a period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as president of South Australia's Rural Youth (1970) and later as Kadina town councillor from 1971 and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter.

→ In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River; following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1985 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

* Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

“ ... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on small business and rural communities, and referring frequently to the situation in his home state.

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. 



SACAT - IDENTIFIED IN 2023 AS INVOLVED IN 2017 CONSPIRED ATTEMPTED MURDER OF VICTIM WITH COV SOURCES INVOLVED AND COVER UP.

Dr Kajani, Pirie Medical Centre, Port Pirie - Long term family doctor - Involvement in falsifying diagnosis resulting in detainment into a Mental Health Facility as a result of a Court ordered Mental Health Evaluation involving Police targeting of the targeted victim - Illegally releasing falsified medical diagnosis into the possession of illegal representation of Heidi Salvemini without the victims authority, authority withdrawn 1 month prior to illegal representation resulting in the illegally obtained falsified medical records being submitted in a court of law, resulting in the detainment of the targeted victim and ordered prescribed medication by monthly injections directly into the blood stream carrying the side effects of Suicidal Tendencies (harm to oneself) - Pre meditated murder to appear as suicide by medication - Connected to Roger Kirchner, Director of the Port Pirie District Hospital, who is connected to Heidi Salvemini through family relations of an employee, Executive assistant Jemma Salvemini - Roger Kirchner connected to Jonnie Weston and David Bradley, connected to motorcycle gang members and involved connections to these individuals involving motorcycle gang members and police officers

Jonnie Weston - Sexual Targeting 2016, Adelaide Casino - Connected to the medical industry / brother is a doctor / connected to SA Health, Roger Kirchner, David Bradley, Dr Kajani, Jemma Salvemini, Heidi Salvemini - Connected to Rebels motorcycle Club / motorcycle gang members - David Bradley connected to all individuals involved and listed involving motorcycle gang members, including connections to Paul Gardner, Michael Fetherstonhaugh, Peter Bannister, officer Scott Bowman, Port Pirie Police Department and Vincent Bulone

Robert Crisci, Voumard Lawyers, Port Pirie - Representing lawyer 2016 Police targeting charges - Deleting evidence recorded on a recording device of the Mental Health Evaluation while in his possession - Issuing fraudulent fines and charges from the Port Pirie Police Department following an acquittal of all charges by Magistrate K.A. Millard in a court of law - Connections to the Legal system and court system - Connections to Maria, Employee of the Adelaide court system who is connected to the listed motorcycle gang members - Connections to Heidi Salvemini involved in the legal system / illegal representation, who is connected to Roger Kirchner

Port Pirie Police Department - Involvement in Police targeting of the targeted victim - 2015 Jake Austin, Hanna O'Neil, Peter O'Neil - .05 excessive alcohol charge - Targeted victim was stalked by police officers while walking up and down a footpath before returning to her parked vehicle, which was then followed by the police officers down a laneway - Impounded vehicle on a .05 alcohol reading, court appearance resulted in a non conviction - Recorded on targeted victims licence as a conviction of Excessive alcohol following non conviction court hearing, loss of demerit points and issued a fine in the amount of more than \$1000.00 - Creating fraudulent charges and fines, illegally impounding a vehicle on a .05 alcohol test reading (not over the limit) - money laundering through fraudulent fines - Connections to officer Scott Bowman, Crystal Brook Police Department and all individuals connected to Officer Scott Bowman involved in the targeting of an individual, including motorcycle gang members connections

Officer Jake Austin - Police officer involved in Sexual Targeting of the targeted victim / Port Pirie foreshore—Suspected direct connections to Paul Gardner involving White Futura vehicle used by the police officer in the Sexual targeting at Port Pirie foreshore sold to targeted victim by Paul Gardner in 2015—Connections to officer Scott Bowman, Crystal Brook Police Department and all individuals connected to Officer Scott Bowman involved in the targeting of an individual, including motorcycle gang members connections

Officer Jake Austin - Present in the Port Pirie Police Station looking at the targeted victim through a window dressed in casual attire during the arrest of the targeted victim by Officer Scott Kelly while being questioned

Officer Jake Austin - 2015 Targeted victim made a 000 phone call from a phone box to the Kadina Police Station concerning the suspected abduction of an infant "India Rose" believed to be in the possession of Paul Gardner, residing with his ex partner Toni in New Zealand. The targeted victim was informed by a police officer (female) when making the report "We are not collectors of information". The targeted victim hung up the phone and returned to her residence. Within minutes of the phone call 2 officers arrived at the targeted victims residence from the Port Pirie Police Station, one being Officer Jake Austin. The targeted victim refused to give any information or statement because of her suspicion of Officer Jake Austin's targeting and involvement with Paul Gardner.

Officer Jake Austin - Involvement and present in the transfer of the targeted victim to the Port Pirie District Hospital following the illegal court ordered Mental Health Evaluation based on the illegally submitted medical records by Heidi Salvemini. Officer Jake Austin was intimidating the targeted victim, standing over her while giving orders, would not let her move from one spot and was disrespectful to her mother who was witnessing the event at the targeted victims place of residence

Officer Hanna O'Neil - Police officer involved in the sexual targeting of the targeted victim - Primo dance floor, Port Pirie - Involving members of the public connected to Hanna O'Neil through personal relationships, Tammy Foster, Port Pirie - Hanna O'Neil and male police officer sighted in the doorway of Primo, Port Pirie while targeted victim was on the dance floor with friends, both officers dressed in Police uniforms. Both officers returned minutes later after leaving, accompanied by Tammy Foster, male police officer now dressed in casual clothing - Targeted victim was approached on the dance floor by Tammy Foster and male police officer, approximately 25 years of age and targeted victim was introduced to the male police officer by Tammy Foster. Male police officer proceeded to engage casually with targeted victim following introduction. Targeted victim walked away from the male police officer and off the dance floor and stood with friends until the male officer left. Male police officer unknown to targeted victim, believed to be the male police officer involved in the 2014 fraudulent fine issues for excessive alcohol - Connections to officer Scott Bowman, Crystal Brook Police Department and all individuals connected to Officer Scott Bowman involved in the targeting of an individual, including motorcycle gang members connections

Port Pirie Police Department - Officer Scott Kelly - Involvement in Police Targeting of targeted victim - 2015 Illegal arrest based on targeted victim refusing to blow in a breathalyser - Targeted victim refused because she was not in a vehicle, near a vehicle or in a position to operate a vehicle - Police brutality resulting in permanent injuries to the targeted victim, right shoulder, nerve damage to left cheek as a result of police brutality, slamming face down onto boot of vehicle rendering the targeted victim nearly unconscious, muscle and nerve damage to right shoulder and involving soft tissue damage as a result of police brutality, suspected sexual intention of the police officer who during the arrest pushed the length of his body up hard against the back length of the targeted victim while bent over the boot of the vehicle following slamming her face down against the boot of the vehicle - Falsified claims of the targeted victim refusing to give personal details - Suspension of licence for 12 months based on refusal to blow in breathalyser resulting in immobilisation of the targeted victim - Targeted victim was locked in a holding cell for a period of 2 hours - DNA, Fingerprints and photographs of the targeted victim were taken during this arrest - Falsified charges and fines of undue care recorded on drivers licence of targeted victim following acquittal of all charges in a court of law by Magistrate K.A. Millard issued by the Port Pirie Police Department—Money laundering through the use of fraudulent fines -Involved in arrest and present during arrest / Kate Hannan, David Brown, Allan Bourke (Port Pirie Police Department, Daniel James Nicolson (Crystal Brook Police

Department) - Tampering with evidence, VTO of arrest, VTO altered, officer was not calm and professional during arrest but extremely aggressive and demanding resulting in permanent injuries to the victim - Targeted victim was arrested for refusing to blow in a breathalyser when not in a position to operate a vehicle / illegal arrest - Connections to officer Scott Bowman, Crystal Brook Police Department and all individuals connected to Officer Scott Bowman involved in the targeting of an individual, including motorcycle gang members connections

Alleged Witnesses - Ernest Edwin Polly, Crystal Brook / Kathy Marie Jacobs, Napperby, Port Pirie - Members of the public involved in police targeting of the targeted victim - Falsifying police affidavits, claiming rang police because targeted victim was driving erratically and appeared to be on drugs and feared for their safety / police did not witness undue care driving offence, was called to the scene - Witnesses claim in falsified statements did not see anything while targeted victim was being arrested and went about filming their activities after claiming called police because feared their safety - Witnesses state (correct statement) that targeted victim exited the vehicle and was not in the vehicle when the police arrived, as stated in targeted victims statement. Victim was approached by the witnesses before police arrived and was taking with her, did not appear to fear for their safety (approached victim to talk) - Police cohesion of witnesses to falsify statements to falsely convict targeted victim - witnesses did not testify in a court of law during court proceedings to this effect / statement details or undue care - victim was charged undue care by the Port Pirie Police Department following acquittal of all charges when did not witness undue care driving offence, was called to the scene and witnesses did not testify to these charges in a court of law.

Detective Leigh Gwilym / BSGT 72048 - Following being assaulted at the Port Side Tavern, Port Pirie by a man from Western Australia, who indecently exposed his genitals and physically pushed the targeted to the ground from off a seat in the outside beer garden when she refused to be sexually involved with him the targeted victim reported the incident to the Port Pirie Police Station, Detective Leigh Gwilym and requested assistance concerning her safety from sexual predators and the assault that took place. The targeted victim was told by the Detective "I can not investigate this as there are police officers involved"

The Detective then contacted the targeted victim at another date and informed her that her story does not collaborate with witnesses of that event that he had questioned and informed her that he was not able to view the event via security footage as the cameras were not working that day. Question: How did he know what witnesses were present out doors of the tavern and who to question that did not collaborate with my version of events if he could not view who was involved as witnesses. All staff of the tavern on that day were not present in the beer garden outside of the premise when the event took place. How did the detective know who to question to confirm details without footage? Obstruction of justice - Falsified claims of carrying out an investigation and providing falsified information regarding the complaint - Cover up of police involvement in corruption / illegal activity and sexual targeting of the targeted victim

Port Pirie Police Department - Officer Gary Brockhouse / Officer Faried Muhsin, Port Pirie / Officer Scott Richard Bowman / Officer / Officer Daniel James Nicolson, Crystal Brook - 2016 Illegal arrest / falsified police statements / Police brutality resulting in severe permanent injuries to the targeted victim of shoulder joint and muscle damage and suspected fractured neck - Police statements claim there was 4 police officers present, there was 2 police officers present and involved, Officer Gary Brockhouse and Officer Faried Muhsin only. Police officers claim victim was yelling profanity and was the reason they arrested the targeted victim / targeted victim has vocal cord damage from continuous strangulation as a result of an severe abusive relationship at age 19, which she now suffers PTSD and can not raise her voice above normal pitch level without severe coughing and tightening in her throat which constricts breathing. Targeted victim was walking home past McDonalds carpark when event took place and was apprehended by the 2 police officers as she walked past their parked police vehicle parked in the McDonalds acrpark in waiting for her. The targeted victim heard the words "Grab her" come from the police vehicles police radio moments before she was pulled aggressively from the footpath by the 2 police officers and slammed down aggressively onto the police vehicles bonnet resulting in a suspected fractured neck, severe bruising to elbows, resulting in nerve damage to her elbows and her arms ripped aggressively behind her back while pinned down against the bonnet by the two police officers who pushed their bodies hard against her on either side of her legs and pinned her to the police vehicle bonnet. The targeted victim was taken back to the Port Pirie Police Station which when arrived the police vehicle with the 2 officers sitting in the front

seat while she sat in the back seat in hand cuffs was reversed back into a side garage and the roller door rolled down. The targeted victim feared for her life and suspected she was about to be raped by the 2 police officers because of the previous sexual targeting involved in this police department prior to the arrest, involving Officer Jake Austin and an Officer on the Port Side Tavern (Primo's) dance floor involving officer Hanna O'Neil and Tammy Foster . The targeted victim who had just been aggressively assaulted by the 2 officers and now in severe physical pain and suffered from PTSD panicked and pulled her knees up to her chest in a gesture that she would kick out if touched by the police officers and said "Don't you touch me" when the back door of the police vehicle was opened by the police officer sitting in the passenger front seat. The garage roller door was then returned to the opened position and she was led out of the garage and led into the police station through a back door entrance. The targeted victim was stripped of all belongings and placed into a padded cell for 3 hours. Following 3 hours detention the targeted victim was taken out of the cell, charged with Disorderly behaviour and resisting arrest and released. When released a police officer in the police station not involved in the arrest stated "She's a pain in the arse" "Get her out of here before the boss gets back"

Officer Scott Bowman claims he was present at this arrest - Falsified police statements to convict the targeted victim and to create a falsified criminal record of the targeted victim - Connections to Paul Gardner Michael Fetherstonhaugh, Roger Gardner, Gail Gardner and Peter Bannister through family relations and all individual, including motorcycle gang members connections

The targeted victim is still receiving medical treatment for the severe injuries sustained during the 2 arrests of Officer Scott Kelly, Farried Muhsin and Gary Brockhouse in 2021, and is ongoing medical treatment for life.

Telstra Employee - Name unknown - Illegally entered into targeted victims bank account with ANZ, Port Pirie without having access to the targeted victims banking details and withdrew funds from the bank account without authority. ANZ manager addressed the issue and had the funds refunded / reversed back into the targeted victims bank account - no charges or follow up concerning this event took place

ANZ, Port Pirie - Businesses within the township of Port Pirie were continuously double dipping / double charging card swiped purchases from the targeted victims ANZ debit card / reported to Consumer Affairs with no follow up action conducted. 2008 ANZ Credit card debt concerning House sale court proceedings / ANZ collaborated with lawyer Kelly Morgan in creating Fraudulent Credit Card debts that did not exist and received funds from the House sale Trust fund following the end of court proceedings resulting in contributing to the depletion of business funding.

NAB, Port Pirie - Concerning a Fraudulent debt created by AGL - Targeted victim was making payments directly into the Debt Collectors bank account details in the NAB, Port Pirie / payment plan instalments of the debt. NAB, Port Pirie did not record the payments made on the payment plan and the whole debt was recorded on the targeted victims Credit rating as debt liability resulting in loss of ability to obtain credit for business funding

Credit Union, Port Pirie - Business account / J Monique - Continuous Fraudulent activity - Missing funds resulting in electronic payments being declines which accumulated fees and charges - Deposits of funds not being recorded - Fraudulent personal payments for goods being recorded in business account - Funds deposited not available for electronic payments on website development of business resulting in declined payments and bad rating of payment with the website development company - Sabotage of business development through fraudulent activity in business bank accounts

Commonwealth Bank, Port Pirie - Denied Credit Facilities for business developments - 2008 Fraudulent created Credit Card debt concerning house sale funds resulting in contributing to the depletion of business funding - Reversed payment of fraudulent created credit card debt back into the possession of the representing lawyer Kelly Morgan, who did not distribute the funds between the 2 parties involved - Involvement in Money laundering through fraudulent credit card debt and paying the lawyer to create the fraudulent credit card debt through reversal of the funds to the lawyer which was not distributed to the 2 involved parties resulting in contributing to depletion of business funding

Wesley Care United, Port Pirie - Creating Fraudulent debts , not recording payments on loans , increasing debts when payments are being made not decreasing the balance - Manager Andrew Hadert involved in Sexual Targeting of the targeted victim in 2015 and recording her youngest sons movements in and out of the home - Access to Police Illegal shared Surveillance - Recording the targeted victims movements when relocating to different addresses without being informed of this information, recorded in Andrew Hadert's personal diary / extract obtained through the targeted victims application of Freedom of Information Act - Andrew Haderty's hand writing in Fraudulent debts created and adjusted balances of loans - Contributing to creating Financial stress and Hardship of the targeted victim , Money laundering through Government services - Connections to Government positions, Michael Fetherstonhaugh, Paul Gardner, Roger Gardner, Gail Gardner, Peter Bannister, Officer Scott Bowman, and including involved individuals, including motorcycle gang members

Centrelink, Port Pirie / Child Support Payments - Continuous missing personal funds from both government payments reducing personal living payments to the targeted victim creating Financial stress and hardship to the targeted victim, living expenses 2010 - 2016 - Connections to Government positions and involvement in targeting the victim - Money laundering through Government payments and services and contributing to creating financial stress and hardship to the targeted victim

SA Housing, Port Pirie - Creating Fraudulent debts of Rental housing bond assistance - Conspiring with a Real Estate Agent to create fraudulent housing bond debts - Professionals Real Estate, Port Pirie claimed a bond through SA Housing, Port Pirie that did not exist, the rental housing bond was paid for in cash and was not a SA Housing bond assistance of \$950.00. SA Housing created the Fraudulent debt claiming it was a SA Housing bond assistance bond and charged the targeted victim with the debt as payment instalments of the debt - Money laundering through Government services - Contributing to create financial stress and hardship to the victim resulting in reduced living finances - Creating Fraudulent debts that did not exist with the Department

Townsville CC Parking, Queensland - Electricity account / Utilities - Obtained in 2016 - 2008 - 2016 continuous excessive rise in utility accounts from \$100.00 a quarter to over \$600.00 a quarter, reported to the Energy Ombudsman which remained unresolved. 2016 obtained the evidence of police involvement in creating Fraudulent debts through utility accounts and illegally remotely accessing servers of Telecommunication systems and account, involving Electricity accounts - Origin electricity account scanned barcode in the Kadina Port Office as Townsville CC Parking, Queensland, evidence of Police targeting the targeted victim and police money laundering through utility accounts - Connections SAPOL, Port Pirie Police Department, Officer Scott Bowman, Crystal Brook, connected to Paul Gardner, Roger Gardner, Gail Gardner, Queensland, who is connected to Michael Fetherstonhaugh, Peter Bannister, Port Pirie, Shaun Steele, Queensland, and including all individuals involved and named in the act of Specific targeting of an individual, including motorcycle gang members

Benleigh Vending, Queensland - Illegally accessing targeted victims bank account without being informed of the targeted victims banking details - Attempted to withdraw funds from targeted victims bank account in the Credit Union, Port Pirie - Event was reported to the manager and an investigation was conducted and the bank account was closed by the targeted victim - Connections to Queensland involvement and the act of Specific targeting of an Individual - Attempted Money laundering through bank account - Connections SAPOL, Port Pirie Police Department, Officer Scott Bowman, Crystal Brook, connected to Paul Gardner, Roger Gardner, Gail Gardner, Queensland, who is connected to Michael Fetherstonhaugh, Peter Bannister, Port Pirie, Shaun Steele, Queensland, and including all individuals involved and named in the act of Specific targeting of an individual, including motorcycle gang members

PATTERN - ISOLATION - CREATING VULNERABILITY / EMOTIONAL COMFORT

After being single for 2 years after the traumatic relationship ceased with David Johnson and I was suffering from the created isolation, loneliness of which I had never experienced before having always been able to make friends easily and was in constant contact with my friends and family, which had ceased through the fraudulent activity / blocked and altered msgs / Telecommunication Systems, I sought a relationship on an online dating site RSVP.

FIRST CONTACT - ONLINE DATING SITE - RSVP

Antonio - Interacted via email and online dating messenger
Ceased contact - Did not meet in person

**GEORGE GEORGIO - MELBOURNE VICTORIA - PORTRAYING SEEKING A
RELATIONSHIP**

I had met George Georgio on RSVP / Online dating site - Bank statement records
After speaking via the online dating sites messenger, exchanging phone numbers / text messages, personal email accounts for a couple of months we had decided to meet in person. I agreed to meet him as I believed that we were in the first stages of beginning a relationship. George Georgio had sent me a photograph of himself through our personal email contact. I had contacted my mother, Cynthia [REDACTED], Kadina and informed her that I had met a nice man on the internet who resided in Melbourne and we had decided to meet, that he was flying from Melbourne to Port Pirie to stay for a weekend to spend time together and get to know one another. I sent an email to my mothers email address containing the photograph of George Georgio but at the moment I sent the email my mothers computer crashed and her computer had to be sent for repairs. She did not receive the email containing the photograph.

The first arrangement of our meeting in person was cancelled due to the fact that George had stated that his father was involved in a car accident - was T-Boned as his car travelled through a set of traffic lights in Melbourne and he had been taken to hospital suffering minor injuries but was recovering well. George seemed emotionally upset by his fathers accident as I spoke to him several times on the phone during that time. One of the phone calls as I tried to call him was diverted to a call centre which I found odd. George had called me back in relation to the missed call.

George Georgio and I made further arrangements in relation to us meeting in person a few weeks after the events of his fathers car accident. We had made the arrangements via the

services of personal email and text messages - mobile phone records / 6th - 8th August 2014
During this time I had relocated from [REDACTED]
[REDACTED] on the 22nd May 2014.

I had been in [REDACTED] for approx. 2-3 months while I got to know George Georgio on the online dating site, RSVP.love.singles

Meeting in Person:

George Georgio informed me that he was flying from Melbourne to Adelaide and I had arranged to pick him up from the Adelaide Airport.

I entered the Adelaide Airport and was told by George Georgio via mobile phone to meet him near Gate 19. I had rang George Georgio on my mobile phone as I could not locate him within the airport and he informed me that I should stand near the shop glass window near the boarding area - shopping area foyer / Book shop

After meeting we left the Adelaide Airport and I drove George Georgio back towards Port Pirie. We stopped at a pub in Lower Light off the highway and stayed for about an hour while we dined and consumed a couple of drinks. George Georgio was very polite and had spoken in detail of his previously owned business dealings with multi million dollar Companies, living a lavish lifestyle and of a previous break down of a relationship that had left him financially hard shipped, had lost everything, of which he had to re-build his life by becoming a teacher and lecturer of machine operating, which he found challenging and enjoyable.

George Georgio had stayed at my place of residence, [REDACTED] for a 2 day period over the weekend. We enjoyed getting to know one another further and enjoyed various activities together within the township, as I believed we were starting a relationship.

Activities over the weekend:

- BH Club, Port Pirie - Playing eightball
- Central Hotel, Port Pirie - Dining / lunch
- Blockbuster Video - Hired movies to watch that evening together

We were served by employee of Blockbuster Video, Port Pirie by Marta Newman and sighted together by this employee.

Marta Newman and I were personally involved / friendship - Phone records

She had asked me after that weekend : "Who was that nice younger man that you were with when you came into Blockbuster?"

During that weekend George Georgio informed me (of which he had not stated during our numerous interactions via mobile phone and email) that he lived with a female whom worked in the **Mining Industry**, but that they were just good friends. Over the that weekend George Georgio had stayed in constant continuous contact with this woman via text messages and mobile phone contact, which I found to be disrespectful, odd and too close for comfort, in regards to his statement that they were only just friends. I questioned in my mind this interaction - Womanising behaviour / lying

On the Sunday morning whilst I slept along side George Georgio in my bed, [REDACTED] I was suddenly awoken by the touch of George Georgio having sex with me while I slept and did not have time to react to stop his penetration before he had finished. A matter of minutes between start and finish of penetration. I had not planned or consented to having sex with George Georgio as I believed that we were

in the starting period of a relationship and was not looking for a sexual relationship before knowing each other further. Sex without my consent or knowledge of sexual targeting.

UNUSUAL COMMENT:

George Georgio had made the comment : "Mistress"

I did not question this comment but had found it questionable and odd. I did not understand what he had meant by this comment.

On the Sunday, late morning I drove George Georgio back to Adelaide to go to the Adelaide Airport to for his flight back to Melbourne. We stopped at a Pizza Café within the metropolitan area CBD of Adelaide / corner café on an intersection, traffic lights on the left hand side heading towards the city / sidewalk dining available. George Georgio had spoken to the woman he shared the apartment with during our meal and had spoken affectionately towards her, affectionate words ; Darling / sweetheart
I found this odd and stared at him as if unimpressed which made him nervous in my company.

I then proceeded to drive George Georgio to the Adelaide Airport and dropped him off at the drive way to the entrance of the airport.

George Georgio had stated : "I'll be back sooner than you think"
I said goodbye to George Georgio and drove back to Port Pirie.

George Georgio had left the airline flight book in my possession when he left at my place of residence, [REDACTED] dated August 2014 - matches phone records of contact

That following week I had stated that I had found his interaction with the woman he lives with to be odd, suspicious and that his treatment towards me while we were together to be disrespectful and not good grounds in order to start a relationship.

True reason: Sex without my consent whilst I slept - Rape/ sexual abuse under the act of sexual targeting

I ceased all contact with George Georgio

EPSTEIN - MAXWELL

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.^[22] A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be ██████████, who was previously known as ██████████. ██████████ met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when Guffre was a 16-year-old spa attendant.^[22] She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".^{[22][63]}

Maxwell has repeatedly denied any involvement in Epstein's crimes.^[54] In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".^{[58][64]}

██████████ asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. ██████████ sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in ██████████ favour,^[65] with Maxwell paying ██████████ "millions".^[66]

SEXUAL DEMANDS - SEXUAL ABUSE RING - TARGETING
██████████ v Epstein and Maxwell (2017) - MAXWELL DESTRUCTION OF CAREER PROSPECTS - COMPLY

In 2017, ██████████ filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[9][48][67][68]}

Affidavit filed by ██████████ (2019)

On 16 April 2019, ██████████ went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, ██████████, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. ██████████ affidavit was filed in support of a defamation suit by ██████████ against Alan Dershowitz.^[69] According to the affidavit, ██████████ had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.^{[70][71]} ██████████ reported the incident to the New York Police Department and the FBI.^{[52][72]} Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, ██████████, to his New Mexico property where he and Maxwell molested her on a massage table.^{[73][74]}

██████████ was interviewed for *CBS This Morning* in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.^[75]

Vincent Bulone informed me that he paid \$600.00 for 2 hours of her sexual services **Deceitful behaviour - Involvement in Prostitution - Refer to file Sexual Targeting Shaun Steele / Involvement in Prostitution - Refer to file 2014 - 2016 Extreme Sexual Targeting Paul Gardner / Threats of Prostitution**

→ I felt disgusted in this behaviour of interacting with Prostitutes and felt an instant loss of respect for Vincent Bulone who had portrayed himself as dignified, respectful, honourable and a gentleman during our phone interaction before meeting.

I tried to understand his position and interaction with a prostitute for sex and continued to get to know him. We had breakfast in a café in the Adelaide CBD then proceeded to go for a drive around the Adelaide foreshores as we interacted and got to know one another more. We returned to the Scotty's Motel, Adelaide where we drank wine together and ordered a take away meal from an Indian Restaurant.

Vincent Bulone portrayed himself as charming, well educated and seeking a relationship.

Vincent Bulone stayed with me that night at the Scotty's Motel, Adelaide and we arranged to meet the following weekend in Kadina.

We continued to interact via text messages on an everyday basis leading up to the following weekend. Vincent Bulone booked a motel room online at the Gateway Motel, Kadina for our next meeting. I met Vincent Bulone at the Gateway Motel, Kadina Saturday morning.

We proceeded to go for brunch in Moonta SA. I believed that we were starting a relationship.

Following this we continued to meet every weekend at the Gateway Motel, Kadina and then at the Wallaroo Apartments, Wallaroo SA. Vincent Bulone proceeded to tell me that he loved me and spoke to me as if we had started a relationship and led me to believe that we had.

During a interaction at the Gateway Motel, Kadina we dined at the Italian Restaurant, Bellagio, Kadina in which Vincent Bulone displayed womanising behaviour and disrespect against me by inappropriate womanising behaviour with a female staff member, waitress. I scolded Vincent Bulone about this behaviour when we returned to the motel room, which Vincent Bulone acknowledged this behaviour was inappropriate and apologised for his behaviour. **Refer to Psychological Report - Relationship Stresses / Womanising behaviour**

- Anna - North Terrace University Campus - Telling her that he would pick her up in the red car (newly purchased Holden Astra for me) - Anna then contacted him telling him that she "missed him" and he replied that he was having drinks with the girls at the university and that she should come join him - he stated in another text message "No regrets"
- Marianne - Meeting her for lunch in Melbourne



I was under the impression that the illegal targeting and activity was confined to Port Pirie and revolved around the contesting of the Intellectual property Theft of the Medical Business Plan and M.S.I.C, communication tool developed between the years of 2006 - 2012.

I believed that the targeting involved Roger Kirchner, Michael Fetherstonhaugh and Dr Kajani all residing in Port Pirie. I received a denial of investigation and the activity from I.C.A.C 2016 - 2017 and believed that I could not take the matter any further and that the activity that had ceased following relocation had ceased due to the relocation to Kadina.

I packed away the evidence and stopped contesting and reporting the illegal activity and Intellectual Property Theft and continued to rebuild my life and my work on the book development. I gained employment in the local area of Kadina and sought a publishing contract for my book which I had completed in 2018. Refer to letter - Austin Macauley Publishers, London 28th March 2018 / approval of manuscript and contract 2018.

I then proceeded to work on a second book development as my intention was to turn the book into a three part series, which I succeeded in obtaining a contract on the second book with Austin macauley Publishers, London in 2019. Refer to letter - Austin Macauley Publishers, London / approval of manuscript and contract 17th February 2020.

Told me that he had bought her a present - a silk scarf - he had also bought a silk scarf for me when we first starting dating - I told him that it was inappropriate and personal and as he had bought one for me does he do that with all the women and I said it was now nothing special and had no special meaning and that I would not now ever wear it. He denied that he was doing anything wrong.

I went to a university conference, Robbie Davies was there, I walked up to join Vincent's PA who was standing with her talking, I was visible to Robbie Davies. She would not look at me and held her head down towards the floor and rushed away quickly, did not say hello or acknowledge me in anyway.

Michelle - Adelaide University - employee

Michelle kept messaging Vincent day and night through personal messaging apps with her personal issues. Contacted Vincent once at 4am in the morning with her personal issues while he was away from the university travelling in the US - He got out of bed to address and support her personal issues.

This went on for months

Would not fir her even though she was submitting wrong results and incompetent at her job - he was letting everyone else go when the grant money ran out but extended her contract.

I told him to back this personal contact off and as her boss his relationship at work should be professional and he was acting inappropriately in a relationship (ours) which was damaging and disrespectful towards me. He denied that he was doing anything wrong. This behaviour stopped.

Annie - Adelaide University - Colleague

Kept getting sms messages at the same time every night when he got home from work - was acting strangely and suspiciously - He never spoke about Annie to me or mentioned her name. I found his behaviour odd and suspicious and relating to previous behaviour so I checked his sms messages on his tablet that were connected to his phone. I found numerous messages to Annie - meeting her for lunch constantly - lots of interaction - picking her up from another location of campus in my red car that he had bought for me and telling her that he missed her - I felt Betrayed. - NO REGRETS

I confronted him and told him that I had read the messages on his tablet - He said that it was a joke - seemed nervous and defensive - we argued - told him he was lying to me, hiding things and it was inappropriate behaviour in a relationship, that he was hurting me.

He denied that he was doing anything wrong and blamed me for not trusting him.

Pattern forming - Behavioural - I was aware

He disconnected his phone from the tablet so no sms messages could be seen on it and changed his password when he travelled next.

Saw the messages to Annie saying he was drinking with the girls and she should come and join him - Denied he was drinking at work and I was being paranoid - he was doing this after he had asked me to stop drinking - I quit for nearly a year - He also asked me to quit cigarettes - I did for nearly 7 months - he was doing this at work while I sat alone at home waiting for him to come home at the end of everyday.



I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint.

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling [REDACTED] or [REDACTED]

I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2018. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament. Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for raising your concerns with me.



short her courses in Adelaide in 1982, and moved to Melbourne to work with the Australian Union of Students.^[20] In 1983, she became the second woman to lead the Australian Union of Students, serving until the organisation's discontinuation in 1984. She was also the secretary of the left-wing organisation Socialist Forum.^{[21][22]} Having transferred her studies to the University of Melbourne, Gillard graduated with a Bachelor of Laws degree in 1986 and a Bachelor of Arts degree in 1989.^[23] In 1987, she joined the law firm Slater & Gordon in Werribee, Victoria, working in industrial law.^[11] In 1990, she was admitted as a partner; at the age of 29, she was the youngest partner within the firm, and one of the first women to hold the position.^{[24][25]}

Early political involvement
From 1985 to 1989, Gillard served as President of the Carlton branch of the Labor Party.^[6] She stood for Labor preselection in the Division of Melbourne prior to the 1993 federal election, but was defeated by Lindsay Tanner.^[26] At the 1996 federal election, Gillard won the third position on Labor's Senate ticket in Victoria, behind Robert Ray and Barney Cooney.^{[27][28]} However, on the final distribution of preferences she was defeated by Lyn Allison of the Australian Democrats.^{[29][30]}

In 1996, Gillard resigned from her position with Slater & Gordon to serve as chief of staff to John Brumby, at that time the Leader of the Opposition in Victoria.^{[6][30][31]} She was responsible for drafting the affirmative-action rules within the Labor Party in Victoria that set the target of pre-selecting women for 35 per cent of "winnable seats". She also played a role in the foundation of EMILY's List, the pro-choice fund-raising and support network for Labor women.^[32]

Gillard has cited Welsh Labour politician Aneurin Bevan as one of her political heroes.^[24]

Member of Parliament (1998–2007)

Gillard was first elected to the House of Representatives at the 1998 federal election representing Lalor, a safe Labor seat near Melbourne, replacing Barry Jones who retired. She made her maiden speech to the House on 11 November 1998.^[33] Gillard was a member of the standing committee for Employment, Education and Workplace Relations from 8 December 1998 to 8 December 2001, in addition to Aboriginal and Torres Strait Islander Affairs from 20 March 2003 to 18 August 2003. Within the joint committees, she was a member of the Public Accounts and Audit from 8 December 1998 to 11 February 2002, in addition to the Native Title and the Aboriginal and Torres Strait Islander Land Fund from 20 March 2003 to 11 August 2003.^[6]

Shadow Minister (2001–2007)

After Labor's defeat at the 2001 federal election, Gillard was elected to the Shadow Cabinet under then-Labor Leader Simon Crean, where she was given responsibility for Population and Immigration. In February 2003, she was given additional responsibilities for Reconciliation and Indigenous Affairs.^[34] In these roles, in the wake of the Tampa and Children Overboard affairs, which were partly credited with Labor's 2001 election loss, Gillard developed a new immigration policy for the Labor Party.^[13]

Gillard was later promoted to the position of Shadow Minister for Health and Deputy Manager of Opposition Business in the House (to Mark Latham) on 2 July 2003.^{[25][35]} During this time, she shadowed Tony Abbott, with the rivalry between the two often attracting attention from the media.^[36] She was later given additional responsibility for managing opposition business in the House of Representatives by Latham, who had succeeded Beazley as Labor Party leader.^[37]





We can now confirm your booking at Rose Park Psychology on Friday 28th February at 1.30pm. Please find your Appointment Schedule attached.

Our reception staff are available for discussion with you. Please feel free to call us at any time.

What to Expect from your Psychologist :

Your psychologist is interested to meet you and will spend most of the first session finding out about you, your life so far, and your current situation. Together, you and your psychologist will aim to come to an agreement about the focus for change. You will draw up a treatment program to treat the identified issues, and a set of goals for change. You can expect an opportunity to talk and express your feelings and ideas about your current situation. Depending on your situation you should expect treatment to take 6 – 10 sessions. Your psychologist will discuss this with you. Each session is for 50 minutes.

Confidentiality:

Information that you share with your psychologist will be kept confidential. Your psychologist will write back to your GP, if you have been referred by a GP. Psychologists are mandated by law to report any incidences of child abuse or indeed any plan to harm an adult including yourself. Under certain circumstances your records could be subpoenaed by the court. Please discuss any concerns about confidentiality with your psychologist. Attendance at your Sessions We ask for your commitment to your treatment program. It is a courtesy to let your psychologist know well ahead of time if you need to change an appointment time. Your psychologist will be left with wasted time and it would really help other clients who are waiting for appointments and your psychologist, if you could, out of courtesy, inform us as soon as possible if you can't attend. Charges apply to late cancellations.

Cost:

Each session costs \$240.00 as a privately paying client. If you have private health cover, you may be eligible for a rebate, and we can swipe most cards here on premises to claim (any HICAPS providers). If you are unsure whether you are covered for psychological services, it is best to enquire with your fund as each person's cover can vary a great deal and we cannot know your level of cover before you attend.

After hours appointments: Appointments after 5pm incur a \$20 surcharge.

Medicare rebates are available if you have a Mental Health Care Plan in place from your GP with a referral to our practice, or a referral from a psychiatrist. The gap you pay per session after the Medicare rebates varies very slightly depending on which practitioner you see, but is about \$113.
