Dear Pitstop Technologies, The Manager,

I am contacting you to ask for your pardon concerning a previous issue that arose between our business transactions previously.

This issue involved a miscommunication involving one of your technicians and my self, and myself either not explaining myself correctly or your technician not understanding the description correctly or not hearing me correctly, which in turn resulted in a what was misconstrued as "unethical conduct" on my behalf.

The issue also involved me asking to speak to the involved technician just outside of the office as at the time it was in regards to the covid pandemic and the fact that I due to health reasons could not be vaccinated against covid and was concerned about the multiple people in the small space of the front office and social distancing and the risk to my health.

In hindsight I should have waited outside the office for your customers to be finished and stepped inside the office, as I can now understand that my actions could have been conceived and misconstrued as unethical or something unethical taking place concerning your business and technician. I did apologise for my actions then and apologise once more for this misunderstanding.

I can assure you at no time was this interaction in anyway unethical or to blame involving either parties involved.

I had actually asked if your company and technicians worked on the weekends and when the technician informed that you didn't I asked for an exception and I was willing to pay for what ever costs to me it was going to cost, as the issue was important and vital to rectify immediately.

It was my understanding that the technician would ask you the manager concerning this request but instead the request was misconstrued and misunderstood, and i received an email alleging unethical practices on my behalf and you the manager had forbidden my business with your company.

Concerning your reaction although I was insulted your reaction was also reassuring to the tight security measures of your practice,as I am heavily involved in major business developments, and at the time confirmed as a victim of organised crime,which did involve computer and email hacking,which your technician involved had confirmed and rectified with the tight security measures he had placed on my computer and the remote computer monitoring of your company.

I am currently involved in a major community business development involving multiple Government sources and officials,which includes our local Government Fraser Ellis MP and the Premier of South Australia and currently have an issue with the same business email system GoDaddy which your technician,Brennon previously rectified and am requesting a pardon of our previous differences and a request to once again conduct business between us.

I can reassure you that this information provided in this email is true and correct and advise if you need further reassurance to contact the office of Fraser Ellis MP who can reassure you of this information of the current business developing involving third parties of Government support and acknowledgement, and our business and professional interactions involving the above mentioned parties.

Relocated following detention Glenside Mental Health Facility from Port Pirie to parents home 65 Stirling Terrace, Kadina SA. Still on medication prescribed by SACAT for falsified diagnosis of Schizophrenia, side effects of medication - Suicidal Tendencies

I was under the impression that the illegal targeting and activity was confined to Port Pirie and revolved around the contesting of the Intellectual property Theft of the Medical Business Plan and ██████████, communication tool developed between the years of 2006 - 2012.

I believed that the targeting involved Roger Kirchner, Michael Fetherstonhaugh and Dr Kajani all residing in Port Pirie. I received a denial of investigation and the activity from I.C.A.C 2016 - 2017 and believed that I could not take the matter any further and that the activity that had ceased following relocation had ceased due to the relocation to Kadina.

I packed away the evidence and stopped contesting and reporting the illegal activity and Intellectual Property Theft and continued to rebuild my life and my work on the book development. I gained employment in the local area of Kadina and sought a publishing contract for my book which I had completed in 2018. Refer to letter - Austin Macauley Publishers, London 28th March 2018 / approval of manuscript and contract 2018.

I then proceeded to work on a second book development as my intention was to turn the book into a three part series, which I succeeded in obtaining a contract on the second book with Austin macauley Publishers, London in 2019. Refer to letter - Austin Macauley Publishers, London / approval of manuscript and contract 17th February 2020.

Told me that he had bought her a present - a silk scarf - he had also bought a silk scarf for me when we first starting dating - I told him that it was inappropriate and personal and as he had bought one for me does he do that with all the women and I said it was now nothing special and had no special meaning and that I would not now ever wear it. He denied that he was doing anything wrong.

I went to a university conference, Robbie Davies was there, I walked up to join Vincent's PA who was standing with her talking, I was visible to Robbie Davies. She would not look at me and held her head down towards the floor and rushed away quickly, did not say hello or acknowledge me in anyway.

Michelle - Adelaide University - employee

Michelle kept messaging Vincent day and night through personal messaging apps with her personal issues. Contacted Vincent once at 4am in the morning with her personal issues while he was away from the university travelling in the US - He got out of bed to address and support her personal issues.

This went on for months

Would not fire her even though she was submitting wrong results and incompetent at her job - he was letting everyone else go when the grant money ran out but extended her contract.

I told him to back this personal contact off and as her boss his relationship at work should be professional and he was acting inappropriately in a relationship (ours) which was damaging and disrespectful towards me. He denied that he was doing anything wrong. This behaviour stopped.

Annie - Adelaide University - Colleague

Kept getting sms messages at the same time every night when he got home from work - was acting strangely and suspiciously - He never spoke about Annie to me or mentioned her name. I found his behaviour odd and suspicious and relating to previous behaviour so I checked his sms messages on his tablet that were connected to his phone. I found numerous messages to Annie - meeting her for lunch constantly - lots of interaction - picking her up from another location of campus in my red car that he had bought for me and telling her that he missed her - I felt Betrayed. - NO REGRETS

I confronted him and told him that I had read the messages on his tablet - He said that it was a joke - seemed nervous and defensive - we argued - told him he was lying to me, hiding things and it was inappropriate behaviour in a relationship, that he was hurting me.

He denied that he was doing anything wrong and blamed me for not trusting him.

Pattern forming - Behavioural - I was aware

He disconnected his phone from the tablet so no sms messages could be seen on it and changed his password when he travelled next.

Saw the messages to Annie saying he was drinking with the girls and she should come and join him - Denied he was drinking at work and I was being paranoid - he was doing this after he had asked me to stop drinking - I quit for nearly a year - He also asked me to quit cigarettes - I did for nearly 7 months - he was doing this at work while I sat alone at home waiting for him to come home at the end of everyday.

I met her at a university lunch for Christmas - seemed very comfortable and friendly with Vincent - playful - sat down inbetween me and Vincent as we sat next to each other on a long wooden bench at the table, nearly in Vincent's lap - I saw it as a rival behaviour and odd and disrespectful to a couple and their relationship.

Vincent was receiving constant messages from her while we were together and still messaging as soon as he got home from work while ignoring me and played with her - playful messages, laughing and giggling - sided with each other playfully against a company - told Natalie the way that this company had treated him which he had not spoke to me about or even mentioned - spoke about her constantly.
