

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

### Victims' rights: *Jane Does v. United States (2014)*

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (██████████) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add ██████████ ██████████ (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim ██████████ against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by ██████████ are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that ██████████ may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

### ██████████ v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> ██████████ ██████████ (then known as ██████████ ██████████), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> ██████████ also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with ██████████. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> ██████████ filed a defamation suit against Dershowitz,

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.<sup>[22]</sup> A 2018 exposé by Julie K. Brown in the *Miami Herald* revealed Jane Doe 3 to be ██████████, who was previously known as ██████████. ██████████ met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when ██████████ was a 16-year-old spa attendant.<sup>[22]</sup> She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".<sup>[22][63]</sup>

Maxwell has repeatedly denied any involvement in Epstein's crimes.<sup>[51]</sup> In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".<sup>[58][64]</sup>

██████████ asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. ██████████ sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in ██████████ favour,<sup>[65]</sup> with Maxwell paying ██████████ "millions".<sup>[66]</sup>

MAXWELL DESTRUCTION OF CAREER PROSPECTS - COMPLY.

In 2017, ██████████ filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.<sup>[9][48][67][68]</sup>

### Affidavit filed by ██████████ (2019)

On 16 April 2019, ██████████ went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, ██████████, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. ██████████ affidavit was filed in support of a defamation suit by ██████████ against Alan Dershowitz.<sup>[69]</sup> According to the affidavit, ██████████ had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.<sup>[70][71]</sup> ██████████ reported the incident to the New York Police Department and the FBI.<sup>[52][72]</sup> Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, ██████████, to his New Mexico property where he and Maxwell molested her on a massage table.<sup>[73][74]</sup>

██████████ was interviewed for CBS This Morning in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.<sup>[75]</sup>



In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.<sup>[92]</sup> She had allegedly undressed, but left the encounter wearing her underwear.<sup>[93]</sup>

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.<sup>[71][94]</sup> During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.<sup>[92]</sup>

The Federal Bureau of Investigation (FBI) then became involved. Subsequently, the police alleged that Epstein had paid several girls to

perform sexual acts with him.<sup>[89]</sup> Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.<sup>[95][96]</sup> The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.<sup>[93]</sup> ██████████, a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.<sup>[97]</sup> The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Recarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude - Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*<sup>[98]</sup>

A former employee told the police that Epstein would receive massages three times a day.<sup>[93]</sup> Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.<sup>[99]</sup> Julie Brown's 2018 exposés in the *Miami Herald* identified about 80 victims and located about 60 of them.<sup>[1][71][100]</sup> She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."<sup>[1]</sup> Details from the investigation included allegations that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.<sup>[95][101][102]</sup>

MODELLING.

In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.<sup>[93][103]</sup> On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.<sup>[5][9][104][105]</sup> State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,<sup>[106]</sup> to which Epstein pleaded not guilty in August 2006.<sup>[107]</sup>

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.<sup>[92][108]</sup> Linguist Steven Pinker also assisted.<sup>[109]</sup>

# Bill Clinton

**William Jefferson Clinton** (né **Blythe III**; born August 19, 1946) is an American politician who served as the 42nd president of the United States from 1993 to 2001. He previously served as governor of Arkansas from 1979 to 1981 and again from 1983 to 1992, and as attorney general of Arkansas from 1977 to 1979. A member of the Democratic Party, Clinton became known as a New Democrat, as many of his policies reflected a centrist "Third Way" political philosophy. He is the husband of Hillary Clinton, who was a senator from New York from 2001 to 2009, secretary of state from 2009 to 2013 and the Democratic nominee for president in the 2016 presidential election.

Clinton was born and raised in Arkansas and attended Georgetown University. He received a Rhodes Scholarship to study at University College, Oxford, and he later graduated from Yale Law School. He met Hillary Rodham at Yale; they married in 1975. After graduating from law school, Clinton returned to Arkansas and won election as state attorney general, followed by two non-consecutive terms as Arkansas governor. As governor, he overhauled the state's education system and served as chairman of the National Governors Association. Clinton was elected president in the 1992 presidential election, defeating incumbent Republican president George H. W. Bush and independent businessman Ross Perot. At 46 years old, he became the third-youngest president of the United States and the first president to be born in the Baby Boomer generation.

Clinton presided over the longest period of peacetime economic expansion in American history. He signed into law the North American Free Trade Agreement (NAFTA) and the Violent Crime Control and Law Enforcement Act, but failed to pass his plan for national health care reform. The Republican Party won unified control of Congress for the first time in 40 years in the 1994 elections, but Clinton was still comfortably re-elected in 1996, becoming the first Democrat since Franklin D. Roosevelt to win a second full term. Starting in the mid-1990s, he began an ideological evolution as he became much more conservative in his domestic policy, advocating for and signing the Personal Responsibility and Work Opportunity Act, the State Children's Health Insurance Program and financial deregulation measures. He appointed Ruth Bader Ginsburg and Stephen Breyer to the U.S. Supreme Court. During the last three years of






# John Howard

2007 INTELLECTUAL PROPERTY THEFT - 2006-2009 MEDICAL BUS PLAN IN GOVERNMENT'S POSSESSION

**John Winston Howard** OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to 2007, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the Howard Government was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

Starting in the 1990s, Trump was a guest about 24 times on the nationally syndicated *Howard Stern Show*.<sup>[145]</sup> He also had his own short-form talk radio program called *Trumped!* (one to two minutes on weekdays) from 2004 to 2008.<sup>[146][147]</sup> From 2011 until 2015, he was a weekly unpaid guest commentator on *Fox & Friends*.<sup>[148][149]</sup>

From 2004 to 2015, Trump was co-producer and host of reality shows *The Apprentice* and *The Celebrity Apprentice*. On *The Apprentice*, Trump played the role of a chief executive, and contestants competed for a year of employment at the Trump Organization. On *The Celebrity Apprentice*, celebrities competed to win money for charities. On both shows, Trump eliminated contestants with the catchphrase "You're fired."<sup>[150]</sup>

Trump, who had been a member since 1989, resigned from the Screen Actors Guild in February 2021 rather than face a disciplinary committee hearing for inciting the January 6, 2021, mob attack on the U.S. Capitol and for his "reckless campaign of misinformation aimed at discrediting and ultimately threatening the safety of journalists."<sup>[151]</sup> Two days later, the union permanently barred him from readmission.<sup>[152]</sup>

## Pre-presidential political career

Trump's political party affiliation changed numerous times. He registered as a Republican in 1987,<sup>[153]</sup> a member of the Independence Party, the New York state affiliate of the Reform Party, in 1999,<sup>[154]</sup> a Democrat in 2001, a Republican in 2009, unaffiliated in 2011, and a Republican in 2012.<sup>[153]</sup>

In 1987, Trump placed full-page advertisements in three major newspapers,<sup>[155]</sup> expressing his views on foreign policy and on how to eliminate the federal budget deficit.<sup>[156]</sup> He ruled out running for local office but not for the presidency.<sup>[155]</sup>

## 2000 presidential campaign and 2011 hints at presidential run

In 2000, Trump ran in the California and Michigan primaries for nomination as the Reform Party candidate for the 2000 United States presidential election but withdrew from the race in February 2000.<sup>[157][158][159]</sup> A July 1999 poll matching him against likely Republican nominee George W. Bush and likely Democratic nominee Al Gore showed Trump with seven percent support.<sup>[160]</sup>

In 2011, Trump speculated about running against President Barack Obama in the 2012 election, making his first speaking appearance at the Conservative Political Action Conference (CPAC) in February 2011 and giving speeches in early primary states.<sup>[161][162]</sup> In May 2011, he announced he would not run,<sup>[161]</sup> and he endorsed Mitt Romney in February 2012.<sup>[163]</sup> Trump's presidential ambitions were generally not taken seriously at the time.<sup>[164]</sup>

Gates is an avid reader, and the ceiling of his large home library is engraved with a quotation from *The Great Gatsby*.<sup>[187]</sup> He also enjoys bridge, tennis and golf.<sup>[188][189]</sup> His days are planned for him on a minute-by-minute basis, similarly to the U.S. president's schedule.<sup>[190]</sup> Despite his wealth and extensive business travel, Gates flew coach (economy class) in commercial aircraft until 1997, when he bought a private jet.<sup>[191]</sup>

Gates purchased the Codex Leicester, a collection of scientific writings by Leonardo da Vinci, for US\$30.8 million at an auction in 1994.<sup>[192]</sup> In 1998, he reportedly paid \$30 million for the original 1885 maritime painting Lost on the Grand Banks, at the time a record price for an American painting.<sup>[193]</sup>

In 2016, he revealed that he was color-blind.<sup>[194]</sup>

**Marriage and divorce**

Gates married Melinda French on the Hawaiian Island of Lanai on January 1, 1994.<sup>[195]</sup> They met in 1987 after Melinda began working at Microsoft.<sup>[196]</sup> At the time of their marriage, Gates was given permission by Melinda to spend limited time with his ex-girlfriend, businesswoman Ann Winblad.<sup>[197]</sup> Bill and Melinda have three children: Jennifer, Rory and Phoebe.<sup>[198]</sup> The family's residence is an earth-sheltered mansion in the side of a hill overlooking Lake Washington in Medina, Washington. In 2009, property taxes on the mansion were reported to be US\$1.063 million, on a total assessed value of US\$147.5 million.<sup>[199]</sup> The 66,000-square-foot (6,100 m<sup>2</sup>) estate has a 60-foot (18 m) swimming pool with an underwater music system, as well as a 2,500-square-foot (230 m<sup>2</sup>) gym and a 1,000-square-foot (93 m<sup>2</sup>) dining room.<sup>[200]</sup> On May 3, 2021, the Gateses announced they had decided to divorce after 27 years of marriage and 34 years as a couple.<sup>[201]</sup> They said they would keep working together on charitable efforts.<sup>[201][202]</sup> *The Wall Street Journal* reported that Melinda had been meeting with divorce attorneys since 2019, citing interviews that suggested Bill's ties with Jeffrey Epstein was at least one of her concerns.<sup>[203]</sup> The divorce was finalized on August 2, 2021.<sup>[204]</sup>

A *New York Times* article reported that Gates's relationship with convicted sex offender Jeffrey Epstein started in 2011, just a few years after Epstein's conviction, and continued for some years, including a visit to Epstein's house with Melinda in the fall of 2013, despite her declared

George, his alleged criminal activities on the islands were concealed through a complex network of companies.<sup>[180]</sup>

### ***Jane Doe v. Maxwell and Epstein's estate (2020)***

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse<sup>[181]</sup> The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.<sup>[181]</sup>

### ***Jane Does v. Epstein estate (2020)***

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.<sup>[182]</sup>

### ***Jane Doe v. Epstein estate (2020)***

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.<sup>[183]</sup>

### ***Jane Doe v. Epstein estate (2021)***

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.<sup>[184]</sup>

## **Second criminal case**

### **Trafficking charges**

On July 6, 2019, Epstein was arrested by the FBI-NYPD Crimes Against Children Task Force at Teterboro Airport in New Jersey on sex trafficking charges.<sup>[27][185][186][187]</sup> He was jailed at the Metropolitan Correctional Center in New York City, which has held prisoners such as John Gotti, Joaquin "El Chapo" Guzman, and Paul Manafort.<sup>[188][189]</sup>

According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds – and perhaps thousands – of sexually suggestive photographs of fully – or partially – nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: "Young [Name] + [Name]", "Misc nudes 1", and "Girl pics nude".<sup>[90]</sup> Also found in the safe were \$70,000 in cash, 48 diamonds,<sup>[190]</sup> and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. The passport showed his place of

residence as Saudi Arabia.<sup>[50][51][191][192][193]</sup> According to his attorneys, Epstein had been advised to acquire the passport because "as an affluent member of the Jewish faith", he was in danger of being kidnapped while traveling abroad.<sup>[194]</sup>

On July 8, prosecutors with the Public Corruption Unit of the Southern District of New York charged him with sex trafficking and conspiracy to traffic minors for sex. The grand jury indictment alleges that "dozens" of underage girls were brought into Epstein's mansions for sexual encounters.<sup>[11][12][195]</sup> Judge Kenneth Marra was to decide whether the non-prosecution agreement that protected Epstein from the more serious charges should still stand.<sup>[196]</sup>

Epstein requested to be released on bond, offering to post \$100 million with the condition that he would also submit to house arrest in his New York City mansion.<sup>[197]</sup> U.S. District Judge Richard M. Berman denied the request on July 18, saying that Epstein posed a danger to the public and a serious flight risk to avoid prosecution.<sup>[197]</sup>

On July 23, Epstein was found injured and semiconscious at 1:30 a.m. on the floor of his cell, with marks around his neck that were suspected to be the result of either a suicide attempt or an assault.<sup>[198]</sup> His cellmate, former New York City police officer Nicholas Tartaglione, who was charged with four counts of murder, was questioned about Epstein's condition. He denied having any knowledge of what happened. Epstein himself said he recollected nothing.<sup>[190][199][200][201]</sup> According to NBC News, two sources said that Epstein might have tried to hang himself, a third said the injuries were not serious and could have been staged, and a fourth source said that an assault by his cellmate had not been ruled out.<sup>[202]</sup>

On August 29, 2019, following Epstein's death 10 days prior, the case against Epstein was closed after Judge Berman dismissed all sex trafficking charges.<sup>[17][18]</sup> However, he also expressed support for Epstein's accusers.<sup>[17]</sup> Prosecutors objected to the ruling and stated they would continue an investigation for potential co-conspirators.<sup>[18]</sup>

## Investigation in France

On August 23, 2019, the prosecutor's office in Paris, France, opened a preliminary investigation into Epstein. He is being investigated for rape and sexual assault of minors under and over the age of 15, criminal association with a view to committing crimes, and association with criminals with a view to committing offenses. The prosecutors said that the goal of the investigation is to find possible crimes committed in France and elsewhere against French citizens.<sup>[203]</sup>

## Personal life

Previous long-term girlfriends associated with Epstein include Eva Andersson-Dubin<sup>[204][205]</sup> and publishing heiress Ghislaine Maxwell.<sup>[30]</sup> Epstein was romantically linked to Andersson-Dubin for an 11-year period<sup>[206]</sup> mostly in the 1980s and the two later remained friendly well after her marriage to Glenn Dubin.<sup>[204][205]</sup> Epstein met Maxwell, daughter of disgraced media baron Robert Maxwell, by 1991.<sup>[162][207][208]</sup> Epstein had Maxwell come to the United States in 1991 to recover from her grief following the death of her father.<sup>[209]</sup> Maxwell was implicated by several of Epstein's accusers as procuring or recruiting underage girls in addition to once being Epstein's girlfriend.<sup>[161][162][208]</sup> In a 2009 deposition, several of Epstein's household employees testified that Maxwell had a central role in both his public and private life, referring to her as his "main

claiming he purposefully made "false and malicious defamatory statements" about her.<sup>[111]</sup> A diary purported to belong to ██████ was published online.<sup>[149][150]</sup> Epstein entered an out-of-court settlement with ██████ as he had done in several other lawsuits.<sup>[89]</sup>

In 2019, ██████ was interviewed by the BBC's *Panorama* where she continued to attest that Epstein had trafficked her to Prince Andrew.<sup>[151]</sup> She appealed directly to the public by stating "I implore the people in the UK to stand up beside me, to help me fight this fight, to not accept this as being ok."<sup>[151]</sup> As of 2016, these accusations had not been tested in any court of law.<sup>[152]</sup>

### ██████████ v. Ghislaine Maxwell (2015)

As a result of Giuffre's allegations and Maxwell's comments about them, ██████ sued Maxwell for defamation in September 2015. After much legal confrontation, the case was settled under seal in May 2017. The *Miami Herald*, other media, and Alan Dershowitz filed to have the documents about the settlement unsealed. After the judge dismissed their request, the matter was appealed to the U.S. Court of Appeals for the Second Circuit.<sup>[153]</sup>

On March 11, 2019, in the appeal of the district judge's refusal to unseal the documents relating to the 2017 defamation settlement of ██████ v. *Maxwell*, the Second Circuit Court gave parties one week to provide good cause as to why they should remain under seal, without which they would be unsealed on March 19, 2019. Later the Court ordered these documents to be unsealed (after having them redacted to protect innocent parties). In ██████ testimony, she claims that she was "directed" by Maxwell to give erotic massages and engage in sexual activities with Prince Andrew; Jean-Luc Brunel; Glenn Dubin; Marvin Minsky; Governor Bill Richardson; another unnamed prince; an unnamed foreign president; "a well known Prime Minister"; and an unnamed hotel chain owner from France, among others.<sup>[154]</sup> The deposition does not claim that any of these men in fact engaged with ██████ and as of August 2019, none of these men have been indicted or sued for related sex crimes.<sup>[154]</sup> ██████ testified, "my whole life revolved around just pleasing these men and keeping Ghislaine and Jeffrey happy. Their whole entire lives revolved around sex."<sup>[154][153]</sup>

On August 9, less than 24 hours before Epstein's death, 2,000 pages of previously sealed documents from the case were released. Two sets of additional sealed documents will be analyzed by a federal judge to determine whether they should also be made public. A "John Doe" asked the judge on September 3 to permanently keep the documents secret, claiming "unproven allegations of impropriety" could damage his reputation, though he had no evidence his name was included.<sup>[155]</sup>

### Jane Doe v. Epstein and Trump (2016)

A federal lawsuit filed in California in April 2016, against Epstein and Donald Trump by a California woman alleged that the two men sexually assaulted her at a series of parties at Epstein's Manhattan residence in 1994, when she was 13 years old. The suit was dismissed by a federal judge in May 2016 because it did not raise valid claims under federal law. The woman filed another federal suit in New York in June 2016, but it was withdrawn three months later, apparently without being served on the defendants. A third federal suit was filed in New York in September 2016.

The two latter suits included affidavits by an anonymous witness who attested to the accusations in the suits, asserting Epstein employed her to procure underage girls for him, and an anonymous person who declared the plaintiff had told him/her about the assaults at the time they occurred. The plaintiff, who had filed anonymously as Jane Doe, was scheduled to appear in a Los Angeles press conference six days before the 2016 election, but abruptly canceled the event; her lawyer Lisa

## Criminal charges

### Arrest and indictment

Maxwell faced persistent allegations of procuring and sexually trafficking underage girls for Epstein and others, charges she denied.<sup>[9]</sup> Maxwell was arrested in Bradford, New Hampshire by the FBI on 2 July 2020, through the use of an IMSI-catcher ("stingray") mobile phone tracking device on a phone used by her to call one of her lawyers, her husband Scott Borgerson, and her sister Isabel.<sup>[103]</sup>

Maxwell was charged with enticement of minors, sex trafficking of children, and perjury.<sup>[10][104][105]</sup> Prosecutors, led by United States District Attorney Audrey Strauss, charged her with six federal crimes, including enticement of minors, sex trafficking, and perjury.<sup>[104][106][107][108]</sup> The indictment charged that between 1994 and 1997, she "assisted, facilitated, and contributed" to the abuse of minor girls despite knowing that one of three unnamed victims was 14 years old.<sup>[109]</sup>

As of 28 April 2021, Maxwell was held at the Metropolitan Detention Center, Brooklyn, New York.<sup>[110][111][112]</sup> Lawyers requested that Judge Nathan release her on \$5 million bond with monitored home confinement while awaiting trial.<sup>[113]</sup> Maxwell appeared by video link before a court in Manhattan on 14 July 2020 and pleaded not guilty to the charges.<sup>[114]</sup> A naturalised US citizen since 2002 who also holds passports from France and the United Kingdom, Maxwell was denied bail as a flight risk amid concerns regarding her "completely opaque" finances, her skill at living in hiding, and the fact that France does not extradite its citizens.<sup>[11][113][115][116][117]</sup> The judge set a trial date of 12 July 2021.<sup>[114][118][119]</sup>

Maxwell's attorney reiterated her request for bail on 18 December 2020, and proposed that Maxwell reside with a friend in New York City while under 24-hour surveillance as she awaited trial.<sup>[120]</sup> Her husband, Scott Borgerson, made a secured offer of US\$22 million to guarantee her presence at future appearances.<sup>[120]</sup> On 28 December 2020, a further request for bail was again rejected by the judge.<sup>[121]</sup> Maxwell's bail request was opposed by alleged victim ██████████ r.<sup>[120]</sup>

On 19 January 2021, a court hearing was disrupted by believers in QAnon – who believe Maxwell to be working in cohort with a cabal of child-sacrificing Satanist liberal elites who traffic children for sex – as the proceedings were illegally livestreamed to YouTube.<sup>[122][123]</sup>

On 26 January 2021, a motion by Maxwell's attorneys challenged her grand jury indictment, claiming that it did not reflect the ethnic diversity of the jurisdiction in which the violations of the law were alleged to have occurred.<sup>[124]</sup>

On 29 March 2021, US prosecutors added new charges of sex trafficking a minor and sex trafficking conspiracy, alleging that Maxwell was involved in grooming a fourth girl, aged 14, to engage in sexual acts with Epstein between 2001 and 2004 at his Palm Beach estate.<sup>[125][126]</sup> Maxwell pleaded not guilty to the additional charges; she faced six counts that included sex trafficking of a minor and sex trafficking conspiracy, in addition to two counts of perjury.<sup>[127]</sup>

Maxwell's attorneys regularly protested about the conditions of her confinement, which included being kept awake by a light shone in her eyes every fifteen minutes to deter the chances of her committing suicide, and being denied a sleep mask.<sup>[128]</sup> One, David Marcus, protested, "There's no

most of his properties to pay down his debts, including personally guaranteed loans, allowing him to avoid personal insolvency.<sup>[56][57]</sup>

In 1996, Trump acquired the mostly vacant 71-story skyscraper at 40 Wall Street, later also known as the Trump Building, and renovated it.<sup>[58]</sup> In the early 1990s, Trump won the right to develop a 70-acre (28 ha) tract in the Lincoln Square neighborhood near the Hudson River. Struggling with debt from other ventures in 1994, Trump sold most of his interest in the project to Asian investors, who were able to finance completion of the project, Riverside South.<sup>[59]</sup>

## Mar-a-Lago

In 1985, Trump acquired the Mar-a-Lago estate in Palm Beach, Florida.<sup>[60]</sup> In 1995, he converted the estate into a private club with an initiation fee and annual dues. He continued to use a wing of the house as a private residence.<sup>[61]</sup> In 2019, Trump declared Mar-a-Lago his primary residence.<sup>[54]</sup>

## Atlantic City casinos

In 1984, Trump opened Harrah's at Trump Plaza, a hotel and casino in Atlantic City, New Jersey, with financing and management help from the Holiday Corporation.<sup>[62]</sup> It was unprofitable, and Trump paid Holiday \$70 million in May 1986 to take sole control.<sup>[63]</sup> Trump had earlier bought a hotel and casino in Atlantic City from the Hilton Corporation for \$320 million. On completion in 1985, it became Trump Castle. His wife Ivana managed it until 1988.<sup>[64][65]</sup>

Trump bought a third Atlantic City venue in 1988, the Trump Taj Mahal. It was financed with \$675 million in junk bonds and completed for \$1.1 billion, opening in April 1990.<sup>[66][67]</sup> It went bankrupt in 1989.<sup>[68]</sup> Reorganizing left him with half his initial stake and required him to personally guarantee future performance.<sup>[69]</sup> To reduce his \$900 million of personal debt, he sold his failing Trump Shuttle airline, his megayacht, the Trump Princess, which had been leased to his casinos and kept docked, and other businesses.<sup>[70]</sup>

In 1995, Trump founded Trump Hotels & Casino Resorts (THCR), which assumed ownership of Trump Plaza, Trump Castle, and the Trump Casino in Gary, Indiana.<sup>[71]</sup> THCR purchased the Taj Mahal in 1996 and went bankrupt in 2004, 2009, and 2014, leaving Trump with 10 percent ownership.<sup>[72]</sup> He remained chairman until 2009.<sup>[73]</sup>

## Golf courses

The Trump Organization began building and buying golf courses in 1999.<sup>[74]</sup> It owns fourteen and manages another three Trump-branded courses worldwide as of July 2020.<sup>[74][75]</sup>

Trump visited a Trump Organization property on 428 (nearly one in three) of the 1461 days of his presidency and is estimated to have played 261 rounds of golf, one every 5.6 days.<sup>[76]</sup>
