#### Suspected Maxwell - "Max's List" -Black Market Sex Trade

Maxwell - Informed that Maxwell who I had met on an online dating site in 2007 at the end of my marriage, who encouraged me to have private conversations with him via personal email addresses real name was Adam Gurgly, who resided in London UK.

Commencement of the 8 year friendship, and in the first year was sexual in nature under Maxwell's encouragement. I had not been sexual in nature prior to meeting Maxwell and had been married for 14 years, and had been with my husband for 17 years, and had four children under 13 years of age. 





"American copper" - When I was interacting with Zac /online dating site / Plenty of Fish - refer to file

Phone text message from Paul Gardner after 000 call to the Port Pirie Police Department reporting the threat of prostitution and 2 officers attending to the call in my place of residence [REDACTED] "The answers staring at you in the face"

"I use to be a conman"

"I buy phone numbers"

"I buy number plates" - Refer to document - number plate given to me by Paul Gardner, Port Germain

\* "I was involved in Prostitution as a child, I was born into it" \*

\* "I could get \$200.00 for you on the market" "You know, hooking"

I was disgusted by this comment and thought that Paul Gardner must have been joking as he had a immature sense of humour and walked away from him at this point - It was said to me at the Port Germain Hotel when we went out to dine. Paul Gardner said that he was only joking and apologised. - Refer to unusual comment government and prostitution making the most money from your sons / threatening behaviour

Probing the subject / suspicious

\* I was probing the subject of prostitution after these comments were made by Paul Gardner suspicious of his comments and wether he had been actually joking / starting to become fearful. When probed for answers Paul Gardner replied :

\* "I will put it to my dad" - Roger Gardner, Queensland

I week later Paul Gardner replied:

\* "Dad said yes, government approved, Howard approved it" - John Howard, Australian \*

\* Government \*

One month later:

\* "Your saved for prostitution by the government and I make the most money from your \*

\* sons" - Attempted entrapment after this comment was made

Bill Clinton lauded Epstein as "a committed philanthropist" with "insights and generosity".<sup>[243]</sup> At the time Epstein was on the board of Rockefeller University, a member of the Trilateral Commission and the Council on Foreign Relations, and was a major donor to Harvard University.<sup>[32]</sup>


Epstein visited the White House while Clinton was president on four known occasions.<sup>[244]</sup> In 1993, he went to a donor event at the White House with his companion Ghislaine Maxwell. Around the same time, he also met with President Clinton's aide Mark Middleton on at least three occasions at the White House. In 1995, financier Lynn Forester discussed "Jeffrey Epstein and currency stabilization" with Clinton.<sup>[244]</sup> Epstein, according to his own accounts, was heavily involved in the foreign exchange market and traded large amounts of currency in the unregulated forex market.<sup>[30][32]</sup> In 1995, Epstein also attended a small political fundraiser dinner for Bill Clinton which included 14 other people including Ron Perelman, Don Johnson, Jimmy Buffett, and dinner organizer Paul Proserpi.<sup>[245]</sup>

From the 1990s to mid-2000s, Epstein often socialized with the future President Donald Trump.<sup>[246]</sup> Author Michael Wolff wrote that Trump, Epstein, and Tom Barrack were at the time like a "set of nightlife musketeers" on the social scene.<sup>[6][247]</sup> Epstein and Trump socialized both in New York City and Palm Beach, where they both had houses.<sup>[234][246]</sup> In April 2003, *New York* magazine reported Epstein hosted a dinner party in his Manhattan residence to honor Bill Clinton, who did not attend, although Trump did attend.<sup>[248]</sup> According to *The Washington Post*, one person who knew Epstein and Trump during this time noted that "they were tight" and "they were each other's wingmen". In November 2004, Epstein and Trump's friendship ran into trouble when they became embroiled in a bidding war for a \$40 million mansion, Maison de L'Amitie, which was being auctioned in Palm Beach. Trump won the auction for \$41 million, and successfully sold the property four years later for \$95 million to the Russian billionaire Dmitry Rybolovlev. That month was the last time Epstein and Trump were recorded to have interacted.<sup>[223]</sup>

## Wealth

The exact origin of Epstein's wealth is unknown.<sup>[249]</sup> Leslie Wexner was one source of Epstein's original wealth.<sup>[249]</sup> An assistant of Epstein also stated that he got his fortune started through Robert Maxwell, the media mogul father of Ghislaine Maxwell.<sup>[250][251]</sup>

When Epstein pleaded guilty in 2008 to soliciting and procuring prostitution, his lawyers stated he was a billionaire with a net worth of over one billion dollars.<sup>[249]</sup> A number of sources, however, have questioned the extent of Epstein's wealth and his status as a billionaire. According to an article in *The New York Times*, his "fortune may be more illusion than fact". Epstein lost "large sums of money" in the 2008 financial crisis, and "friends and patrons"—including retail billionaire Leslie Wexner, "deserted him" following his pleading guilty to prostitution charges in 2008.<sup>[56]</sup> *New York* magazine claimed that "there's scant proof" of Epstein's "financial bona fides",<sup>[249]</sup> and *Forbes* also ran an article entitled "Why sex offender Jeffrey Epstein is not a billionaire".<sup>[252]</sup>

Spencer Kuvin, an attorney for three of Epstein's alleged victims in the case where Epstein pleaded guilty to sexual activity with minors, stated that "he and his team 'pursued every possible angle' to find out Epstein's net worth but found that much of his wealth is offshore."<sup>[252]</sup> An investigation by the *Miami Herald* of the Swiss Leaks documents indicated that Epstein had multiple financial accounts with millions of dollars in offshore tax havens. In the Paradise Papers, records showed

At least 26 women, including his first wife, have publicly accused Trump of rape, kissing and groping without consent, looking under women's skirts, or walking in on naked teenage pageant contestants.<sup>[803][804][805]</sup> In 2016, he denied all accusations, calling them "false smears" and alleging a conspiracy against him and the American people.<sup>[806]</sup>

## Incitement of violence

Research suggests Trump's rhetoric caused an increased incidence of hate crimes.<sup>[807][808]</sup> During his 2016 campaign, he urged or praised physical attacks against protesters or reporters.<sup>[809][810]</sup> Numerous defendants investigated or prosecuted for violent acts and hate crimes, including participants of the January 6, 2021, storming of the U.S. Capitol, cited Trump's rhetoric in arguing that they were not culpable or should receive a lighter sentence.<sup>[811][812]</sup> A nationwide review by ABC News in May 2020 identified at least 54 criminal cases from August 2015 to April 2020 in which Trump was invoked in direct connection with violence or threats of violence mostly by white men and primarily against members of minority groups.<sup>[813]</sup>

## Popular culture

Trump has been the subject of parody, comedy, and caricature on television, in movies, and in comics. Trump was named in hundreds of hip hop songs since the 1980s, mostly positive. Mentions turned largely negative and pejorative after he began running for office in 2015.<sup>[814]</sup>



## Relationship with Jeffrey Epstein

Accounts differ on when Maxwell first met American financier Jeffrey Epstein. According to Epstein's former business partner, Steven Hoffenberg, Robert Maxwell introduced his daughter to Epstein in the late 1980s.<sup>[49]</sup> *The Times* reported that Maxwell met Epstein in the early 1990s at a New York party following "a difficult break-up with Count Gianfranco Cicogna Mozzoni" (1962–2012) of the CIGA Hotels clan.<sup>[50]</sup>

Maxwell had a romantic relationship with Epstein for several years in the early 1990s and remained closely associated with him for more than 25 years until his death in 2019.<sup>[22][48][51]</sup> The nature of their relationship remains unclear. In a 2009 deposition, several of Epstein's household employees testified that Epstein referred to her as his "main girlfriend" who also hired, fired, and supervised his staff, starting around 1992.<sup>[52]</sup> She has also been referred to as the "Lady of the House" by Epstein's staff and as his "aggressive assistant".<sup>[53]</sup> In a 2003 *Vanity Fair* profile on Epstein, author Vicky Ward said Epstein referred to Maxwell as "my best friend".<sup>[54]</sup> Ward also observed that Maxwell seemed "to organize much of his life".<sup>[54]</sup>

Politico reported that Maxwell and Epstein had friendships with several prominent individuals in elite circles of politics, academia, business and law, including former Presidents Donald Trump and Bill Clinton, attorney Alan Dershowitz, and Prince Andrew, Duke of York.<sup>[55]</sup>

Maxwell is known for her longstanding friendship<sup>[56]</sup> with Prince Andrew, and for having escorted him to a "hookers and pimps" social function in New York.<sup>[57]</sup> She introduced Epstein to Prince Andrew, and the three often socialised together.<sup>[58]</sup> In 2000, Maxwell and Epstein attended a party thrown by Prince Andrew at the Queen's Sandringham House estate in Norfolk, England, reportedly for Maxwell's 39th birthday.<sup>[59]</sup> In a November 2019 interview with the BBC, Prince Andrew confirmed that Maxwell and Epstein had attended an event at his invitation, but he denied that it was anything more than a "straightforward shooting weekend".<sup>[60]</sup>

In 1995, Epstein renamed one of his companies the Ghislaine Corporation; based in Palm Beach, Florida, the company was dissolved in 1998.<sup>[52]</sup> As a trained helicopter pilot, Maxwell also transported Epstein to his private Caribbean island.<sup>[61][6]</sup>

In 2008, Epstein was convicted of soliciting a minor for prostitution and served 13 months of an 18-month jail sentence. Following Epstein's release, although Maxwell continued to attend prominent social functions, she and Epstein were no longer seen together publicly.<sup>[9]</sup>

By late 2015, Maxwell had largely retreated from attending social functions.<sup>[9][62]</sup>

## Civil cases and accusations

### Civil suits


█ v *Maxwell* (2015)

In 1975, he settled a 1973 Department of Justice lawsuit that alleged housing discrimination against black renters.<sup>[46]</sup> He has also been accused of racism for insisting a group of black and Latino teenagers were guilty of raping a white woman in the 1989 Central Park jogger case, even after they were exonerated by DNA evidence in 2002. As of 2019, he maintained this position.<sup>[774]</sup>

Trump relaunched his political career in 2011 as a leading proponent of "birther" conspiracy theories alleging that Barack Obama, the first black U.S. president, was not born in the United States.<sup>[775][776]</sup> In April 2011, Trump claimed credit for pressuring the White House to publish the "long-form" birth certificate, which he considered fraudulent, and later saying this made him "very popular".<sup>[777][778]</sup> In September 2016, amid pressure, he acknowledged that Obama was born in the U.S. and falsely claimed the rumors had been started by Hillary Clinton during her 2008 presidential campaign.<sup>[779]</sup> In 2017, he reportedly still expressed birther views in private.<sup>[780]</sup>

According to an analysis in *Political Science Quarterly*, Trump made "explicitly racist appeals to whites" during his 2016 presidential campaign.<sup>[781]</sup> In particular, his campaign launch speech drew widespread criticism for claiming Mexican immigrants were "bringing drugs, they're bringing crime, they're rapists".<sup>[782][783]</sup> His later comments about a Mexican-American judge presiding over a civil suit regarding Trump University were also criticized as racist.<sup>[784]</sup>

Trump's comments on the 2017 far-right rally in Charlottesville, Virginia, condemning "this egregious display of hatred, bigotry and violence on many sides" and stating that there were "very fine people on both sides", were widely criticized as implying a moral equivalence between the white supremacist demonstrators and the counter-protesters.<sup>[785][786][787][788]</sup>



Trump answers questions from reporters about the Unite the Right rally in Charlottesville.

In a January 2018 Oval Office meeting to discuss immigration legislation, Trump reportedly referred to El Salvador, Haiti, Honduras, and African nations as "shithole countries".<sup>[789]</sup> His remarks were condemned as racist.<sup>[790][791]</sup>

In July 2019, Trump tweeted that four Democratic congresswomen—all minorities, three of whom are native-born Americans—should "go back" to the countries they "came from".<sup>[792]</sup> Two days later the House of Representatives voted 240–187, mostly along party lines, to condemn his "racist comments".<sup>[793]</sup> White nationalist publications and social media sites praised his remarks, which continued over the following days.<sup>[794]</sup> Trump continued to make similar remarks during his 2020 campaign.<sup>[795]</sup>

## Misogyny and allegations of sexual misconduct

Trump has a history of insulting and belittling women when speaking to media and on social media.<sup>[796][797]</sup> He made lewd comments, demeaned women's looks, and called them names, such as 'dog', 'crazed', 'crying lowlife', 'face of a pig', or 'horseface'.<sup>[797][798][799]</sup>

In October 2016, two days before the second presidential debate, a 2005 "hot mic" recording surfaced in which Trump is heard bragging about kissing and groping women without their consent, saying "when you're a star, they let you do it, you can do anything... grab 'em by the pussy."<sup>[800]</sup> The incident's widespread media exposure led to Trump's first public apology during the campaign<sup>[801]</sup> and caused outrage across the political spectrum.<sup>[802]</sup>

Trump appointed three justices to the Supreme Court: Neil Gorsuch, Brett Kavanaugh, and Amy Coney Barrett. In 2016, Senate Republicans had taken the unprecedented step of refusing to consider Obama's nomination of Merrick Garland to fill the vacancy left by the death of Antonin Scalia in February 2016, arguing that the seat should not be filled in an election year. Gorsuch was confirmed to the seat in 2017 in a mostly party-line vote of 54–45, after Republicans invoked the "nuclear option" (a historic change to Senate rules removing the 60-vote threshold for advancing Supreme Court nominations) to defeat a Democratic filibuster.<sup>[458]</sup> Trump nominated Kavanaugh in 2018 to replace retiring Justice Anthony Kennedy; the Senate confirmed Kavanaugh in a mostly party-line vote of 50–48, after a bitter confirmation battle centered on Christine Blasey Ford's allegation that Kavanaugh had attempted to rape her when they were teenagers, which Kavanaugh denied.<sup>[459]</sup> Five weeks before the November 2020 election, Trump nominated Amy Coney Barrett to fill the vacancy left by the death of Justice Ruth Bader Ginsburg. Eight days before the election, after 60 million Americans had already voted, Senate Republicans confirmed Barrett to the Supreme Court without any Democratic votes. Many observers strongly criticized the confirmation, arguing that it was a gross violation of the precedent Republicans set in 2016.<sup>[460]</sup>

As president, Trump disparaged courts and judges whom he disagreed with, often in personal terms, and questioned the judiciary's constitutional authority. Trump's attacks on the courts have drawn rebukes from observers, including sitting federal judges, who are concerned about the effect of Trump's statements on the judicial independence and public confidence in the judiciary.<sup>[461][462][463]</sup>

## COVID-19 pandemic

In December 2019, COVID-19 erupted in Wuhan, China; the SARS-CoV-2 virus spread worldwide within weeks.<sup>[464][465]</sup> The first confirmed case in the U.S. was reported on January 20, 2020.<sup>[466]</sup> The outbreak was officially declared a public health emergency by Health and Human Services (HHS) Secretary Alex Azar on January 31, 2020.<sup>[467]</sup>

Trump's public statements on COVID-19 were at odds with his private statements. In February 2020 Trump publicly asserted that the outbreak in the U.S. was less deadly than influenza, was "very much under control", and would soon be over.<sup>[468]</sup> At the same time he acknowledged the opposite in a private conversation with Bob Woodward. In March 2020, Trump privately told Woodward that he was deliberately "playing it down" in public so as not to create panic.<sup>[469][470]</sup>

## Initial response

Trump was slow to address the spread of the disease, initially dismissing the imminent threat and ignoring persistent public health warnings and calls for action from health officials within his administration and Secretary Azar.<sup>[471][472]</sup> Instead, throughout January and February he focused on economic and political considerations of the outbreak.<sup>[473]</sup> By mid-March, most global financial markets had severely contracted in response to the emerging pandemic.<sup>[474]</sup> Trump continued to claim that a vaccine was months away, although HHS and Centers for Disease Control and Prevention (CDC) officials had repeatedly told him that vaccine development would take 12–18 months.<sup>[475]</sup> Trump also falsely claimed that "anybody that wants a test can get a test," despite the availability of tests being severely limited.<sup>[476]</sup>

During his premiership Olsen had overseen the privatisation of South Australia's electricity system, the outsourcing of its water industry, and a number of development projects intended to boost the state's ailing economy. The citation for his appointment as an Officer of the Order of Australia in January 2007 reads in part: - 200

After the election, Marshall continued to lead the Liberals in opposition.<sup>[20]</sup> Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.<sup>[21]</sup> Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.<sup>[22]</sup>

2018 state election - \*OLSEN - STEVEN MARSHALL\*

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.<sup>[23]</sup> The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.<sup>[24][25][26]</sup> At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former \*Senator Nick Xenophon\*, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election.

\*JOHN OLSEN - KADINA - COMMENCEMENT OF TARGETING\*

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. \*Marshall\* was introduced to the election day function by former \*Liberal Premier John Olsen\* and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.<sup>[27][28][29][30]</sup> Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.<sup>[31]</sup>

\*CONNECTED TO STEVEN MARSHALL\* - CONSPIRING AGAINST TARGETED VICTIM IN 2020 WITH VICKIE CHAPMAN, SA ATTORNEY GENERAL. Premier of South Australia

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.<sup>[32]</sup> The full ministry was sworn in on 22 March.<sup>[33]</sup> In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.<sup>[34]</sup>

**John Winston Howard** OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to 2007, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal–National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the Howard Government was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

Contrary to his claims of financial health and business acumen, Trump's tax returns from 1985 to 1994 show net losses totaling \$1.17 billion. The losses were higher than those of almost every other American taxpayer. The losses in 1990 and 1991, more than \$250 million each year, were more than double those of the nearest losers. In 1995, his reported losses were \$915.7 million.<sup>[42][43]</sup>

Over twenty years, Trump lost hundreds of millions of dollars and deferred declaring \$287 million in forgiven debt as taxable income. His income mainly came from his share in *The Apprentice* and businesses in which he was a minority partner, and his losses mainly from majority-owned businesses. Much income was in tax credits for his losses, which let him avoid annual income tax payments or lowered them to \$750. In the last decade, he balanced his businesses' losses by selling and borrowing against assets, including a \$100 million mortgage on Trump Tower (due in 2022) and the liquidation of over \$200 million in stocks and bonds. He personally guaranteed \$421 million in debt, most of which is due by 2024.<sup>[44]</sup>

As of October 2020, Trump has over \$1 billion in debts, secured by his assets. He owed \$640 million to banks and trust organizations, including Deutsche Bank, UBS, and Bank of China, and approximately \$450 million to unknown creditors. The value of his assets exceeds his debt.<sup>[45]</sup>

Starting in 1968, Trump was employed at his father Fred's real estate company, Trump Management, which owned middle-class rental housing in New York City's outer boroughs.<sup>[46][47]</sup> In 1971, he became president of the company and began using The Trump Organization as an umbrella brand.<sup>[48]</sup>


### Manhattan developments

Trump attracted public attention in 1978 with the launch of his family's first Manhattan venture, the renovation of the derelict Commodore Hotel, adjacent to Grand Central Terminal. The financing was facilitated by a \$400 million city property tax abatement arranged by Fred Trump<sup>[49]</sup> who also, jointly with Hyatt, guaranteed a \$70 million in bank construction financing.<sup>[50]</sup> The hotel reopened in 1980 as the Grand Hyatt Hotel,<sup>[51]</sup> and that same year, Trump obtained rights to develop Trump Tower, a mixed-use skyscraper in Midtown Manhattan.<sup>[52]</sup> The building houses the headquarters of the Trump Corporation and Trump's PAC and was Trump's primary residence until 2019.<sup>[53][54]</sup>

In 1988, Trump acquired the Plaza Hotel in Manhattan with a loan of \$425 million from a consortium of banks. Two years later, the hotel filed for bankruptcy protection, and a reorganization plan was approved in 1992.<sup>[55]</sup> In 1995, Trump sold the Plaza Hotel along with
