

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

**Victims' rights: Jane Does v. United States (2014)**

SEXUAL ABUSE RING  
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of Two Jane Does v. United States, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

**Virginia Giuffre v. Epstein (2015)**

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> Giuffre filed a defamation suit against Dershowitz,

**John Winston Howard** OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to \*2007\*, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the \*Howard Government was re-elected at the 1998\*, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

**Sarah Ransome v. Epstein and Maxwell (2017)**

In 2017, Sarah Ransome filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.<sup>[161][20][162]</sup>

### **Bradley Edwards' defamation v. Epstein (2018)**

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential.<sup>[137][163]</sup>



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

### **Maria Farmer v. Epstein and Maxwell (2019)**

TARGETED VICTIM - FIRST SEXUAL TARGETING - POLICE OFFICER - 16 YRS OLD - KADINA  
On April 16, 2019, Maria Farmer went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. Farmer met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted.<sup>[164]</sup> Farmer reported the incident to the New York City Police Department and the FBI.<sup>[165]</sup>

Farmer's affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table.<sup>[166]</sup>

### **Jennifer Araoz v. Epstein and Maxwell (2019)**

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by Jennifer Araoz.<sup>[167]</sup> She stated that an associate for Epstein had recruited her outside Talent Unlimited High School at age 14 and she was gradually groomed for over a year before Epstein raped her in his New York City mansion when she was 15.<sup>[168]</sup> Araoz filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place.<sup>[169]</sup> In October 2019, Araoz amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and Kimberly Espinosa as enablers.<sup>[170]</sup>

### **Katlyn Doe, et al. v. Epstein's estate (2019)**

Jane Doe v. Maxwell and Epstein's estate (2020)

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse<sup>[181]</sup> The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.<sup>[181]</sup>

Jane Does v. Epstein estate (2020)

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.<sup>[182]</sup>

Jane Doe v. Epstein estate (2020)

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.<sup>[183]</sup>

Jane Doe v. Epstein estate (2021)

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.<sup>[184]</sup>

**Trafficking charges**

On July 6, 2019, Epstein was arrested by the FBI-NYPD Crimes Against Children Task Force at Teterboro Airport in New Jersey on sex trafficking charges.<sup>[27][185][186][187]</sup> He was jailed at the Metropolitan Correctional Center in New York City, which has held prisoners such as John Gotti, Joaquin "El Chapo" Guzman, and Paul Manafort.<sup>[188][189]</sup>

According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds - and perhaps thousands - of sexually suggestive photographs of fully - or partially - nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: \*Young [Name] + [Name]\*, \*Misc nudes 1\*, and \*Girl pics nude\*.<sup>[90]</sup> Also found in the safe were \$70,000 in cash, 48 diamonds,<sup>[190]</sup> and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. Thank you for your letter of 31 August 2012 about establishing a specialist medical centre at Port Pirie and offering to provide the business plans and research information collected throughout your project.

I asked Adjunct Professor Belinda Moyes, Chief Executive Officer, Country Health SA - Local Health Network (CHSA), who is responsible for Port Pirie Regional Health Service (PPRHS), to consider your offer and I am advised as follows:

*As Ms [REDACTED] may be aware, the PPRHS already provides consulting room facilities for some specialties identified through consultation with the local general practitioners.*

*In these instances, PPRHS pays the travel allowance and provides hospital accommodation for visiting specialists providing medical inpatient services.*

*PPRHS also distributes monthly information to all doctors and health units within the town and surrounding area of the specialists' visiting dates and the waiting times to see new patients.*

\* The completed Port Pirie GP Plus Health Care Centre, scheduled for September 2013, will also have capacity to provide additional consulting space, if needed. The nature of what additional medical services may be required is yet to be determined.

The Port Pirie Health Advisory Council has undertaken a 10 year planning process, and is now engaging the local general practitioner in planning how to shape medical services into the future.\*

*If Ms [REDACTED] would like to have input into the development of the Port Pirie GP Plus Health Care Centre, there is a consumer group that she may wish to join. Residents of Port Augusta and Mount Gambier will now be able to access up-to-date information about the amount of people being treated in their local public hospitals.


The Country Health SA Local Health Network (CHSALHN) launched inpatient dashboards for Port Augusta and Mount Gambier Hospitals following the successful release of the metropolitan data earlier this year.

Professor Belinda Moyes, Chief Executive Officer CHSA LHN said the inpatient dashboards provide country residents with an opportunity to learn more about how their hospitals are managed.

"The inpatient dashboard provides detailed information on the number of inpatients at each hospital at any one time," Professor Moyes said.

"South Australia was the first state in the country to make this level of information available to the public and we are excited to extend this technology to country residents."

"Through the dashboard the general public can gain a better understanding about how patient flow is managed in our busy hospital environments."



## How to interpret this chart

This table shows a summary of the status of all inpatient beds in the Port Augusta Hospital (PAHS).

In an online environment, you can click on the chosen hospital in the table and the whole dashboard will update to show data specific to that hospital.

The dashboard displays occupancy per hospital split across 'general' beds and 'all' beds, breakdown of inpatients, the length of stay, and much more.

Professor Moyes said the dashboard, which is available online, will be updated every 30 minutes to provide real-time information about bed occupancy, average length of stay and inpatient flows.

"The dashboard also includes information specific to each hospital about the number of patients currently within each area or clinical unit at the hospital," Professor Moyes said.

"It allows people to easily see all of the different 'streams' of inpatient care that each hospital provides, such as surgical or pediatrics, and the status of each of these areas."

"Staff already use the dashboard, along with a range of other tools, to help monitor and manage capacity and ensure that patient safety is maintained."

"By releasing this data publicly we are continuing to make our health system more transparent."



The Building the Education Revolution program rolled out 23,670 school projects around Australia representing a completion rate of 92 per cent.<sup>[124]</sup> However, claims of overpricing and poor value for money in some projects resulted in a taskforce being established to examine the implementation of the scheme, led by Brad Orgill, the former CEO of UBS Australasia. Only 3% of complaints about the scheme were upheld, and most projects were found to have been good value for money.<sup>[125]</sup>

In early 2009,<sup>[126]</sup> in the wake of the global financial crisis,<sup>[127]</sup> Rudd stated "that the great neo-liberal experiment of the past 30 years has failed", and that "Neo-liberalism and the free-market fundamentalism it has produced has been revealed as little more than personal greed dressed up as an economic philosophy. And, ironically, it now falls to social democracy to prevent liberal capitalism from cannibalising itself." Rudd called for a new era of "social capitalism" from social democrats such as himself and US President Barack Obama to "support a global financial system that properly balances private incentive with public responsibility".<sup>[128]</sup> The Center for Strategic and International Studies has acknowledged Kevin Rudd as one of the founders of the G20 that helped prevent a second global depression.<sup>[129]</sup>

The Rudd Government's third budget in 2010 projected a \$40.8 billion deficit for 2010–11<sup>[130]</sup> but forecast that Australia would return to surplus by 2012–13. The government proposed a "super profits" tax on the mining industry and included \$12 billion in revenue from the proposal in the forecast, although the tax had not been passed by the Senate.<sup>[131]</sup>

In February 2008 Rudd announced the Australia 2020 Summit, held from 19–20 April 2008, which brought together 1000 leading Australians to discuss ten major areas of policy innovation.<sup>[132]</sup> Among the initiatives supported at the event, the summit voted in favour of a plebiscite on Australia "relinquishing ties" to the United Kingdom followed by a referendum on the model for an Australian republic,<sup>[133]</sup> a bill of rights, the re-formation of an Indigenous peak representative body similar to ATSIC, (which had been abolished by the Howard Government), the introduction of an Emissions Trading Scheme and a National Disability Insurance Scheme, and a review of the taxation system.<sup>[134]</sup>

Findings released in April 2009 reported that nine out of the 1000 submitted ideas were to be immediately enacted and that the government was deliberating on other ideas proposed.<sup>[135]</sup> By mid-2010, among the key reform ideas suggested, Prime Minister Rudd had sought to introduce an ETS, but postponed it after failing to secure passage through the senate;<sup>[136]</sup> formed a consultative committee on a Bill of rights then rejected its recommendation for implementation;<sup>[137]</sup> established the National Congress of Australia's First Peoples in 2010;<sup>[138]</sup> commissioned the Henry Review of taxation (on the basis of which the Rudd Government proposed a new "super-profits" tax on mining);<sup>[139]</sup> and Rudd had described the issue of a vote on a republic as not being "a priority".<sup>[140]</sup>

In early 2011 Rann reshuffled his cabinet after Deputy Premier and Treasurer Kevin Foley resigned from both positions but remained in the cabinet. Attorney-General John Rau became Deputy Premier and Jack Snelling became Treasurer.<sup>[43]</sup> - 2016 COVER UP - CONSPIRED - INTELLECTUAL PROPERTY THEFT - 2006 - 2012 MED BCS ALIEN.

The first Newspoll of the third term of the Rann Labor government in March 2011 showed Rann's personal satisfaction-dissatisfaction rating at a new low of 30–59 and a two-party vote of 44–56, a swing against Labor of 4.4 percent since the 2010 election. Labor's primary vote dived to 29 percent, down 8.5 percent, the Liberal vote remained at 42 percent, whilst the Greens surged to 14 percent, an increase of 6 percent, with "other" slightly higher. The subsequent Newspoll saw the two-party vote narrow to 46–54, a swing against Labor of just 2.4 percent, however there was no statistical change in Rann's personal satisfaction-dissatisfaction ratings.

In late July 2011, the Australian Broadcasting Corporation (ABC) and The Advertiser reported that senior figures within Labor had indicated to Rann that the state party's left and right factions had formally decided to replace Rann with Education Minister Jay Weatherill as party leader. A day later, Rann confirmed he would stand down and undergo a party leadership transition to Weatherill, with the handover occurring in October 2011.<sup>[44][45][46][47][48]</sup>

Rann formally resigned from the premiership on 21 October 2011, and Weatherill was elected unopposed as his successor.<sup>[49]</sup>

Rann resigned from parliament on 13 January 2012 which created an 11 February 2012 Ramsay by-election. Zoe Bettison easily retained the seat for Labor with only a slight swing against her, and

Ramsay remained the safest of Labor's lower house seats.<sup>[50][51][52]</sup>

## Post-parliamentary career

Rann's post-parliamentary appointments include the new Urban Policy Forum created by the federal government, as a professor in the School of Social and Policy Studies with Flinders University and as a visiting fellowship in political studies at the University of Auckland. He has also joined the International Leadership Council of The Climate Group, and the International Advisory Board of the Ecological Sequestration Trust.<sup>[53][54][55]</sup> Rann was also appointed adjunct professor in public policy at Carnegie Mellon University, Fellow for Democracy and Development at the Washington, D.C.-based Center for National Policy and as member of the Council of the Royal Institution Australia.<sup>[56]</sup>

Rann was appointed chair of Low Carbon Australia Pty Ltd in early 2012, the federal government's "green bank" providing finance to companies to reduce carbon emissions.<sup>[57]</sup> and to the International Leadership Council of The Climate Group.<sup>[58]</sup>

Rann was announced on 23 August 2012 as the next Australian High Commissioner to the United Kingdom.<sup>[59][60][61]</sup> Rann also assumed the role of Permanent Representative to the United Nations International Maritime Organisation, Commonwealth War Graves Commissioner and Trustee of the Imperial War Museum.<sup>[56]</sup> Mike Rann acted as Australia's Ambassador to Italy, San Marino, Albania and Libya. He is also Australia's Permanent Representative to the United Nation's Food and Agriculture Organization and World Food Programme. - 2019 VINCENT BULONE 12 MILLION AUD GRANT.

As of 2020, he works as a business consultant for the Rann Strategy Group.<sup>[62]</sup>

I was contacted on the 21st may 2021 by Officer Leong, stating that she was from Services SA on the phone number [REDACTED]. During this phone contact I was informed that the phone call was being Recorded and the information given was not to be shared with a third party during the recorded phone call. Officer Leong (woman) informed me of the issue of suspected Identity Theft (my Identity) which involved numerous bank accounts being opened in my Identity and being used for Illegal purposes of Drug Trafficking, Money Laundering, Money Transfers to a corporation, Fraudulent Activity and were operating in numerous locations, from recalled memory being Queensland, ANZ, NAB, as some of the numerous accounts, and involved over 1 million dollars illegally rotating through the bank accounts. I informed Officer Leong that the accounts were set up by the Commonwealth Bank Manager, Paul Flavel, Kadina and could be confirmed by Paul Flavel, Manager.

Following providing my bank account details I informed Officer Leong that this was a case of Identity Theft. Officer Leong agreed with me on the case of Identity Theft and informed me that the case would be referred to Federal Agencies - Federal Police.- Legal Investigation. \*

Officer Leong then informed me that my bank accounts and Tax file number would not be subjected to a suspension and the case would be referred to the Federal agencies for a thorough investigation and I was not instigated in the illegal activity that had occurred because of the Identity Theft - Legal Investigation. I was informed by Officer Leong that the details would be sent to me via email services.

\* I have not received an email from Officer Leong concerning this matter and contact.

Currently my email service registered under a business registration with GoDaddy is under investigation for email hacking and Malicious Activity that has been reported by myself and occurring in 2020 - 2021.

As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation



Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

### Victims' rights: *Jane Does v. United States* (2014)

SEXUAL ABUSE RING  
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

### *Virginia Giuffre v. Epstein* (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> Giuffre filed a defamation suit against Dershowitz,

\* "Dad said yes, government approved, Howard approved it" - John Howard, Australian Government \*

\* "Your saved for prostitution by the government and I make the most money from your sons" - Attempted entrapment after this comment was made

Gates is an avid reader, and the ceiling of his large home library is engraved with a quotation from *The Great Gatsby*.<sup>[187]</sup> He also enjoys bridge, tennis and golf.<sup>[188][189]</sup> His days are planned for him on a minute-by-minute basis, similarly to the U.S. president's schedule.<sup>[190]</sup> Despite his wealth and extensive business travel, Gates flew coach (economy class) in commercial aircraft until 1997, when he bought a private jet.<sup>[191]</sup>

Gates purchased the Codex Leicester, a collection of scientific writings by Leonardo da Vinci, for US\$30.8 million at an auction in 1994.<sup>[192]</sup> In 1998, he reportedly paid \$30 million for the original 1885 maritime painting Lost on the Grand Banks, at the time a record price for an American painting.<sup>[193]</sup>

In 2016, he revealed that he was color-blind.<sup>[194]</sup>

## Marriage and divorce

Gates married Melinda French on the Hawaiian Island of Lanai on January 1, 1994.<sup>[195]</sup> They met in 1987 after Melinda began working at Microsoft.<sup>[196]</sup> At the time of their marriage, Gates was given permission by Melinda to spend limited time with his ex-girlfriend, businesswoman Ann Winblad.<sup>[197]</sup> Bill and Melinda have three children: Jennifer, Rory and Phoebe.<sup>[198]</sup> The family's residence is an earth-sheltered mansion in the side of a hill overlooking Lake Washington in Medina, Washington. In 2009, property taxes on the mansion were reported to be US\$1.063 million, on a total assessed value of US\$147.5 million.<sup>[199]</sup> The 66,000-square-foot (6,100 m<sup>2</sup>) estate has a 60-foot (18 m) swimming pool with an underwater music system, as well as a 2,500-square-foot (230 m<sup>2</sup>) gym and a 1,000-square-foot (93 m<sup>2</sup>) dining room.<sup>[200]</sup> On May 3, 2021, the Gateses announced they had decided to divorce after 27 years of marriage and 34 years as a couple.<sup>[201]</sup> They said they would keep working together on charitable efforts.<sup>[201][202]</sup> *The Wall Street Journal* reported that Melinda had been meeting with divorce attorneys since 2019, citing interviews that suggested Bill's ties with Jeffrey Epstein was at least one of her concerns.<sup>[203]</sup> The divorce was finalized on August 2, 2021.<sup>[204]</sup>

Thank you for your recent enquiry, and we are sorry to hear how this is affecting you.

### eSafety and Adult Cyber Abuse

The eSafety Commissioner's (eSafety's) primary role in dealing with cyberbullying complaints is to assist with the rapid removal of cyberbullying material targeted at Australian children, on social media services.

Please be aware that eSafety, therefore, has no legislative power to investigate adult cyber abuse complaints, formally. However, we do work to guide people where we can and provide advice on what they can do themselves.

In the most serious cases, we will use our existing relationships and escalation pathways with social media services to effect take-down of harmful material that is considered to be serious cyber abuse in nature or, where required, we will refer the matter to law enforcement.

Officer Leong (woman) informed me of the issue of suspected Identity Theft (my Identity) which involved numerous bank accounts being opened in my Identity and being used for Illegal purposes of Drug Trafficking, Money Laundering, Money Transfers to a corporation, Fraudulent Activity and were operating in numerous locations, from recalled memory being Queensland, ANZ, NAB, as some of the numerous accounts, and involved over 1 million dollars illegally rotating through the bank accounts. I was informed that my Tax file number was being Illegally misused in Australia and that my bank accounts and tax file number would be suspended.

I was asked to provide the details of my banking institutions and the balances of the bank accounts in my name. I have not received an email from Officer Leong concerning this matter and contact.

Currently my email service registered under a business registration with GoDaddy is under investigation for email hacking and Malicious Activity that has been reported by myself and occurring in 2020 - 2021. As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation


**John Winston Howard** OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to *\*2007*, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the *\* Howard Government was re-elected at the 1998, 2001 and 2004 elections.* Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the *\*2007 federal election, with the Labor Party's Kevin Rudd succeeding him* as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

only canceled her Liberal endorsement, but declared she would not be allowed to sit as a Liberal if elected.<sup>[69]</sup> Howard repudiated Hanson's views seven months after her maiden speech.<sup>[68]</sup>

Following the Wik Decision of the High Court in 1996, the Howard government moved swiftly to legislate limitations on its possible implications through the so-called Ten-Point Plan.

From 1997, Howard spearheaded the Coalition push to introduce a Goods and Services Tax (GST) at the subsequent election. Before winning the prime ministership, Howard said that he considered the Coalition's defeat in 1993 to be a rejection of the GST, and as a result it would "never ever" be part of Coalition policy.<sup>[70]</sup> A long-held conviction of Howard's, his tax reform package was credited with "breaking the circuit" of party morale—boosting his confidence and direction, which had appeared to wane early in the Government's second term.<sup>[71]</sup> The 1998 election was dubbed a "referendum on the GST", and the tax changes—including the GST—were implemented in the government's second term after amendments to the legislation were negotiated with the Australian Democrats to ensure its passage through the Senate.<sup>[72]</sup>

Through much of its first term, opinion polling was disappointing for the government.<sup>[73][74][75]</sup> The popularity of Pauline Hanson, and the new restrictions on gun ownership drew many traditionally Coalition voters away from the Howard government. Also unpopular with voters were large spending cuts aimed at eliminating the budget deficit (and Howard's distinction between "core" and "non-core" election promises when cutting spending commitments), industrial changes and the 1998 waterfront dispute, the partial sale of government telecommunications company Telstra, and the Government's commitment to a GST.<sup>[76]</sup>

Howard called a snap election for October 1998, three months sooner than required. The Coalition actually lost the national two-party preferred vote to Labor, suffering a 14-seat swing. However, the uneven nature of the swing allowed Howard to win a second term in government, with a considerably reduced majority (from 45 seats to 12). Howard himself finished just short of a majority on the first count in his own seat, and was only assured of reelection on the ninth count. He ultimately finished with a fairly comfortable 56 percent of the two-party preferred vote.<sup>[72]</sup>

## Second term, 1998–2001

In 1998, Howard convened a Constitutional Convention which decided in principle that Australia should become a Republic. At the convention Howard confirmed himself as a monarchist, and said that of the Republican options, he preferred the minimalist model. Howard outlined his support for retaining the Australian constitutional monarchy.<sup>[77]</sup> Despite opinion polls suggesting Australians favoured a republic, a 1999 referendum rejected the model chosen by the convention.<sup>[78]</sup>

Although new Indonesian President B.J. Habibie had some months earlier agreed to grant special autonomy to Indonesian-occupied East Timor, his subsequent snap decision for a referendum on the territory's independence triggered a Howard and Downer orchestrated shift in Australian policy. In September 1999, Howard organised an Australian-led international peace-keeping force to East Timor (INTERFET), after pro-Indonesia militia launched a violent "scorched-earth" campaign in retaliation to the referendum's overwhelming vote in favour of independence. The successful mission was widely supported by Australian voters, but the government was criticised for "foreign policy failure" following the violence and collapse of diplomatic relations with Indonesia. By Howard's fourth term, relations with Indonesia had recovered to include counter-

In January 2008, Howard signed with the speaking agency called the Washington Speakers Bureau, joining Tony Blair, Colin Powell, Madeleine Albright, and others. He was available for two speeches, *Leadership in the New Century* and *The Global Economic Future*.<sup>[127]</sup>

The Australian and New Zealand cricket boards unsuccessfully nominated Howard as their candidate for president of the International Cricket Council.<sup>[128]</sup> Howard was the chairman of the International Democrat Union, a body of international conservative political parties, until December 2014, when he was succeeded by John Key of New Zealand.<sup>[129]</sup> In 2008, he was appointed a director of the foundation established to preserve the legacy of Donald Bradman.<sup>[130]</sup>

Howard's autobiography *Lazarus Rising: A Personal and Political Autobiography* was released on 26 October 2010.<sup>[131]</sup>

In 2014 Howard published *The Menzies Era*, concerning the premiership of Prime Minister Robert Menzies.<sup>[132]</sup>

Howard was the subject of a lengthy interview series by *The Australian* columnist Janet Albrechtsen in 2014, which aired as a featured story on Seven Network's *Sunday Night*, and again in January 2015 as its own five-part series on Sky News Australia entitled *Howard Defined*.<sup>[133]</sup>

In November 2017, Howard launched the Ramsay Centre for Western Civilisation, headed by Simon Haines, formerly professor of English at the Chinese University of Hong Kong.<sup>[134][135]</sup>

In 2017, Howard endorsed a "No" vote in the Australian Marriage Law Postal Survey and joined the campaign against same-sex marriage.<sup>[136]</sup>

 In February 2019, Howard provided a character reference for Cardinal George Pell, a senior leader of the Catholic Church in Australia and former Vatican Treasurer, whose conviction on five counts of child sexual abuse while Archbishop of Melbourne was later overturned by the High Court.<sup>[137][138][139]</sup> Howard's character reference followed Pell's convictions, and was provided along with nine others<sup>[140]</sup> to support Pell's barrister's submissions in the pre-sentencing hearing.<sup>[141]</sup>

In October 2021, Howard endorsed Dominic Perrottet to succeed Gladys Berejiklian as Premier of New South Wales following Berejiklian's resignation as Premier.<sup>[142]</sup>

**Anthony John Abbott** AC (/ˈæbɒt/<sup>[3]</sup> born 4 November 1957) is an Australian former politician. He served as the 28th prime minister of Australia from 2013 to 2015, holding office as the leader of the Liberal Party of Australia.<sup>[4]</sup>

Abbott was born in London, England, to an Australian mother and a British father, and moved to Sydney at the age of two. He studied economics and law at the University of Sydney, and then attended The Queen's College, Oxford, as a Rhodes Scholar, studying Philosophy, Politics and Economics. After graduating from Oxford, Abbott briefly trained as a Roman Catholic seminarian, and later worked as a journalist, manager, and political adviser. In 1992, he was appointed director of Australians for Constitutional Monarchy, a position he held until his election to parliament as a member of parliament (MP) for the division of Warringah at the 1994 Warringah by-election.


After the 1998 election, Abbott was appointed Minister for Employment Services in the Second Howard Ministry. He was promoted to cabinet in 2001 as Minister for Employment, Workplace Relations and Small Business. In 2003, Abbott became Minister for Health and Ageing, retaining this position until the defeat of the Howard Government at the 2007 election. Initially serving in the shadow cabinets of Brendan Nelson and then Malcolm Turnbull, Abbott resigned from the front bench in November 2009, in protest against Turnbull's support for the Rudd Government's proposed Emissions Trading Scheme (ETS).<sup>[5]</sup> Forcing a leadership ballot on the subject, Abbott narrowly defeated Turnbull to become the party's leader and Leader of the Opposition.

Abbott led the Liberal-National Coalition going into the 2010 federal election, which resulted in a hung parliament, and a narrow victory for the Australian Labor Party (ALP).<sup>[6]</sup> Abbott remained as party leader, and led the Coalition to a landslide victory at the 2013 federal election, becoming prime minister. Upon assuming government, the Abbott Government introduced new border control measures known as Operation Sovereign Borders in an effort to stop illegal maritime arrivals,<sup>[7]</sup> and abolished the Minerals Resource Rent Tax and Australia's carbon pricing
