

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

### Victims' rights: *Jane Does v. United States* (2014) **SEXUAL ABUSE RING PREMINENT POSITIONS**

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government: the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

### *Virginia Giuffre v. Epstein* (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> Giuffre filed a defamation suit against Dershowitz,

**Non-prosecution agreement (NPA) (2006–2008)****DESTRUCTION OF CAREER  
TARGETED VICTIM 1993-2021**

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".<sup>[110]</sup> It resulted in a 53-page indictment in June 2007.<sup>[71]</sup> Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,<sup>[111]</sup> to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators". According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."<sup>[1]</sup>

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".<sup>[52][53][112]</sup> Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.<sup>[1][89]</sup> The plea deal was later described as a "sweetheart deal".<sup>[113]</sup>

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".<sup>[114][115]</sup>

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.<sup>[116]</sup>

**Conviction and sentencing (2008–2011)**

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,<sup>[117]</sup> he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.<sup>[100]</sup>

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade visitor logs were not).<sup>[118]</sup> He was allowed to use his own driver to drive him between jail and his office and other appointments.<sup>[100][118]</sup>

**\* JOHN WAYNE OLSEN - KADINA - SOURCE \***

A colourful backgrounder in the *Australian* on 29 November 1996, the day after he became Premier of South Australia, argued that there was a defining moment in Olsen's life when he was eighteen and with his father when the latter suffered a massive heart attack and died while driving the family speedboat. Other defining moments revolved around his fortunes as a state politician; his two years in the Senate rated barely a mention. State politics was clearly the main game for John Olsen. **CONNECTED TO AMERICA AND STEVEN MARSHALL, PREMIER OF SA.**

\* Born in Kadina in rural South Australia on 7 June 1945, Olsen was the son of Stanley John Olsen, owner of an agricultural machine and motor vehicle business, and his wife Joyce Rosalind, née Heath. He was educated at Kadina Memorial High School, studied accountancy at the South Australian School of Business Studies, spent a period from 1962 as a bank clerk with the SA Savings Bank, and by 1968 was managing director of the family business, J. R. Olsen & Sons Pty Ltd. His determination to be part of the political process and influence policy direction was inspired by what he saw as the need to address the neglect of small business interests under Don Dunstan, and 'the excesses of the Dunstan and Whitlam era'. Olsen became politically engaged first as \* president of South Australia's Rural Youth (1970) and later as a Kadina town councillor from 1971 and mayor of Kadina from 1974 to 1977. He was also South Australian president of the Federation of Chambers of Commerce from 1974 to 1976. In May 1968 he married Julie Abbott; they were to have two sons and a daughter. -1971

\* In 1976 Olsen was elected president of the South Australian division of the Liberal Party, an office which he held until 1979 when he was elected to the South Australian House of Assembly as the member for Rocky River; following a boundary redistribution in 1985 he became the member for Custance. Olsen served as Chief Secretary and Minister for Fisheries in the Tonkin Liberal Government from March 1982 until the ALP victory in the state election in November of that year. David Tonkin resigned from Parliament, and Olsen defeated Dean Brown in a ballot for leadership of the party. As Leader of the Opposition in the South Australian Parliament, he contested and lost the 1985 and 1989 state elections against Labor Premier John Bannon. Following the defeat of November 1989, in which his party obtained more than fifty per cent of the two-party preferred vote, Olsen indicated that he would accept nomination for the Senate vacancy to be caused by the impending resignation of Senator Tony Messner. He resigned as Leader in January 1990, and resigned his seat in the House of Assembly immediately before being chosen for the vacancy by a joint sitting of the Houses of the SA Parliament on 7 May 1990; he was sworn in the Senate on the following day.[1]

\* Olsen's first speech, delivered on 21 May 1990, called for increased unity for a 'fragmented and nervous nation'. He criticised the regulatory duplication that characterised federal and state administration of health, education and housing, and urged the restructuring of the economy through privatisation and the deregulation of financial and labour markets, to create an environment 'where freedom and incentive are the basics'.

He raised the issue of the maladministration of the Murray-Darling and the impact this was having on South Australia:

... the heart of Australia is being left to die. Its main artery is clogged with the salinity and pollution of the States through which it passes, with my State of South Australia ... condemned by a political inertia to being in effect the sewer of Australia.

And he addressed immigration issues, arguing that migrants should be encouraged to settle in places other than the east coast, that they should be obliged to become citizens, and to take English language courses.[2]

An experienced parliamentarian, during his brief time in the Senate Olsen made 'articulate and forceful, and, at times, emotional' contributions to debate. He spoke often on the state of the economy, particularly its effect on small business and rural communities, and referring frequently to the situation in his home state.

After the election, Marshall continued to lead the Liberals in opposition.<sup>[20]</sup> Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.<sup>[21]</sup> Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.<sup>[22]</sup>

2018 state election



The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.<sup>[23]</sup> The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.<sup>[24][25][26]</sup> At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election.

\*JOHN OLSEN - KADINA - COMMENCEMENT OF TARGETING\*

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.<sup>[27][28][29][30]</sup> Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.<sup>[31]</sup>

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.<sup>[32]</sup> The full ministry was sworn in on 22 March.<sup>[33]</sup> In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.<sup>[34]</sup>

I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint.

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling 1300 366 424 or (08) 8436 3555.

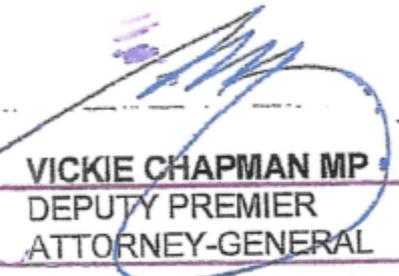
I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament. Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for raising your concerns with me.

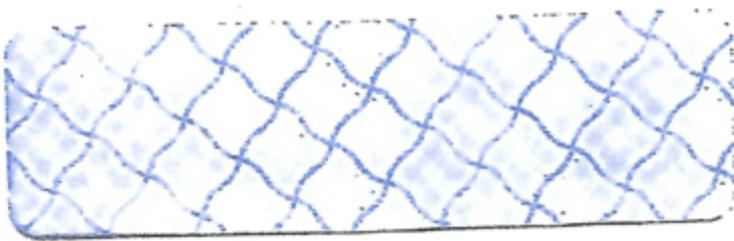
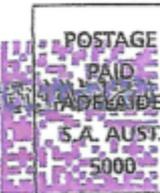

short her courses in Adelaide in 1982, and moved to Melbourne to work with the Australian Union of Students.<sup>[20]</sup> In 1983, she became the second woman to lead the Australian Union of Students, serving until the organisation's discontinuation in 1984. She was also the secretary of the left-wing organisation Socialist Forum.<sup>[21][22]</sup> Having transferred her studies to the University of Melbourne, Gillard graduated with a Bachelor of Laws degree in 1986 and a Bachelor of Arts degree in 1989.<sup>[23]</sup> In 1987, she joined the law firm Slater & Gordon in Werribee, Victoria, working in industrial law.<sup>[11]</sup> In 1990, she was admitted as a partner; at the age of 29, she was the youngest partner within the firm, and one of the first women to hold the position.<sup>[24][25]</sup>

## Early political involvement

From 1985 to 1989, Gillard served as President of the Carlton branch of the Labor Party.<sup>[6]</sup> She stood for Labor preselection in the Division of Melbourne prior to the 1993 federal election, but was defeated by Lindsay Tanner.<sup>[26]</sup> At the 1996 federal election, Gillard won the third position on Labor's Senate ticket in Victoria, behind Robert Ray and Barney Cooney.<sup>[27][28]</sup> However, on the final distribution of preferences she was defeated by Lyn Allison of the Australian Democrats.<sup>[29][30]</sup>

In 1996, Gillard resigned from her position with Slater & Gordon to serve as chief of staff to John Brumby, at that time the Leader of the Opposition in Victoria.<sup>[6][30][31]</sup> She was responsible for drafting the affirmative-action rules within the Labor Party in Victoria that set the target of pre-selecting women for 35 per cent of "winnable seats". She also played a role in the foundation of EMILY's List, the pro-choice fund-raising and support network for Labor women.<sup>[32]</sup>

Gillard has cited Welsh Labour politician Aneurin Bevan as one of her political heroes.<sup>[24]</sup>

## Member of Parliament (1998–2007)

Gillard was first elected to the House of Representatives at the 1998 federal election representing Lalor, a safe Labor seat near Melbourne, replacing Barry Jones who retired. She made her maiden speech to the House on 11 November 1998.<sup>[33]</sup> Gillard was a member of the standing committee for Employment, Education and Workplace Relations from 8 December 1998 to 8 December 2001, in addition to Aboriginal and Torres Strait Islander Affairs from 20 March 2003 to 18 August 2003. Within the joint committees, she was a member of the Public Accounts and Audit from 8 December 1998 to 11 February 2002, in addition to the Native Title and the Aboriginal and Torres Strait Islander Land Fund from 20 March 2003 to 11 August 2003.<sup>[6]</sup>

## Shadow Minister (2001–2007)

After Labor's defeat at the 2001 federal election, Gillard was elected to the Shadow Cabinet under then-Labor Leader Simon Crean, where she was given responsibility for Population and Immigration. In February 2003, she was given additional responsibilities for Reconciliation and Indigenous Affairs.<sup>[34]</sup> In these roles, in the wake of the Tampa and Children Overboard affairs, which were partly credited with Labor's 2001 election loss, Gillard developed a new immigration policy for the Labor Party.<sup>[13]</sup>

Gillard was later promoted to the position of Shadow Minister for Health and Deputy Manager of Opposition Business in the House (to Mark Latham) on 2 July 2003.<sup>[25][35]</sup> During this time, she shadowed Tony Abbott, with the rivalry between the two often attracting attention from the media.<sup>[36]</sup> She was later given additional responsibility for managing opposition business in the House of Representatives by Latham, who had succeeded Beazley as Labor Party leader.<sup>[37]</sup>

Dear Bruce Lander,

I would like to introduce myself, my name is [REDACTED] I was born an Australian citizen and have resided in Australia during my life time of 50 years.

I have obtained numerous qualifications, including Business Management, Business Administration, Business Development (Business Plan development), Fashion Design, Nail Technician, Published Author, author under contract with publishing house Austin Macauley Publishers, London, and have been involved in numerous community and council projects, Government developments and was a registered participant in the Flinders University, Adelaide Venture Dorm Program and a participant in the Eventbrite, Women in Business Organisation.

I have an extensive employment history, of which I gained valuable employment skills and opportunities to advance my directions in Business Development and creating my own paths, directions and to reach my goals of creating, developing and establishing my own business and businesses. I have a natural ability and Entrepreneurial qualities and skills, of which I wished to develop and establish myself in world of business.

Following surviving a Near Death Experience of a violent relationship at the age of 19, which resulted in PTSD, and an abusive marriage of 14 years, that resulted in a Restraining Order being placed on the Ex husband, I stepped out of the shadows of abuse at the age of 36 and set out to explore the opportunities of establishing a Professional career of Business Development.

At the age of 22, 1993 I gave birth to twin boys, my first born children, one of which suffered from severe reflux, which resulted in severe discomfort and crying in the middle of the night each time he would roll over onto his stomach in his sleep. Having obtained a Fashion Design degree at the age of 15 I set out to ease the discomfort of my infant son suffering from the reflux condition. I came up with a solution to the problem by designing and sewing an Infant Sleep Positioner, a sling that wrapped around my infant sons stomach, held in place by Velcro and straps that attached to the cots bars to secure his sleeping position, and stop him from rolling over onto his stomach. The infant Sleep Positioner , baby sleeping sling was a success and my son no longer suffered this discomfort and began to sleep through the night. At the time I was residing in Willimulka, South Australia in a small, isolated farm house with my Defacto partner, father of the children, who in 1996 became my husband.

This design, Infant Sleep Positioner was the first of my developments, which resulted in Intellectual Property Theft in the Privacy of my own Home.

Following my divorce of the marriage in 2007 I set out to achieve my Professional goals, of which I had been denied at age 14, a career in modelling and a University Degree in Medical Science, but had remained my focus, passion and aspirations of my ambitious goals throughout the years of my sacrifice of marriage and raising children.

As a single mother of 4 children from the marriage I began the journey of establishing a Professional Career and commenced on the continual development of a Business Plan that I had begun in 2006, prior to the end of my marriage. I enrolled in numerous courses to further develop my business qualifications and skills

and became a registered client of the Regional Development Board, Port Pirie, giving me access to Business Advisors, to further develop the Business Plan, and the goal of establishing my own business.

The Business Plan remained in Hand written form only, between the years of 2006 - 2009, while I conducted the extensive Market Research into the Medical Industry and communities to complete the Business Plans business infrastructure, objectives, progressive advancement and to secure Medical Professionals into the correct Professional structures of the business.

In 2009 the Business Plan was completed and installed on a newly purchased business computer, and the process of applying for funding and establishment of the business plan, The Specialist Medical Centre, involving the centralisation of Medical Specialists operating from within one centre began.

Within the Hand written form of the 2006 Business Plan of The Specialist Medical Centre another advancement business development, to be utilised and operated within the Medical Centre was in the designed, developmental stages, and to be completed and implemented into the centre upon establishment and operation of the centre. This Business development was named M.S.I.C, a communication tool to aid and assist Medical Professionals and the patients referral system.

This continuous development, including conducting numerous Market Research amongst Medical Professionals and Medical Centres commenced in 2009, and continued until 2012.

In 2009, following the completed Business Plans development, The Specialist Medical Centre I applied for funding of the establishment of the Medical Centre with numerous sources, which included Hon Jon Hill, Minister of Health, Roger Kirchner, Director of the Port Pirie Hospital and Secret Administration of SA Health, Commonwealth Bank, Port Pirie and the local Government of Port Pirie, all to no avail. All applied funding of these applications were denied and not even considered.

Following the denied funding of The Specialist Medical Centre I continued with the development of the second business plan, M.S.I.C, Communication Tool, an implementation of The Specialist Medical Centre, and also commenced on the development of a Fashion Design Business, Lil Devil Designs, which at a later stage of development was renamed J Monequic, while I continued to complete the business plan M.S.I.C, and obtain funding for the two Medical Business Developments.

In 2012, following the completion of M.S.I.C, Communication Tool development I once again applied to the Minister of Health, Hon Jon Hill for funding to establish the two medical businesses.

The funding was once again denied, but this time I was informed of the establishment of the Government Initiative GP Plus Health Care Centres, Specialist Centres utilising Specialists operating in one centre and working in conjunction with GP'S, the exact objectives, infrastructure and business development that I had commenced in 2006 and continued development until 2012, but had been continuously denied Government funding. The GP Plus Health Care Centres, a Government Initiative are owned and operated by SA Health, Government.

This is the second recorded event of Intellectual Property Theft occurring in the Privacy of my own Home.

In 2012 - 2017, I began the journey of Contesting the Intellectual Property Theft and reporting the extensive, continuous Illegal Activity that had targeted my life over a period of, commencing in 2007 and escalating in 2014 - 2017, during this period of Contesting and reporting and resulting in denial of the Intellectual Property Theft, denied assistance, denied investigations and extreme Sexual targeting and Police Targeting, following suffering Isolation through the use of Remote Access to Telecommunication Systems servers blocking contact and altering messages to family, friends and including children, discovered as the source of continuous Fraudulent Activity in 2021.

Following the contesting and reporting in 2013 - 2017 and extensive Police Targeting, discovered in 2020, construction of a Legal Case against the accused as Fraudulent fines and charges, illegal arrests, resulting in permanent injury of the victim, as result of Police Brutality applied during the arrests I then encountered a Falsified diagnosis of Psychosis, Dr Kajani, Port Pirie, Illegal Representation of a Lawyer, Heidi Salvemini, Westside Lawyers, Port Pirie, Adelaide, who is connected to Roger Kirchner's Executive Assistant, Jemma Salvemini (Maiden name), who was involved in the applied funding of the Medical Centre in 2009, illegally released medical records (falsified diagnosis of Psychosis) into the possession of the Illegal

Representation of lawyer, Heidi Salvemini, and submitted into a Court of Law, resulting in an ordering of a Mental Health Evaluation of the victim by the residing Magistrate A.Grasso, Port Pirie Court House. This illegal conduct resulted in further falsified diagnosis's as a result of the Mental Health Evaluation, evaluator connected to SA Health and detention into Glenside Mental Health Facility, Adelaide.

During the detainment in Glenside Mental Health Facility, Adelaide, detained for a period of 6 weeks I applied for release from the facility based on the documented evidence in my possession of the Illegal representation of the lawyer, Illegally obtained medical records of the falsified diagnosis submitted in a Court of Law through the SACAT Appeal System.

Following the appeal to SACAT to be released from the detainment and submitting the documented evidence, and including the Medical Business Plan completed in 2009, and of which is how the detainment had occurred, contesting of the Intellectual property Theft and reporting the Illegal targeted activity I was denied release, placed on a 12 Month Community Order under a falsified diagnosis of Paranoid Schizophrenia, SACAT claiming the victim was suffering from a "Paranoid Delusional Condition", and ordered onto a medication administered monthly by injection, directly into the bloodstream, that carried the side effects and high risk of causing Harm to Oneself, Suicidal Tendencies, which was administered for 16 months, and did almost cost me my life from Suicidal Tendencies.

The medication ordered by SACAT under a falsified diagnosis, 400mg Aripiprazole (Maintema Abilify) resulted in the severe side effects, which included :

- Loss of memory
- Loss of concentration
- Loss of vocabulary - Speech
- Severe continuous clenching of the jaw and hands, every minute of everyday, and seizure like stiffness in the legs and feet - all of which resulted in fractured teeth and severe muscle aches and Pain
- Constant movement of the feet
- Loss connections to thought patterns, creativity, intellect and speech patterns - a feeling as if the mind was fragmented and could not connect to any part of that part of the mind resulting in mind blanks while trying to speak / silence
- Loss of hair - Long, thick blonde hair to middle of the back falling out, breaking off through brittleness until shoulder length / short and thin
- Weight gain
- Suicidal Tendencies - Resulting in a Suicide attempt
- Addictions to Cigarettes and gambling
- Loss of normal, everyday functions resulting on impeding on employment opportunities and the continual development of my first manuscript, commencing in 2013 "Reality"

Following 9 months of suffering from severe side effects of the ordered prescribed medication, ordered under the act of a falsified diagnosis by SACAT of the victim suffering from a "Paranoid Delusional Condition", the medication was reduced to 300mg, which eased the severity of the side effects and I was able to reconstruct my mind to work against the medication affects and gained employment and continued the development of my writing career, commencing in 2013, my first novel "Reality", which was placed under contract within a 3 month period of submitting the manuscript with Austin Macauley Publishers, London, and the novel was published in October 2020.

- Following a 2 hear court process and battle in the Port Pirie Court House, involving the Port Pirie Police Department, of which during this process I had been detained I was finally Acquitted of all charges and awarded an Unconditional Release and No penalty by Magistrate K.A. Millard. Following the court proceedings and Acquitted of all charges, the Magistrates ruling in a Court of Law I received Fraudulent Charges and fines from the Port Pirie Police Department and Port Pirie Fines Department, regarding the charges that I had been acquitted of by Magistrate K.A. Millard.

Following the release from Glenside Mental Health Facility, Adelaide in February 2017 I submitted extensive documented evidence of the Intellectual Property Theft, Police corruption and Targeting, Sexual Targeting, continuous Fraudulent Activity in all accounts to I.C.A.C, Corruption Commissioner. Upon this submission of supported claim of Illegal Targeted Activity / Corruption by documented evidence, which included an Origin Electricity account of Excessive Rise in Utilities, obtained in 2016 resulting

the barcode scanning in Australia Post, Kadina as Townsville CC Parking Fines - Queensland Police Involvement in Fraudulent Activity and Police Targeting, accessing utility accounts resulting in Excessive Rise in billing and Fraudulent Activity reducing income and source of funding for business developments.

In 2017 following requested investigation to I.C.A.C, Corruption Commissioner, the Corruption Commissioner denied the activity, denied an investigation and closed the case.

Following this denied investigation and the decision of the Corruption Commissioner I packed away the documented evidence in my possession, involving the Intellectual Property Thefts, Fraudulent Activity, Police Targeting and Sexual Targeting and began to re-build my life, following re-locating to Kadina from Port Pirie, believing that the targeted illegal activity was confined to the Port Pirie region, and continued the development of my book, published novel in 2020, "Reality". During the process of developing the first manuscript I began 2 more books, manuscripts to construct the story into a series of books, the second book under contract in February 2020, Austin Macauley Publishers, London.

In 2018, believing the confined targeting of Port Pirie had ceased I met a man, Professor Vincent Bulone, KTH Sweden University, Director of Research, Adelaide University, and started a relationship, which resulted in a Defacto relationship, and I relocated to Adelaide.

During this relationship, which I was led to believe was a new beginning of my life, following the trauma of the events in Port Pirie, and the relationship was honest and very real I began to notice Professor Vincent Bulone's unusual behaviour, which resembled the exact nature and behaviour of the prior individuals involved in the Sexual Targeting that had occurred in Port Pirie.

Following an 18 month relationship with Vincent Bulone, including a period of a Defacto Relationship with this man, and experiencing the obvious signs of his displayed unusual pattern of behaviour of continuous womanising, lying, appearing as if betraying the relationship, occurring in secret behind my back, his constant denial of his behaviour when confronted, which the behaviour continued although constantly confronted and questioned, and his comment which eventuated from the final confrontation of his pattern of behaviour, claiming that I was "Delusional, and was extensively encouraging me to seek Psychological Counselling, blaming my state of mind for the questioning of his continuous pattern of behaviour that had continued over the course of the 18 months together.

This comment "Delusional" alerted me to his involvement in the targeted illegal activity that had occurred in Port Pirie, that had resulted in detainment into Glenside Mental Health Facility in 2017, under falsified diagnosis of SACAT claiming I suffered from a "Paranoid Delusional Condition", following the submission of documented evidence to support my claim of foul play, Illegal Activity.

I ended the relationship with this man and permanently relocated to my parents residence in Kadina as their permanent Carer, for their Medical Conditions, my father suffering from Terminal Cancer, diagnosed as Bladder cancer in 2017 and my mothers Heart Condition that resulted in a Triple ByPass.

Upon the realisation that the Targeted Illegal Activity that had occurred in Port Pirie prior to this relationship and event was not contained to the Port Pirie region alone, I pursued to find the answers to the source of the targeting, that was still present in 2018 and continued into 2019.

In 2019 - 2021 I commenced the continued development of my registered business JC INNOVATIONS, involving numerous business concepts, involving Private Social Media Website, Commercial and Public products, businesses and developments, Government Funded Projects and Medical and Scientific Research projects, and designed into a 5 Stage Business developmental process, each stage of development financially supporting the next stage. I formed a business network of Professional support, including Software Developers, University Support and contacts involving Flinders University and Accountants and Insurance. I became a Voluntary registered customer of MADEC Employment Agency, Kadina to seek support, business advice and funding for the establishment of the registered business

In 2020 I applied for funding with Madec Employment Agency, Kadina, submitting the 5 Stage business plan and business concepts, under the act of their Intellectual property Laws - Government Department, but was once again denied funding and referred to the NEIS Program, a Government Initiative for support. I was denied entry into the NEIS Program claiming that I was too advanced for this program and funding and support was once again denied.

During this process I once again pulled out the extensive documented evidence that I had collected over an eight year period while residing in Port Pirie, but dated back 16 years of the Multiple Intellectual Property Theft, Targeted Illegal Activity of Sexual targeting, Police Targeting, Fraudulent Activity and reports and continuously denied investigations that had occurred over a period of 27 years, to construct a plan to reveal the source of this activity and construct the evidence into a Legal Case against the sources and individuals involved.

### \* EVIDENCE SUPPLIED OF GOV SOURCES INVOLVEMENT

\* I contacted and personally delivered a report of the Targeted Illegal Activity, and documented evidence in my possession supporting my claims, constructed into files on a USB Flash drive, extending over an eight year period and delivered this report and documented evidence to Hon Steven Marshall, Premier of South Australia and Hon Vicki Chapman, Attorney General of South Australia, and requested their assistance and investigation into the reported documented supported claim and illegal activity.

This report was submitted during the time of Australia's extensive Bushfires in 2019 - 2020.

\* I received a reply from both parties within two weeks of submitting eight years of documented evidence of Illegal Targeted Activity, including the Intellectual Property Theft of The Medical Business Plan and M.S.I.C, Communication Tool and requesting an investigation into the reported illegal activity.

### \* PRIOR TO GOV BILL PASSED AGAINST ICAC AUGUST 2021.

The Targeted Illegal Activity that I had reported occurring from 2006 - 2019 was once again denied an investigation and denied that it was a case for the Corruption Commissioner, I.C.A.C, a case of corruption. Included in the reply letter from both parties was the advice to contact a law firm, Slater & Gordon, who contained a lawyer employed with their firm with the same surname as the Medical Professional connected to SA Health, who conducted the 2017 Court Ordered Mental Health Evaluation, which resulted in a falsified diagnosis and detainment into Glenside mental Health Facility, Adelaide - "Nuygen"

Refer to Stage 3 Police Targeting and Name Comparisons

I was also informed to contact Hon Stephen Wade, Minister of Health for an investigation of the alleged Intellectual Property Theft of the Medical Business Plan and M.S.I.C, Communication Tool, developed during the years of 2006 - 2012.

I submitted documented evidence supporting my claim and evidence of the Targeted Illegal Activity, uploaded onto a USB Flash drive, and as submitted to the two Government Sources, to advised contact Hon Stephen Wade, Minister of Health.

I received a reply within a 2 week period of submission of 8 years of documented evidence and was once again denied an investigation into the Intellectual Property Theft and claimed that the GP Plus Health Care Centres are not under the governance of the Government - GP Plus Health Centres are owned and operated by SA Health as a Government Initiative.

Following these denied assistance and investigations and realisation of another "Set up" staged now by the Government, Premier of South Australia and the Attorney General of South Australia - "Nuygen", the denied Intellectual Property Theft of the Medical Business Plan and M.S.I.C, Communication Tool by Hon Stephen Wade, Minister of Health, of which I had received the exact same answer / reply in 2016 from Hon Jack Snelling, Minister of Health and David Swan, I realised I had finally uncovered the involvement and source of the Targeted Illegal Activity.

Refer to Letters Supplied, Hon Steven Marshall, Hon Vicki Chapman, Hon Stephen Wade

I then proceeded to contact the following Government Sources :

- Hon Rex Patrick, Federal Government
- Hon Pauline Hanson, Senator of Queensland
- Hon Adam Bandt, Senator of Victoria

I submitted the same exact report and documented evidence uploaded onto a USB Flashdrive, as I had submitted to the previous Government sources, extending over an eight year period and requested their assistance and an investigation into the Illegal Targeted Activity. Included in the documented evidence was the 2016 Origin Electricity Account, barcode scanned as Townsville CC Fines, Queensland - Queensland Police involvement in targeting electricity accounts remotely, forging electricity account billings, Excessive Rise in Utilities billing, Fraudulent Activity involving Police Targeting between 2012 - 2016, which had contributed and resulted in the 2014 closure of my Fashion Design Business, J Monequic, registered in

2011, as a result of Fraudulent Activity depleting Source of income and source of funding of business developments. The Fashion Design Business, J Monequic was denied a Trademark in 2012, and resulted in Intellectual Property Theft of the clothing design in 2014, following closure of the business by Lorna Jane Fashion.

Following the submissions of reports and evidence to the following three Government Sources, Hon Rex Patrick, Hon Pauline Hanson, Hon Adam Bandt, I was once again denied assistance and an investigation into the Targeted Illegal Activity, by Ho Rex Patrick and Hon Pauline Hanson.

The submission to Hon Adam Bandt, Senator of Victoria resulted in Mail Interception, Obstruction of Evidence to a Senators Office, a Fraudulent email reply from an individual impersonating a Senators Office, Harry Hook.

**Refer to document - Hon Adam Bandt, Senator of Victoria, Email Reply, Harry Hook**

In the submission of documented evidence to Hon Adam Bandt I had not supplied an email address as a point of contact, details of business concepts and developments of JC INNOVATIONS and the issues that the developments were addressing, and reported extensive Police Targeting, Including photographic evidence and medical reports of permanent injuries sustained during the arrests, Police Brutality but was advised by "Harry Hook" to contact police if I was feeling "At risk of my safety as a result of the targeting and illegal activity" - Providing misleading advice to Endanger my safety from Police Targeting.

I was once again denied assistance and an investigation from all of the Government Sources contacted, resulting in continuous Entrapment in the Targeting.

I then realised I had now discovered and uncovered the source of the Specific Targeting of an Individual over a 27 year period, stalked from location to location, and following change of all details and regions, and that the detainment and falsified diagnosis in 2017, and the ordered prescribed medication carrying the risks of causing Self Harm, Suicidal Tendencies was an attempt on my life by the targeted source, Murder to Appear as Suicide by medication.

**Refer to Stage 3 Police Targeting**

In early 2020, following this denied assistance and investigations I began to construct the 27 years of documented evidence in my possession into a Legal Case against the source and individuals involved in Conspiring with the Government in the Targeted Illegal Activity and Government Targeting, and contacted a law firm, Gordon Legal Law Firm, Melbourne, Victoria, requesting contact with the Senior Lawyer, Peter Gordon, for Legal Assistance and Legal representation.

At this point of contact with Gordon Legal Law Firm, Peter Gordon, Senior Lawyer was currently involved in representing the victims of the Centrelink Robodebts, that had resulted in the Suicide of some of the victims that had incurred these Fraudulent, illegal Debts.

Following my contact, direct contact on their Official Website seeking Peter Gordon's Legal Assistance and representation I experienced blocked passage to Peter Gordon, impersonating a lawyer of the law firm, misleading information and advice and denied legal representation, claiming that they "Do not represent victims".

I was once again blocked from contact with Peter Gordon in 2021, requesting a Skype meeting, following change of phone number with Telstra, Registered Business Account with Restricted Access to employees applied, and received no reply from this contact.

During the period of 2019 - 2021, and during the Legal Case construction of documented evidence in my possession, spanning over a period of 27 years the Illegal Targeted Activity continued and involved :

- Multiple Intellectual Property Theft of JC INNOVATIONS
- Altered BAS Statements resulting in the denied rebate claims by the Australian taxation Office, Grant Brodie
- Fraudulent Activity in Telecommunication Systems, Blocked contact, altered messages, synchronised emails from computer to mobile not registering on the computer system that were being delivered to the mobile phone synchronised email from Social Media Networks - marketing of published novel "Reality"

- Blocked access and marketing of published novel "Reality" on Social Media Websites
- Computer hacking and email hacking of newly purchased business computer, purchased in 2020 and registered under the registration of JC INNOVATIONS and professionally installed / recreated Business registered email accounts, accounts and numerous Security systems, involving 2 Step Verification and Authenticators and connected to the newly registered business account with Telstra, change of details and phone number, with Restricted Access to employees applied / in store access only with the Manager and Business Consultant
- Altered payment details through Netbanking, Commonwealth Bank for contract payments to recipient Austin Macauley Publishers, London, who confirmed they had received the payment in altered bank account name details occurring during the transaction, and confirmed by the Commonwealth Bank Payment Investigations Department following a lodged Trace on that payment as being altered
- Missing funds of \$123.00 from a Superannuation claim

Following this continuous targeted Illegal Activity, Specific Targeting of an Individual I contacted the CEO's Head Office of each company that I was registered with and had incurred the Fraudulent Activity, which resulted in investigations into the continuous Illegal activity.

In May 2021 it was confirmed by Telstra Head Office that the continuous Fraudulent Activity in my Telecommunication Systems occurring in every server, and reported over a ten year period was a result of Government and Police sources Remotely Accessing servers and computer hardware, resulting in the conduct of Illegal activity of Fraudulent Activity, blocked contact and passage, Excessive rise in Telecommunication Systems billing, altered messages and confirmed Government and Police Targeting of an Individual over a 27 year period, Corruption, and the continuous denied assistance and investigations of the reported activity and Intellectual Property Theft, that resulted in detainment and medication in 2017.

The extensive documented evidence in my possession spanning over a period of 27 years from location to location, involving Hand Written form only Business Developments and concepts written in the Privacy of my own Home, not installed on a computer, or shared with a third party, including family members, which include Government Policies, Council Developments, Medical Projects and Developments, Housing Projects, including Affordable Student Accommodation designed and hand written while detained in Glenside mental Health Facility in 2017, Business concepts and infrastructure, Commercial and public business products were all subjected to Intellectual Property Theft within the Privacy of my own Home, place of residence.

#### Refer to Stage 4 Multiple Intellectual Property Theft

This documented evidence revealed the Government and Police Targeting was conducted by the use of continuous Government and Police Illegal Surveillance, and Shared Surveillance of the Privacy of my own Home, extending over a period of 27 years, 1993, the first account of Intellectual Property Theft, Willimulka, Infant Sleep Positioner, and explained the reason for continuous Intellectual Property Theft, Illegal Activity that continuously occurred from location to location, and the individuals targeting in person, Sexual Targeting and involved, being in the Exact locations at the Exact moment I am in that location, public locations, and including Dating Sites and Social Media Sites Breaching the Human Rights Act of Privacy and Privacy in own Home and endangerment of the victim, and is still current, active and present this current day, May 2021, resulting in the Entrapment in Government and Police Targeting.

This is a Disgraceful act by the Australian Government, Australian Police Force, Conspiring Government from foreign Country's and involved numerous individuals conspiring with the Government and Police, a Syndicate of Individuals resulting in the victims dramatically altered lifestyle and Emotional Destruction as a result of :

- Severed relationships, family, children and friends
- Money laundering - Fraudulent activity reducing income and funding of business developments
- Loss of interaction with the public and forming relationships as a result of Sexual Targeting, isolating the victim from society
- Loss of Legal Services available to the victim as a result of Police Targeting
- Permanent injuries sustained by Police Brutality resulting in constant, daily severe burning pain in muscles, joint pain, suspected fractured neck, and daily headaches and migraines
- Loss of Professional Opportunities as a result of Intellectual Property Theft over a 27 year period

- Loss of employment opportunities equalled to qualifications - Denied employment applications as a result of individuals involvement
- Blocked marketing of published novel "Reality" impeding upon Professional career, income and profit from sales
- Endangerment of death threats from Police involvement and individuals involvement restricted movement outside of the home and public locations
- Attempted Suicide as a result of ordered medication - Threatened loss of life
- Deformation of Character as a result of falsified claims of suffering from a delusional condition impeding upon employment opportunities - Medically recorded and recorded in Centrelink and Employment Agency departments
- Denied investigations and assistance resulting in Entrapment in the Government and Police Targeting
- Loss of Sexual interaction as a result of Sexual Violation of Sexual Targeting and Illegal Surveillance watching nakedness and sexual interaction, and including masturbation
- Denied services including Legal, Medical, Government, Police Protection and being under threat of violence or Sexual Targeting in every location, including relocation in public locations
- Loss of Psychological Counselling as a result of trauma suffered from targeted Illegal Activity and the mistrust of medical Professionals, as a result of their involvement and fear of another Attempted Murder to Appear as Suicide by medication

The Targeted Illegal Activity was finally Identified as Specific Targeting of an Individual over a 27 year period in 2021, stalking the victim from location to location, and including relocation to different regions and cities, and following change of details, names, Business Registrations, phone numbers, account servers, partners, addresses, computer systems, Security systems and account registrations, and has been Identified and Confirmed by Telstra Head Office, following a 10 year history of reporting Fraudulent activity in every server in the individuals accounts, as Government and Police sources gaining access to the servers and accounts, and including computer hardware through the use of Remote Access, use of Technology to conduct Illegal Activity and Breach the Human Rights act of the victim.

The Government and Police Targeting, and individuals involved, who have been given access to the Illegal Surveillance or Privacy of the victims home, and including family home, children and parents home is a Severe Breach of Privacy and Human Rights of Privacy and Freedom of Choice, Lifestyle choices and Professional Choices.

I am contacting you to request your assistance and investigation into the Breach of the Human Rights Act, as a result of this reported, Identified and confirmed Government and Police Targeting by the use of Technology, Identified as Specific Targeting of an Individual over a 27 year period, and resulted in a dramatically altered lifestyle in order to protect myself from the Targeting, Isolation from the public and society, and endangerment in my own home from the use of Illegal Surveillance and Shared Illegal Surveillance. I am requesting your assistance in being an advocate, to result in the exposure of the truth, the victims voice to be heard and assist in the victims release from the entrapment of targeting so that I am able to rebuild my life from a entrapped, shattered life of continuous abuse.

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the *Independent Commissioner Against Corruption Act 2012* prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling 1300 366 424 or (08) 8436 3555.

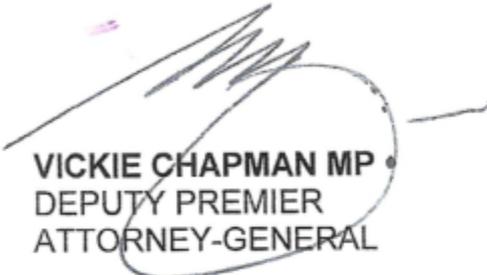
I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament. Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

South Australia's Parliament passed the bill with little debate or dissent. (ABC News: Michael Clements)

The passage of a bill through South Australian Parliament can often be slow.

\* Parliament only sits about 17 weeks a year for a start, and then when a bill comes before the house there are often lengthy debates and amendments to be voted on.

It has to make its way through both the Lower and Upper House until finally some version of the bill is either passed or not.

A bill from the crossbench can face an even more difficult passage, only allocated a small amount of time amid government business and other responsibilities of the house.

\* That makes the passage of SA Best Frank Pangallo's bill to rewrite the laws that govern the state's anti-corruption watchdog "extraordinary" — the word used by Independent Commissioner Against Corruption (ICAC) Ann Vanstone herself.

\* The Upper House MP introduced the bill in late August, it came to a vote in the Legislative Council on Wednesday, and by Thursday evening it had passed Parliament altogether.

There were some amendments made, but not a single MP voted against it.\*

**Concerns about current situation and changes**

The bill is the result of a parliamentary inquiry into the ICAC that heard testimony from people who said their lives were ruined by investigations that ultimately resulted in acquittals or charges dropped.

In response to that, the commissioner said it was no different to police investigations and court hearings — an unfortunate but necessary cost of an open justice system.

She pointed out the changes in the bill went beyond the recommendations of the parliamentary committee, and she raised red flags about provisions that seemed designed to protect politicians.

The bill takes away Ms Vanstone's ability to investigate maladministration and misconduct, passing those responsibilities to the state ombudsman.

But even Ombudsman Wayne Lines, while happy to take on those roles, has flagged concerns with the bill.

Earlier this week, he told a parliamentary committee the definition of misconduct had been narrowed too far, meaning he would no longer be able to investigate the same kinds of cases he did now.

Like the commissioner, he expressed concerns parliamentary privilege had been overly strengthened to allow it to be used as a shield to hide things from his office.

Both the commissioner and ombudsman gave their evidence to Parliament on Monday, giving politicians less than three days to consider it before voting on the bill.

## **Silent Liberals had pushed for ICAC**

The events of this week are a long way from the arguments of a decade ago, when the Liberal Party, then in opposition, was lobbying hard for an Independent Commission Against Corruption in South Australia.

Labor pushed against it, describing other state's watchdogs as 'festivals of lawyers', suggesting South Australia did not have endemic corruption and saying what did exist could be dealt with by existing bodies.

During one attempt to establish an ICAC in Mike Rann's time as Premier, now-Attorney-General Vickie Chapman told Parliament: "Anyone who purports to suggest that we do not need an ICAC in this state is ... crazy."

Eventually, under pressure from the opposition, and with most other states establishing their own anti-corruption bodies, Labor relented, and in 2013 Bruce Lander became SA's first Independent

Commissioner Against Corruption.

The Liberal Party pushed for it, Labor established it, and now MPs from both sides have voted on laws the commissioner says will cripple it.

In response, MPs will argue the ICAC still does exist, its functions will now be narrowed to focus on the worst forms of corruption in the state rather than wasting time on more trifling matters of misconduct.

But whether it will exist under the auspices of Ann Vanstone is in doubt after she questioned, with such a narrow scope, whether there would be a point to having the agency at all.

# GOV + POLICE TARGETING CONFIRMED TELECOMMUNICATION SYSTEMS - TELSTRA HEAD OFFICE

I reported the Fraudulent malicious Activity of the newly created business account to Joshua Adams, Business Consultant, Telstra Store, Kadina who proceeded to file a report to the Fraud Department and requested an investigation into the activity - Refer to Telstra Report dated 1/10/2020

I received no reply or response from this report.

The Fraudulent and malicious Activity continued and escalated.

On the 25/03/2021 I reported the activity again to Joshua Adams, Business Consultant, Telstra Store, Kadina and reported that I had not received any contact from the Fraud Department concerning the report that he had submitted. I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

following Restricted Access applied, change of phone numbers, change of details personal and business, change of servers and relocation was identified as Government and Police Sources

that had been occurring, which included blocked contact, altered and blocked messages, blocked access to internet services, websites and contacts, impersonating of companies, unusual messages and phone calls from unknown people, blocked contact and altered messages to my children, as informed by my children and resulted in isolation in 2014 - 2016 Extreme Sexual Targeting, Police Targeting and detention. This information confirmed the details obtained in 2016 Origin Electricity account that incurred an Excessive Rise in billing that remained unexplained and resulted in the barcode being scanned as a Police Source causing the Fraudulent Activity.
