

Bloom asserted that the woman had received threats. The suit was dropped on November 4, 2016. Trump attorney Alan Garten denied the allegations, while Epstein declined to comment.<sup>[156][157][158][159][160]</sup>

### ***Sarah Ransome v. Epstein and Maxwell (2017)***

In 2017, Sarah Ransome filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.<sup>[161][20][162]</sup>

### ***Bradley Edwards' defamation v. Epstein (2018)***

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential.<sup>[137][163]</sup>



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

### ***Maria Farmer v. Epstein and Maxwell (2019)***

On April 16, 2019, Maria Farmer went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. Farmer met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted.<sup>[164]</sup> Farmer reported the incident to the New York City Police Department and the FBI.<sup>[165]</sup>

Farmer's affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table.<sup>[166]</sup>

### ***Jennifer Araoz v. Epstein and Maxwell (2019)***

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by Jennifer Araoz.<sup>[167]</sup> She stated that an associate for Epstein had recruited her outside Talent Unlimited High School at age 14 and she was gradually groomed for over a year before Epstein raped her in his New York City mansion when she was 15.<sup>[168]</sup> Araoz filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place.<sup>[169]</sup> In October 2019, Araoz amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and Cimberly Espinosa as enablers.<sup>[170]</sup>

### ***Katlyn Doe, et al. v. Epstein's estate (2019)***

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

### Victims' rights: *Jane Does v. United States (2014)*

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.<sup>[138]</sup>

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

### *Virginia Giuffre v. Epstein (2015)*

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> Giuffre filed a defamation suit against Dershowitz,

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.<sup>[26]</sup> In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.<sup>[29]</sup> He began playing the piano when he was five.<sup>[30]</sup> He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.<sup>[31][32]</sup> Later that year, he attended classes at Cooper Union until he changed colleges in 1971.<sup>[31]</sup> From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.<sup>[31][32]</sup>

## Career

---

### Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.<sup>[31][33]</sup> Donald Barr, who served as the headmaster until June 1974,<sup>[34][35][36]</sup> was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.<sup>[33][37][38]</sup> Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.<sup>[38]</sup> Epstein allegedly showed inappropriate behavior toward underage students at the time.<sup>[33][37]</sup> He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.<sup>[35]</sup> In June 1976, after Epstein was dismissed from Dalton for "poor performance",<sup>[33][39][40]</sup> Greenberg offered him a job at Bear Stearns.<sup>[30][41]</sup>

### Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.<sup>[42]</sup> He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.<sup>[32][43][44]</sup> Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.<sup>[42]</sup>

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".<sup>[45][32][30]</sup> Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.<sup>[42]</sup>

### Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),<sup>[46]</sup> which assisted clients in recovering stolen money from fraudulent brokers and lawyers.<sup>[30]</sup> Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.<sup>[30][47]</sup> Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.<sup>[48]</sup>

## Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".<sup>[110]</sup> It resulted in a 53-page indictment in June 2007.<sup>[71]</sup> Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,<sup>[111]</sup> to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators".<sup>\*</sup> According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."<sup>[1]</sup>

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".<sup>[52][53][112]</sup> Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.<sup>[1][89]</sup> The plea deal was later described as a "sweetheart deal".<sup>[113]</sup>

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".<sup>[114][115]</sup>

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.<sup>[116]</sup>

## Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,<sup>[117]</sup> he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.<sup>[100]</sup>

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade visitor logs were not).<sup>[118]</sup> He was allowed to use his own driver to drive him between jail and his office and other appointments.<sup>[100][118]</sup>

Liquid Funding was initially 40 percent owned by Bear Stearns. Through the help of the credit rating agencies – Standard & Poor's, Fitch Ratings and Moody's Investors Service – the new bundled securities were able to be created for companies so that they got a gold-plated AAA rating. The implosion of such complex securities, because of their inaccurate ratings, led to the collapse of Bear Stearns in March 2008 and set in motion the financial crisis of 2007–2008 and the subsequent Great Recession. If Liquid Funding were left holding large amounts of such securities as collateral, it could have lost large amounts of money.<sup>[65][67]</sup>


## Investments

### Hedge funds

Between 2002 and 2005, Epstein invested \$80 million in the D.B. Zwirn Special Opportunities Fund, a hedge fund that invested in illiquid debt securities.<sup>[68][69]</sup> In November 2006, Epstein attempted to redeem his investment after he was informed of accounting irregularities in the fund.<sup>[70]</sup> By this time, his investment had grown to \$140 million. The D.B. Zwirn fund refused to redeem the investment. Hedge funds that invest in illiquid securities typically have years-long "lockups" on their capital for all investors and require redemption requests to be made in writing 60 to 90 days in advance.<sup>[68]</sup> The fund was closed in 2008, and its remaining assets of approximately \$2 billion, including Epstein's investment, were transferred to Fortress Investment Group when that firm bought the assets in 2009.<sup>[68][69]</sup> Epstein later went to arbitration with Fortress over his redemption attempt. The outcome of that arbitration is not publicly known.<sup>[68]</sup>

 In August 2006, Epstein, a month after the federal investigation of him began,<sup>[71]</sup> invested \$57 million in the Bear Stearns High-Grade Structured Credit Strategies Enhanced Leverage hedge fund.<sup>[68][72]</sup> This fund was highly leveraged in mortgage-backed collateralized debt obligations (CDOs).<sup>[72]</sup>

On April 18, 2007, an investor in the fund, who had \$57 million invested, discussed redeeming his investment.<sup>[73]</sup> At this time, the fund had a leverage ratio of 17:1, which meant for every dollar invested there were seventeen dollars of borrowed funds; therefore, the redemption of this investment would have been equivalent to removing \$1 billion from the thinly traded CDO market.<sup>[74]</sup> The selling of CDO assets to meet the redemptions that month began a repricing process and general freeze in the CDO market. The repricing of the CDO assets caused the collapse of the fund three months later in July, and the eventual collapse of Bear Stearns in March 2008. It is likely Epstein lost most of this investment, but it is not known how much was his.<sup>[73][72]</sup>



The government began negotiation with Epstein for a plea agreement in mid-2007, as the hedge fund began to collapse.

By the time that the Bear Stearns fund began to fail in May 2007, Epstein had begun to negotiate a plea deal with the U.S. Attorney's Office concerning imminent charges for sex with minors.<sup>[68][71]</sup> In August 2007, a month after the fund collapsed, the U.S. attorney in Miami, Alexander Acosta, entered into direct discussions about the plea agreement.<sup>[71]</sup> Acosta brokered a lenient deal, according to him, because he had been ordered by higher government officials, who told him that Epstein was an individual of importance to the government.<sup>[52][53]</sup> As part of the negotiations, according to the Miami Herald, Epstein provided "unspecified information" to the Florida federal prosecutors for a more lenient sentence and was supposedly an unnamed key witness for the New York federal prosecutors in their unsuccessful June 2008 criminal case against the two managers

**John Winston Howard** OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to ~~2007~~, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the ~~Howard Government~~ was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre, the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the ~~2007~~ federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

**John David Hill** (born 3 December 1949), Australian politician, represented the electoral district of Kaurna in the South Australian House of Assembly for the Labor Party from 1997 to 2014.

Born in Sydney, Hill attended the University of Sydney and graduated with a Bachelor of Arts. He moved to South Australia in 1974 and became a teacher. He also studied at the University of Adelaide and received his law degree.

Following a brief stint as a ministerial adviser during the Bannon Government, Hill became a party official, becoming State Secretary in 1994. He was elected to Parliament as member for Kaurna at the 1997 state election.

After Labor won the 2002 election, Hill became a minister in the Rann Government. Initially given the portfolios of Minister for Environment and Conservation, Minister for the River Murray, Minister for the Southern Suburbs, Minister Assisting the Premier in the Arts and Minister for Gambling, Hill gained his current portfolios after a number of cabinet reshuffles.

The 2006 election saw Hill gain a swing of 11.0% to a total margin of 22.0%.

Hill did not re-contest his seat at the 2014 election.<sup>[1]</sup>

Hill is a member of the Ministers' Club at EPODE International Network – the world's largest obesity-prevention network.<sup>[2][3]</sup>

John Hill's political memoir, *On Being a Minister - Behind the Mask*, was published in February 2016.<sup>[4]</sup>

In early 2011 Rann reshuffled his cabinet after Deputy Premier and Treasurer Kevin Foley resigned from both positions but remained in the cabinet. Attorney-General John Rau became Deputy Premier and Jack Snelling became Treasurer.<sup>[43]</sup> - 2016 COVER UP - CONSPIRED - INTELLECTUAL PROPERTY THEFT - 2006-2012 MED BUS PLAN.

The first Newspoll of the third term of the Rann Labor government in March 2011 showed Rann's personal satisfaction-dissatisfaction rating at a new low of 30–59 and a two-party vote of 44–56, a swing against Labor of 4.4 percent since the 2010 election. Labor's primary vote dived to 29 percent, down 8.5 percent, the Liberal vote remained at 42 percent, whilst the Greens surged to 14 percent, an increase of 6 percent, with "other" slightly higher. The subsequent Newspoll saw the two-party vote narrow to 46–54, a swing against Labor of just 2.4 percent, however there was no statistical change in Rann's personal satisfaction-dissatisfaction ratings.

In late July 2011, the Australian Broadcasting Corporation (ABC) and The Advertiser reported that senior figures within Labor had indicated to Rann that the state party's left and right factions had formally decided to replace Rann with Education Minister Jay Weatherill as party leader. A day later, Rann confirmed he would stand down and undergo a party leadership transition to Weatherill, with the handover occurring in October 2011.<sup>[44][45][46][47][48]</sup>

Rann formally resigned from the premiership on 21 October 2011, and Weatherill was elected unopposed as his successor.<sup>[49]</sup>

Rann resigned from parliament on 13 January 2012 which created an 11 February 2012 Ramsay by-election. Zoe Bettison easily retained the seat for Labor with only a slight swing against her, and Ramsay remained the safest of Labor's lower house seats.<sup>[50][51][52]</sup>

## Post-parliamentary career

Rann's post-parliamentary appointments include the new Urban Policy Forum created by the federal government, as a professor in the School of Social and Policy Studies with Flinders University and as a visiting fellowship in political studies at the University of Auckland. He has also joined the International Leadership Council of The Climate Group, and the International Advisory Board of the Ecological Sequestration Trust.<sup>[53][54][55]</sup> Rann was also appointed adjunct professor in public policy at Carnegie Mellon University, Fellow for Democracy and Development at the Washington, D.C.-based Center for National Policy and as member of the Council of the Royal Institution Australia.<sup>[56]</sup>

Rann was appointed chair of Low Carbon Australia Pty Ltd in early 2012, the federal government's "green bank" providing finance to companies to reduce carbon emissions<sup>[57]</sup> and to the International Leadership Council of The Climate Group.<sup>[58]</sup>

Rann was announced on 23 August 2012 as the next Australian High Commissioner to the United Kingdom.<sup>[59][60][61]</sup> Rann also assumed the role of Permanent Representative to the United Nations International Maritime Organisation, Commonwealth War Graves Commissioner and Trustee of the Imperial War Museum.<sup>[56]</sup> Mike Rann acted as Australia's Ambassador to Italy, San Marino, Albania and Libya. He is also Australia's Permanent Representative to the United Nation's Food and Agriculture Organization and World Food Programme. - 2019 VINCENT BULONE 12 MILLION GOV GRANT.\*

As of 2020, he works as a business consultant for the Rann Strategy Group.<sup>[62]</sup>

On 23.6 percent of the primary vote and 51.7 percent of the two-candidate-preferred vote, Brock's election depended on preferences from Labor, Nationals SA, and the SA Greens, the former two having placed him second on their how-to-vote card. His own how-to-vote card saw him preference the Nationals, Labor, Liberal, Greens, and One Nation, in that order.<sup>[9]</sup> The by-election was closely contested, with the result being uncertain for over a week. Initial reports suggested a slight swing to the Liberal candidate Terry Boylan on the two-party-preferred count against Labor, with Brock close behind Labor. By 21 January 2009, both the ABC's Antony Green and the state electoral office were indicating a 2-point swing against the Liberals toward Labor on 51.4 percent, but not enough to lose the seat.<sup>[10][11][12]</sup> Liberal leader Martin Hamilton-Smith claimed victory on behalf of the party.<sup>[13][14][15]</sup>

However, the result hinged on the performance of Brock against Labor in the competition for second place. Brock won the primary vote in the Port Pirie area and picked up enough National and Green preferences to overtake the Labor candidate for second place by 30 votes. He then picked up enough Labor preferences to take the seat off the Liberals on a two-candidate-preferred vote of 51.7 percent (a majority of 665 votes), despite a slight improvement in the Liberal vote since the previous count.<sup>[16][17]</sup>

## 2010 election

Brock increased his primary vote to 37.7 percent and two-candidate vote to 57.5 percent at the 2010 election. Labor won from the Liberals the two-party-preferred vote on 50.1 percent.

## 2014 election

Brock increased his primary vote to 45.2 percent and two-candidate vote to 58.8 percent at the 2014 election. The election resulted in a hung parliament with 23 Labor seats, 22 Liberal seats, and two independents. The balance of power was held by crossbench independents Brock and Bob Such.<sup>[18]</sup> Such did not indicate who he would support in a minority government before he was diagnosed and hospitalised with a brain tumour and took medical leave one week after the election. University of Adelaide Professor and Political Commentator Clem McIntyre said Such's situation virtually guaranteed Brock would side with Labor. With 24 seats required to govern, Brock backed Labor. McIntyre said:<sup>[19]</sup>

✱ If Geoff Brock had gone with the Liberals, then the Parliament would have effectively been tied 23 to 23, so once Bob Such became ill and stepped away then Geoff Brock, I think had no choice but to side with Labor.

Brock accepted the cabinet positions of Minister for Regional Development and Minister for State and Government Local Relations. Brock agreed to support the Labor government on confidence and supply while retaining the right to otherwise vote on conscience.<sup>[20]</sup>

Martin Hamilton-Smith resigned from the Liberals and joined the Labor cabinet two months after the election. Labor achieved majority government when Nat Cook won the 2014 Fisher by-election which was triggered by the death of Such. Despite this, the Jay Weatherill Labor government kept Brock and Hamilton-Smith in cabinet, giving the government a 26 to 21 parliamentary majority.<sup>[21]</sup>

In the Weatherill Ministry, between 2014 and 2018 Brock has served as the minister with responsibilities for regional development and for local government.<sup>[22]</sup>

Gates is an avid reader, and the ceiling of his large home library is engraved with a quotation from *The Great Gatsby*.<sup>[187]</sup> He also enjoys bridge, tennis and golf.<sup>[188][189]</sup> His days are planned for him on a minute-by-minute basis, similarly to the U.S. president's schedule.<sup>[190]</sup> Despite his wealth and extensive business travel, Gates flew coach (economy class) in commercial aircraft until 1997, when he bought a private jet.<sup>[191]</sup>

Gates purchased the Codex Leicester, a collection of scientific writings by Leonardo da Vinci, for US\$30.8 million at an auction in 1994.<sup>[192]</sup> In 1998, he reportedly paid \$30 million for the original 1885 maritime painting Lost on the Grand Banks, at the time a record price for an American painting.<sup>[193]</sup>

In 2016, he revealed that he was color-blind.<sup>[194]</sup>

## Marriage and divorce

Gates married Melinda French on the Hawaiian Island of Lanai on January 1, 1994.<sup>[195]</sup> They met in 1987 after Melinda began working at Microsoft.<sup>[196]</sup> At the time of their marriage, Gates was given permission by Melinda to spend limited time with his ex-girlfriend, businesswoman Ann Winblad.<sup>[197]</sup> Bill and Melinda have three children: Jennifer, Rory and Phoebe.<sup>[198]</sup>

The family's residence is an earth-sheltered mansion in the side of a hill overlooking Lake Washington in Medina, Washington. In 2009, property taxes on the mansion were reported to be US\$1.063 million, on a total assessed value of US\$147.5 million.<sup>[199]</sup> The 66,000-square-foot (6,100 m<sup>2</sup>) estate has a 60-foot (18 m) swimming pool with an underwater music system, as well as a 2,500-square-foot (230 m<sup>2</sup>) gym and a 1,000-square-foot (93 m<sup>2</sup>) dining room.<sup>[200]</sup>

Gates and Melinda, 2009

On May 3, 2021, the Gateses announced they had decided to divorce after 27 years of marriage and 34 years as a couple.<sup>[201]</sup> They said they would keep working together on charitable efforts.<sup>[201][202]</sup> *The Wall Street Journal* reported that Melinda had been meeting with divorce attorneys since 2019, citing interviews that suggested Bill's ties with Jeffrey Epstein was at least one of her concerns.<sup>[203]</sup> The divorce was finalized on August 2, 2021.<sup>[204]</sup>

# Country Health SA launches Inpatient Dashboards for Port Augusta and Mount Gambier

Residents of Port Augusta and Mount Gambier will now be able to access up-to-date information about the amount of people being treated in their local public hospitals.


The Country Health SA Local Health Network (CHSALHN) launched inpatient dashboards for Port Augusta and Mount Gambier Hospitals following the successful release of the metropolitan data earlier this year.

Professor Belinda Moyes, Chief Executive Officer CHSA LHN said the inpatient dashboards provide country residents with an opportunity to learn more about how their hospitals are managed.

"The Inpatient dashboard provides detailed information on the number of inpatients at each hospital at any one time," Professor Moyes said.

"South Australia was the first state in the country to make this level of information available to the public and we are excited to extend this technology to country residents."

"Through the dashboard the general public can gain a better understanding about how patient flow is managed in our busy hospital environments."



**How to interpret this chart**  
 This table shows a summary of the status of all inpatient beds in the Port Augusta Hospital (PAHS).  
 In an online environment, you can click on the chosen hospital in the table and the whole dashboard will update to show data specific to that hospital.  
 The dashboard displays occupancy per hospital split across 'general' beds and 'all' beds, breakdown of inpatients, the length of stay, and much more.

Professor Moyes said the dashboard, which is available online, will be updated every 30 minutes to provide real-time information about bed occupancy, average length of stay and inpatient flows.

"The dashboard also includes information specific to each hospital about the number of patients currently within each area or clinical unit at the hospital," Professor Moyes said.

"It allows people to easily see all of the different 'streams' of inpatient care that each hospital provides, such as surgical or pediatrics, and the status of each of these areas."

"Staff already use the dashboard, along with a range of other tools, to help monitor and manage capacity and ensure that patient safety is maintained."

"By releasing this data publicly we are continuing to make our health system more transparent."
