

laws for gays and for the private sector Employment Non-Discrimination Act, which, buoyed by his lobbying, failed to pass the Senate by a single vote in 1996.^[141] Advocacy for these issues, paired with the politically unpopular nature of the gay rights movement at the time, led to enthusiastic support for Clinton's election and reelection by the Human Rights Campaign.^[137] Clinton came out for gay marriage in July 2009^[142] and urged the Supreme Court to overturn DOMA in 2013.^[143] He was later honored by GLAAD for his prior pro-gay stances and his reversal on DOMA.^[144]

The 1996 United States campaign finance controversy was an alleged effort by China to influence the domestic policies of the United States, before and during the Clinton administration, and involved the fundraising practices of the administration itself.^{[146][147]} Despite the evidence,^{[146][148]} the Chinese government denied all accusations.^[149]

As part of a 1996 initiative to curb illegal immigration, Clinton signed the Illegal Immigration Reform and Immigrant Responsibility Act (IIRIRA) on September 30, 1996. Appointed by Clinton,^[150] the U.S. Commission on Immigration Reform recommended reducing legal immigration from about 800,000 people a year to about 550,000.^{[151][152]}

Ken Gormley, author of *The Death of American Virtue: Clinton vs. Starr*, reveals in his book that Clinton narrowly escaped possible assassination in the Philippines in November 1996. During his visit to the Asia-Pacific Economic Cooperation (APEC) forum in Manila, while he was on his way to meet with a senior member of the Philippine government, Clinton was saved from danger minutes before his motorcade was scheduled to drive over a bridge charged with a timed improvised explosive device (IED).^[153] According to officials, the IED was large enough to "blow up the entire presidential motorcade".^[154] Details of the plot were revealed to Gormley by Lewis C. Merletti, former member of the presidential protection detail and Director of the Secret Service. Intelligence officers intercepted a radio transmission indicating there was a wedding cake under a bridge.^[153] This alerted Merletti and others as Clinton's motorcade was scheduled to drive over a major bridge in downtown Manila.^[154] Once more, the word "wedding" was the code name used by a terrorist group for a past assassination attempt.^[154] Merletti wanted to reroute the motorcade, but the alternate route would add forty-five minutes to the drive time. Clinton was very angry, as he was already late for the meeting, but following the advice of the secret service possibly saved his life. Two other bombs had been discovered in Manila earlier in the week so the threat level that day was high.^[155] Security personnel at the Manila International Airport uncovered several grenades and a timing device in a travel bag.^[156] Officials also discovered a bomb near a major U.S. naval base.^[156] The president was scheduled to visit both these locations later in the week. An intense investigation took place into the events in Manila and it was discovered that the group behind the bridge bomb was a Saudi terrorist group in Afghanistan known as al-Qaeda and the plot was masterminded by Osama bin Laden.^[154] Until recently, this thwarted assassination attempt was never made public and remained top secret. Only top members of the U.S. intelligence community were aware of these events.^[154]

continually emphasized that mask-wearing was optional; and suggested that wearing a mask was a political statement against him personally.^[520] Trump's contradiction of medical recommendations weakened national efforts to mitigate the pandemic.^{[519][520]}

Despite record numbers of COVID-19 cases in the U.S. from mid-June onward and an increasing percentage of positive test results, Trump largely continued to downplay the pandemic, including his false claim in early July 2020 that 99 percent of COVID-19 cases are "totally harmless".^{[521][522]} He also began insisting that all states should open schools to in-person education in the fall despite a July spike in reported cases.^[523]

* Political pressure on health agencies *

Trump repeatedly pressured federal health agencies to take actions he favored,^[511] such as approving unproven treatments^{[524][525]} or speeding up the approval of vaccines.^[525] Trump administration political appointees at HHS sought to control CDC communications to the public that undermined Trump's claims that the pandemic was under control. CDC resisted many of the changes, but increasingly allowed HHS personnel to review articles and suggest changes before publication.^{[526][527]} Trump alleged without evidence that FDA scientists were part of a "deep state" opposing him, and delaying approval of vaccines and treatments to hurt him politically.^[528]

On October 2, 2020, Trump tweeted that he had tested positive for COVID-19.^{[529][530]} His wife, their son Barron, and numerous staff members and visitors also became infected.^{[531][532]}

Later that day Trump was hospitalized at Walter Reed National Military Medical Center, reportedly due to labored breathing and a fever. He was treated with antiviral and experimental antibody drugs and a steroid. He returned to the White House on October 5, still struggling with the disease.^[533] During and after his treatment he continued to downplay the virus.^[531] In 2021, it was revealed that his condition had been far more serious; he had dangerously low blood oxygen levels, a high fever, and lung infiltrates, indicating a severe case of the disease.^[532]

Effects on the 2020 presidential campaign

By July 2020, Trump's handling of the COVID-19 pandemic had become a major issue for the 2020 presidential election.^[534] Democratic challenger Joe Biden sought to make the pandemic the central issue of the election.^[535] Polls suggested voters blamed Trump for his pandemic response^[534] and disbelieved his rhetoric concerning the virus, with an Ipsos/ABC News poll indicating 65 percent of respondents disapproved of his pandemic response.^[536] In the final

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".^[110] It resulted in a 53-page indictment in June 2007.^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed **potential co-conspirators**. According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."^[1]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".^{[52][53][112]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.^{[1][89]} The plea deal was later described as a "sweetheart deal".^[113]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".^{[114][115]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.^[116]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,^[117] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs were destroyed per the department's "records retention" rules (although inexplicably the Stockade visitor logs were not).^[118] He was allowed to use his own driver to drive him between jail and his

In early 2011 Rann reshuffled his cabinet after Deputy Premier and Treasurer Kevin Foley resigned from both positions but remained in the cabinet. The first Newspoll of the third term of the Rann Labor government in March 2011 showed Rann's personal satisfaction-dissatisfaction rating at a new low of 30-59 and a two-party vote of 44-56, a swing against Labor of 4.4 percent since the 2010 election. Labor's primary vote dived to 29 percent, down 8.5 percent, the Liberal vote remained at 42 percent, whilst the Greens surged to 14 percent, an increase of 6 percent, with "other" slightly higher. The subsequent Newspoll saw the two-party vote narrow to 46-54, a swing against Labor of just 2.4 percent, however there was no statistical change in Rann's personal satisfaction-dissatisfaction ratings.

In late July 2011, the Australian Broadcasting Corporation (ABC) and The Advertiser reported that senior figures within Labor had indicated to Rann that the state party's left and right factions had formally decided to replace Rann with Education Minister Jay Weatherill as party leader. A day later, Rann confirmed he would stand down and undergo a party leadership transition to Weatherill, with the handover occurring in October 2011.^{[44][45][46][47][48]}

Rann formally resigned from the premiership on 21 October 2011, and Weatherill was elected unopposed as his successor.^[49]

Rann resigned from parliament on 13 January 2012 which created an 11 February 2012 Ramsay by-election. Zoe Bettison easily retained the seat for Labor with only a slight swing against her, and

Ramsay remained the safest of Labor's lower house seats.^{[50][51][52]}

Post-parliamentary career

Rann's post-parliamentary appointments include the new Urban Policy Forum created by the federal government, as a professor in the School of Social and Policy Studies with Flinders University and as a visiting fellowship in political studies at the University of Auckland. He has also joined the International Leadership Council of The Climate Group, and the International Advisory Board of the Ecological Sequestration Trust.^{[53][54][55]} Rann was also appointed adjunct professor in public policy at Carnegie Mellon University, Fellow for Democracy and Development at the Washington, D.C.-based Center for National Policy and as member of the Council of the Royal Institution Australia.^[56]

Rann was appointed chair of Low Carbon Australia Pty Ltd in early 2012, the federal government's "green bank" providing finance to companies to reduce carbon emissions^[57] and to the International Leadership Council of The Climate Group.^[58]

Rann was announced on 23 August 2012 as the next Australian High Commissioner to the United Kingdom.^{[59][60][61]} Rann also assumed the role of Permanent Representative to the United Nations International Maritime Organisation, Commonwealth War Graves Commissioner and Trustee of the Imperial War Museum.^[56] Mike Rann acted as Australia's Ambassador to Italy, San Marino, Albania and Libya. He is also Australia's Permanent Representative to the United Nation's Food and Agriculture Organization and World Food Programme. - 2019 VINCENT BULONE 12 MILLION AUD GRANT.

As of 2020, he works as a business consultant for the Rann Strategy Group.^[62]

Thank you for your letter of 31 August 2012 about establishing a specialist medical centre at Port Pirie and offering to provide the business plans and research information collected throughout your project.

* I asked Adjunct Professor Belinda Moyes, Chief Executive Officer, Country Health SA - Local Health Network (CHSA), who is responsible for Port Pirie Regional Health Service (PPRHS), to consider your offer and I am advised as follows:

As Ms [REDACTED] may be aware, the PPRHS already provides consulting room facilities for some specialties identified through consultation with the local general practitioners.

In these instances, PPRHS pays the travel allowance and provides hospital accommodation for visiting specialists providing medical inpatient services.

PPRHS also distributes monthly information to all doctors and health units within the town and surrounding area of the specialists' visiting dates and the waiting times to see new patients.

* The completed Port Pirie GP Plus Health Care Centre, scheduled for September 2013, will also have capacity to provide additional consulting space, if needed. The nature of what additional medical services may be required is yet to be determined.

The Port Pirie Health Advisory Council has undertaken a 10 year planning process, and is now engaging the local general practitioner in planning how to shape medical services into the future.

If Ms [REDACTED] would like to have input into the development of the Port Pirie GP Plus Health Care Centre, there is a consumer group that she may wish to join. 



