

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.^[106]

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States* (2014)

SEXUAL ABUSE RING
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

Virginia Giuffre v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.^{[146][147][148]} Giuffre filed a defamation suit against Dershowitz,

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year"^[110] It resulted in a 53-page indictment in June 2007.^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators".^[112] According to the Miami Herald, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The Miami Herald said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."^[113]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".^{[52][53][112]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.^[1189] The plea deal was later described as a "sweetheart deal".^[113]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".^{[114][115]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.^[116]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,^[117] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs

John Winston Howard OM AC (born 26 July 1939) is an Australian former politician who served as the 25th prime minister of Australia from 1996 to 2007, holding office as leader of the Liberal Party of Australia. His eleven-year tenure as prime minister is the second-longest in history, behind only Sir Robert Menzies, who served for eighteen non-consecutive years. He has also been the oldest living former Australian prime minister since the death of Bob Hawke in 2019.

Howard was born in Sydney and studied law at the University of Sydney. He was a commercial lawyer before entering parliament. A former federal president of the Young Liberals, he first stood for office at the 1968 New South Wales state election, but lost narrowly. At the 1974 federal election, Howard was elected as a member of parliament (MP) for the division of Bennelong. He was promoted to cabinet in 1977, and later in the year replaced Phillip Lynch as treasurer of Australia, remaining in that position until the defeat of Malcolm Fraser's government at the 1983 election.

In 1985, Howard was elected leader of the Liberal Party for the first time, thus replacing Andrew Peacock as Leader of the Opposition. He led the Liberal-National coalition to the 1987 federal election, but lost to Bob Hawke's Labor government, and was removed from the leadership in 1989. Remaining a key figure in the party, Howard was re-elected leader in 1995 (replacing Alexander Downer), and subsequently led the Coalition to a landslide victory at the 1996 federal election.

After defeating Paul Keating's Labor government in 1996, the Howard Government was re-elected at the 1998, 2001 and 2004 elections. Howard's actions as prime minister included implementing new gun laws in response to the Port Arthur massacre; the introduction of a nationwide value-added tax, immigration reform, and a controversial set of industrial relations reforms. Under his governance, Australia also contributed troops to the War in Afghanistan and the Iraq War, and led the International Force for East Timor. The Howard government was defeated at the 2007 federal election, with the Labor Party's Kevin Rudd succeeding him as prime minister. Howard also lost his own seat of Bennelong at the election to Maxine McKew, becoming only the second prime minister to do so, after Stanley Bruce in 1929. Following this loss, Howard retired from politics.

Entry to parliament

In 2000, Turnbull intended to seek Liberal preselection for Wentworth but did not eventually contest after concluding that preselection hopeful Peter King had the numbers in the branches.^[26] In 2003, Turnbull announced that he would challenge King for the seat and successfully defeated him to become the Liberal candidate.^{[53][26]} During what was a bitter preselection campaign, King accused Turnbull of branch stacking, by having local members transferring their membership to a branch that would decide the pre-selection, what King referred to as "branch stripping".^[54]

Following his preselection loss, King stood against Turnbull at the 2004 federal election as an independent candidate. As a result, the traditionally safe Liberal seat became an electoral wildcard, the contest becoming a three-person race between Turnbull, King and the Labor candidate David Patch. During the campaign, Turnbull spent over A\$600,000 on his campaign.^[55] While the Liberal primary vote eventually fell by 10.3% to a total 41.8%, King received only 18% of the primary vote with a 57%/43% Liberal/Labor preference split which meant Turnbull was elected, albeit on a reduced 55.5% two-party vote after a 2.4% swing. The result meant that Wentworth was classified as a marginal seat for the first time since the 1993 federal election.^[56]

Cabinet Minister

Announcing a cabinet reshuffle on 24 January 2006, Prime Minister John Howard promoted Turnbull from the backbench to the role of parliamentary secretary, giving him special responsibility for water at the height of the 2000s Australian drought.^[57] On 26 September 2006, Howard announced the creation of a new Office of Water Resources, sitting within the Department of the Prime Minister and Cabinet,^[58] to address the problem of drought in Australia; Turnbull was given responsibility for this office.

In January 2007, Howard promoted Turnbull to the Cabinet as Minister for the Environment and Water. In this position, Turnbull approved a proposed A\$1.7 billion Bell Bay Pulp Mill in north Tasmania, near Launceston.^[59] Turnbull's approval of the Bell Bay Pulp Mill project of Gunns came on 4 October 2007 and followed a report by the Government's chief scientist Jim Peacock on the project's potential environmental impact, which required the project to meet 48 "strict environmental" conditions.

FRAUD AND DECEPTION - MIS USE / CONDUCT OF GOV FUNDS .
In February 2007, Turnbull was criticised for claiming a government allowance of A\$175 a night and paying it to his wife as rent while living in a townhouse owned by her in Canberra.^[60]

During the 2007 federal election campaign, Turnbull announced that if re-elected the Government would contribute A\$10 million to the investigation of an untried Russian technology that aims to trigger rainfall from the atmosphere, even when there are no clouds. The Australian Rain Corporation presented research documents written in Russian, explained by a Russian researcher who spoke to local experts in Russian.^[61] Although Turnbull claimed that the Australian Rain Corporation was Australian-based, investigations revealed that it was 75% Swiss-owned. It was also revealed that a prominent stakeholder in the Australian Rain Corporation, Matt Handbury, is a nephew of Rupert Murdoch. Turnbull refused to answer questions regarding Handbury's contribution to the Wentworth Forum, the main fund-raising organisation for Turnbull's 2007 election campaign.^[61]

Opposition

Four hours after the close of polls, at approximately 10pm ACDST, incumbent Premier Jay Weatherill telephoned Steven Marshall and conceded defeat. Weatherill subsequently publicly announced that he had conceded, saying, "I'm sorry I couldn't bring home another victory, but I do feel like one of those horses that has won four Melbourne Cups and I think the handicap has caught up with us on this occasion."^{[77][78][79][80]}

Peter Malinauskas became Leader of the Opposition and succeeded Weatherill who had resigned as Labor leader, with Susan Close as deputy, following a Labor caucus meeting on 9 April 2018.^[81]

* In June 2019, he was appointed as an industry professor at the University of South Australia.^[82] In July 2019, he was appointed to conduct a review of Federal Labor's loss at the 2019 Australian federal election.^[83] In 2021, he was reported to have moved to Perth, Western Australia and be working for Andrew Forrest's Minderoo Foundation, promoting an early childhood development campaign named *Thrive by Five*.^[84]

In the 2021 Australia Day Honours, Weatherill was awarded Officer of the Order of Australia for "distinguished service to the people and Parliament of South Australia, particularly as Premier, and to early childhood and tertiary education".^[85]

Personal life

Weatherill is married to Melissa, and they have two young daughters.^[86] He is a supporter of the Port Adelaide Football Club.^[87]

After the election, Marshall continued to lead the Liberals in opposition.^[20] Former Liberal leader Martin Hamilton-Smith became an independent two months after the election and indicated his support for the government.^[21] Following the death of Such and the subsequent 2014 Fisher by-election which Labor won by five votes from a 7.3% 2PP swing away from the Liberals, Labor went from minority to majority government. Brock and Hamilton-Smith maintained their confidence and supply support for the government which provided a 26 to 21 parliamentary majority.^[22]

VINCENT BOLONE - 2018 SEXUAL TARGETING

2018 state election - *OLSEN - STEVEN MARSHALL*

The 2018 state election was held on 17 March. The July to September 2014 Newspoll had seen Labor begin to lead the Liberals on the two-party-preferred vote for the first time since 2009.^[23] The October to December 2015 Newspoll saw Marshall's leadership approval rating drop 11 points to 30%, the equal lowest Newspoll approval rating in history for a South Australian Opposition Leader since Dale Baker in 1990.^{[24][25][26]} At the election, Marshall again faced Weatherill and Labor which were seeking a record fifth term in office and the "wild card" centrist party, SA-Best, led by former Senator Nick Xenophon, who was seeking the balance of power in the Assembly. The 2016 electoral redistribution had given the Liberals an advantage of 27 seats to Labor's 20 seats heading into the election.

JOHN OLSEN - KADINA - COMMENCEMENT OF TARGETING

Four hours after the close of polls on election day, at approximately 10pm ACDST, Weatherill telephoned Steven Marshall and conceded defeat. Marshall was introduced to the election day function by former Liberal Premier John Olsen and claimed victory. The SA Liberals had won the election with 25 seats to Labor's 19, a bare majority of two – the first time the Liberals had won a state election since Olsen's victory in 1997.^{[27][28][29][30]} Despite the outcome, there was actually a state-wide two-party-preferred swing away from the Liberals toward Labor.^[31]

CONNECTED TO STEVEN MARSHALL - CONSPIRING AGAINST TARGETED VICTIM IN 2020 WITH VICKIE CHAPMAN, SA ATTORNEY GENERAL. Premier of South Australia

Two days after the election, with the result beyond doubt even though counting was still under way, Marshall had himself, deputy leader Vickie Chapman, and Father of the South Australian Parliament Rob Lucas sworn in as an interim three-person government by the Governor of South Australia, Hieu Van Le. Marshall became Premier, Chapman Deputy Premier and Attorney-General, and Lucas Treasurer. Lucas had previously served as Treasurer in the last Liberal government.^[32] The full ministry was sworn in on 22 March.^[33] In addition to serving as Premier, Marshall retained responsibility for portfolio areas of The Arts, Aboriginal Affairs and Reconciliation, Defence and Space Industries, Veterans' Affairs and Multicultural Affairs, although these were no longer named as ministries.^[34]

I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint.

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in [REDACTED] between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the *Independent Commissioner Against Corruption Act 2012* prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling 1300 366 424 or (08) 8436 3555.

I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

Julia Gillard

Julia Eileen Gillard AC (born 29 September 1961) is an Australian former politician who served as the 27th prime minister of Australia from 2010 to 2013. She held office as leader of the Australian Labor Party (ALP). She is the first and only female prime minister in Australian history.

Born in Barry, Wales, Gillard migrated with her family to Adelaide in South Australia in 1966. She attended Mitcham Demonstration School and Unley High School. Gillard went on to study at the University of Adelaide, but switched to the University of Melbourne in 1982, where she graduated with a Bachelor of Laws in 1986 and a Bachelor of Arts in 1989. During this time, she was President of the Australian Union of Students from 1983 to 1984. In 1987, Gillard joined the law firm Slater & Gordon, eventually becoming a partner in 1990, specialising in industrial law. In 1996, she became Chief of Staff to John Brumby, the Leader of the Opposition in Victoria.

Gillard was first elected to the House of Representatives at the 1998 election for the seat of Lalor. Following the 2001 election, she was appointed to the Shadow Cabinet. In December 2006, Gillard became the running mate of Kevin Rudd in a successful leadership challenge to Kim Beazley, becoming deputy leader of the opposition. After Labor's victory at the 2007 election, she was appointed as the deputy prime minister of Australia, and was also given the roles of Minister for Education, Minister for Employment and Workplace Relations, and Minister for Social Inclusion.

On 24 June 2010, after Rudd lost internal support within the Labor Party and resigned as leader, Gillard was elected unopposed as his replacement in a leadership spill, and was sworn-in as prime minister. She led Labor through the 2010 election weeks later, which saw the first hung parliament since 1940. Gillard was able to form a minority government with the support of a Green MP and three independents. The Gillard Government introduced the National Disability Insurance Scheme, introduced Gonski funding for Australian education, implemented carbon pricing in Australia, and oversaw the National Broadband Network (NBN). On 26 June 2013, after a lengthy period of leadership instability, Gillard lost the leadership of the Labor Party back to Rudd at a leadership spill. Her resignation as prime minister took effect the next day, and she announced her retirement from politics.

Pauline Lee Hanson (*née* **Seccombe**, formerly **Zagorski**; born 27 May 1954) is an Australian politician who is the founder and leader of One Nation, a right-wing populist political party. Hanson has represented Queensland in the Australian Senate since 2016 Federal Election.

Hanson ran a fish and chip shop before entering politics in 1994 as a member of Ipswich City Council in her home state. She joined the Liberal Party of Australia in 1995 and was preselected for the Division of Oxley in Brisbane at the 1996 federal election. She was disendorsed shortly before the election after making contentious comments about Aboriginal Australians, but remained listed as a Liberal on the ballot paper. Hanson won the election and took her seat as an independent, before co-founding One Nation in 1997 and becoming its only MP. She attempted to switch to the Division of Blair at the 1998 federal election but was unsuccessful.

After her defeat in 1998, Hanson contested several state and federal elections as the leader of One Nation, as the leader of Pauline Hanson's United Australia Party and as an independent. She was expelled from One Nation in 2002. A District Court jury found Hanson guilty of electoral fraud in 2003, but her convictions were later overturned by three judges on the Queensland Court of Appeal. She spent 11 weeks in jail prior to the appeal being heard.

Hanson rejoined One Nation in 2013, becoming leader again the following year. She was narrowly defeated at the 2015 Queensland state election, but at the 2016 federal election was elected to the Senate, along with three other members of the party.

Kevin Michael Rudd AC (born 21 September 1957) is an Australian former politician and diplomat who served as the 26th prime minister of Australia, from December 2007 to June 2010 and again from June 2013 to September 2013. He held office as the leader of the Australian Labor Party.

In December 2006, he defeated Kim Beazley in a leadership spill to become the leader of the Labor Party, thus becoming Leader of the Opposition. Rudd led Labor to a landslide victory at the 2007 election, defeating the Howard Government. The

* Rudd Government's earliest acts included action on climate change through ratification of the Kyoto Protocol and delivering the first national apology to Australia's Indigenous peoples for the Stolen Generations. The Government also provided economic stimulus packages in response to the financial crisis of 2007–2008, resulting in Australia becoming one of the only developed countries to avoid the late-2000s recession. Other signature policies included establishing the National Broadband Network (NBN), launching the Digital Education Revolution and the Building the Education Revolution, dismantling WorkChoices, and withdrawing Australian troops from the Iraq War.

In 2010, Rudd would begin to face instability within his party, after the Australian Senate rejected his government's proposed Carbon Pollution Reduction Scheme. This prompted deputy prime minister Julia Gillard to challenge him for the leadership of the Labor Party in June of that year. Rather than contest the leadership, Rudd chose to resign, meaning that Gillard replaced him as prime minister. His removal from office would mark a sequence of four subsequent prime ministers who would all be removed by their own parties before completing their full first term.^[2] Rudd would remain in the party as a backbencher, and chose to re-contest his seat at the 2010 election, which resulted in a Gillard-led minority government. 

eSafety and Adult Cyber Abuse

The eSafety Commissioner's (eSafety's) primary role in dealing with cyberbullying complaints is to assist with the rapid removal of cyberbullying material targeted at Australian children, on social media services.

Please be aware that eSafety, therefore, has no legislative power to investigate adult cyber abuse complaints, formally. However, we do work to guide people where we can and provide advice on what they can do themselves.

POLICE INVOLVEMENT - FRAUDULENT ACTIVITY OBTAINED 2021 - GOV INVOLVEMENT

I reported the Fraudulent malicious Activity of the newly created business account to Joshua Adams, Business Consultant, Telstra Store, [REDACTED] who proceeded to file a report to the Fraud Department and requested an investigation into the activity - Refer to Telstra Report dated 1/10/2020

I received no reply or response from this report.

The Fraudulent and malicious Activity continued and escalated.

On the 25/03/2021 I reported the activity again to Joshua Adams, Business Consultant, Telstra Store, [REDACTED] and reported that I had not received any contact from the Fraud Department concerning the report that he had submitted. I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

On the 25/03/2021 I reported the Fraudulent Malicious activity to Isobelle Oppeloar, Manager, Telstra Store, [REDACTED] who proceeded to file a report to a higher authority, requesting an investigation with the higher authority of the Fraud Division or CEO of Telstra, due to ongoing issues over a 10 year period of continuous Fraudulent Activity. - Refer to Letter addressed to Isobelle Oppeloar, Manager - Refer to document filed report and Case ID number

I received contact from Telstra higher authority but missed the call and am waiting for the second contact, to ring me back as informed in the voice recorded message left on my mobile phone to discuss the issue.

On the 13th April 2021 I sent a letter addressed to the CEO of Telstra Head Office, Mr Andrew Penn, Melbourne, Victoria from the Norwood Post Office branch, Adelaide informing the CEO of the continuous Fraudulent Malicious Activity that had been occurring in my personal and newly created business account with Restricted Access, and requested a thorough investigation into the activity and provided the documented evidence of the activity that had been occurring in all servers and over a long period of time, and following re-location and change of details Refer to letter addressed to CEO - Mr Andrew Penn - Telstra Head Office, Melbourne Specific Targeting of an Individual - Every location, re-location, changed servers and personal details, including change of phone numbers - Pattern of Illegal Activity

I received phone contact from Ron, Telstra Head Office following the submitted letter to Mr Andrew Penn, CEO of Telstra Head Office - Recorded Phone call.


I was informed that the reports that had been submitted over a 10 year period in

* Telecommunication Systems concerning continuous ongoing Fraudulent Activity in my accounts, * following Restricted Access applied, change of phone numbers, change of details personal and business, change of servers and relocation was identified as Government and Police Sources

* Remotely Accessing servers, accounts and computer hardware to result in the Fraudulent activity * that had been occurring, which included blocked contact, altered and blocked messages, blocked access to internet services, websites and contacts, impersonating of companies, unusual messages and phone calls from unknown people, blocked contact and altered messages to my children, as informed by my children and resulted in isolation in 2014 - 2016 Extreme Sexual Targeting, Police Targeting and detention. * This information confirmed the details obtained in 2016 Origin Electricity account that incurred an Excessive Rise in billing that remained unexplained and resulted in the barcode being scanned as a Police Source causing the Fraudulent Activity. * Townsville CC Parking Fines (Queensland Police Source). *

The source of the Continuous Illegal Activity has now been Identified as Government and Police Specific Targeting of an Individual over a 27 year period which resulted in the 2017 Murder to Appear as Suicide by medication as a result of Police Targeting (Detention in Glenside Mental Health Facility)

In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.^[92] She had allegedly undressed, but left the encounter wearing her underwear.^[93]

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.^{[71][94]} During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.^[92]

The Federal Bureau of Investigation (FBI) then became involved. Subsequently, the police alleged that Epstein had paid several girls to perform sexual acts with him.^[89] Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.^{[95][96]} The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.^[93] Adriana Ross, a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.^[97] The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Recarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude – Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*^[98]

A former employee told the police that Epstein would receive massages three times a day.^[93] Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.^[99] Julie Brown's 2018 exposés in the Miami Herald identified about 80 victims and located about 60 of them.^{[1][71][100]} She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."^[1] Details from the investigation included allegations that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.^{[95][101][102]}

In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.^{[93][103]} On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.^{[5][9][104][105]} State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,^[106] to which Epstein pleaded not guilty in August 2006.^[107]

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.^{[92][108]} Linguist Steven Pinker also assisted.^[109]

Criminal charges

Arrest and indictment

Maxwell faced persistent allegations of procuring and sexually trafficking underage girls for Epstein and others, charges she denied.^[9] Maxwell was arrested in Bradford, New Hampshire by the FBI on 2 July 2020, through the use of an IMSI-catcher ("stingray") mobile phone tracking device on a phone used by her to call one of her lawyers, her husband Scott Borgerson, and her sister Isabel.^[103]

Maxwell was charged with enticement of minors, sex trafficking of children, and perjury.^{[10][104][105]} Prosecutors, led by United States District Attorney Audrey Strauss, charged her with six federal crimes, including enticement of minors, sex trafficking, and perjury.^{[104][106][107][108]} The indictment charged that between 1994 and 1997, she "assisted, facilitated, and contributed" to the abuse of minor girls despite knowing that one of three unnamed victims was 14 years old.^[109]

As of 28 April 2021, Maxwell was held at the Metropolitan Detention Center, Brooklyn, New York.^{[110][111][112]} Lawyers requested that Judge Nathan release her on \$5 million bond with monitored home confinement while awaiting trial.^[113] Maxwell appeared by video link before a court in Manhattan on 14 July 2020 and pleaded not guilty to the charges.^[114] A naturalised US citizen since 2002 who also holds passports from France and the United Kingdom, Maxwell was denied bail as a flight risk amid concerns regarding her "completely opaque" finances, her skill at living in hiding, and the fact that France does not extradite its citizens.^{[11][113][115][116][117]} The judge set a trial date of 12 July 2021.^{[114][118][119]}

Maxwell's attorney reiterated her request for bail on 18 December 2020, and proposed that Maxwell reside with a friend in New York City while under 24-hour surveillance as she awaited trial.^[120] Her husband, Scott Borgerson, made a secured offer of US\$22 million to guarantee her presence at future appearances.^[120] On 28 December 2020, a further request for bail was again rejected by the judge.^[121] Maxwell's bail request was opposed by alleged victim Annie Farmer.^[120]

On 19 January 2021, a court hearing was disrupted by believers in QAnon – who believe Maxwell to be working in cohort with a cabal of child-sacrificing Satanist liberal elites who traffic children for sex – as the proceedings were illegally livestreamed to YouTube.^{[122][123]}

On 26 January 2021, a motion by Maxwell's attorneys challenged her grand jury indictment, claiming that it did not reflect the ethnic diversity of the jurisdiction in which the violations of the law were alleged to have occurred.^[124]

On 29 March 2021, US prosecutors added new charges of sex trafficking a minor and sex trafficking conspiracy, alleging that Maxwell was involved in grooming a fourth girl, aged 14, to engage in sexual acts with Epstein between 2001 and 2004 at his Palm Beach estate.^{[125][126]} Maxwell pleaded not guilty to the additional charges; she faced six counts that included sex trafficking of a minor and sex trafficking conspiracy, in addition to two counts of perjury.^[127]

Maxwell's attorneys regularly protested about the conditions of her confinement, which included being kept awake by a light shone in her eyes every fifteen minutes to deter the chances of her committing suicide, and being denied a sleep mask.^[128] One, David Marcus, protested, "There's no

At least 26 women, including his first wife, have publicly accused Trump of rape, kissing and groping without consent, looking under women's skirts, or walking in on naked teenage pageant contestants.^{[803][804][805]} In 2016, he denied all accusations, calling them "false smears" and alleging a conspiracy against him and the American people.^[806]

Incitement of violence

Research suggests Trump's rhetoric caused an increased incidence of hate crimes.^{[807][808]} During his 2016 campaign, he urged or praised physical attacks against protesters or reporters.^{[809][810]} Numerous defendants investigated or prosecuted for violent acts and hate crimes, including participants of the January 6, 2021, storming of the U.S. Capitol, cited Trump's rhetoric in arguing that they were not culpable or should receive a lighter sentence.^{[811][812]} A nationwide review by ABC News in May 2020 identified at least 54 criminal cases from August 2015 to April 2020 in which Trump was invoked in direct connection with violence or threats of violence mostly by white men and primarily against members of minority groups.^[813]

Popular culture

Trump has been the subject of parody, comedy, and caricature on television, in movies, and in comics. Trump was named in hundreds of hip hop songs since the 1980s, mostly positive. Mentions turned largely negative and pejorative after he began running for office in 2015.^[814]

While in college, Trump obtained four student draft deferments during the Vietnam War era.^[11] In 1966, he was deemed fit for military service based upon a medical examination, and in July 1968 a local draft board classified him as eligible to serve.^[12] In October 1968, he was classified 1-Y, a conditional medical deferment,^[13] and in 1972, he was reclassified 4-F due to bone spurs, permanently disqualifying him from service.^[14]

* Family * EPSTEIN - MAXWELL - MODELLING * - TRUMP

In 1977, Trump married Czech model Ivana Zelníčková.^[15] They have three children, Donald Jr. (born 1977), Ivanka (born 1981), and Eric (born 1984). Ivana became a naturalized United States citizen in 1988.^[16] The couple divorced in 1992, following Trump's affair with actress Marla Maples.^[17] He and Maples have one daughter, Tiffany (born 1993).^[18] They married in 1993, separated in 1997, and divorced in 1999.^[19] Tiffany was raised by Marla in California.^[20] In 2005, Trump married Slovenian model Melania Knauss.^[21] They have one son, Barron (born 2006).^[22] Melania gained U.S. citizenship in 2006.^[23]

Religion

Trump went to Sunday school and was confirmed in 1959 at the First Presbyterian Church in Jamaica, Queens.^{[24][25]} In the 1970s, his parents joined the Marble Collegiate Church in Manhattan, which belongs to the Reformed Church.^{[24][26]} The pastor at Marble, Norman Vincent Peale,^[24] ministered to the family until his death in 1993.^[26] Trump has described him as a mentor.^[27] In 2015, the church stated that Trump was not an active member.^[25] In 2019, he appointed his personal pastor, televangelist Paula White, to the White House Office of Public Liaison.^[28] In 2020, he said he identified as a non-denominational Christian.^[29]

Wealth

In 1982, Trump made the initial Forbes list of wealthy people for holding a share of his family's estimated \$200 million net worth. His losses in the 1980s dropped him from the list between 1990 and 1995.^[30] After filing mandatory financial disclosure forms with the FEC in July 2015, he announced a net worth of about \$10 billion. Records released by the FEC showed at least \$1.4 billion in assets and \$265 million in liabilities.^[31] Forbes estimated his net worth at \$4.5 billion in 2015 and \$3.1 billion in 2018.^[32] In its 2021 billionaires ranking, it was \$2.4 billion (1,299th in the world), making him one of the wealthiest officeholders in American history.^[33]

Journalist Jonathan Greenberg reported in 2018 that Trump, using the pseudonym "John Barron" and claiming to be a Trump Organization official, called him in 1984 to falsely assert that he owned "in excess of ninety percent" of the Trump family's business, to secure a higher ranking on the Forbes 400 list of wealthy Americans. Greenberg also wrote that Forbes had vastly overestimated Trump's wealth and wrongly included him on the Forbes 400 rankings of 1982, 1983, and 1984.^[34]

Trump has often said he began his career with "a small loan of one million dollars" from his father, and that he had to pay it back with interest.^[35] He was a millionaire by age eight, borrowed at least \$60 million from his father, largely failed to repay those loans, and received another \$413 million (adjusted for inflation) from his father's company.^{[36][37]} In 2018, he and his family were reported to have committed tax fraud, and the New York tax department began investigating.^[38] His investments underperformed the stock and New York property markets.^{[39][40]} Forbes estimated in October 2018 that his net worth declined from \$4.5 billion in 2015 to \$3.1 billion in 2017 and his product licensing income from \$23 million to \$3 million.^[41]

The Fraudulent and malicious Activity continued and escalated.

On the 25/03/2021 I reported the activity again to Joshua Adams, Business Consultant, Telstra Store, [REDACTED] and reported that I had not received any contact from the Fraud Department concerning the report that he had submitted. I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

On the 25/03/2021 I reported the Fraudulent Malicious activity to Isobelle Oppeloar, Manager, Telstra Store, [REDACTED] who proceeded to file a report to a higher authority, requesting an investigation with the higher authority of the Fraud Division or CEO of Telstra, due to ongoing issues over a 10 year period of continuous Fraudulent Activity. - Refer to Letter addressed to Isobelle Oppeloar, Manager - Refer to document filed report and Case ID number

I received contact from Telstra higher authority but missed the call and am waiting for the second contact, to ring me back as informed in the voice recorded message left on my mobile phone to discuss the issue.

On the 13th April 2021 I sent a letter addressed to the CEO of Telstra Head Office, Mr Andrew Penn, Melbourne, Victoria from the Norwood Post Office branch, Adelaide informing the CEO of the continuous Fraudulent Malicious Activity that had been occurring in my personal and newly created business account with Restricted Access, and requested a thorough investigation into the activity and provided the documented evidence of the activity that had been occurring in all servers and over a long period of time, and following re-location and change of details Refer to letter addressed to CEO - Mr Andrew Penn - Telstra Head Office, Melbourne Specific Targeting of an Individual - Every location, re-location, changed servers and personal details, including change of phone numbers - Pattern of Illegal Activity

I received phone contact from Ron, Telstra Head Office following the submitted letter to Mr Andrew Penn, CEO of Telstra Head Office - Recorded Phone call.

I was informed that the reports that had been submitted over a 10 year period in

Telecommunication Systems concerning continuous ongoing Fraudulent Activity in my accounts,

following Restricted Access applied, change of phone numbers, change of details personal and business, change of servers and relocation was identified as Government and Police Sources

Remotely Accessing servers, accounts and computer hardware to result in the Fraudulent activity

that had been occurring, which included blocked contact, altered and blocked messages, blocked access to internet services, websites and contacts, impersonating of companies, unusual messages and phone calls from unknown people, blocked contact and altered messages to my children, as informed by my children and resulted in isolation in 2014 - 2016 Extreme Sexual Targeting, Police Targeting and detention.

This information confirmed the details obtained in 2016 Origin Electricity account that incurred an Excessive Rise in billing that remained unexplained and resulted in the barcode being scanned as a Police Source causing the Fraudulent Activity, Townsville CC Parking Fines (Queensland Police Source).

The source of the Continuous Illegal Activity has now been Identified as Government and Police Specific Targeting of an Individual over a 27 year period which resulted in the 2017 Murder to Appear as Suicide by medication as a result of Police Targeting (Detention in Glenside Mental Health Facility)

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

Bloom asserted that the woman had received threats. The suit was dropped on November 4, 2016. Trump attorney Alan Garten denied the allegations, while Epstein declined to comment.^{[156][157][158][159][160]}

DESTRUCTION OF CAREER FOR SEX DEMAND

Sarah Ransome v. Epstein and Maxwell (2017)

In 2017, Sarah Ransome filed a suit against Epstein and Maxwell, alleging that Maxwell had hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York City and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.^{[161][162]}

Bradley Edwards' defamation v. Epstein (2018)

A state civil lawsuit in Florida filed by attorney Bradley Edwards against Epstein was scheduled for trial in December 2018. The trial was expected to provide victims with their first opportunity to make their accusations in public. However, the case was settled on the first day of the trial, with Epstein publicly apologizing to Edwards; other terms of the settlement were confidential.^{[137][163]}



Epstein was accused of sex trafficking of minors at his mansion at 9 East 71st Street.

Maria Farmer v. Epstein and Maxwell (2019)

On April 16, 2019, Maria Farmer went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. Farmer met Epstein and Maxwell at her graduate art gallery reception at the New York Academy of Art in 1995. The following year, in the summer of 1996, they hired her to work on an art project in Leslie Wexner's Ohio mansion, where she was then sexually assaulted.^[164] Farmer reported the incident to the New York City Police Department and the FBI.^[165]

Farmer's affidavit also stated that during the same summer, Epstein flew her then-15-year-old sister to his New Mexico property where he and Maxwell sexually abused her on a massage table.^[166]

Jennifer Araoz v. Epstein and Maxwell (2019)

On July 22, 2019, while in jail awaiting trial, Epstein was served with a petition regarding a pending state civil lawsuit filed by Jennifer Araoz.^[167] She stated that an associate for Epstein had recruited her outside Talent Unlimited High School at age 14 and she was gradually groomed for over a year before Epstein raped her in his New York City mansion when she was 15.^[168] Araoz filed her suit on August 14, 2019, when New York State law was updated to allow one year for adult survivors of child sexual abuse to sue for previous offenses, regardless of how long ago the abuse took place.^[169] In October 2019, Araoz amended her complaint to include over 20 corporate entities associated with Epstein and named the additional individuals Lesley Groff and Cimberly Espinosa as enablers.^[170]

Katlyn Doe, et al. v. Epstein's estate (2019)

George, his alleged criminal activities on the islands were concealed through a complex network of companies.^[180]

Jane Doe v. Maxwell and Epstein's estate (2020)

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse^[181] The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.^[181]

Jane Does v. Epstein estate (2020)

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.^[182]

Jane Doe v. Epstein estate (2020)

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.^[183]

Jane Doe v. Epstein estate (2021)

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.^[184]



According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds - and perhaps thousands - of sexually suggestive photographs of fully - or partially - nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: "Young [Name] + [Name]", "Misc nudes 1", and "Girl pics nude".^[90] Also found in the safe were \$70,000 in cash, 48 diamonds,^[190] and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. 





 The dashboard displays occupancy per hospital split across 'general' beds and 'all' beds, breakdown of inpatients, the length of stay, and much more.

* "South Australia was the first state in the country to make this level of information available to the public and we are excited to extend this technology to country residents."

"Through the dashboard the general public can gain a better understanding about how patient flow is managed in our busy hospital environments."

Professor Moyes said the dashboard, which is available online, will be updated every 30 minutes to provide real-time information about bed occupancy, average length of stay and inpatient flows.

"The dashboard also includes information specific to each hospital about the number of patients currently within each area or clinical unit at the hospital," Professor Moyes said.

"It allows people to easily see all of the different 'streams' of inpatient care that each hospital provides, such as surgical or pediatrics, and the status of each of these areas.

"Staff already use the dashboard, along with a range of other tools, to help monitor and manage capacity and ensure that patient safety is maintained.

"By releasing this data publicly we are continuing to make our health system more transparent."



Criminal charges

Arrest and indictment

Maxwell faced persistent allegations of procuring and sexually trafficking underage girls for Epstein and others, charges she denied.^[9] Maxwell was arrested in Bradford, New Hampshire by the FBI on 2 July 2020, through the use of an IMSI-catcher ("stingray") mobile phone tracking device on a phone used by her to call one of her lawyers, her husband Scott Borgerson, and her sister Isabel.^[103]

Maxwell was charged with enticement of minors, sex trafficking of children, and perjury.^{[10][104][105]} Prosecutors, led by United States District Attorney Audrey Strauss, charged her with six federal crimes, including enticement of minors, sex trafficking, and perjury.^{[104][106][107][108]} The indictment charged that between 1994 and 1997, she "assisted, facilitated, and contributed" to the abuse of minor girls despite knowing that one of three unnamed victims was 14 years old.^[109]

As of 28 April 2021, Maxwell was held at the Metropolitan Detention Center, Brooklyn, New York.^{[110][111][112]} Lawyers requested that Judge Nathan release her on \$5 million bond with monitored home confinement while awaiting trial.^[113] Maxwell appeared by video link before a court in Manhattan on 14 July 2020 and pleaded not guilty to the charges.^[114] A naturalised US citizen since 2002 who also holds passports from France and the United Kingdom, Maxwell was denied bail as a flight risk amid concerns regarding her "completely opaque" finances, her skill at living in hiding, and the fact that France does not extradite its citizens.^{[11][113][115][116][117]} The judge set a trial date of 12 July 2021.^{[114][118][119]}

Maxwell's attorney reiterated her request for bail on 18 December 2020, and proposed that Maxwell reside with a friend in New York City while under 24-hour surveillance as she awaited trial.^[120] Her husband, Scott Borgerson, made a secured offer of US\$22 million to guarantee her presence at future appearances.^[120] On 28 December 2020, a further request for bail was again rejected by the judge.^[121] Maxwell's bail request was opposed by alleged victim Annie Farmer.^[120]

On 19 January 2021, a court hearing was disrupted by believers in QAnon – who believe Maxwell to be working in cohort with a cabal of child-sacrificing Satanist liberal elites who traffic children for sex – as the proceedings were illegally livestreamed to YouTube.^{[122][123]}

On 26 January 2021, a motion by Maxwell's attorneys challenged her grand jury indictment, claiming that it did not reflect the ethnic diversity of the jurisdiction in which the violations of the law were alleged to have occurred.^[124]

On 29 March 2021, US prosecutors added new charges of sex trafficking a minor and sex trafficking conspiracy, alleging that Maxwell was involved in grooming a fourth girl, aged 14, to engage in sexual acts with Epstein between 2001 and 2004 at his Palm Beach estate.^{[125][126]} Maxwell pleaded not guilty to the additional charges; she faced six counts that included sex trafficking of a minor and sex trafficking conspiracy, in addition to two counts of perjury.^[127]

Maxwell's attorneys regularly protested about the conditions of her confinement, which included being kept awake by a light shone in her eyes every fifteen minutes to deter the chances of her committing suicide, and being denied a sleep mask.^[128] One, David Marcus, protested, "There's no



Relationship with Jeffrey Epstein

Accounts differ on when Maxwell first met American financier Jeffrey Epstein. According to Epstein's former business partner, Steven Hoffenberg, Robert Maxwell introduced his daughter to Epstein in the late 1980s.^[49] The Times reported that Maxwell met Epstein in the early 1990s at a New York party following "a difficult break-up with Count Gianfranco Cicogna Mozzoni" (1962–2012) of the CIGA Hotels clan.^[50]

Maxwell had a romantic relationship with Epstein for several years in the early 1990s and remained closely associated with him for more than 25 years until his death in 2019.^{[22][48][51]} The nature of their relationship remains unclear. In a 2009 deposition, several of Epstein's household employees testified that Epstein referred to her as his "main girlfriend" who also hired, fired, and supervised his staff, starting around 1992.^[52] She has also been referred to as the "Lady of the House" by Epstein's staff and as his "aggressive assistant".^[53] In a 2003 Vanity Fair profile on Epstein, author Vicky Ward said Epstein referred to Maxwell as "my best friend".^[54] Ward also observed that Maxwell seemed "to organize much of his life".^[54]

Politico reported that Maxwell and Epstein had friendships with several prominent individuals in elite circles of politics, academia, business and law, including former Presidents Donald Trump and Bill Clinton, attorney Alan Dershowitz, and Prince Andrew, Duke of York.^[55]

Maxwell is known for her longstanding friendship^[56] with Prince Andrew, and for having escorted him to a "hookers and pimps" social function in New York.^[57] She introduced Epstein to Prince Andrew, and the three often socialised together.^[58] In 2000, Maxwell and Epstein attended a party thrown by Prince Andrew at the Queen's Sandringham House estate in Norfolk, England, reportedly for Maxwell's 39th birthday.^[59] In a November 2019 interview with the BBC, Prince Andrew confirmed that Maxwell and Epstein had attended an event at his invitation, but he denied that it was anything more than a "straightforward shooting weekend".^[60]

In 1995, Epstein renamed one of his companies the Ghislaine Corporation; based in Palm Beach, Florida, the company was dissolved in 1998.^[52] As a trained helicopter pilot, Maxwell also transported Epstein to his private Caribbean island.^{[61][6]}

In 2008, Epstein was convicted of soliciting a minor for prostitution and served 13 months of an 18-month jail sentence. Following Epstein's release, although Maxwell continued to attend prominent social functions, she and Epstein were no longer seen together publicly.^[9]


By late 2015, Maxwell had largely retreated from attending social functions.^{[9][62]}





A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States* (2014)

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

Virginia Giuffre v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.^{[146][147][148]} Giuffre filed a defamation suit against Dershowitz,

Presidential campaigns

CONNECTIONS TO NEW YORK - EPSTEIN - MAXWELL

1992

In the first primary contest, the Iowa Caucus, Clinton finished a distant third to Iowa senator Tom Harkin. During the campaign for the New Hampshire primary, reports surfaced that Clinton had engaged in an extramarital affair with Gennifer Flowers. Clinton fell far behind former Massachusetts senator Paul Tsongas in the New Hampshire polls.^[12] Following Super Bowl XXVI, Clinton and his wife Hillary went on 60 Minutes to rebuff the charges.^[66] Their television appearance was a calculated risk, but Clinton regained several delegates. He finished second to Tsongas in the New Hampshire primary, but after trailing badly in the polls and coming within single digits of winning, the media viewed it as a victory. News outlets labeled him "The Comeback Kid" for earning a firm second-place finish.^[67]

Winning the big prizes of Florida and Texas and many of the Southern primaries on Super Tuesday gave Clinton a sizable delegate lead. However, former California governor Jerry Brown was scoring victories and Clinton had yet to win a significant contest outside his native South.^{[12][65]} With no major Southern state remaining, Clinton targeted New York, which had many delegates. He scored a resounding victory in New York City, shedding his image as a regional candidate.^[65] Having been transformed into the consensus candidate, he secured the Democratic Party nomination, finishing with a victory in Jerry Brown's home state of California.^[12]

During the campaign, questions of conflict of interest regarding state business and the politically powerful Rose Law Firm, at which Hillary Rodham Clinton was a partner, arose. Clinton argued the questions were moot because all transactions with the state had been deducted before determining Hillary's firm pay.^[68] Further concern arose when Bill Clinton announced that, with Hillary, voters would be getting two presidents "for the price of one".^[69]

Clinton was still the governor of Arkansas while campaigning for U.S. president, and he returned to his home state to see that Ricky Ray Rector would be executed. After killing a police officer and a civilian, Rector shot himself in the head, leading to what his lawyers said was a state where he could still talk but did not understand the idea of death. According to both Arkansas state law and Federal law, a seriously mentally impaired inmate cannot be executed. The courts disagreed with the allegation of grave mental impairment and allowed the execution. Clinton's return to Arkansas for the execution was framed in an article for The New York Times as a possible political move to counter "soft on crime" accusations.^{[54][70]}

Bush's approval ratings were around 80 percent during the Gulf War, and he was described as unbeatable. When Bush compromised with Democrats to try to lower Federal deficits, he reneged on his promise not to raise taxes, which hurt his approval rating. Clinton repeatedly condemned Bush for making a promise he failed to keep.^[65] By election time, the economy was souring and Bush saw his approval rating plummet to just slightly over 40 percent.^{[65][71]} Finally, conservatives were previously united by anti-communism, but with the end of the Cold War, the party lacked a uniting issue. When Pat Buchanan and Pat Robertson addressed Christian themes at the Republican National Convention—with Bush criticizing Democrats for omitting God from their platform—many moderates were alienated.^[72] Clinton then pointed to his moderate, "New Democrat" record as governor of Arkansas, though some on the more liberal side of the party

Contrary to his claims of financial health and business acumen, Trump's tax returns from 1985 to 1994 show net losses totaling \$1.17 billion. The losses were higher than those of almost every other American taxpayer. The losses in 1990 and 1991, more than \$250 million each year, were more than double those of the nearest losers. In 1995, his reported losses were \$915.7 million. [42][43]

Over twenty years, Trump lost hundreds of millions of dollars and deferred declaring \$287 million in forgiven debt as taxable income. His income mainly came from his share in *The Apprentice* and businesses in which he was a minority partner, and his losses mainly from majority-owned businesses. Much income was in tax credits for his losses, which let him avoid annual income tax payments or lowered them to \$750. In the last decade, he balanced his businesses' losses by selling and borrowing against assets, including a \$100 million mortgage on Trump Tower (due in 2022) and the liquidation of over \$200 million in stocks and bonds. He personally guaranteed \$421 million in debt, most of which is due by 2024. [44]

As of October 2020, Trump has over \$1 billion in debts, secured by his assets. He owed \$640 million to banks and trust organizations, including Deutsche Bank, UBS, and Bank of China, and approximately \$450 million to unknown creditors. The value of his assets exceeds his debt. [45]

Business career



Real estate

Starting in 1968, Trump was employed at his father Fred's real estate company, Trump Management, which owned middle-class rental housing in New York City's outer boroughs. [46][47] In 1971, he became president of the company and began using The Trump Organization as an umbrella brand. [48]

Manhattan developments

Trump attracted public attention in 1978 with the launch of his family's first Manhattan venture, the renovation of the derelict Commodore Hotel, adjacent to Grand Central Terminal. The financing was facilitated by a \$400 million city property tax abatement arranged by Fred Trump [49] who also, jointly with Hyatt, guaranteed a \$70 million in bank construction financing. [50] The hotel reopened in 1980 as the Grand Hyatt Hotel, [51] and that same year, Trump obtained rights to develop Trump Tower, a mixed-use skyscraper in Midtown Manhattan. [52] The building houses the headquarters of the Trump Corporation and Trump's PAC and was Trump's primary residence until 2019. [53][54]

In 1988, Trump acquired the Plaza Hotel in Manhattan with a loan of \$425 million from a consortium of banks. Two years later, the hotel filed for bankruptcy protection, and a reorganization plan was approved in 1992. [55] In 1995, Trump sold the Plaza Hotel along with

Personal life 2013 EASY EDITOR - CRIME

Gates is an avid reader, and the ceiling of his large home library is engraved with a quotation from *The Great Gatsby*.^[187] He also enjoys bridge, tennis and golf.^{[188][189]} His days are planned for him on a minute-by-minute basis, similarly to the U.S. president's schedule.^[190] Despite his wealth and extensive business travel, Gates flew coach (economy class) in commercial aircraft until 1997, when he bought a private jet.^[191]

Gates purchased the Codex Leicester, a collection of scientific writings by Leonardo da Vinci, for US\$30.8 million at an auction in 1994.^[192] In 1998, he reportedly paid \$30 million for the original 1885 maritime painting Lost on the Grand Banks, at the time a record price for an American painting.^[193]

In 2016, he revealed that he was color-blind.^[194]

Marriage and divorce

Gates married Melinda French on the Hawaiian Island of Lanai on January 1, 1994.^[195] They met in 1987 after Melinda began working at Microsoft.^[196] At the time of their marriage, Gates was given permission by Melinda to spend limited time with his ex-girlfriend, businesswoman Ann Winblad.^[197] Bill and Melinda have three children: Jennifer, Rory and Phoebe.^[198]

The family's residence is an earth-sheltered mansion in the side of a hill overlooking Lake Washington in Medina, Washington. In 2009, property taxes on the mansion were reported to be US\$1.063 million, on a total assessed value of

US\$147.5 million.^[199] The 66,000-square-foot (6,100 m²) estate has a 60-foot (18 m) swimming pool with an underwater music system, as well as a 2,500-square-foot (230 m²) gym and a 1,000-square-foot (93 m²) dining room.^[200] On May 3, 2021, the Gateses announced they had decided to divorce after 27 years of marriage and 34 years as a couple.^[201] They said they would keep working together on charitable efforts.^{[201][202]} *The Wall Street Journal* reported that Melinda had been meeting with divorce attorneys since 2019, citing interviews that suggested Bill's ties with Jeffrey Epstein was at least one of her concerns.^[203] The divorce was finalized on August 2, 2021.^[204]

A *New York Times* article reported that Gates's relationship with convicted sex offender Jeffrey Epstein started in 2011, just a few years after Epstein's conviction, and continued for some years, including a visit to Epstein's house with Melinda in the fall of 2013, despite her declared

discomfort.^[205] Gates said in 2011 about Epstein: "His lifestyle is very different and kind of intriguing although it would not work for me".^[206]

The depth of the friendship between Gates and Epstein is unclear. Gates generally commented about his relationship with Epstein that "I met him. I didn't have any business relationship or friendship with him".^[207] However, Gates visited Epstein "many times, despite [Epstein's] past".^[205] Gates took at least one flight in 2013 in Epstein's infamous *Lolita Express* aircraft.^[205]

It was reported that Epstein and Gates "discussed the Gates Foundation and philanthropy".^[205] However, in an interview in 2019 Gates completely denied any connection between Epstein and the Gates Foundation or his philanthropy generally.^[207] In August 2021, Gates said the reason he had meetings with Epstein was because Gates hoped Epstein could provide money for philanthropic work, though nothing came of the idea. Gates added, "It was a huge mistake to spend time with him, to give him the credibility of being there."^[85]

* It has also been reported that Epstein and Gates met with Nobel Committee chair Thorbjørn Jagland at his residence in Strasbourg, France in March 2013 to discuss the Nobel Prize.^{[208][209]} Also in attendance were representatives of the International Peace Institute which has received millions in grants from the Gates Foundation, including a \$2.5 million "community engagement" grant in October 2013.^[210]

Public image

Gates's public image has changed over the years. At first he was perceived as a brilliant but ruthless "robber baron", a "nerd-turned-tycoon".^[211] Starting in 2000 with the foundation of the Bill and Melinda Gates Foundation, and particularly after he stepped down as head of Microsoft, he turned his attention to philanthropy, spending more than \$50 billion on causes like health, poverty, and education. His image morphed "from tyrannical technocrat to saintly savior", a "huggable billionaire techno-philanthropist", celebrated on magazine covers and sought after for his opinions on major issues like global health and climate change.^[211] Still another shift in public opinion came in 2021 with the announcement that he and Melinda were divorcing. Coverage of that proceeding brought out information about romantic pursuits of women who worked for him, a long-term extra-marital affair, and a friendship with convicted child sex trafficker Jeffrey Epstein.^[206] This resulted in some deterioration of his public image.^[212]

Religion

In an interview with *Rolling Stone*, Gates said in regard to his faith: "The moral systems of religion, I think, are super important. We've raised our kids in a religious way; they've gone to the Catholic church that Melinda goes to and I participate in. I've been very lucky, and therefore I owe it to try and reduce the inequity in the world. And that's kind of a religious belief. I mean, it's at least a moral belief."^[213] In the same 2014 interview he also said: "I agree with people like Richard Dawkins that mankind felt the need for creation myths. Before we really began to understand disease and the weather and things like that, we sought false explanations for them. Now science has filled in some of the realm – not all – that religion used to fill. But the mystery and the beauty of the world is overwhelmingly amazing, and there's no scientific explanation of how it came
