Direct targeting of targeted victim by Epstein and Maxwell commenced 2006 and continued until 2013 and contained sexual encouragement by Maxwell of the targeted victim, who had recently become separated from a 14 year marriage and was naive towards sexuality and being sexual / inexperienced
