I do not wish to reveal my identity or my personal details for my own protection and safety and would appreciate that all personal details within this cover letter remain confidential, as the nature of what I have submitted is of a controversial nature and could pose a risk to my own safety from certain individuals who are involved or disagree.

I am an educated woman who holds a degree in Business Management, Business Administration and have a publishing contract with a publisher in London, whom will be releasing my first book this year.

My interests include Psychology, Philosophy, Medical Science and Human behaviour.

I am submitting this article that I have written as I wish to express my views and hopefully have it published in order to deliver a different perspective to the public, which may change their perspective and take a different view upon what I feel is a very important issue within our society and has remained unaddressed in it 's entirety.

My article addresses all individuals involved which include society, the worker and the client, and addresses the Psychological behaviours and impact it imposes upon these individuals and society.

**I give you permission to publish the following statements :**

Each client, demand of this nature contributes to the illegal activity of human trafficking, child abduction for human trafficking, drugs, enslavement and violence, which in turn creates a part of society that is unrespected and develops extensive Psychological problems within these individuals who then can not contribute to society on an educated level.

## A Psychological View of Prostitution - The Sex Industry

In a world full of technology and knowledge have we really evolved into an educated society or have we forgotten an underlining issue of human behaviour that we have not addressed in it 's entirety.

Prostitution, the sex trade, is it really a profession or merely a means to an end, a quick solution for the under privileged and the unfortunate.

As a society we condemn the act of a woman who has one night stands with strangers or whom have many sexual partners and view it as unacceptable behaviour of which we frown upon and then label that woman as unrespectable. Then why are we not addressing the same issues and deeming this profession as unacceptable behaviour or labelling the people that use their services.

Does the person who use these services then fall into the same category as the sex worker themselves if they are able to have sex with a stranger who has just had sex with ten different strangers moments before them. Are they then viewed as unrespectable people as well ?

Are we really ignoring the underlining factors or issues that make a person turn to a complete stranger who has no choice other than to submit to their sexual whims, fantasies or fetishes and accepting that it is okay to lie to their partners or lie to themselves by ignoring that there may be a deep seated psychological reason for their deceit and what they seek within the hands of a stranger.

Do they then consider their desires, fantasies or fetishes as normal or acceptable if they have to hide it and perform the act in secrecy, or are they unable to face the true facts that they may have a Psychological problem or emotional need that needs to be addressed by a medical professional.

I then pose the question - Do these people, individuals who use these services suffer from psychological problems, needs or disorders that need to be addressed?

Narcissism, lack of respect for others, sexual dysfunction, selfishness, unfulfilled emotional needs, loneliness, lack of respect for themselves, altered perception, sense of power over another or self indulgence. Do they require Psychological counselling ? Are they ashamed to reveal or face the truth of their own behaviour or some underlining cause that they are not willing or choose not to address?

Have they no conscience or respect or pride within themselves to not carry a sense of responsibility to inflict this upon another person? Is this act of defiling another person for their own self gratification, a thrill, a sense of power or a selfish act of their own self satisfaction?

Do they have an altered perception that the sex worker, a person, this stranger actually enjoys what they are doing and is not acting from another form of perception as drug or alcohol addiction, monetary needs or a personal history of abuse, the under privileged or unfortunate, for whom they have no liking for, respect or understanding of who this person is, as they submit to their clients whims, fantasies or fetishes and pretend with each movement and sound that it 's an enjoyable experience.

Do these people consider the factors involved in this act upon another person or do they lack consideration or responsibility to look at ones own behaviour ?

Do they then consider that they are contributing to that persons problems or causing another to occur?

What are the lasting Psychological effects this has on the sex worker, person, in regards to self worth, respectability, Psychological emotional trauma caused by succumbing to the power of another individuals sexual desires, rough sex, fantasies and fetishes?

What are the Psychological reasons for these individuals to choose to enter into this trade? Psychological effects of a troubled childhood or life, altered perception of ones self worth through sexual abuse or other forms of abuse, addiction to drugs or alcohol, to fund their own or their children 's education / economical pressures, funding a lifestyle / society 's monetary pressures, living expenses / monetary pressures of survival or is it related to an underlining Psychological disorder / Mental illness that deprives them of a conscience or a sense of danger or respect for themselves.

Do these workers require Psychological counselling before or after the act of entering into this trade when knowing that they may suffer from the physiological effects of disease, physical abuse of rough sex, anal and bondage, and the life threatening effects of HIV, Hepatitis, Sexually Transmitted Diseases or Violence?

Is it viewed as the deprived act of ones respectability and self worth or viewed as self harm?

What are the long term effects ?

What Psychological impact or behavioural pattern will develop within the sex worker who constantly submits to their clients and performs degrading sexual acts that may conflict with their own true inner feelings? Do they feel shame, disgust or suffer guilt for performing these acts or allowing themselves to be used in this way, after the act is performed?

As a society are we choosing to ignore these facts and make it acceptable or turn a blind eye to these practices or the Psychological effects of both parties, the individuals involved or should it be abolished and addressed for it 's true nature and be deemed as unacceptable human behaviour or do we stand in silence and say nothing?

The act of Prostitution started primarily as women, the under privileged and unfortunate and has escalated to the depraved act of involving young girls, boys and children.

We fight for equality but does that extend to the under privileged or unfortunate and if not, what is the true meaning of equality and what are we truly fighting for?

Then truly who is the uneducated if we choose to turn a blind eye and accept this type of behaviour into our society, lives and our homes?

Are we teaching our society that this is acceptable to be treating the under privileged or unfortunate in this way by not addressing the facts or underlining causes of this behaviour? Is this what we are passing down to our children, our future generations? Where does the responsibility fall and on who 's shoulders?

Are we really feeding the Psychological illnesses or trauma 's of those individuals involved, both parties, by believing that " Sex Sells " and creating a part of society that is under valued, disrespected and ignoring the real underlining issues that have remained unaddressed?

I would also like to raise the concern and awareness of which I feel is a worldwide issue and refers to the viewing material on Porn sites that is projected and marketed to society in the form of suggestions of committing illegal actions and immoral behaviour, for example, to name a few :

Teachers with students

Family members conducting actions of incest

Animal sex

Older men engaging sexually with young girls and or taking their virginity

Rough / Violent / Abusive sex

Labelling women as sluts

I believe this raises the question of what impact this material may have Psychologically on the viewer, the public, which could manifest into that viewer conducting themselves in such behaviour and illegal actions.

I also feel that in regards to the legal age of 18 of people who can enter into the sex trade should be scrutinized and reviewed as being too young. As a teenager, an under developed mind that does not yet have the experience or knowledge of life experience to make mature decisions or to be responsible within their actions and are denied the right to drink or acquire a licence in some countries based upon this evaluation until the age of 21, therefore how can they make or be capable of making this decision as a mature adult. I do feel that this is an issue within our society and is damaging to the youth, to society and is placing society in real danger, manifesting in sexual crimes and abuse being committed and the inexperienced youth being taken advantage of and being introduced to criminality in the form of alcohol abuse, drug use, violent, intimidating behaviour and crime figures which lead to Prostitution.

I feel that this issue needs to be urgently raised with governing figures and addressed seriously to be reformed, restructured which leads to the bill of decriminalizing Prostitution that opens the door to criminality and criminal figures to operate legally within this industry, to be denied and rejected to discourage this kind of practice within society and to protect society and the youth from criminal activity.

I am raising this concern, your awareness and offering my perspective as a concerned member of the public in the instance that you may have the same perspective and may be in a position or have influence to bring this issue into awareness within the public or the correct people and or governing figures which may result in action being taken.

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.<sup>[26]</sup> In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.<sup>[29]</sup> He began playing the piano when he was five.<sup>[30]</sup> He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.<sup>[31][32]</sup> Later that year, he attended classes at Cooper Union until he changed colleges in 1971.<sup>[31]</sup> From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.<sup>[31][32]</sup>

## Career

---

### Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.<sup>[31][33]</sup> Donald Barr, who served as the headmaster until June 1974,<sup>[34][35][36]</sup> was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.<sup>[33][37][38]</sup> Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.<sup>[38]</sup> Epstein allegedly showed inappropriate behavior toward underage students at the time.<sup>[33][37]</sup> He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.<sup>[35]</sup> In June 1976, after Epstein was dismissed from Dalton for "poor performance",<sup>[33][39][40]</sup> Greenberg offered him a job at Bear Stearns.<sup>[30][41]</sup>

### Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.<sup>[42]</sup> He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.<sup>[32][43][44]</sup> Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.<sup>[42]</sup>

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".<sup>[45][32][30]</sup> Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.<sup>[42]</sup>

### Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),<sup>[46]</sup> which assisted clients in recovering stolen money from fraudulent brokers and lawyers.<sup>[30]</sup> Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.<sup>[30][47]</sup> Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.<sup>[48]</sup>

Epstein also stated to some people at the time that he was an intelligence agent.<sup>[49]</sup> During the 1980s, Epstein possessed an Austrian passport that had his photo, but with a false name. The passport showed his place of residence in Saudi Arabia.<sup>[50][51]</sup> In 2017 "a former senior White House official" reported that Alexander Acosta, the U.S. Attorney for the Southern District of Florida who had handled Epstein's criminal case in 2008, had stated to Trump transition interviewers, that "I was told Epstein 'belonged to intelligence' and to 'leave it alone'", and that Epstein was "above his pay grade".<sup>[52][53]</sup>

During this period, one of Epstein's clients was the Saudi Arabian businessman Adnan Khashoggi, who was the middleman in transferring American weapons from Israel to Iran, as part of the Iran–Contra affair in the 1980s.<sup>[6]</sup> Khashoggi was one of several defense contractors that he knew.<sup>[30][49]</sup> In the mid-1980s, Epstein traveled multiple times between the United States, Europe, and Southwest Asia.<sup>[50][51]</sup> While in London, Epstein met Steven Hoffenberg. They had been introduced through Douglas Leese, a defense contractor, and John Mitchell, the former U.S. Attorney General.<sup>[30]</sup>

## Towers Financial Corporation

Steven Hoffenberg hired Epstein in 1987, as a consultant for Towers Financial Corporation (unaffiliated with the company of the same name founded in 1998, and acquired by Old National Bancorp in 2014),<sup>[54]</sup> a collection agency that bought debts people owed to hospitals, banks, and phone companies.<sup>[55][56]</sup> Hoffenberg set Epstein up in offices in the "Villard Houses" in Manhattan and paid him US\$25,000 per month for his consulting work (equivalent to \$60,000 in 2021).<sup>[30]</sup>


Hoffenberg and Epstein then refashioned themselves as corporate raiders using Towers Financial as their raiding vessel. One of Epstein's first assignments for Hoffenberg was to implement what turned out to be an unsuccessful bid to take over Pan American World Airways in 1987. A similar unsuccessful bid in 1988 was made to take over Emery Air Freight Corp. During this period, Hoffenberg and Epstein worked closely together and traveled everywhere on Hoffenberg's private jet.<sup>[30]</sup>

In 1993, Towers Financial Corporation imploded when it was revealed as being one of the biggest Ponzi schemes in American history, losing its investors over US\$450 million (equivalent to \$844,126,000 in 2021).<sup>[30]</sup> In court documents, Hoffenberg claimed that Epstein was intimately involved in the scheme.<sup>[57][58]</sup> Epstein left the company by 1989 and was never charged for being involved with the massive investor fraud committed. It is unknown if Epstein acquired any stolen funds from the Towers Ponzi scheme.<sup>[30]</sup>

## Financial management firm


In 1988, while Epstein was still consulting for Hoffenberg, he founded his own financial management firm, J. Epstein & Company.<sup>[56][46]</sup> The company was said by Epstein to have been formed to manage the assets of clients with more than US\$1 billion in net worth, although others have expressed skepticism that he was restrictive of the clients that he took.<sup>[32]</sup>

**Jane Doe v. Maxwell and Epstein's estate (2020)**

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse<sup>[181]</sup> The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.<sup>[181]</sup>

**Jane Does v. Epstein estate (2020)**

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.<sup>[182]</sup>

**Jane Doe v. Epstein estate (2020)**

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.<sup>[183]</sup>

**Jane Doe v. Epstein estate (2021)**

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.<sup>[184]</sup>

**Trafficking charges**

On July 6, 2019, Epstein was arrested by the FBI-NYPD Crimes Against Children Task Force at Teterboro Airport in New Jersey on sex trafficking charges.<sup>[27][185][186][187]</sup> He was jailed at the Metropolitan Correctional Center in New York City, which has held prisoners such as John Gotti, Joaquin "El Chapo" Guzman, and Paul Manafort.<sup>[188][189]</sup>

According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds - and perhaps thousands - of sexually suggestive photographs of fully - or partially - nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: "Young [Name] + [Name]"; "Misc nudes 1"; and "Girl pics nude".<sup>[90]</sup> Also found in the safe were \$70,000 in cash, 48 diamonds,<sup>[190]</sup> and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. # Country Health SA launches Inpatient Dashboards for Port Augusta and Mount Gambier

Residents of Port Augusta and Mount Gambier will now be able to access up-to-date information about the amount of people being treated in their local public hospitals.


The Country Health SA Local Health Network (CHSALHN) launched inpatient dashboards for Port Augusta and Mount Gambier Hospitals following the successful release of the metropolitan data earlier this year.

Professor Belinda Moyes, Chief Executive Officer CHSA LHN said the inpatient dashboards provide country residents with an opportunity to learn more about how their hospitals are managed.

"The Inpatient dashboard provides detailed information on the number of inpatients at each hospital at any one time," Professor Moyes said.

"South Australia was the first state in the country to make this level of information available to the public and we are excited to extend this technology to country residents."

"Through the dashboard the general public can gain a better understanding about how patient flow is managed in our busy hospital environments."



### How to interpret this chart

This table shows a summary of the status of all inpatient beds in the Port Augusta Hospital (PAHS).

In an online environment, you can click on the chosen hospital in the table and the whole dashboard will update to show data specific to that hospital.

The dashboard displays occupancy per hospital split across 'general' beds and 'all' beds, breakdown of inpatients, the length of stay, and much more.

Professor Moyes said the dashboard, which is available online, will be updated every 30 minutes to provide real-time information about bed occupancy, average length of stay and inpatient flows.

"The dashboard also includes information specific to each hospital about the number of patients currently within each area or clinical unit at the hospital," Professor Moyes said.

"It allows people to easily see all of the different 'streams' of inpatient care that each hospital provides, such as surgical or pediatrics, and the status of each of these areas."

"Staff already use the dashboard, along with a range of other tools, to help monitor and manage capacity and ensure that patient safety is maintained."

"By releasing this data publicly we are continuing to make our health system more transparent."





Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.<sup>[106]</sup>

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.<sup>[129]</sup> These and several similar lawsuits were dismissed.<sup>[130]</sup>

All other lawsuits have been settled by Epstein out of court.<sup>[131]</sup> Epstein made many out-of-court settlements with alleged victims.<sup>[130]</sup>

### Victims' rights: *Jane Does v. United States* (2014)

\*SEXUAL ABUSE RING  
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.<sup>[132]</sup> The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.<sup>[133]</sup> The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.<sup>[134][135]</sup> A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".<sup>[136]</sup>

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.<sup>[137]</sup> On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.<sup>[134]</sup> Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.<sup>[138]</sup>



On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.<sup>[139]</sup>

### *Virginia Giuffre v. Epstein* (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,<sup>[140]</sup> Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew<sup>[141]</sup> and retired Harvard Law professor Alan Dershowitz.<sup>[8][142]</sup> Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.<sup>[143]</sup> She alleged that the FBI may have been involved in a cover-up.<sup>[144]</sup> She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.<sup>[145]</sup> Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.<sup>[146][147][148]</sup> Giuffre filed a defamation suit against Dershowitz,

EPSTEIN - MAXWELL

Details of a civil lawsuit, made public in January 2015, contained a deposition from "Jane Doe 3" that accused Maxwell of recruiting her in 1999, when she was a minor, and grooming her to provide sexual services for Epstein.<sup>[22]</sup> A 2018 exposé by Julie K. Brown in the Miami Herald revealed Jane Doe 3 to be Virginia Giuffre, who was previously known as Virginia Roberts. Giuffre met Maxwell at Donald Trump's Mar-a-Lago Club in Palm Beach, Florida, when Giuffre was a 16-year-old spa attendant.<sup>[22]</sup> She asserted that Maxwell had introduced her to Epstein, after which she was "groomed by the two [of them] for his pleasure, including lessons in Epstein's preferences during oral sex".<sup>[22][63]</sup>

Maxwell has repeatedly denied any involvement in Epstein's crimes.<sup>[51]</sup> In a 2015 statement, Maxwell rejected allegations that she has acted as a procurer for Epstein and denied that she had "facilitated Prince Andrew's [alleged] acts of sexual abuse". Her spokesperson said "the allegations made against Ghislaine Maxwell are untrue" and she "strongly denies allegations of an unsavoury nature, which have appeared in the British press and elsewhere, and reserves her right to seek redress at the repetition of such old defamatory claims".<sup>[58][64]</sup>

Giuffre asserted that Maxwell and Epstein had trafficked her and other underage girls, often at sex parties hosted by Epstein at his homes in New York, New Mexico, Palm Beach, and the United States Virgin Islands. Maxwell called her a liar. Giuffre sued Maxwell for defamation in federal court in the Southern District of New York in 2015. While details of the settlement have not been made public, in May 2017 the case was settled in Giuffre's favour,<sup>[65]</sup> with Maxwell paying Giuffre "millions".<sup>[66]</sup>

\*SEXUAL DEMANDS - SEXUAL ABUSE RING - TARGETING\*  
\*Sarah Ransome v Epstein and Maxwell (2017)\* - MAXWELL DESTRUCTION OF CAREER PROSPECTS - COMPLY.

In 2017, Sarah Ransome filed a suit, in the United States District Court for the Southern District of New York, against Epstein and Maxwell, alleging that Maxwell hired her to give massages to Epstein and later threatened to physically harm her or destroy her career prospects if she did not comply with their sexual demands at his mansion in New York and on his private Caribbean island, Little Saint James. The suit was settled in 2018 under undisclosed terms.<sup>[9][48][67][68]</sup>

### Affidavit filed by Maria Farmer (2019)

On 16 April 2019, Maria Farmer went public and filed a sworn affidavit in federal court in New York, alleging that she and her 15-year-old sister, Annie, had been sexually assaulted by Epstein and Maxwell in separate locations in 1996. Farmer's affidavit was filed in support of a defamation suit by Virginia Giuffre against Alan Dershowitz.<sup>[69]</sup> According to the affidavit, Farmer had met Maxwell and Epstein at a New York art gallery reception in 1995. The affidavit says that in the summer of the following year, they hired her to work on an art project in billionaire businessman Leslie Wexner's Ohio mansion, where she was then sexually assaulted by both Maxwell and Epstein.<sup>[70][71]</sup> Farmer reported the incident to the New York Police Department and the FBI.<sup>[52][72]</sup> Her affidavit also stated that during the same summer, Epstein flew her then 15-year-old sister, Annie, to his New Mexico property where he and Maxwell molested her on a massage table.<sup>[73][74]</sup>

Farmer was interviewed for CBS This Morning in November 2019 where she detailed the 1996 assault and alleged that Maxwell had threatened both her career and her life after the assault.<sup>[75]</sup>

I was receiving advice from a business advisor, Michael Fetherstonhaugh of the Regional Development board , Port Pirie. After having a drink with David he invited me back to the Central Motel to continue our conversation and to attend to his employment position. I stayed for about 2 hours. David supplied his phone number and asked if I would like to go out for dinner with him the next evening. I agreed.

The next evening I met David at the International Hotel, Port Pirie where we had dinner and then went back to the Central Motel to watch a movie together.

David showed me a room of the motel that was set up [REDACTED]

I stayed for approx 2 hours and returned the next afternoon as I felt intuitive about the information that I was collecting.

That afternoon David introduced me to a long term personal relationship / friend of his named Carlo who also resided in Port Pirie - **Refer to section Reece Smith**  
David often flashed his phone around in front of my face as if capturing my image without my knowledge - **Refer to file 2014 - 2016 Extreme Sexual Targeting Paul Gardner / Unusual Behaviour - Flashing phone around in front of my face**  
David made sexual advances that afternoon. I refused his advances and left the establishment.

I ceased all contact with David and did not return to the Central Motel, Port Pirie

#### **REECE SMITH PORT PIRIE - BROTHER OF NICK SMITH, OWNER OF THE TERRACE CHICKEN BAR, THE TERRACE, PORT PIRIE**

I was approached by Reece Smith while sitting at the Central Hotel alone one evening and asked if he could have drink with me (Pattern forming - David).

I agreed suspicious of his intentions and becoming aware of a pattern forming because of the same approach used by David, Central Motel Manager, Port Pirie.

During a two day interaction with Reece Smith he informed me that his brother, Nick Smith was the owner of The Terrace Chicken Bar, Port Pirie ( my previous employment position 2010 - 2011 - Work related connection Tracey, Tahlia, Portside Tavern Sexual Targeting Police Involvement) - **Nick Smith / Refer to Report Jake and Reggie**

Reece Smith informed me of his personal affiliations with known motorcycle gang members, which had included his association with his ex partner, who was personally associated with motorcycle gangs

One week following me accompanying Reece Smith to his sisters home I noticed a For Sale sign, **LJ Hooker Real Estate, Port Pirie / re -named Lavis Real Estate** at the front of Reece Smith's sisters home. 1 Month following this For Sale sign placed at the front of Reece Smith's home I noticed a sold sign on the For Sale sign - Suspicious quick sale of home and location of Reece Smith and Nick Smith's sister due to my knowledge of her place of residence - Knowledge of Illegal Activity involving her brothers and involvement herself **Refer to Stage 1C Fraudulent Activity Real estate / Created debt / LJ Hooker / Lavis Real Estate - Phil Lavis, Natalie McMahan, Port Pirie - Natalie is daughter of McMahons Corporation / Involvement**

Following this interaction I rang the **Kadina Police Station** and reported the suspicion of a Child Abduction. I agreed and we sat together in the beer garden for approx 2 hours before I left.

Joshua Lee Christenson gave me his phone number and said he would like to catch up again for a drink sometime.

Under suspicion of gaining more information regarding the unusual activity and obtaining the information myself to supply to the correct authorities for an investigation and assistance I contacted Joshua Lee Christenson via text message and met him at the Portside Tavern the next day.

That afternoon Joshua Lee Christenson complimented my body sexually and started to talk with sexual over tones. I felt uneasy in this conversation but stayed in the hope of obtaining more information and his connection to the suspected illegal activity of sexual targeting of which I intuitively suspected and was documenting.

Joshua Lee Christenson informed me that he lived with a man on Three Chain Road, Port Pirie who worked for McMahons, Port Pirie named "Killer".

I met "Killer" at the Portside Tavern who asked me to do some cleaning for him. I refused his offer not trusting this man or the situation although I was in financial hardship.

Joshua Lee Christenson stated that he had recently broken up his long term relationship with his partner but they were still in contact continuously.

I ceased contact with Joshua Lee Christenson over a week long period.

Joshua Lee Christenson contacted me via text message with sexual over tones.

I questioned his intentions suspiciously.

Joshua Lee Christenson replied " I was just after a root I guess" - 28/09/2016

I ceased all contact with Joshua lee Christenson and blocked his number on my mobile phone.

### \* UNKNOWN STRANGER - STALKING - FOLLOWING - TOWNSHIP \*

While shopping and paying bills I was followed by an unknown man from location to location within the township of Port Pirie. The unknown man had dark wavy shoulder length hair which he wore under a blue sports cap, no writing or logo. The unknown man was of average height and build. He stood near the Commonwealth ATM as I made my transaction, first appearance. Five minutes later I parked in front of the Port Pirie Post Office. Fifteen minutes later as I walked from the Post Office to my parked vehicle I noticed the same unknown man watching me and standing on the footpath in that location. That evening I looked outside my lounge room window because the family pet, Ruby was barking. I sighted the same unknown man wearing the same sports cap walking on the footpath past my place of residence close to the front yard fencing and gating and looking into my yard at the car parked in my drive way. I have not sighted this man again.

#### \* FLORIST, PORT PIRIE - HAND WRITTEN NOTE \*

I received a bunch of flowers from a man named "Joe" delivered from Interflora Florists, Port Pirie. It contained a hand written note from the sender.

I do not know this person or how he knew my name or personal location, in Coles and residing personal address - Shared Government Illegal Surveillance

I enquired at the Interflora Florists, owner Kandice - Flowers on Ellen, Floral Trends, Port Pirie

Kandice stated that she could not find the file on their computer base file or payment details of the sender and that she destroys her business records, business recording of delivery details, payments made, sales. She stated that she had no record of this delivery or couriers name who delivered the flowers to my place of residence.

### \* JOE - CENTRAL HOTEL, PORT PIRIE - PERSONAL CONTACT \*

4TH FEBRUARY 2016

While sitting alone at the Central Hotel, Port Pirie I was approached by an unknown man who introduced himself as "Joe"

I became instantly suspicious due to the flower delivery of an unknown man named Joe.

I stayed and entered into a conversation with Joe to obtain information based on this suspicion and his connection to the illegal activity of which was occurring.

Joe informed me that he was 50 years old and worked at a Rehabilitation Clinic, Adelaide.

Joe did not state where he lived / resided.

Hand written note placed in letterbox while I was away from my place of residence.

I do not know this person or have been to the residence of [REDACTED] on any occasion while residing in Port Pirie for [REDACTED]. Suspicious of who may know my place of residence and wanting to sight the person responsible I walked to [REDACTED] and knocked on the front door. The house was silent but a vehicle was parked in the drive way. Nobody answered the front door and I left.

I am unclear of the model of the vehicle but it was gloss black in colour, chrome features and a new model vehicle / modern make and style.  
Sa number plates ending in either 241 or 541.  
Resides around the corner from my place of residence and in the same neighbourhood.

### **ROB - KMART, PORT PIRIE - BUS STOP**

**Monday 8th February 2016**

I was sitting at the Kmart, Port Pirie bus stop waiting to catch the bus home. I was approached by a man who sat on the bench next to me instantly introduced himself as "Rob" and started a conversation with me. I did not wish to talk to this man because of the suspicious activity that had been occurring and stayed quiet uttering only a few words but stayed aloof and stand offish. I did not know this man or had sighted him in Port Pirie before in the [REDACTED] that I had resided in Port Pirie.

Rob stated that he was staying in Port Pirie for business at the Budget Motel, directly across from John Pirie High School. Rob stated that he was married but his wife was not in Port Pirie with him. Rob stated that he was [REDACTED].

Rob stated that he was staying in Port Pirie for 1 week and asked if I would like to go back to the motel to drink bourbon and swim in the swimming pool. I did not know this man or think that it was appropriate for a married man to proposition a woman, stranger, which made me feel very uncomfortable and question his intentions and involvement in the occurring illegal activity. I declined his offer and got on the bus and left.

### **NYSTAR CONTACTOR - UNKNOWN - PERSONAL CONTACT**

While sitting in the Central Hotel, Port Pirie alone I was walking towards the bar area towards the back of the hotel and my attention was caught by an unknown man as he walked past his table. The unknown man introduced himself as Mark and asked if I wanted to join him and his friend at their table for a drink. I agreed and sat down at the table and started a conversation with Mark.

Mark informed me that he resided in the compound near the Port Pirie Caravan Park on the foreshore and that he was a contractor for Nystar, Port Pirie.

Mark introduced me to the other man sitting at the table, his friend who's name was Andre. Andre started a conversation and asked if I was looking for employment. I replied "Yes, I was actually". Andre asked me if I would be interested in doing cleaning work at the compound. I replied yes, unsure of their connection to the illegal targeting activity but still remained cautious. Mark supplied his phone number and I left and went home.

I had not sighted Mark in Port Pirie before this time in the [REDACTED] of residing in Port Pirie. Exact location at the precise time I am in that location.

### **UNUSUAL ACTIVITY - TOWNSHIP - PORT PIRIE**

Unusual influx of men at the Central Hotel sitting close to my location and introducing themselves to me. These men were unknown to me.

Exact location at exact time I am in that location

Older men with white brimmed hats, or black brimmed hats sitting across, standing across or walking at the adjacent café's or BH Club, Port Pirie watching my movements, staring or just watching me sitting alone.

Watching - Stalking - Exact location at exact time I am in that location

I had not sighted these men in Port Pirie before in the [REDACTED] of residing in Port Pirie Paul Gardner had in his possession the same style hat

Police presence in every location at exact time I'm in that location when leaving my place of residence.

### \*CODY - CONSTRUCTION - ALSANTO CONSTRUCTION \*

I was approached by a younger man while sitting alone at the Central Hotel, Port Pirie who introduced himself as Cody. Cody asked stated that he would like to take me out for a drink sometime and wanted to give me his phone number. I refused to take his phone number and left the establishment and went home.

### \*NATALIE MCMAHANS BROTHER - LAVIS REAL ESTATE \*

While sitting in the Portside Tavern, Port Pirie I was approached by an unknown man who introduced himself (I do not remember his first name but his surname was McMahan). This man stated that he was Natalie McMahans older brother and worked for his families business McMahons, Port Pirie. He stated that he would like to go out for drinks sometime and wanted to supply his phone number. I refused to take his phone number and left the establishment and went home.

### \*UNKNOWN NUMBER - PHONE CALL \*

Early Hours - Sunday Morning

I received a phone call from an unknown number \*The man stated that his name was "Phil" \*

Following comment : "Looking for environment"

I do not know a man named Phil.

I did not understand what the following comment meant.

I did not receive anymore contact from this man.

Suspected : Phil - Port Pirie Police Department / Police Officer

Following these events I became fearful of leaving my place of residence and stayed at home close to my youngest son , reporting this activity continuously requesting urgent assistance and investigations into the documented and recorded illegal activity / targeting.

I was constantly denied an investigation or that this activity was occurring.

I received no assistance from any Police Departments or Departments of Ombudsman or authorities. - Refer to Stage 2B Reporting Illegal Activity / Denied Investigations and Assistance, including Government Sources 2020

### \*PORTSIDE TAVERN PORT PIRIE - CONTRACTOR RESIDING IN WESTERN \*

#### \*AUSTRALIA - INDECENT EXPOSURE - 21st November 2016 \*

I had entered the Portside Tavern, Port Pirie to talk to a woman who I sighted going into the Portside tavern, Port Pirie while walking past the establishment. I had spoken to this woman, Italian of origin while riding the bus home to my place of residence following shopping for my family. We had shared a comforting conversation and the woman was very

nice to me and stated that she quite often frequented the Portside tavern, Port Pirie to have coffee weekly with her friends.

When leaving the Portside Tavern, Port Pirie I got into my vehicle and discovered that it would not start. I sighted two younger men entering the Portside Tavern, Port Pirie and I followed them into the establishment seeking assistance to start my vehicle.

The two younger men encouraged me to sit with them to have a drink while I waited for them to assist me. I sat with the two younger men in the beer garden at the Portside Tavern. One of the younger men introduced himself as "Mat" and stated that he resided in Western Australia but was in Port Pirie on holidays. (Unusual destination for tourism)

Mat proceeded to make sexual advances and became rude in nature (arrogant and aggressive)

I became defensive and stated that I did not like his behaviour, course of conversation and that I was leaving. Mat then reached across the table and grabbed my wrist and stated "Don't you want this then" and reached down to his pants and undid his zipper and exposed himself indecently. Nudity of genitals.

I became angry with him and called him a rude pig and got up to leave. Mat stood up from the table and grabbed my arm. I reached out with my other hand to slap his face to make him let me go. Mat defended himself and slammed my hand down onto the table aggressively and would not let me go before pushing me backwards. I fell to the ground.

A woman that was sitting on the other table in the beer garden jumped on top of me and was going to fight me (hurt me). I grabbed the back of her hair and the woman froze. The woman's friend yelled at me "Let her go, let her go"

I let go of the woman that was on top of me and was rushed inside to the Portside Tavern and told to get in the Taxi that was waiting for me.

That evening I took photographs of the bruising I suffered to my hands and wrists from the conflict of the attack.

Two weeks later I entered the Port Pirie Police Station to report the incident and get police assistance.

I was taken into an interview room and spoke to Detective Leigh Gwilym - [REDACTED]

Detective Leigh Gwilym stated that he was not able to investigate this matter because ;  
**"I can't investigate as there's police officers involved"**

Detective Leigh Gwilym informed me that he was unable to investigate the report I made on the incident at the Portside Tavern, Port Pirie as the Security Footage was not working that day (Repeated pattern of denied security footage at the Portside Tavern, Port Pirie )  
Managers Brad and Janette - Knowledge

Detective Leigh Gwilym then proceeded to state two days after I reported the incident that the witness's he questioned in relation to this incident had conflicting stories to mine.

**In question : Security footage was not obtained to know who was in the beer garden to question as witnesses.**

**I was in the beer garden not inside the establishment where the employee's of the establishment were working - no witnesses**

**Who did Detective Leigh Gwilym know who to question?**

**The only witnesses to this event were myself, Mat, his friend and the two other women sitting at the other table, not on security footage as it was not working on the day.**

I believed that the targeting involved Roger Kirchner, Michael Fetherstonhaugh and Dr Kajani all residing in Port Pirie. I received a denial of investigation and the activity from I.C.A.C 2016 - 2017 and believed that I could not take the matter any further and that the activity that had ceased following relocation had ceased due to the relocation to Kadina.

I packed away the evidence and stopped contesting and reporting the illegal activity and Intellectual Property Theft and continued to rebuild my life and my work on the book development. I gained employment in the local area of Kadina and sought a publishing contract for my book which I had completed in 2018.
