Thanks for the chance to talk about your Optus mobile service with account number [REDACTED]

I refer to your recent communication with Optus, wherein you advised that you had been the victim of fraudulent activity. You have advised that you contacted Optus approx. 2-3 months ago to make a payment arrangement and spoke with a staff member you feel was not actually an Optus representative and this time you state the following issues:

- received blocked and altered text messages and there is evidence of phone calls that the consumer states she never made.
- noticed excess usage on her mobile, and saw her bills jump dramatically after this time.

You have another mobile 0437 199 381 (Optus) and that some photos from August were accidentally deleted.

\*-Please note the mobile number you have provided of [REDACTED] is not an Optus number and is not listed on Optus systems.\*

To enable Optus to investigate this matter, it would be appreciated if you would provide a Statutory Declaration which sets out the details of your dispute. To assist you, we have enclosed a Statutory Declaration for you to complete and return.

It is important that the Statutory Declaration contains as much detail as possible, including:

- Your personal details; Name, DOB, residential address, occupation, employer and your daytime contact phone number/s
- Full explanation of what (including account reference / number) you are disputing and the reason you are disputing ownership of this account
- Confirmation as to whether you currently or previously have held an Optus service - and the relevant service or account details.
- Confirmation as to whether or not any other person is / was authorised to act on your behalf
- Any other relevant information that may assist Optus to investigate and resolve this dispute.

## POLICE INVOLVEMENT - FRAUDULENT ACTIVITY OBTAINED 2021 - GOV INVOLVEMENT

I reported the Fraudulent malicious Activity of the newly created business account to Joshua Adams, Business Consultant, Telstra Store, Kadina who proceeded to file a report to the Fraud Department and requested an investigation into the activity - Refer to Telstra Report dated 1/10/2020

I received no reply or response from this report.

The Fraudulent and malicious Activity continued and escalated.

On the 25/03/2021 I reported the activity again to Joshua Adams, Business Consultant, Telstra Store, Kadina and reported that I had not received any contact from the Fraud Department concerning the report that he had submitted. I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

On the 25/03/2021 I reported the Fraudulent Malicious activity to Isobelle Oppeloar, Manager, Telstra Store, Kadina who proceeded to file a report to a higher authority, requesting an investigation with the higher authority of the Fraud Division or CEO of Telstra, due to ongoing issues over a 10 year period of continuous Fraudulent Activity. - Refer to Letter addressed to Isobelle Oppeloar, Manager - Refer to document filed report and Case ID number  
I received contact from Telstra higher authority but missed the call and am waiting for the second contact, to ring me back as informed in the voice recorded message left on my mobile phone to discuss the issue.

On the 13th April 2021 I sent a letter addressed to the CEO of Telstra Head Office, Mr Andrew Penn, Melbourne, Victoria from the Norwood Post Office branch, Adelaide informing the CEO of the continuous Fraudulent Malicious Activity that had been occurring in my personal and newly created business account with Restricted Access, and requested a thorough investigation into the activity and provided the documented evidence of the activity that had been occurring in all servers and over a long period of time, and following re-location and change of details

I received phone contact from Ron, Telstra Head Office following the submitted letter to Mr Andrew Penn, CEO of Telstra Head Office - Recorded Phone call.

I was informed that the reports that had been submitted over a 10 year period in

Telecommunication Systems concerning continuous ongoing Fraudulent Activity in my accounts,

following Restricted Access applied, change of phone numbers, change of details personal and business, change of servers and relocation was identified as Government and Police Sources

Remotely Accessing servers, accounts and computer hardware to result in the Fraudulent activity

that had been occurring, which included blocked contact, altered and blocked messages, blocked access to internet services, websites and contacts, impersonating of companies, unusual messages and phone calls from unknown people, blocked contact and altered messages to my children, as informed by my children and resulted in isolation in 2014 - 2016 Extreme Sexual Targeting, Police Targeting and detention. This information confirmed the details obtained in 2016 Origin

Electricity account that incurred an Excessive Rise in billing that remained unexplained and resulted in the barcode being scanned as a Police Source causing the Fraudulent Activity.

Townsville CC Parking Fines (Queensland Police Source).

The source of the Continuous Illegal Activity has now been Identified as Government and Police Specific Targeting of an Individual over a 27 year period which resulted in the 2017 Murder to Appear as Suicide by medication as a result of Police Targeting (Detention in Glenside Mental Health Facility)

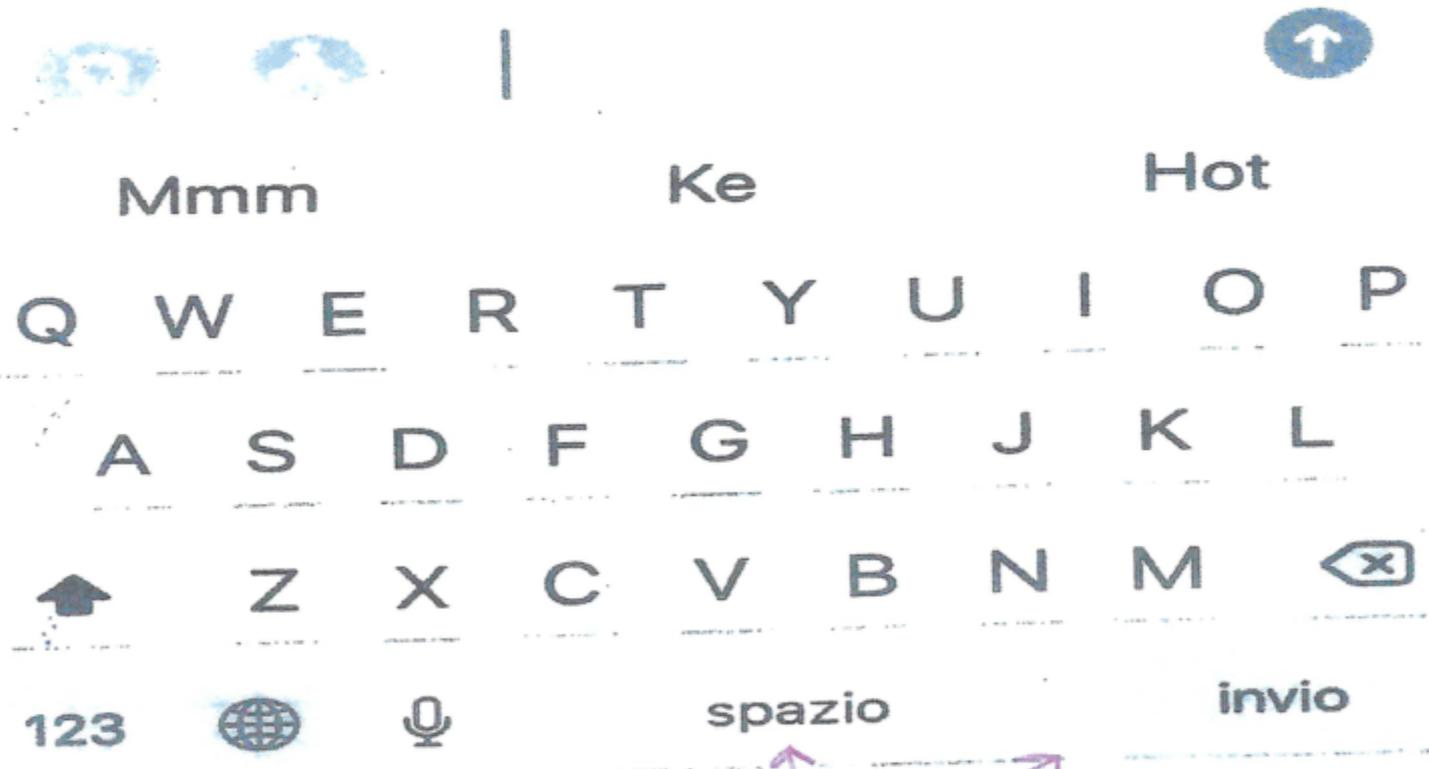

I was contacted on the 21st May 2021 by Officer Leong, stating that she was from Services SA on the phone number [REDACTED]. During this phone contact I was informed that the phone call was being recorded and the information given was not to be shared with a third party during the recorded phone call. Officer Leong (woman) informed me of the issue of suspected Identity Theft (my Identity) which involved numerous bank accounts being opened in my Identity and being used for illegal purposes of Drug Trafficking, Money Laundering, Money Transfers to a corporation, Fraudulent Activity and were operating in numerous locations, from recalled memory being Queensland, ANZ, NAB, as some of the numerous accounts, and involved over 1 million dollars illegally rotating through the bank accounts. I was informed that my Tax file number was being illegally misused in Australia and that my bank accounts and tax file number would be suspended.

I was asked to provide the details of my banking institutions and the balances of the bank accounts in my name. I informed Officer Leong that I held 3 bank accounts with the Commonwealth Bank, 2 personal accounts and 1 business accounts, balances being \$530.00, Goal Saver account, \$10.00 - \$15.00 in the business account and \$15.00 - \$20.00 in the personal account. I informed Officer Leong that the accounts were set up by the Commonwealth Bank Manager, Paul Flavel, Kadina and could be confirmed by Paul Flavel, Manager.

\* Following providing my bank account details I informed Officer Leong that this was a case of Identity Theft. Officer Leong agreed with me on the case of Identity Theft and informed me that the case would be referred to Federal Agencies - Federal Police - Legal Investigation. \*

Officer Leong then informed me that my bank accounts and Tax file number would not be subjected to a suspension and the case would be referred to the Federal agencies for a thorough investigation and I was not instigated in the illegal activity that had occurred because of the Identity Theft - Legal Investigation.

I was informed by Officer Leong that the details would be sent to me via email services.

I have not received an email from Officer Leong concerning this matter and contact.

Currently my email service registered under a business registration with GoDaddy is under investigation for email hacking and Malicious Activity that has been reported by myself and occurring in 2020 - 2021.

As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation

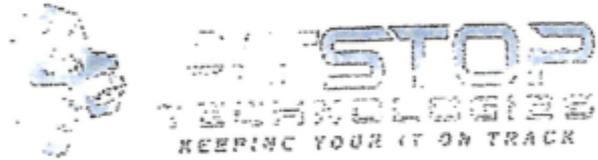

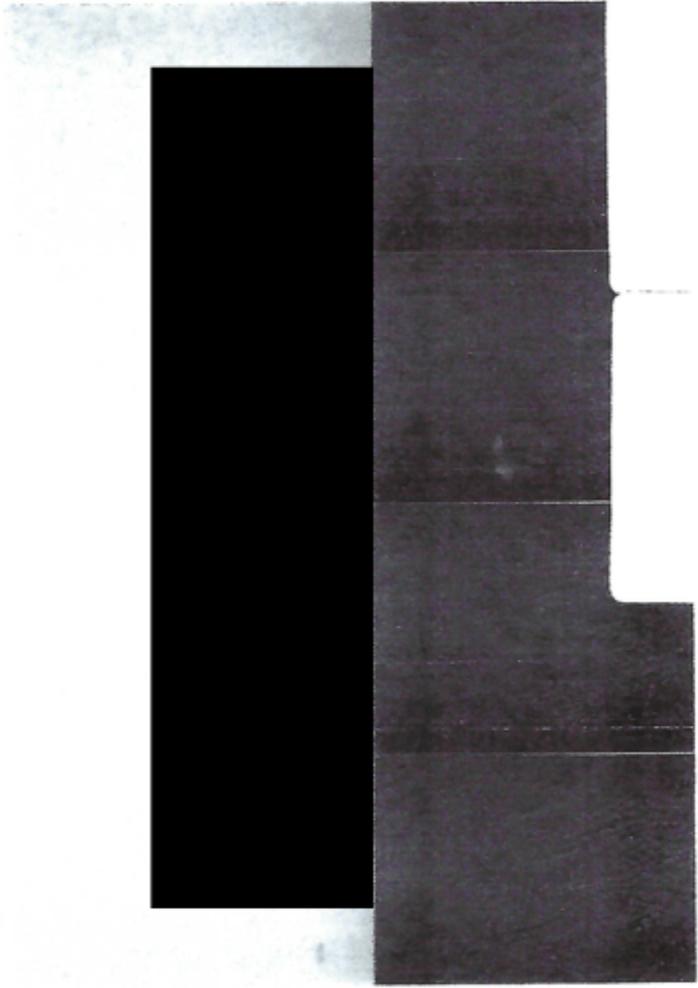

**eSafety and Adult Cyber Abuse**

The eSafety Commissioner's (eSafety's) primary role in dealing with cyberbullying complaints is to assist with the rapid removal of cyberbullying material targeted at Australian children, on social media services.

Please be aware that eSafety, therefore, has no legislative power to investigate adult cyber abuse complaints, formally. However, we do work to guide people where we can and provide advice on what they can do themselves.

In the most serious cases, we will use our existing relationships and escalation pathways with social media services to effect take-down of harmful material that is considered to be serious cyber abuse in nature or, where required, we will refer the matter to law enforcement.

Digital surveillance - IDENTIFIED AS ILLEGAL SURVEILLANCE RESULTING IN ILLEGAL ACTIVITY

Your situation sounds like it may be digital surveillance, which is not an area we generally handle or have experience in. You may wish to approach your email (and any other relevant) service provider about the situation.

Regarding increased security measures for sending and receiving of mail, unfortunately Australia Post is unable to implement the suggestions you have provided. While we do not have the capability, infrastructure, or dedicated personnel to design a restricted access scenario as you have suggested, Australia Post has existing transparent sending options.

Where there is need for transit and delivery visibility, we recommend the use of trackable products such as Registered Post, Express Post, or the new Domestic Letter with Tracking. I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint. - USB FLASH DRIVE

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.\*

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling 1300 366 424 or (08) 8436 3555.

I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage. - AGREES WITH THE BILL BEING PASSED FOR PROSTITUTION TO BE LEGALISED, REFER TO STAGE 2 SEXUAL TARGETING.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament.

Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for raising your concerns with me.

short her courses in Adelaide in 1982, and moved to Melbourne to work with the Australian Union of Students.<sup>[20]</sup> In 1983, she became the second woman to lead the Australian Union of Students, serving until the organisation's discontinuation in 1984. She was also the secretary of the left-wing organisation Socialist Forum.<sup>[21][22]</sup> Having transferred her studies to the University of Melbourne, Gillard graduated with a Bachelor of Laws degree in 1986 and a Bachelor of Arts degree in 1989.<sup>[23]</sup> In 1987, she joined the law firm Slater & Gordon in Werribee, Victoria, working in industrial law.<sup>[11]</sup> In 1990, she was admitted as a partner; at the age of 29, she was the youngest partner within the firm, and one of the first women to hold the position.<sup>[24][25]</sup>

### Early political involvement

From 1985 to 1989, Gillard served as President of the Carlton branch of the Labor Party.<sup>[6]</sup> She stood for Labor preselection in the Division of Melbourne prior to the 1993 federal election, but was defeated by Lindsay Tanner.<sup>[26]</sup> At the 1996 federal election, Gillard won the third position on Labor's Senate ticket in Victoria, behind Robert Ray and Barney Cooney.<sup>[27][28]</sup> However, on the final distribution of preferences she was defeated by Lyn Allison of the Australian Democrats.<sup>[29][30]</sup>

In 1996, Gillard resigned from her position with Slater & Gordon to serve as chief of staff to John Brumby, at that time the Leader of the Opposition in Victoria.<sup>[6][30][31]</sup> She was responsible for drafting the affirmative-action rules within the Labor Party in Victoria that set the target of pre-selecting women for 35 per cent of "winnable seats". She also played a role in the foundation of EMILY's List, the pro-choice fund-raising and support network for Labor women.<sup>[32]</sup>

Gillard has cited Welsh Labour politician Aneurin Bevan as one of her political heroes.<sup>[24]</sup>

## Member of Parliament (1998–2007)

Gillard was first elected to the House of Representatives at the 1998 federal election representing Lalor, a safe Labor seat near Melbourne, replacing Barry Jones who retired. She made her maiden speech to the House on 11 November 1998.<sup>[33]</sup> Gillard was a member of the standing committee for Employment, Education and Workplace Relations from 8 December 1998 to 8 December 2001, in addition to Aboriginal and Torres Strait Islander Affairs from 20 March 2003 to 18 August 2003. Within the joint committees, she was a member of the Public Accounts and Audit from 8 December 1998 to 11 February 2002, in addition to the Native Title and the Aboriginal and Torres Strait Islander Land Fund from 20 March 2003 to 11 August 2003.<sup>[6]</sup>

### Shadow Minister (2001–2007)

After Labor's defeat at the 2001 federal election, Gillard was elected to the Shadow Cabinet under then-Labor Leader Simon Crean, where she was given responsibility for Population and Immigration. In February 2003, she was given additional responsibilities for Reconciliation and Indigenous Affairs.<sup>[34]</sup> In these roles, in the wake of the Tampa and Children Overboard affairs, which were partly credited with Labor's 2001 election loss, Gillard developed a new immigration policy for the Labor Party.<sup>[13]</sup>

Gillard was later promoted to the position of Shadow Minister for Health and Deputy Manager of Opposition Business in the House (to Mark Latham) on 2 July 2003.<sup>[25][35]</sup> During this time, she shadowed Tony Abbott, with the rivalry between the two often attracting attention from the media.<sup>[36]</sup> She was later given additional responsibility for managing opposition business in the House of Representatives by Latham, who had succeeded Beazley as Labor Party leader.<sup>[37]</sup>

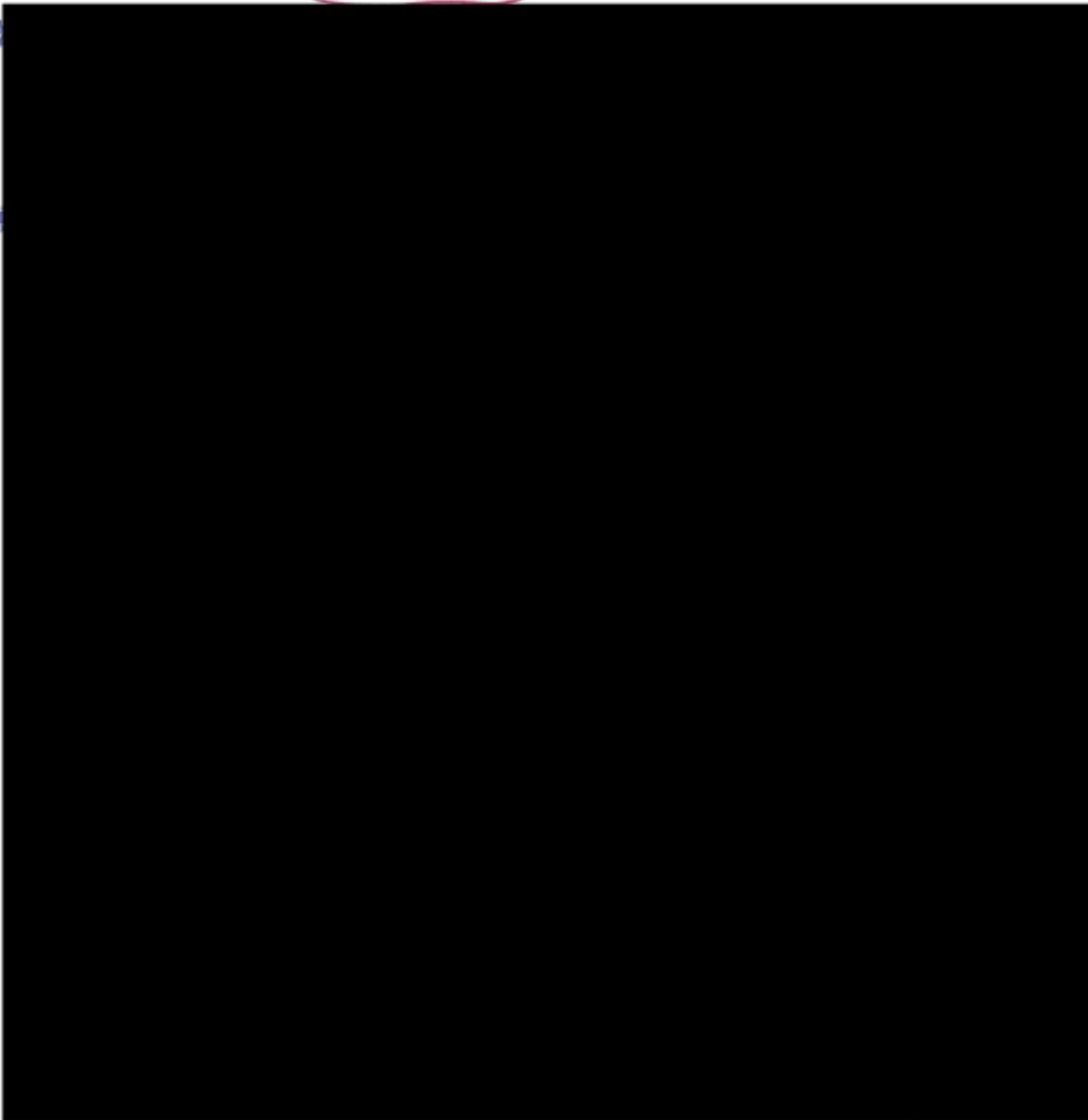

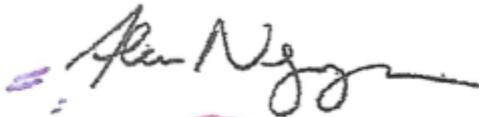

Each session costs \$240.00 as a privately paying client. If you have private health cover, you may be eligible for a rebate, and we can swipe most cards here on premises to claim (any HICAPS providers). residence as Saudi Arabia.<sup>[50][51][191][192][193]</sup> According to his attorneys, Epstein had been advised to acquire the passport because "as an affluent member of the Jewish faith", he was in danger of being kidnapped while traveling abroad.<sup>[194]</sup>

On July 8, prosecutors with the Public Corruption Unit of the Southern District of New York charged him with sex trafficking and conspiracy to traffic minors for sex. The grand jury indictment alleges that "dozens" of underage girls were brought into Epstein's mansions for sexual encounters.<sup>[11][12][195]</sup> Judge Kenneth Marra was to decide whether the non-prosecution agreement that protected Epstein from the more serious charges should still stand.<sup>[196]</sup>

Epstein requested to be released on bond, offering to post \$100 million with the condition that he would also submit to house arrest in his New York City mansion.<sup>[197]</sup> U.S. District Judge Richard M. Berman denied the request on July 18, saying that Epstein posed a danger to the public and a serious flight risk to avoid prosecution.<sup>[197]</sup>

On July 23, Epstein was found injured and semiconscious at 1:30 a.m. on the floor of his cell, with marks around his neck that were suspected to be the result of either a suicide attempt or an assault.<sup>[198]</sup> His cellmate, former New York City police officer Nicholas Tartaglione, who was charged with four counts of murder, was questioned about Epstein's condition. He denied having any knowledge of what happened. Epstein himself said he recollected nothing.<sup>[190][199][200][201]</sup> According to NBC News, two sources said that Epstein might have tried to hang himself, a third said the injuries were not serious and could have been staged, and a fourth source said that an assault by his cellmate had not been ruled out.<sup>[202]</sup>

On August 29, 2019, following Epstein's death 10 days prior, the case against Epstein was closed after Judge Berman dismissed all sex trafficking charges.<sup>[17][18]</sup> However, he also expressed support for Epstein's accusers.<sup>[17]</sup> Prosecutors objected to the ruling and stated they would continue an investigation for potential co-conspirators.<sup>[18]</sup>

## Investigation in France

On August 23, 2019, the prosecutor's office in Paris, France, opened a preliminary investigation into Epstein. He is being investigated for rape and sexual assault of minors under and over the age of 15, criminal association with a view to committing crimes, and association with criminals with a view to committing offenses. The prosecutors said that the goal of the investigation is to find possible crimes committed in France and elsewhere against French citizens.<sup>[203]</sup>

## Personal life

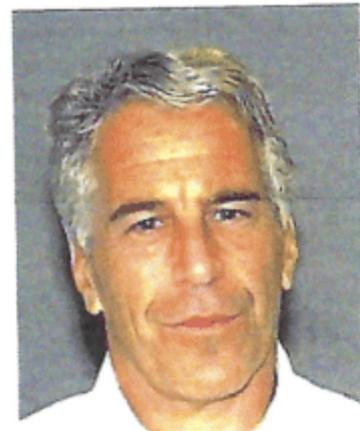
Previous long-term girlfriends associated with Epstein include Eva Andersson-Dubin<sup>[204][205]</sup> and publishing heiress Ghislaine Maxwell.<sup>[30]</sup> Epstein was romantically linked to Andersson-Dubin for an 11-year period<sup>[206]</sup> mostly in the 1980s and the two later remained friendly well after her marriage to Glenn Dubin.<sup>[204][205]</sup> Epstein met Maxwell, daughter of disgraced media baron Robert Maxwell, by 1991.<sup>[162][207][208]</sup> Epstein had Maxwell come to the United States in 1991 to recover from her grief following the death of her father.<sup>[209]</sup> Maxwell was implicated by several of Epstein's accusers as procuring or recruiting underage girls in addition to once being Epstein's girlfriend.<sup>[161][162][208]</sup> In a 2009 deposition, several of Epstein's household employees testified that Maxwell had a central role in both his public and private life, referring to her as his "main

In March 2005, a woman contacted Florida's Palm Beach Police Department and alleged that her 14-year-old stepdaughter had been taken to Epstein's mansion by an older girl. While there, she was allegedly paid \$300 (equivalent to \$420 in 2021) to strip and massage Epstein.<sup>[92]</sup> She had allegedly undressed, but left the encounter wearing her underwear.<sup>[93]</sup>

Palm Beach Police began a 13-month undercover investigation of Epstein, including a search of his home.<sup>[71][94]</sup> During the investigation, Palm Beach Police Chief Michael Reiter publicly accused the Palm Beach County state prosecutor, Barry Krischer, of being too lenient and called for help from the FBI.<sup>[92]</sup>

Subsequently, the police alleged that Epstein had paid several girls to perform sexual acts with him.<sup>[89]</sup> Interviews with five alleged victims and 17 witnesses under oath, a high-school transcript and other items found in Epstein's trash and home allegedly showed that some of the girls involved were under 18, the youngest being 14, with many under 16.<sup>[95][96]</sup> The police search of Epstein's home found two hidden cameras and large numbers of photos of girls throughout the house, some of whom the police had interviewed in the course of their investigation.<sup>[93]</sup> Adriana Ross, a former model from Poland who became an Epstein assistant, reportedly removed computer drives and other electronic equipment from the financier's Florida mansion before Palm Beach Police searched the home as part of their investigation.<sup>[97]</sup> The court documents record that a search of Epstein's residence by Palm Beach Police detective Joseph Recarey in 2005 uncovered an incriminating Amazon receipt containing books on S&M. The books he ordered are titled: *SM 101: A Realistic Introduction*, *SlaveCraft: Roadmaps for Erotic Servitude - Principles, Skills and Tools* and *Training with Miss Abernathy: A Workbook for Erotic Slaves and Their Owners.*<sup>[98]</sup>

A former employee told the police that Epstein would receive massages three times a day.<sup>[93]</sup> Eventually the FBI compiled reports on "34 confirmed minors" eligible for restitution (increased to 40 in the NPA) whose allegations of sexual abuse by Epstein included corroborating details.<sup>[99]</sup> Julie Brown's 2018 exposés in the Miami Herald identified about 80 victims and located about 60 of them.<sup>[1][71][100]</sup> She quotes the then police chief Reiter as saying "This was 50-something 'shes' and one 'he'—and the 'shes' all basically told the same story."<sup>[1]</sup> Details from the investigation included allegations that 12-year-old triplets were flown in from France for Epstein's birthday, and flown back the following day after being sexually abused by the financier. It was alleged that young girls were recruited from Brazil and other South American countries, former Soviet countries, and Europe, and that Jean-Luc Brunel's "MC2" modeling agency was also supplying girls to Epstein.<sup>[95][101][102]</sup>

In May 2006, Palm Beach police filed a probable cause affidavit saying that Epstein should be charged with four counts of unlawful sex with minors and one count of sexual abuse.<sup>[93][103]</sup> On July 27, 2006, Epstein was arrested by the Palm Beach Police Department on state felony charges of procuring a minor for prostitution and solicitation of a prostitute. He was booked at the Palm Beach County jail and later released on a \$3,000 bond.<sup>[5][9][104][105]</sup> State prosecutor Krischer later convened a Palm Beach County grand jury, which was usually only done in capital cases. Presented evidence from only two victims, the grand jury returned a single charge of felony solicitation of prostitution,<sup>[106]</sup> to which Epstein pleaded not guilty in August 2006.<sup>[107]</sup>

Epstein's defense lawyers included Roy Black, Gerald Lefcourt, Harvard Law School professor Alan Dershowitz, and former U.S. Solicitor General Ken Starr.<sup>[92][108]</sup> Linguist Steven Pinker also assisted.<sup>[109]</sup>
