

GOVERNMENT BILL PASSED AGAINST ICAC/OPI AUGUST 2021 - PROTECTION OF POLITICIANS FROM INVESTIGATION

FRASER ELLIS MP KADINA - INNOCENT - NOT CONNECTED OR INVOLVED IN CRIMINAL NETWORK TARGETING OF AN INDIVIDUAL - ALL CONFIRMED DOCUMENTED EVIDENCE OF ILLEGAL TARGETED ACTIVITY OF THE TARGETED VICTIM OBTAINED BY THE TARGETED VICTIM 2016-2022 KADINA UNDER THE LEADERSHIP OF FRASER ELLIS MP KADINA - NOT INVOLVED IN FRAUDULENT ACTIVITY OR DECEPTION

ICAC/OPI CONSPIRED FALSIFIED ALLEGATIONS AGAINST FRASER ELLIS MP KADINA CLAIMING INVOLVEMENT IN DECEPTION AND FRAUD DISCREDITED UNDER THE OBTAINED AND SUBMITTED EVIDENCE OF THE TARGETED VICTIM - ICAC/OPI CONSPIRING IN A COVER UP WITH GOVERNMENT SOURCES INVOLVED IN CRIMINAL NETWORK TARGETING OF AN INDIVIDUAL, DENYING THE TARGETED VICTIM WAS A TARGET OF ILLEGAL TARGETED ACTIVITY INVOLVING GOVERNMENT AND POLICE SOURCES 2016-2017 AND 2021-2022 AND DURING THE PERIOD OF ALLEGING THE ONLY SENATOR TO ASSIST THE TARGETED VICTIM WHEN SEEKING GOVERNMENT ASSISTANCE AND REPORTING THE ILLEGAL TARGETED ACTIVITY 2021-2022 AND FOLLOWING SUBMITTING THE GOVERNMENT SOURCES INVOLVED IN CRIMINAL NETWORK TARGETING OF AN INDIVIDUAL CONNECTED TO EPSTEIN AND MAXWELL INVOLVING SEXUAL ABUSE RINGS AND MULTIPLE INTELLECTUAL PROPERTY THEFT PRIOR TO FRASER ELLIS MP KADINA POSITION AS A GOVERNMENT OFFICIAL, AND INCLUDING THE INTELLECTUAL PROPERTY THEFT OF ICAC/OPI IN 2013-2016 THE INTELLECTUAL PROPERTY OF THE TARGETED VICTIM WHILE RESIDING IN PORT PIRIE UNDER THE LEADERSHIP OF ROWAN RAMSAY

- CONSPIRING WITH INTERNAL INVESTIGATIONS OF POLICE SOURCES INVOLVED IN CRIMINAL NETWORK TARGETING OF AN INDIVIDUAL 2007-2016 IN A CONSPIRED COVER UP
- CONSPIRING WITH A CRIMINAL NETWORK 2016-2022

SUBMITTED TO ICAC/OPI BY THE TARGETED VICTIM 2021 FOLLOWING THE TARGETED VICTIMS CONTACT SEEKING ASSISTANCE AND INVESTIGATION FROM GOVERNMENT SOURCES - STEVEN MARSHALL, PREMIER OF SA AND VICKIE CHAPMAN, ATTORNEY GENERAL OF SA AND REPLY LETTERS - AND INCLUDING ALL OBTAINED CONFIRMED DOCUMENTED EVIDENCE REPORTS CONFIRMING THE TARGETED VICTIM IS A VICTIM OF ORGANISED ILLEGAL TARGETED ACTIVITY INVOLVING GOVERNMENT AND POLICE SOURCES

ICAC/OPI denied the report and extensive legal case files of constructed documented evidence spanning over a period of 30 years in 2022, and including confirmed targeted organised illegal activity of a Criminal Network targeting of an individual, confirmed in 2020, reply letters obtained by the targeted victim from Steven Marshall and Vickie Chapman Conspiring with Julia Gillard against the targeted victim in a third attempt of Attempted Assassination of the targeted victim by lethal injection involving conspired lawyers and Forensic Mental Health Services as was Attempted in 2017, confirmed as involving Vickie Chapman.

Julia Gillard confirmed as Conspiring against the targeted victim with an individual involved and connected to Epstein and Maxwell and involved in Sexual Abuse Rings and targeting of the targeted victim, 2018-2019 Vincent Bulone, Adelaide University and France criminal connections and involved in Conspiring with a Government sources involved and connected in a Criminal Network targeting of an individual, Julia Gillard in an attempted second Attempted assassination of the targeted victim by lethal injection involving mental Health services, Exact Conspired Attempt as occurred in 2017 , during the period of the targeted victim residing in Port Pirie and 2013 Contesting the Intellectual Property Theft of her Intellectual Property The Specialist Medical Centre and M.S.I.C that involved Epstein and Maxwell designing the M.S.I.C logo and was received via email as %20MSIClogo, confirming Epstein and Maxwell connection to the Australian Government sources involved in the Intellectual Property Theft of both Intellectual Property of the targeted victim and the Intellectual Property in the possession of the Australian Government sources involved and Australian Medical sources involved and Intellectual Property Theft of the targeted victim over a 30 year period in multiple possessions was a Conspired Targeted act of Destruction of Career for sexual demand of a Criminal Network Sexual Abuse Ring, involving submitted government sources contained within the evidence submitted to ICAC/OPI in 2021-2022 by the targeted victim, involving :
