Russian women at Epstein's New York residence during his last visit to the mansion in 2010, and had realised "that the recipient of Irina's foot massage was His Royal Highness, Prince Andrew, the Duke of York".^[97]

In July 2020, Caroline Kaufman, an alleged victim of Epstein, said in a federal lawsuit that she had seen Andrew at Epstein's New York mansion in December 2010.^[98] In November 2021 Lawrence Vioski, Epstein's pilot, testified in court during Ghislaine Maxwell's trial that Prince Andrew flew in Epstein's private plane along with other prominent individuals, including Bill Clinton, Donald Trump and John Glenn. Vioski stated he did not notice any sexual activity or wrongdoing on the plane.^[99] Similarly, Andrew's name was recorded on 12 May 2001 by Epstein's pilot David Rodgers in his logbook, and he testified that Andrew flew three times with Epstein and Giuffre in 2001.^[100] The following month a picture of Epstein and Maxwell, sitting at a cabin on the Queen's Balmoral estate, around 1999, at the invitation of Andrew, was shown to the jury to establish their status as partners.^[101]

On 5 January 2022, Virginia Giuffre's former boyfriend, Anthony Figueroa, said on *Good Morning Britain* that Giuffre told him Epstein would take her to meet Prince Andrew. He said, "She called me when she was on the trip and she was talking about she knew what they wanted her to do and she was really nervous and scared because she didn't know how to react to it". He alleged the meeting had taken place in London.^[102] In a court filing, Andrew's lawyers had previously referred to a statement by Figueroa's sister, Crystal Figueroa, who alleged that in her bid to find victims for Epstein, Giuffre had asked her, "Do you know any girls who are kind of slutty?"^[103] The same month, Carolyn Andriano, who as a 14-year-old was introduced by Giuffre to Ghislaine Maxwell and Jeffrey Epstein and was a prosecution witness in Maxwell's trial, said in an interview with the *Daily Mail* that then 17-year-old Giuffre told her in 2001 that she had slept with Prince Andrew. She stated, "And [Giuffre] said, 'I got to sleep with him'. She didn't seem upset about it. She thought it was pretty cool."^[104]

In an *ITV* documentary, former royal protection officer Paul Page recounted Maxwell's frequent visits to Buckingham Palace, and suggested the two might have had an intimate relationship,^[105] while Lady Victoria Hervey added that Andrew was present at social occasions held by Maxwell.^[106] The Duke of York's name and contact numbers for Buckingham Palace, Sunninghill Park, Wood Farm and Balmoral also appeared in Maxwell and Epstein's 'Little Black Book', a list of contacts of the duo's powerful and famous friends.^[106] In February 2022, *The Daily Telegraph* published a photograph of Andrew along with Maxwell giving a tour of Buckingham Palace to Andrew's guests Bill Clinton and Kevin Spacey, with a member of the tour party describing Maxwell as "the one who led us into Buckingham Palace".^[107]

Tina Brown, a journalist who edited *Vanity Fair*, *The New Yorker* and *The Daily Beast*, maintains Epstein described Andrew behind his back as an idiot but found him useful. Brown stated, "Epstein confided to a friend that he used to fly Andrew to obscure foreign markets, where governments were obliged to receive him, and Epstein went along as HRH's investment adviser. With Andrew as frontman, Epstein could negotiate deals with these (often) shady players".^[108]

Newsnight interview

In November 2019, the *BBC's Newsnight* arranged an interview between Andrew and presenter Emily Maitlis in which he recounted his friendship with Epstein for the first time.^[109] In the interview, Prince Andrew says he met Epstein in 1999 through Maxwell; this contradicts comments made by Andrew's private secretary in 2011, who said the two met in "the early 1990s".^[110] The Duke also said he did not regret his friendship with Epstein, saying "the people that I met and the opportunities that I was given to learn either by him or because of him were actually very useful".^[111]

In the interview, Andrew denied having sex with Giuffre on 10 March 2001, as she had accused, because he had been at home with his daughters after attending a party at PizzaExpress in Woking with his elder daughter Beatrice.^{[112][113]} Prince Andrew also added that Giuffre's claims about dancing with him at a club in London while he was sweaty were false due to him temporarily losing the ability to sweat after an "adrenaline overdose" during the Falklands War.^{[114][115]} According to physicians consulted by *The Times*, an adrenaline overdose typically causes excessive sweating in humans.^[116] He also said that he does not drink, despite Giuffre's account of him providing alcohol for them both.^{[117][118]} Accounts from other people have supported his statement that he does not drink.^{[119][120][121]}

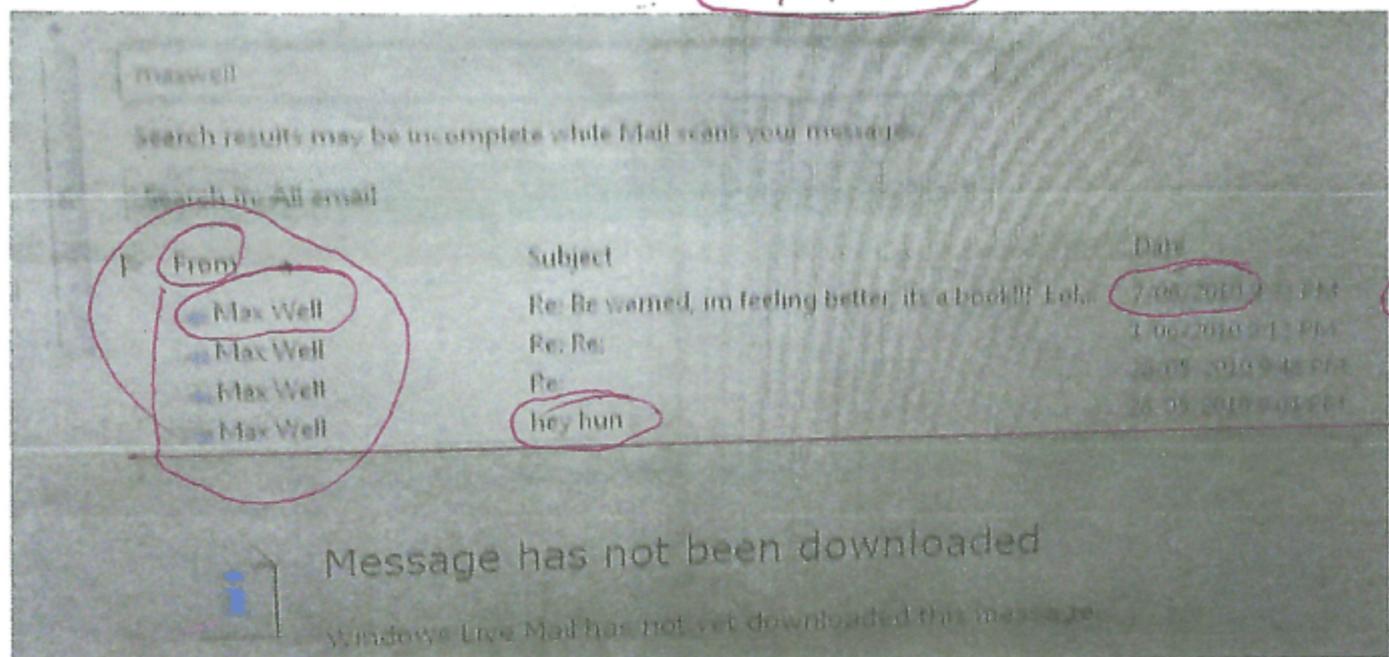
Andrew said that he had stayed in Epstein's mansion for three days in 2010, after Epstein's conviction for sex offences against a minor, describing the location as "a convenient place to stay". The Duke said that he met Epstein for the sole purpose of breaking off any future relationship with him.^[122] He also said that he would be willing to testify under oath regarding his associations with Epstein.^[111]

In July 2022 it was announced that a film would be made of the preparations for the interview and the interview itself. Shooting was planned to start in November 2022. According to *Deadline*, *Scoop* is being written by Peter Moffat.^[123]

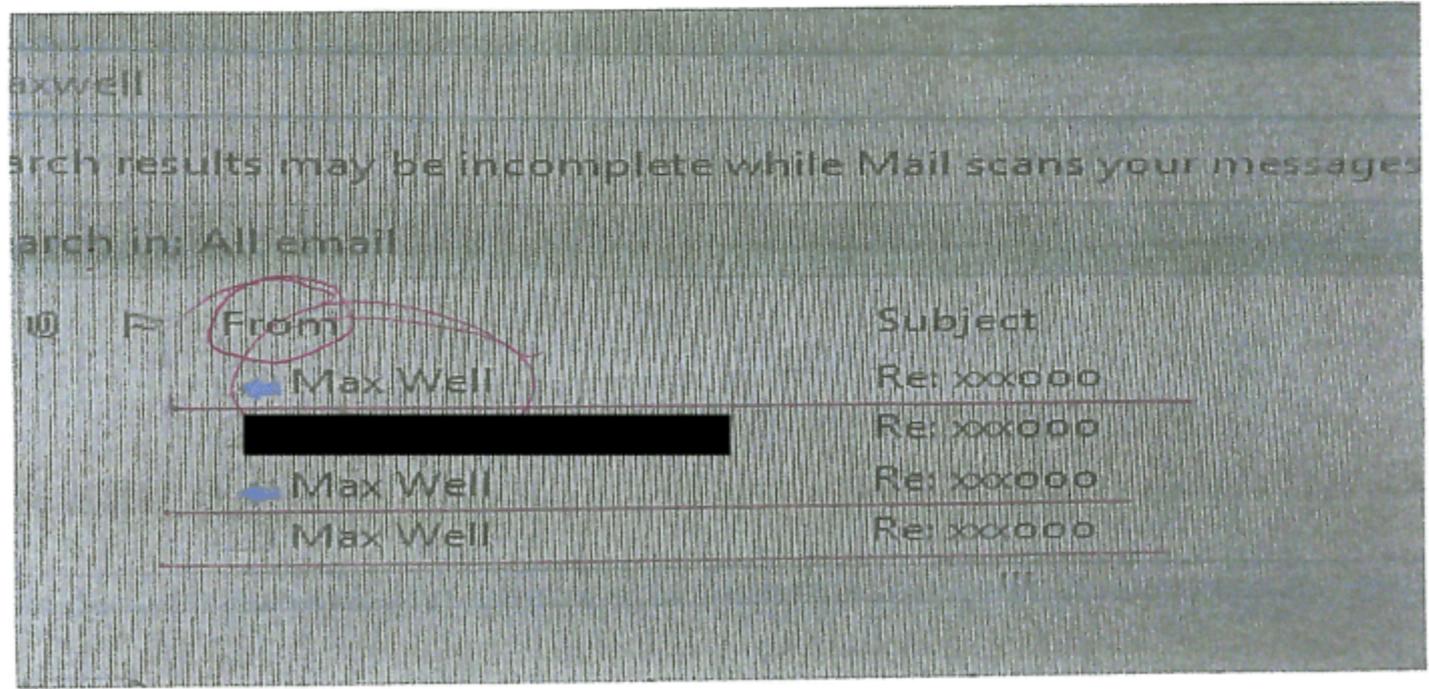
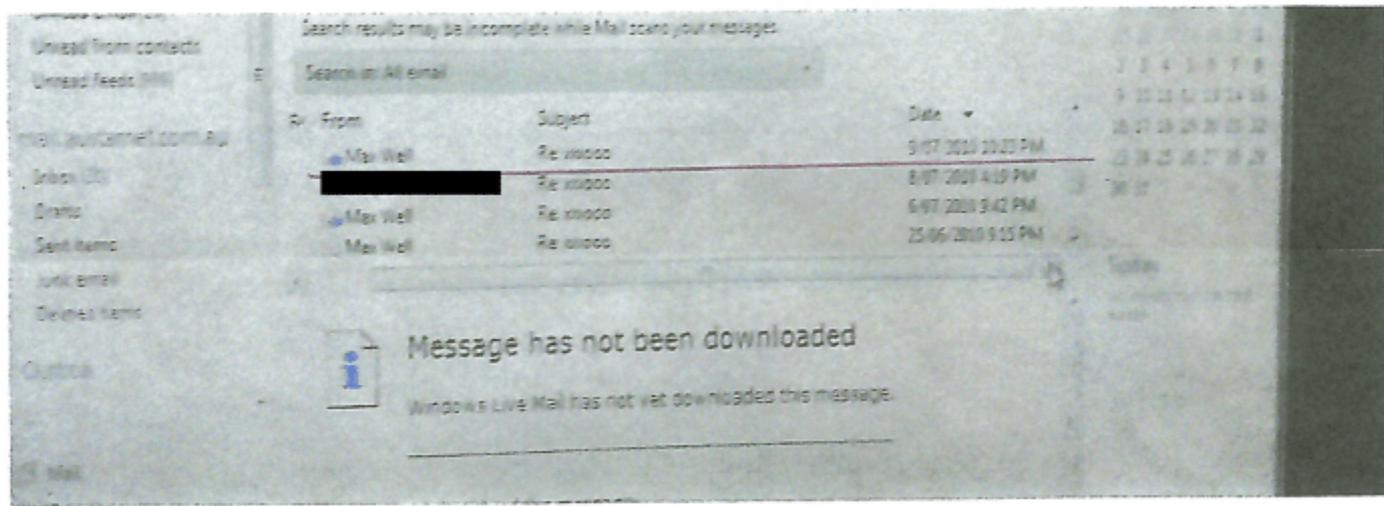

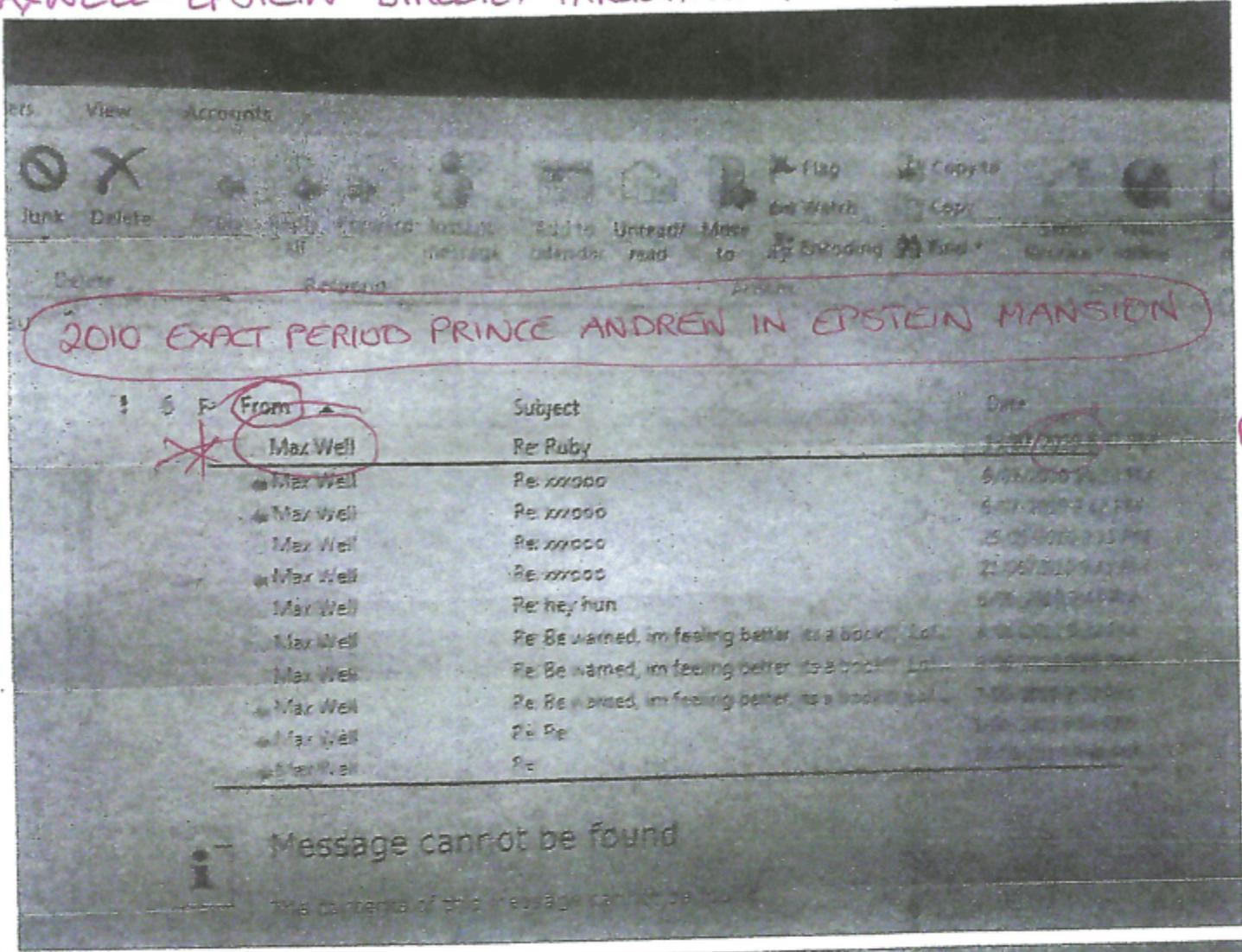

PRINCE ANDREW - EPSTEIN - MANSION 2010

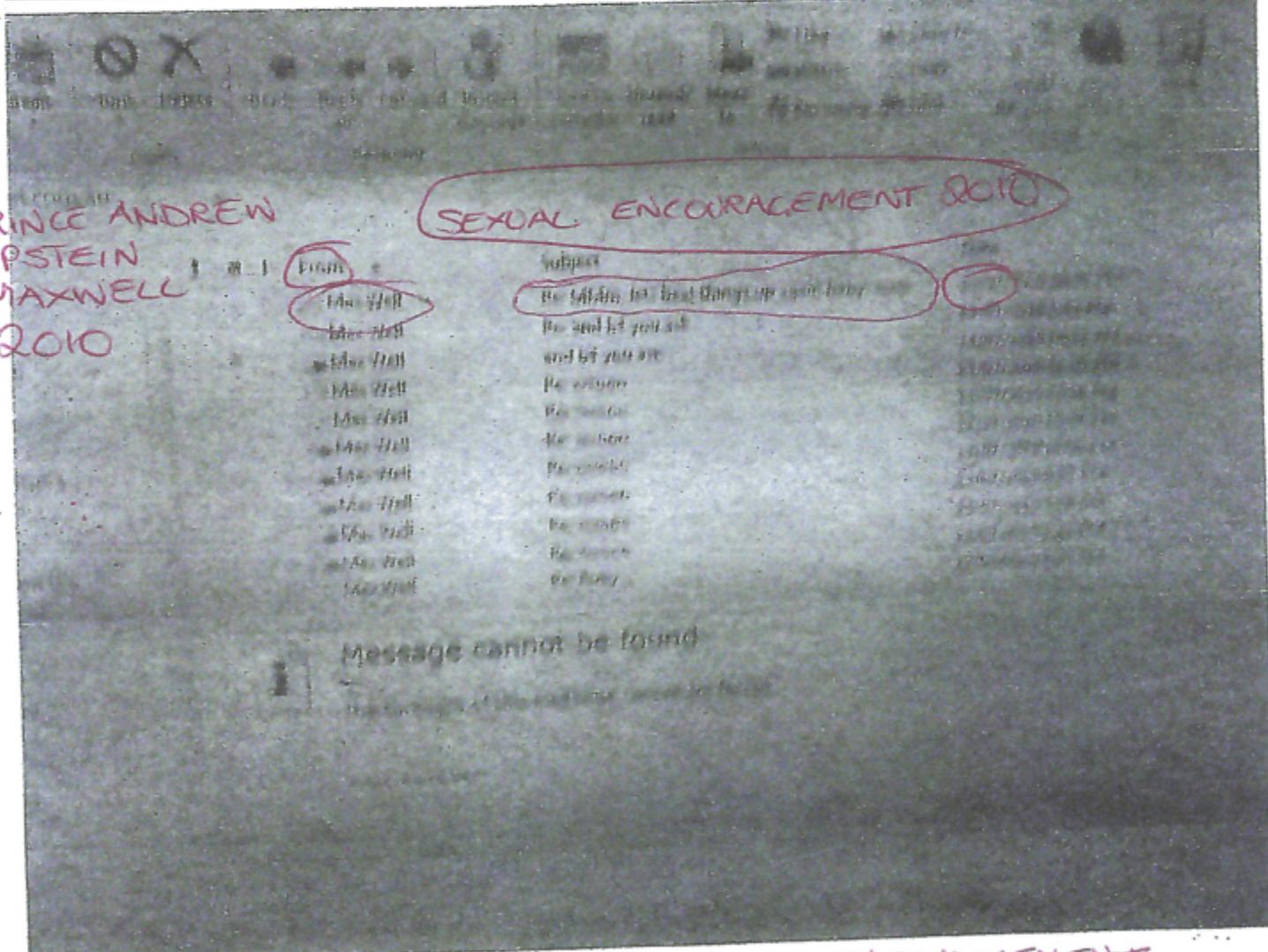

Epstein attended local public schools, first attending Public School 188, and then Mark Twain Junior High School nearby.^[26] In 1967, Epstein attended the National Music Camp at the Interlochen Center for the Arts.^[29] He began playing the piano when he was five.^[30] He graduated in 1969 from Lafayette High School at age 16, having skipped two grades.^{[31][32]} Later that year, he attended classes at Cooper Union until he changed colleges in 1971.^[31] From September 1971, he attended the Courant Institute of Mathematical Sciences at New York University, but left without receiving a degree in June 1974.^{[31][32]}

Career

Teaching

Epstein started working in September 1974 as a physics and mathematics teacher for teens at the Dalton School on the Upper East Side of Manhattan.^{[31][33]} Donald Barr, who served as the headmaster until June 1974,^{[34][35][36]} was known to have made several unconventional recruitments at the time, although it is unclear whether he had a direct role in hiring Epstein.^{[33][37][38]} Three months after Barr's departure, Epstein began to teach at the school, despite his lack of credentials.^[38] Epstein allegedly showed inappropriate behavior toward underage students at the time.^{[33][37]} He became acquainted with Alan Greenberg, the chief executive officer of Bear Stearns, whose son and daughter were attending the school. Greenberg's daughter, Lynne Koepfel, pointed to a parent-teacher conference where Epstein influenced another Dalton parent into advocating for him to Greenberg.^[35] In June 1976, after Epstein was dismissed from Dalton for "poor performance",^{[33][39][40]} Greenberg offered him a job at Bear Stearns.^{[30][41]}

Banking

Epstein joined Bear Stearns in 1976 as a low-level junior assistant to a floor trader.^[42] He swiftly moved up to become an options trader, working in the special products division, and then advised the bank's wealthiest clients, such as Seagram president Edgar Bronfman, on tax mitigation strategies.^{[32][43][44]} Jimmy Cayne, the bank's later chief executive officer, praised Epstein's skill with wealthy clients and complex products. In 1980, four years after joining Bear Stearns, Epstein became a limited partner.^[42]

In 1981, he was asked to leave Bear Stearns for, according to his sworn testimony, being guilty of a "Reg D violation".^{[45][32][30]} Even though Epstein departed abruptly, he remained close to Cayne and Greenberg and was a client of Bear Stearns until its collapse in 2008.^[42]

Financial consulting

In August 1981, Epstein founded his own consulting firm, Intercontinental Assets Group Inc. (IAG),^[46] which assisted clients in recovering stolen money from fraudulent brokers and lawyers.^[30] Epstein described his work at this time as being a high-level bounty hunter. He told friends that he worked sometimes as a consultant for governments, and the very wealthy to recover embezzled funds, while at other times he worked for clients who had embezzled funds.^{[30][47]} Spanish actress and heiress Ana Obregón was one such wealthy client, whom Epstein helped in 1982 to recover her father's millions in lost investments, which had disappeared when Drysdale Government Securities collapsed because of fraud.^[48]

George, his alleged criminal activities on the islands were concealed through a complex network of companies.^[180]

Jane Doe v. Maxwell and Epstein's estate (2020)

In January 2020, a lawsuit was filed against Maxwell and Epstein alleging that they recruited a 13-year-old music student at the Interlochen Center for the Arts in 1994 and subjected her to sexual abuse.^[181] The suit states that Jane Doe was repeatedly sexually assaulted by Epstein over a four-year period and that Maxwell played a key role in both her recruitment and by participating in the assaults.^[181]

Jane Does v. Epstein estate (2020)

In August 2020 9 Jane Does filed suit accusing Epstein of sexual abuse. The alleged victims in the lawsuit include a 11 and 13 year old and a victim who alleged abuse in 1975.^[182]

Jane Doe v. Epstein estate (2020)

In August 2020 Epstein was sued by a Jane Doe accusing him of sexually abusing her for one and a half years, beginning when she was an 18-year-old aspiring singer and model in New York.^[183]

Jane Doe v. Epstein estate (2021)

A civil suit was filed against Epstein's estate in March 2021 by a Broward County woman who accused Epstein and Maxwell of trafficking her after repeatedly raping her in Florida in 2008.^[184]

On July 6, 2019, Epstein was arrested by the FBI-NYPD Crimes Against Children Task Force at Teterboro Airport in New Jersey on sex trafficking charges.^{[27][185][186][187]} He was jailed at the Metropolitan Correctional Center in New York City, which has held prisoners such as John Gotti, Joaquin "El Chapo" Guzman, and Paul Manafort.^{[188][189]}

According to witnesses and sources on the day of his arrest, about a dozen FBI agents forced open the door to his Manhattan townhouse, the Herbert N. Straus House, with search warrants. The search of his townhouse turned up evidence of sex trafficking and also found "hundreds – and perhaps thousands – of sexually suggestive photographs of fully – or partially – nude females". Some of the photos were confirmed as those of underage females. In a locked safe, compact discs were found with handwritten labels including the descriptions: "Young [Name] + [Name]", "Misc nudes 1", and "Girl pics nude".^[90] Also found in the safe were \$70,000 in cash, 48 diamonds,^[190] and a fraudulent Austrian passport, which expired in 1987, that had Epstein's photo but another name. The passport had numerous entrance and exit stamps, including entrance stamps that showed the use of the passport to enter France, Spain, the United Kingdom, and Saudi Arabia in the 1980s. 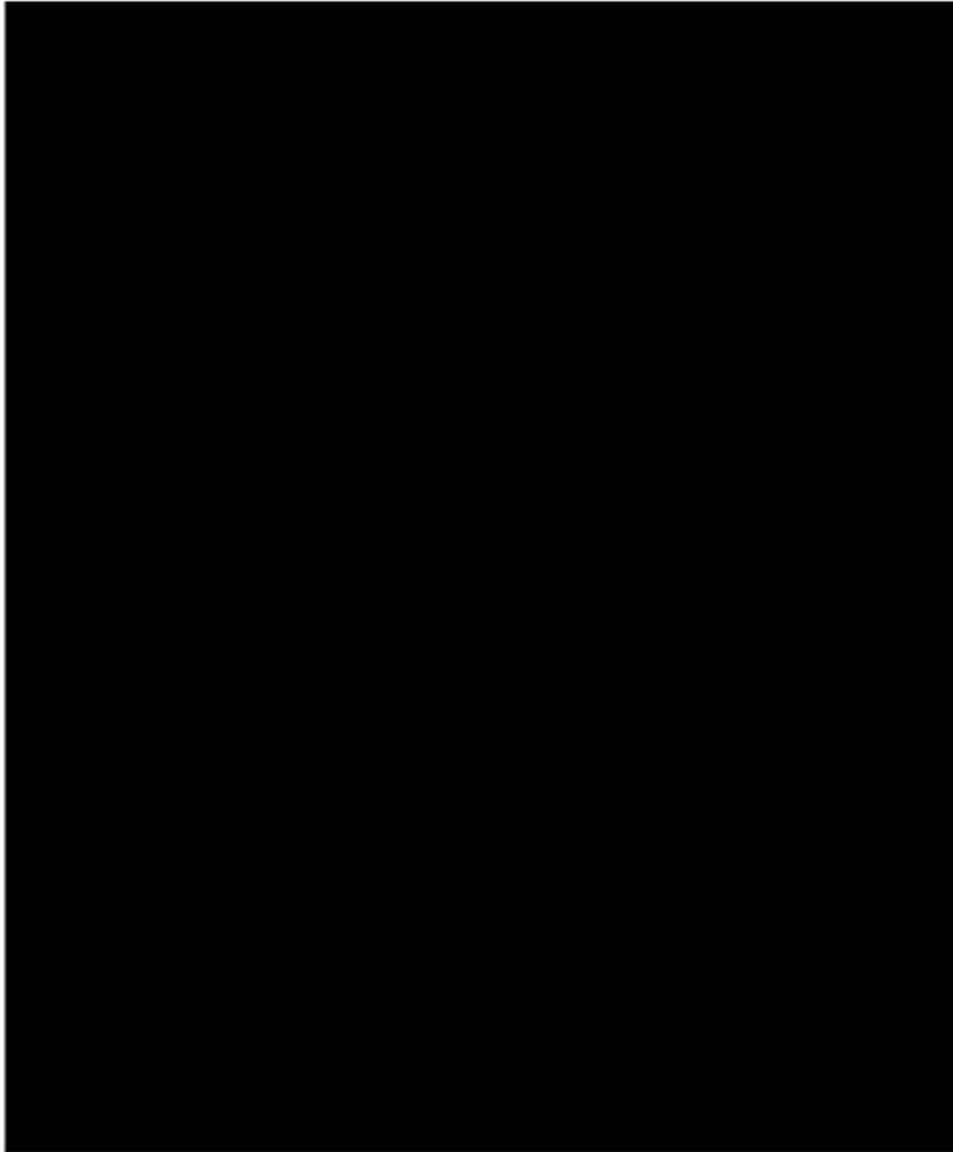

The Fraudulent and malicious Activity continued and escalated.

I requested a change of mobile phone number with the account still having Restricted Access applied. Joshua Adams proceeded to change the mobile phone number and did a check to ensure that the new number that I had been given was a newly created number that had not been circulated before my use, to ensure that the same activity would not occur and if it did would be seen as suspicious activity continued.

On the 25/03/2021 I reported the Fraudulent Malicious activity to Isobelle Oppeloar, Manager, Telstra Store, Kadina who proceeded to file a report to a higher authority, requesting an investigation with the higher authority of the Fraud Division or CEO of Telstra, due to ongoing issues over a 10 year period of continuous Fraudulent Activity. - Refer to Letter addressed to Isobelle Oppeloar, Manager - Refer to document filed report and Case ID number
I received contact from Telstra higher authority but missed the call and am waiting for the second contact, to ring me back as informed in the voice recorded message left on my mobile phone to discuss the issue.

On the 13th April 2021 I sent a letter addressed to the CEO of Telstra Head Office, Mr Andrew Penn, Melbourne, Victoria from the Norwood Post Office branch, Adelaide informing the CEO of the continuous Fraudulent Malicious Activity that had been occurring in my personal and newly created business account with Restricted Access, and requested a thorough investigation into the activity and provided the documented evidence of the activity that had been occurring in all servers and over a long period of time, and following re-location and change of details

I am contacting you today to place a complaint against the activity that I continuously encounter while attending the entertainment venue the Portside Tavern, Port Pirie. I have recently submitted a report of sexual targeting that had occurred on the premise and in various locations within the Port Pirie location.

On the 20 / 11 / 2016 at about 2pm I attended the Portside tavern to sit in the beer garden to have a couple of drinks and when I was about to leave I had car trouble and sighted two men walking into the venue as I sat in my car.

I entered the venue to ask the two men for assistance and was invited to stay for one drink before they looked at my car.

As confirmed by Telstra Head office, concerning continuous Fraudulent Activity occurring in all accounts over a 10 year period, the source of the continuous Fraudulent Activity in every account, server has been a result of Remote Access to servers, accounts and Computer Hardware resulting in blocked access, blocked contact, altered details and Fraudulent Activity and has been conducted by Government and Police Sources Government and Police Targeting over a 27 year period resulting in Specific Targeting of an Individual by the use of Technology - Illegal Government and Police Surveillance, and shared surveillance from location to location, and following relocation - REPORTED SINCE 2013 - 2021

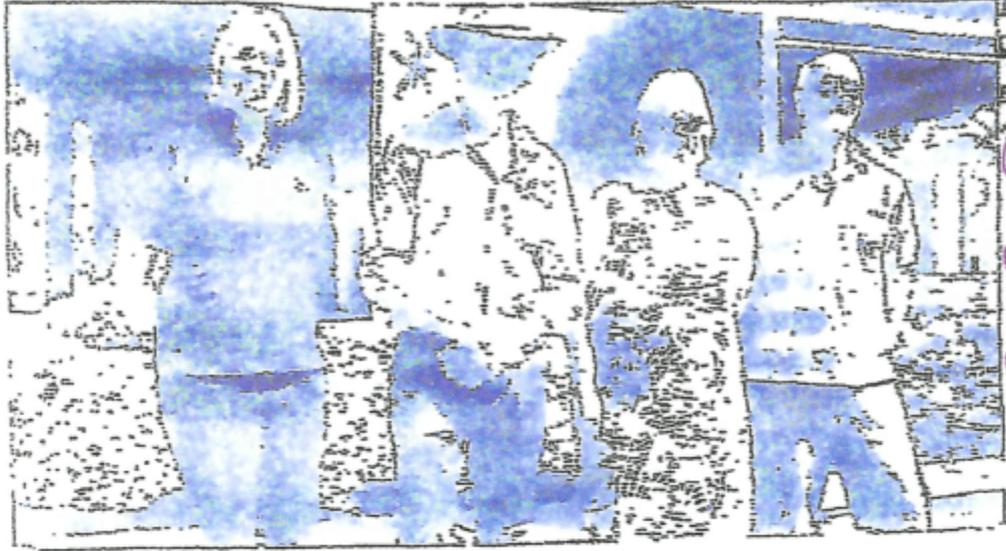

Discussing homelessness and community housing across YP

contribute \$5m and build more community housing,” he said.

“We know homelessness is more hidden in regions and a lot of people either couch surf or live with other people causing severe overcrowding.

“We’d love to see this government money come into regions — being here (in regions) is a great way to talk to community groups and service providers to better work together.”

Mrs Talbot said the visit was an opportunity to highlight for affordable housing in the area. “While it (homelessness) isn’t a core function of council, he (Mr Howarth) has given us some suggestions of ways to advocate for solutions for our area,” she said.

“We are a growth area and we are trying to encourage more people here but affordable housing is a real issue.

“I also highlighted the need for accessible information for people, to have more Copper Coast-specific connections.” Mrs Armstrong said she wanted the assistant minister to know the region had a lack of

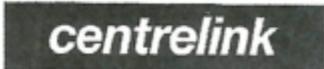

Epstein a massage". She claims she was taken to his mansion, where he exposed himself and had sexual intercourse with her, and paid her \$200 immediately afterward.^[106]

A similar \$50-million suit was filed in March 2008, by a different woman, who was represented by the same lawyer.^[129] These and several similar lawsuits were dismissed.^[130]

All other lawsuits have been settled by Epstein out of court.^[131] Epstein made many out-of-court settlements with alleged victims.^[130]

Victims' rights: *Jane Does v. United States (2014)*

*SEXUAL ABUSE RING
PROMINENT POSITIONS

A December 30, 2014, federal civil suit was filed in Florida by Jane Doe 1 (Courtney Wild) and Jane Doe 2 against the United States for violations of the Crime Victims' Rights Act by the U.S. Department of Justice's NPA with Epstein and his limited 2008 state plea. There was a later unsuccessful effort to add Virginia Roberts (Jane Doe 3) and another woman (Jane Doe 4) as plaintiffs to that case.^[132] The addition accused Alan Dershowitz of sexually abusing a minor, Jane Doe 3, provided by Epstein.^[133] The allegations against Dershowitz were stricken by the judge and eliminated from the case because he said they were outside the intent of the suit to re-open the plea agreement.^{[134][135]} A document filed in court alleges that Epstein ran a "sexual abuse ring", and lent underage girls to "prominent American politicians, powerful business executives, foreign presidents, a well-known prime minister, and other world leaders".^[136]

This long-running lawsuit is pending in federal court, aimed at vacating the federal plea agreement on the grounds that it violated victims' rights.^[137] On April 7, 2015, Judge Kenneth Marra ruled that the allegations made by alleged victim Virginia Roberts against Prince Andrew had no bearing on the lawsuit by alleged victims seeking to reopen Epstein's non-prosecution plea agreement with the federal government; the judge ordered that allegation to be struck from the record.^[134] Judge Marra made no ruling as to whether claims by Roberts are true or false. Though he did not allow Jane Does 3 and 4 to join the suit, Marra specifically said that Roberts may later give evidence when the case comes to court.^[138]

On February 21, 2019, in the case of *Two Jane Does v. United States*, Senior Judge of the U.S. District Court for the Southern District of Florida Kenneth Marra said federal prosecutors violated the law by failing to notify victims before they allowed him to plead guilty to only the two Florida offenses. The judge left open what the possible remedy could be.^[139]

Virginia Giuffre v. Epstein (2015)

In a December 2014 Florida court filing by Bradley Edwards and Paul G. Cassell meant for inclusion in the Crime Victims Rights Act lawsuit,^[140] Virginia Giuffre (then known as Virginia Roberts), alleged in a sworn affidavit that at age 17, she had been sexually trafficked by Epstein and Ghislaine Maxwell for their own use and for use by several others, including Prince Andrew^[141] and retired Harvard Law professor Alan Dershowitz.^{[8][142]} Giuffre also claimed that Epstein, Maxwell and others had physically and sexually abused her.^[143] She alleged that the FBI may have been involved in a cover-up.^[144] She said she had served as Epstein's sex slave from 1999 to 2002, and had recruited other underage girls.^[145] Prince Andrew, Epstein, and Dershowitz all denied having had sex with Giuffre. Dershowitz took legal action over the allegations.^{[146][147][148]} Giuffre filed a defamation suit against Dershowitz,

Non-prosecution agreement (NPA) (2006–2008)

In July 2006, the FBI began its own investigation of Epstein, nicknamed "Operation Leap Year".^[110] It resulted in a 53-page indictment in June 2007.^[71] Alexander Acosta, then the U.S. Attorney for the Southern District of Florida, agreed to a plea deal, which Alan Dershowitz helped to negotiate,^[111] to grant immunity from all federal criminal charges to Epstein, along with four named co-conspirators and any unnamed "potential co-conspirators".^[112] According to the *Miami Herald*, the non-prosecution agreement "essentially shut down an ongoing FBI probe into whether there were more victims and other powerful people who took part in Epstein's sex crimes". At the time, this halted the investigation and sealed the indictment. The *Miami Herald* said: "Acosta agreed, despite a federal law to the contrary, that the deal would be kept from the victims."^[1]

The controversial non-prosecution agreement

Acosta later said he offered a lenient plea deal because he was told that Epstein "belonged to intelligence", was "above his pay grade" and to "leave it alone".^{[113][114]} Epstein agreed to plead guilty in Florida state court to two felony prostitution charges, serve 18 months in prison, register as a sex offender, and pay restitution to three dozen victims identified by the FBI.^[115] The plea deal was later described as a "sweetheart deal".^[116]

A federal judge later found that the prosecutors had violated the victims' rights in that they had concealed the agreement from the victims and instead urged them to have "patience".^{[117][118]}

According to an internal review conducted by the Department of Justice's Office of Professional Responsibility, which was released in November 2020, Acosta showed "poor judgment" in granting Epstein a non-prosecution agreement and failing to notify Epstein's alleged victims about this agreement.^[119]

Conviction and sentencing (2008–2011)

On June 30, 2008, after Epstein pleaded guilty to a state charge (one of two) of procuring for prostitution a girl below age 18,^[120] he was sentenced to 18 months in prison. While most convicted sex offenders in Florida are sent to state prison, Epstein was instead housed in a private wing of the Palm Beach County Stockade and, according to the sheriff's office, was after 3½ months allowed to leave the jail on "work release" for up to 12 hours a day, 6 days a week. This contravened the sheriff's own policies requiring a maximum remaining sentence of 10 months and making sex offenders ineligible for the privilege. He was allowed to come and go outside of specified release hours.^[100]

Epstein's cell door was left unlocked, and he had access to the attorney room where a television was installed for him, before he was moved to the Stockade's previously unstaffed infirmary. He worked at the office of a foundation he had created shortly before reporting to jail; he dissolved it after he had served his time. The Sheriff's Office received \$128,000 from Epstein's non-profit to pay for the costs of extra services being provided during his work release. His office was monitored by "permit deputies" whose overtime was paid by Epstein. They were required to wear suits, and checked in "welcomed guests" at the "front desk". Later the Sheriff's Office said these guest logs

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling 1300 366 424 or (08) 8436 3555.

I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament. Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for raising your concerns with me.

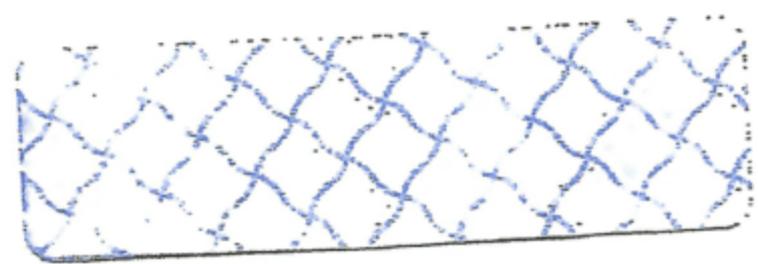

short her courses in Adelaide in 1982, and moved to Melbourne to work with the Australian Union of Students.^[20] In 1983, she became the second woman to lead the Australian Union of Students, serving until the organisation's discontinuation in 1984. She was also the secretary of the left-wing organisation Socialist Forum.^{[21][22]} Having transferred her studies to the University of Melbourne, Gillard graduated with a Bachelor of Laws degree in 1986 and a Bachelor of Arts degree in 1989.^[23] In 1987, she joined the law firm Slater & Gordon in Werribee, Victoria, working in industrial law.^[11] In 1990, she was admitted as a partner; at the age of 29, she was the youngest partner within the firm, and one of the first women to hold the position.^{[24][25]}

Early political involvement

From 1985 to 1989, Gillard served as President of the Carlton branch of the Labor Party.^[6] She stood for Labor preselection in the Division of Melbourne prior to the 1993 federal election, but was defeated by Lindsay Tanner.^[26] At the 1996 federal election, Gillard won the third position on Labor's Senate ticket in Victoria, behind Robert Ray and Barney Cooney.^{[27][28]} However, on the final distribution of preferences she was defeated by Lyn Allison of the Australian Democrats.^{[29][30]}

In 1996, Gillard resigned from her position with Slater & Gordon to serve as chief of staff to John Brumby, at that time the Leader of the Opposition in Victoria.^{[6][30][31]} She was responsible for drafting the affirmative-action rules within the Labor Party in Victoria that set the target of pre-selecting women for 35 per cent of "winnable seats". She also played a role in the foundation of EMILY's List, the pro-choice fund-raising and support network for Labor women.^[32]

Gillard has cited Welsh Labour politician Aneurin Bevan as one of her political heroes.^[24]

Member of Parliament (1998–2007)

Gillard was first elected to the House of Representatives at the 1998 federal election representing Lalor, a safe Labor seat near Melbourne, replacing Barry Jones who retired. She made her maiden speech to the House on 11 November 1998.^[33] Gillard was a member of the standing committee for Employment, Education and Workplace Relations from 8 December 1998 to 8 December 2001, in addition to Aboriginal and Torres Strait Islander Affairs from 20 March 2003 to 18 August 2003. Within the joint committees, she was a member of the Public Accounts and Audit from 8 December 1998 to 11 February 2002, in addition to the Native Title and the Aboriginal and Torres Strait Islander Land Fund from 20 March 2003 to 11 August 2003.^[6]

Shadow Minister (2001–2007)

After Labor's defeat at the 2001 federal election, Gillard was elected to the Shadow Cabinet under then-Labor Leader Simon Crean, where she was given responsibility for Population and Immigration. In February 2003, she was given additional responsibilities for Reconciliation and Indigenous Affairs.^[34] In these roles, in the wake of the Tampa and Children Overboard affairs, which were partly credited with Labor's 2001 election loss, Gillard developed a new immigration policy for the Labor Party.^[13]

Gillard was later promoted to the position of Shadow Minister for Health and Deputy Manager of Opposition Business in the House (to Mark Latham) on 2 July 2003.^{[25][35]} During this time, she shadowed Tony Abbott, with the rivalry between the two often attracting attention from the media.^[36] She was later given additional responsibility for managing opposition business in the House of Representatives by Latham, who had succeeded Beazley as Labor Party leader.^[37]

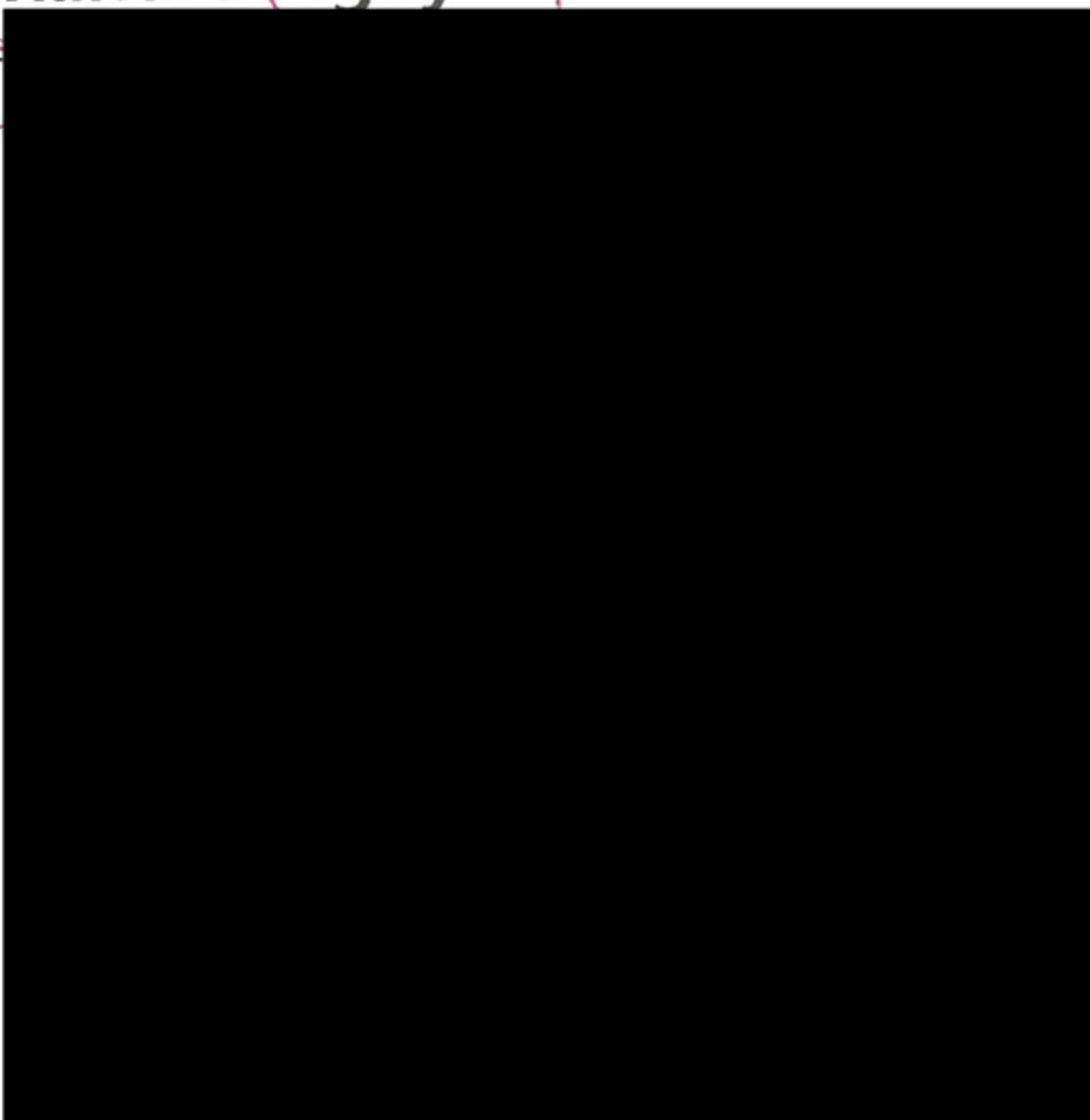

The Duke was patron of the Middle East Association (MEA), the UK's premier organisation for promoting trade and good relations with the Middle East, North Africa, Turkey and Iran.^[185] Since his role as [Special Representative for International Trade and Investment](#) ended Andrew continued to support UK enterprise without a special role. [Robert Jobson](#) said he did this work well and wrote, "He is particularly passionate when dealing with young start-up entrepreneurs and bringing them together with successful businesses at networking and showcasing events. Andrew is direct and to the point, and his methods seem to work".^[186]

The Duke was also patron of [Fight for Sight](#), a charity dedicated to research into the prevention and treatment of blindness and eye disease,^[187] and was a member of [the Scout Association](#).^[188] He toured Canada frequently to undertake duties related to his Canadian military role. Rick Peters, the former Commanding Officer of [the Royal Highland Fusiliers of Canada](#) stated that Prince Andrew was "very well informed on Canadian military methods".^[189]

While touring India as a part of the [Queen's Diamond Jubilee](#) in 2012,^[190] Andrew became interested in the work of Women's Interlink Foundation (WIF), a charity which helps women acquire skills to earn income. He and his family later initiated Key to Freedom, a project which tries to "find a route to market for products made by WIF".^{[191][192]} On 3 September 2012, Andrew was among a team of 40 people who abseiled down [The Shard](#) (tallest building in Europe) to raise money for educational charities the Outward Bound Trust and the Royal Marines Charitable Trust Fund.^{[193][194]}

In 2013, it was announced that Andrew was becoming the patron of [London Metropolitan University](#).^[195] and the [University of Huddersfield](#).^{[196][197]} In July 2015, he was installed as Chancellor of the University of Huddersfield.^[198] In recognition of Andrew's promotion of entrepreneurship he was elected to an Honorary Fellowship at [Hughes Hall](#) in the [University of Cambridge](#) on 1 May 2018.^[199] He became the patron of the charity [Attend](#)^[200] in 2003, and was a member of the International Advisory Board of the [Royal United Services Institute](#).

In 2014, Andrew founded the Pitch@Palace initiative^[201] to support entrepreneurs with the amplification and acceleration of their business ideas. Entrepreneurs selected for Pitch@Palace Bootcamp are officially invited by Andrew^[202] to attend St. James Palace in order to pitch their ideas and to be connected with potential investors, mentors and business contacts.^[203] The Duke also founded The Prince Andrew Charitable Trust which aimed to support young people in different areas such as education and training.^[204] He also founded a number of awards including Inspiring Digital Enterprise Award (iDEA), a programme to develop the digital and enterprise skills,^{[205][206]} the Duke of York Award for Technical Education, given to talented young people in technical education,^{[207][208]} and the Duke of York Young Entrepreneur Award, which recognised talents of young people in entrepreneurship.^[209] The Duke of York lent his support to organisations that focus on science and technology by becoming the patron of [Catalyst Inc](#) and [TeenTech](#).^{[210][211][212]} In 2014, Andrew visited Geneva, Switzerland, to promote British science at CERN's 60th anniversary celebrations.^[213] In May 2018, he visited China and opened the Pitch@Palace China Bootcamp 2.0 at [Peking University](#).^[214]

In March 2019, Andrew took over the patronage of the [Outward Bound](#) Trust from his father, the Duke of Edinburgh, serving up until his own resignation in November 2019.^[215] Prince Andrew had held the position of chairman of the board of trustees of the organisation since 1999.^[216] The charity tries to instil leadership qualities among young people.^[217] In May 2019, it was announced that Andrew had succeeded [Lord Carrington](#) as patron of the Royal Fine Art Commission Trust.^[218]

Our reception staff are available for discussion with you. Please feel free to call us at any time.

What to Expect from your Psychologist :

Your psychologist is interested to meet you and will spend most of the first session finding out about you, your life so far, and your current situation. Together, you and your psychologist will aim to come to an agreement about the focus for change. You will draw up a treatment program to treat the identified issues, and a set of goals for change. You can expect an opportunity to talk and express your feelings and ideas about your current situation. Depending on your situation you should expect treatment to take 6 – 10 sessions. Your psychologist will discuss this with you. Each session is for 50 minutes.

Confidentiality:

Information that you share with your psychologist will be kept confidential. Your psychologist will write back to your GP, if you have been referred by a GP. Psychologists are mandated by law to report any incidences of child abuse or indeed any plan to harm an adult including yourself. Under certain circumstances your records could be subpoenaed by the court. Please discuss any concerns about confidentiality with your psychologist. Attendance at your Sessions We ask for your commitment to your treatment program. It is a courtesy to let your psychologist know well ahead of time if you need to change an appointment time. Your psychologist will be left with wasted time and it would really help other clients who are waiting for appointments and your psychologist, if you could, out of courtesy, inform us as soon as possible if you can't attend. Charges apply to late cancellations.

Cost:

Each session costs \$240.00 as a privately paying client. If you have private health cover, you may be eligible for a rebate, and we can swipe most cards here on premises to claim (any HICAPS providers). If you are unsure whether you are covered for psychological services, it is best to enquire with your fund as each person's cover can vary a great deal and we cannot know your level of cover before you attend.

After hours appointments: Appointments after 5pm incur a \$20 surcharge.

Medicare rebates are available if you have a Mental Health Care Plan in place from your GP with a referral to our practice, or a referral from a psychiatrist. The gap you pay per session after the Medicare rebates varies very slightly depending on which practitioner you see, but is about \$113.
