OFFENCE DETAILS - SUMMARY OF EVIDENCE

Brief Overview

At about 11.32 pm on Tuesday, 19th May, 2015, at Port Pirie the accused, Jaqueline Carol PEARCE, drove a motor vehicle namely a Mitsubishi sedan [REDACTED] on a road namely The Terrace, whilst she exceeded the prescribed concentration of alcohol, reading being 0.050.

Police

At about 11.32 pm on Tuesday, 19th May, 2015, Police [REDACTED] were on mobile uniform patrol when they stopped the accused who was driving a Mitsubishi sedan [REDACTED] south along The Terrace, Port Pirie for a random breath test.

At 11.33 pm the same date the accused submitted to an alcotest and gave a positive reading.

The accused was conveyed to the Port Pirie Police Station, where at 12.02 am on Wednesday, 20th May, 2015, the accused submitted to a breath analysis instrument. These two blows were not accepted by the breath analysis instrument.

At 12.15 am the same date, the accused again submitted to two blows into the breath analysis instrument and gave the reading of 0.050.

The accused declined a blood test kit.

The accused was issued with a Driver Direction Notice Number A0181796, not to drive for 6 hours.

The accused motor vehicle was impounded for 28 days from 20052015 Notice 044752 refers.

FIRST OFFENCE - 18 / 12 / 2014

In regards to the matter of the drink driving charge dated - 18 / 12 / 2014
Fined - \$623 .00

After reporting to the Port Pirie Police Department two weeks prior to this charge via a phone call made to a 000 call centre and transferred to the Port Pirie Police Department, of which a female and a male officer of the Port Pirie Police Department came to my place of residence, 7 Meadow Crescent, Port Pirie, in order to question and obtain a statement in relation to this phone call of threatening behaviour and the report that I had made in relation to the alleged threats of the physical endangerment and the entrapment within the Port Germain residence while in a relationship with Paul Gardner.

- Threats of Prostitution made against myself and my children
- Entrapment of myself by Paul Gardner at his Port Germain residence on that evening in question
- Possession of illegal firearms of which I sighted in his possession at his Port Germain residence

05 After this date of the 000 report of these threats and endangerment I began to suffer from the [REDACTED] and episodes of random drinking under the effects of the stress related condition as a result of these threats, of which was not resolved by the Port Pirie Police Department upon my reporting of the incidents and whom was involved.

On the day in question of the recorded drink driving charges, I had been receiving constant vicious harassment and intimidation of threatening behaviour in relation to my physical wellbeing and emotional trauma while drinking within the privacy of my residence, [REDACTED] Port Pirie, via the use of telecommunication systems, text messages and phone calls made to my mobile phone.

I had suffered a severe [REDACTED] while under the influence of alcohol and the threatening behaviour via these services and fled in fear and panic of being physically attacked whilst alone in my place of residence via the use of my vehicle, registration number: [REDACTED]

I proceeded to drive down Senate Road towards the place of my friends residence who lived in the vicinity of Senate Road and the intersection of the laneway, Revell Street.

While standing on the footpath next to the Telstra phone box on Senate Road, Port Pirie, of which I was trying to contact my friend via the use of the phone box facilities, I noticed a police vehicle driving back and forth along Senate Road, Port Pirie, continuously passing myself as I stood on the footpath next to the phone box.

In a panicked emotional state of confusion and fear I quickly walked back to my parked vehicle situated in the laneway, the corner of Senate Road and Revell Street intersection, and got back into my vehicle and proceeded to drive slowly down the laneway to return to my place of residence, [REDACTED]

Whilst driving down the laneway at a slow speed I looked into the view of my vehicles rear view mirror and noticed that the police vehicle had followed me down the laneway and had turned on the police vehicles flashing lights in their pursuit of pulling me over.

Upon noticing the police vehicles flashing lights I began to come to a stop and park my vehicle on the left hand side of the laneway, Revell Street, Port Pirie.

Upon the police vehicle parking behind my vehicle I exited my vehicle in a state of confusion and fear and approached the police officer, [REDACTED] whom had exited the police vehicle and began to question why I had been asked to pull over as I had not committed any type of driving offence, erratic behaviour and my car was in good condition.

Upon approaching the police officer, Jake he had said to me, " Don't you recognise me ?". I answered " No , I don't ", looking and feeling puzzled and confused at his line of questioning. The police officer, Jake replied , " You don't, I know some of the boys " , motioning his head towards the direction of The Red Devils Motorcycle Clubhouse, situated within the vicinity of the Senate Road and Revell Street corner intersection within our view. I still remained puzzled and confused as to his statement and questions concerning the established clubhouse of The Red Devils Motorcycle Clubhouse.

The police officer, [REDACTED] then started to question me in relation to my days events and asked if I had been drinking prior to this arrest on the day.

I informed the police officer that I had been drinking in my place of residence, [REDACTED] Port Pirie prior to my arrest but had fled my residence within the fear of a [REDACTED] due to the vicious harassment and intimidation of which I had been receiving over a period of hours on that day and that I feared for my safety and that of my children's.

Paul Gardner - 000 call centre transfer - Police interview within the Port Pirie Police Station of the reporting of the threat of prostitution, firearms and entrapment two weeks prior.

The police officer , Jake then proceeded to breath test me - breathalyser unit - and informed me that the reading was positive and that I would have to accompany him to the Port Pirie Police Station. Another police vehicle arrived on the scene, Revell Street , Port Pirie and proceeded to drive my vehicle with my pet dog , Ruby inside the vehicle back to the Port Pirie Police Station.

Whilst in the interview room of the Port Pirie Police Station I was questioned by the police officer , Jake and a female officer in relation to the days events that had led up to me being arrested and questioned for drink driving.

I had not committed a driving offence or at any time drove my car in an erratic manner while in the panic attack to warrant the attention of the police, nor was my vehicle inspected for faults or it's condition during this arrest.

Upon the finished questioning of the drink driving charge the police officer, [REDACTED] then proceeded to ask me misleading questions in relation to the Red Devils Motorcycle Club which held no relevance to the offence of drink driving.

I refused to answer his line of questioning as I felt confused and puzzled as to his line of irrelevant questioning in relation to the drink driving offence, of which I had been arrested for on that day.

This line of questioning had left me very confused and suspicious in relation to the comments made by the police officer , [REDACTED] whilst standing within his line of comments and questioning upon the footpath of the laneway, Revell Street, Port Pirie.

I was informed that due to the positive alcohol reading that I could not drive my vehicle for a period of 6 hours and I proceeded to sit in my vehicle with my pet dog, Ruby for the remaining 6 hours in front of the Port Pirie Police Station as instructed by the police officer before returning to my place of residence , [REDACTED]

The continuous vicious harassment continued from the date of the reporting of Paul Gardner and from that day forth and is present to this current day via the use of telecommunication systems - Report of fraudulent activity and the reporting of the vicious harassment and the change of mobile number - Optus - Telecommunications Ombudsman
