

I write in response to your letter dated 31 December 2019, enclosing a package of documents relating to your complaint. * - USB FLASHDRIVE

I have reviewed your correspondence and the associated documents. I understand that your primary concern is that employees of SA Health allegedly stole your business development plans in Port Pirie between 2007 and 2011.*

While I appreciate receiving your correspondence, I am unable to investigate this matter as it falls outside of my portfolio responsibilities. Matters relating to SA Health fall within the portfolio responsibility of the Minister for Health and Wellbeing, the Hon Stephen Wade MLC. You may wish to raise your concerns with Minister for Health and Wellbeing directly. You can write to his office at GPO Box 2555, Adelaide SA 5001.

I have not referred your correspondence to the Minister for Health and Wellbeing in the usual course given your reference to your complaint to the Office of Public Integrity. I remind you that section 54(3) of the Independent Commissioner Against Corruption Act 2012 prohibits the disclosure of information that is connected to a matter that forms or is the subject of a complaint under that Act, except in very limited circumstances.

I suggest that you consider obtaining independent legal advice in relation to these matters. The Legal Services Commission of South Australia provide a free advisory service on most legal matters. The service is available by calling [redacted] or [redacted]

I also note your comments about the decriminalisation of sex work in South Australia. The Statutes Amendment (Decriminalisation of Sex Work) Bill 2018 was introduced into Parliament by the Hon Tammy Franks MLC. The Bill failed to receive the votes required in the House of Assembly on 13 November 2019. While I respect the views of my Parliamentary colleagues, it is disappointing that the Parliament denied the Bill passing to the Committee Stage. - AGREES WITH THE BILL BEING

VICKI CHAPMAN CONNECTED TO GLENSIDE / DIRECT INVOLV.

In my view, the practice of the sale of sex has existed since time immemorial, and will continue to exist without the passage of the Bill through the Parliament.

Unfortunately, the practice will occur without the protections that could have been afforded to sex workers under the Bill. Sex workers remain in a position where their health, welfare and safety is a risk and where they may be prosecuted for their work. I will consider any new legislation to decriminalise sex work that may be brought before the Parliament in the future.

Thank you for your letter dated 19 January 2020, regarding an investigation into alleged intellectual property theft of two business plans you developed between 2007 and 2011. I note you have also written to Hon Vickie Chapman MP, Attorney-General, and Hon Steven Marshall MP, Premier. *

* GP Plus Health Care Centres are a State Government initiative. * The Port Pirie GP Plus Centre was one of the last of eight GP Plus Centres to be constructed in South Australia. These centres are the foundation of primary health care. They provide advice on how to manage chronic diseases, provision of support for more in-home care and guidance for those who want to stay healthy.

The Port Pirie GP Plus Centre does not have an after-hours GP service, however, the local GPs provide some after-hours services through their privately run medical practices.

* I note your concerns raised regarding intellectual property theft, however, SA Health is not in a position to investigate this further as private medical practices or specialist clinics are not under the governance of SA Health. *

I can see you have previously been provided with contact information for the Legal Services Commission of South Australia (LSC). Should you wish to pursue this matter further you can reach the LSC Legal Helpline on [REDACTED]
