- \* • When the alleged conduct occurred (specific dates, timeframes)
- \* • How you became aware of the matter

We request that you keep information brief and concise. Voluminous information or large attachments may cause a significant delay to our assessment process and not be reviewed.

\* We will be unable to review information you provide via USB, please do not send information in this format. \*

Initially, we need to assess whether the information falls within the jurisdiction of the Integrity Commissioner. If you could please answer the above questions in a brief email that would be sufficient at this time.

As stated, excessive information and attachments will not be reviewed by us. If we require further information after we have determined whether the allegations fall within ACLEI's jurisdiction, we will request it. At this stage, to provide large volumes of information will not be helpful to our assessment of your allegations.
