Dear Mr Turnbull,

Between the years of 2007 - 2012 I, Jacqueline Pearce of Port Pirie conducted numerous and various forms of research to develop two business concepts as a registered client of the Regional Development Board, Port Pirie which consisted of the business developments :

- **The Medical Specialist Centre, Port Pirie - Business plan 1**
- **M.S.I.C - A development of The Medical Specialist Centre, Port Pirie which consisted of the innovative technology link of information and constructed for the use of Medical professionals as a vital tool to be incorporated into the structures of the Medical Specialist Centre, Port Pirie in regards to advance communication in reference to the referral system for the appointments of specialists services.**

These business concepts were developed under the guidance of Michael Fetherstonhaugh and Terry Reichelt, Business advisors of the Regional Development Board, Port Pirie and registered in the year of 2010.

As outlined in the business plan, The Medical Specialist Centre, Port Pirie - Sources of Funds - The funding sought to establish the centre in the township of Port Pirie was to be derived from the sale of the matrimonial home, 109 French Street, Port Pirie. Due to the circumstances surrounding the court proceedings involving occurred debts within the marriage and the sale of the property, [REDACTED] which consisted of :

- Youmard Lawyers, Port Pirie - Kelly Morgan - Brooke Kennedy
- Unrepresented - Darren McDiarmid, Epping, Victoria
- Credit card payments - Debts occurred within the marriage

Which resulted in a numerous amount of debt in the form of Council rates / property [REDACTED], Utility accounts, Store accounts, McDiarmid Woodcraft, Home based business partnership and numerous other debts incurred within the marriage being left in my responsibility and unsolved by my representing lawyer, Kelly Morgan and conducted over a two year period which had incurred excessive lawyers fees although I had obtained legal aid for representation. Funding was no longer available or could be derived from this source of funding.

The involvement of the sale of the house consisted of Lavis Real Estate, Port Pirie, Phil Lavis and Wardle Co. Real Estate, Port Pirie.

In the following circumstances involving Lavis Real Estate, Port Pirie, Phil Lavis, Sally Lee and Natalie McMahon and the tenancy of 9 Yates Street, Port Pirie I incurred various maintenance issues and accounts of Tribunal matters that resulted in a debt incurred of my bond claimed by Lavis Real Estate, Port Pirie which is not registered on the Tribunal files but court proceedings conducted in the township of Port Pirie and resulted in a registered debt on my SA Housing Trust account - Bond claimed by Lavis Real Estate, Port Pirie - Phil Lavis.

The involvement of Wardle Co. Real Estate, Port Pirie - Sale of the house - 109 French street, Port Pirie - Resulted in the incident of my son, [REDACTED] and various maintenance issues which resulted in my son's bond being claimed after and in my presence the property's maintenance issues were rectified and maintained but resulted in a debt being created in the bond claimed against my son, [REDACTED]

Thereafter and contained within the reports - Police Involvement - Immediate family members - [REDACTED] was denied housing in the form of 156 denied rental applications - Metropolitan areas and the township of Port Pirie between the years of 2014 - 2016 and in alliance with the fraudulent activity of which had been occurring over the years of 2007 - 2016.

This creation of falsified debts and deformation of character against myself and immediate family members continued over a 9 year period which resulted in the following :

- **Financial Hardship** - Debts occurred and created - Rental property's - Utility accounts - Tax Audits - Telecommunication Systems - Internet Services - Closure of a home based business and business accounts, J Monequic, Fashion Design - Debt Collection Agencies - Loss of employment and blocked employment opportunities - Monies withdrawn illegally from Banking Institutions - sharing of personal information containing the information of Utility accounts / organisations, Telecommunication Systems, Banking Institutions, Housing and Real Estate details and personal information containing family matters / children's details / personal accounts of information.
- **Telecommunication Systems** - Fraudulent Activity - excessive charges for services creating financial hardship - Fraudulent activity involving payment plans - Information collected and given - Internet Services disruptions and excessive charges after the closure of an online business - Blocked and altered messages and phone calls - Unregistered representatives of the company - stolen phone handsets from the home - all activity contained within this report has been reported to my Telecommunications Service provider, Optus and the Telecommunications Ombudsmen - Refer to attached
- **Isolation** - Loss of friendships - loss of relationships - loss of contact with family members - telecommunication systems blocked and altered messages, diverted phone calls resulting in the disconnection and loss of contact with family members, friends and relationships resulting in isolation and entrapment within the family home and the township of Port Pirie. Vicious harassment report - Optus - Telecommunication Ombudsman
- **Various forms of household and car repairs over a 5 year period** - Refrigerator - Washing Machine - Mobile phones - Computers - Car repairs - Unusual influx of sudden repairs needed - Televisions - Set top boxes - Household appliances
- **Immobilisation** - Police assaults / Permanent injuries sustained - Loss of licence over an 11 month period - Police targeting / Metropolitan areas / Port Pire district / Online Dating Sites - Falsified charges - Falsifies witnesses and statements - Port Pirie Police Department / Kadina Police Department, reporting **Paul Gardner, Port Germain / immediate family member of Michael Fetherstonhaugh for the threats of Prostitution** against myself and my children and the suspicion of child abduction, [REDACTED] - The police did not intervene which resulted in a continuum of threats and vicious harassment reported as a change of number, Optus - Vicious harassment. Sexual Targeting involving members of the Port Pirie Police Department / Portside Tavern report - Personal contact / Intent of a sexual nature without my knowledge or consent / suspected Illegal Sex Trade conducted within the township of Port Pirie - Police Involvement / Sexual intent / internal searches - bodily contact - online dating sites - comments and statements made by various members of the Port Pirie Police Department - Refer to Police Involvement - Port Pirie Police Department charges 1,2,3,4

- **Stalking** - Port Pirie Township - Shopping areas - Place of residence - Hotels / Pubs - Telecommunication Systems - Entertainment venues

In the year of 2011 while residing in a defacto relationship with David Johnson [REDACTED] Port Pirie I overheard an illegal broadcast conducted by Magic FM, Port Pirie containing the Private and Confidential business files and information in regards to The Medical Specialist Centre, Port Pirie confined, contained and stored strictly upon my business registered laptop computer, Home based office.

Upon me hearing this broadcast released to the public I contacted Magic FM, Port Pirie via my registered business facebook account, J Monequic, Fashion Design informing Magic FM, Port Pirie of my knowledge of the details contained within this illegal broadcast of my confidential business files and concepts of the business plan, The Medical Specialist Centre, Port Pirie 2007 - 2009.

In the year of 2013 I obtained an Official Letter of Involvement of Mr Roger Kirchner, Executive Health Minister, Regional Health, Port Pirie, Executive Assistant, Jemma Salvemini, **Immediate family member, Heidi Salvemini, Westside Lawyers - Port Pirie Police Department** - as being involved in obtaining funding to establish The Medical Specialist Centre, Port Pirie.

This funding was denied by Mr Roger Kirchner, Port Pirie and I was advised to contact my local member of parliament, Mr Geoff Brock, Port Pirie to seek the funding of which I was seeking.

Upon the appointment held with Mr Geoff Brock, Port Pirie I was also denied the funding in order to establish the medical centre in the township of Port Pirie and once again contacted the SA Medical Association, Hon Jon Hill to obtain the funding necessary to establish the medical centre in the township of Port Pirie.

Within the reply received I was once again denied funding on the grounds that funding was being allocated to the new development of the GP Plus Health Centre's and to be established within the township of Port Pirie.

Within the letter received and dated 2009 - Seeking funding - I was denied the funding and was informed by Hon Jon Hill to contact Mr Roger Kirchner, Port Pirie to seek the funding of which I was seeking but was not informed of the new developments of the GP Plus Health Centre's which was incorporated into the denial of funding in the year of 2012.

In accordance with the 10 year Health Planning Strategy it is contained within this report that funding would not be allocated to the developments of establishing and construction of new Medical Establishments but rather that the funding would be allocated to improve existing medical establishments and structures already in place and established.

Over the following 9 year period I incurred numerous unexplained occurrences of suspected Fraudulent activity within my business dealings, Utility accounts, telecommunication Systems, relationship breakdowns, personal contacts, strange occurrences within my home and unexplained occurrences within my children's behaviour, education, employment and the relationship of which we shared suffered enormously from tension, heartbreak and suffering and the breakdown of the family's relationship.

These occurrences and incidents of isolation and vicious harassment and personal contact have occurred over a 5 year period and started in the year of 2011 after I reported the knowledge of the illegal broadcast, Magic FM, Port Pirie and are continuing to this current day of 2016.

The two Confidential business concepts developed as a registered client of the Regional Development Board, Port Pirie and under the guidance of Business advisors Michael Fetherstonhaugh and Terry Reichelt have held the admittance of their theft by Michael Fetherstonhaugh, Port Pirie who as an employee of Service SA, Port Pirie, of which I had held a confidential business meeting in the year of 2013, questioning the development of the business concepts 2007 - 2009 - and the suspected Intellectual Property Theft that had occurred between the years of 2007 - 2009.

During this meeting I was informed by Michael Fetherstonhaugh of his disappointment for myself on the theft of the business concepts developed as his registered business client of the Regional Development Board and he had made the distinctive comments and statements -

"I still talk about your stolen business concepts to my friends and family and how unfair that it was " - And also in reference to the stolen business concepts - " I would stand up in a court of law and state this to that effect in your defence ".

I am well aware of the Illegal Technology used to infiltrate the privacy of family homes, Telecommunication Systems of selected individuals and I do believe that the use of this Illegal Technology has been used within the township of Port Pirie to construct and conspire a conspiracy against myself and immediate family members in their attempt to cover up the truth of the Intellectual Property Theft, 2007 - 2012, of which was fraudulently and criminally submitted and illegally funded as their own developments and concepts that was used to construct and establish the GP Plus Health Centre's and MISC, Port Augusta, which consisted and contained the exact replica concepts and developments as outlined and contained within the business plan, The Medical Specialist Centre, Port Pirie and the development of this business plan M.S.I.C.

I am under the belief that the business concepts and research were stolen before completion and the funding that i was denied had already been pre meditated in it's denial by the members of the letters of involvement.

I am requesting a thorough investigation be conducted into the Regional Development Board of Port Pirie under the act of the suspected Intellectual Property Theft of the business plan , The medical Specialist Centre, Port Pirie and the development M.S.I.C, registered in the year 2010 for tax purposes and the business advisors involved in the business concept research and development, Michael Fetherstonhaugh, Port Pirie and Terry Reichelt, Port Pirie, and as a registered business client of the Regional Development Board, Port Pirie and within the knowledge and possession of the business concepts review - Review - Handwritten references The criminal and fraudulent activity that occurred over a 9 year period thereafter and contained evidence attached and written within this report.

I am requesting a thorough investigation into the Fraudulent and criminal activity that occurred thereafter, believed to be that of a pre meditated conspiracy against myself and immediate family members upon the illegal submitting and illegally funded business concepts developed between the years of 2007 - 2012 , which resulted in the establishment of the GP Plus Health centre's and MISC, Port Augusta.

I am requesting a thorough investigation into the illegal use of illegal technology used in order to form the fraudulent and criminal activity contained within this report and believed to be used to conduct an illegal sex trade within the community of Port Pirie in connection with the Intellectual Property Theft of which was threatened against myself and immediate family members.

I am requesting a thorough investigation into the activities surrounding the Port Pirie Police Department, Port Pirie Fines and Recovery Unit, Port Pirie, witness statements , Westside lawyers, Port Pirie, illegal representation, illegal access to medical records, illegal ordering of a Mental Health evaluation, Denied Healthcare, Denied public safety and the intent of Deformation of Character in an attempt to cover up the truth of the Intellectual Property theft.

I am seeking to place charges against the Regional Development Board, Port Pirie for breach of client confidentiality, Intellectual Property Theft, the individual business advisors involved, funding involvement and the involvement of various organisations, individual members of these organisations and numerous members of the public within the township of Port Pirie including the illegal broadcast, Magic FM, Port Pirie for the release of confidential business files into the public and the fraudulent and criminal activity that occurred thereafter and in connection with the Intellectual Property Theft.

I am contacting you to request your assistance in these matters as a matter of **URGENCY** before I contact a variety of media sources and take this information to the public in my stand to stop this fraudulent and criminal activity from impacting any further in a negative manner upon myself and immediate family members in a continuum of vicious harassment and onslaught of derogation towards our lives.
