Gordon Legal Reporting - Website reporting - Reported on law firm website

1/6/2020 - Received a phone call from Nick claiming employee of Gordon Legal law firm Informed that i would receive a call back to discuss the reported issues and of being a potential client for representation

1/6/2020 - Received call back from Emma Walters (name displayed on my phone as the phone number) claiming to be an employee of Gordon Legal law firm - Ashley - Informed me that Gordon Legal could not assist me in the legal matter and that i should contact the Victorian Law Institute for advice and assistance [REDACTED] - provided an email address for me to send you evidence, i had said in the privacy of my own home that i was going to get an email address to send you evidence

([REDACTED]) - informed you of this contact and name on your website 1/6/2020

I researched your website for the name of Emma Walters resulting in a no result found on your website - i researched the internet for the name Emma Walters - resulted in electoral officer of Victoria

2/6/2020 - Received an email from Angelica Nippard at 7.15am claiming to be a lawyer of your law firm - claimed that your law firm could not assist me and that i should contact the Victorian law Institute on the same number as instructed previously - I researched your website for this name which resulted in no results found - i reported this contact on your website

2/6/2020 - Left voice message to your law firm - Received a phone call from Kirsty Greggall claiming to be a criminal lawyer of your law firm (phone number [REDACTED]) - Informed me that your law firm does not represent victims but rather individuals who have been charged and therefore could not assist me - I questioned the class 4 litigation against the government that you are currently involved in - claimed you do not represent sole individuals/ victims - when i questioned that your firm does represent victims which is the sole purpose of your law firm as stated on the website she replied i don't even know what is on the website and she will have to check that out - She claimed that Emma Walters was an old employee / her assistant and Ashley who had contacted me previously was her new assistant and she did not know why Emma Walters name was still displayed in the phone number - she advised me once again to contact the Victorian Law Institute for assistance and provided the same number - i could hear her taking notes on a computer while i was speaking to her - she asked the events that had taken place / i gave her a brief description and also asked what the losses were that i had suffered / i gave her a brief description - she mentioned the Mental Health Act - I researched your website for this name which resulted in a no results found - i reported this contact on your website

Separation of relationship through pattern of targeting that was in my life before meeting my partner now targeting him - altered and blocked messages and emails, fraudulent debts, loss privileges and income at the university, denied grants and deformation of his career, police presence and fines, sexual targeting/ increased popularity - separating us from contact when went to Sweden, Telstra report of blocked contact / escalated issue

Keeping us apart - isolation - continuous targeting

Intention - I registered JC INNOVATIONS in 2019, company involving numerous business concepts, product designs, Medical and Scientific research projects and government funding and involvement projects and the development of my books with Austin Macauley Publishers, London

Partner offered credibility, support and financial support

I am a qualified Business Manager, Business Administration and first time author

Viber messages on my phone to my ex partner of the University do not match synchronised messages to my tablet and contained on my tablet - ex partner reported to my

mother that i had sent him nasty messages to him when he was in Sweden for work/KTH Sweden University - Telstra report of loss of contact / disconnected service/ escalated event / contacted through the Kadina Telstra store

There is no longer contact between myself and my partner - we went to Thailand together in January for my birthday before he left for Sweden and we stayed in contact for a couple of weeks while he was in Sweden then all of a sudden loss contact

Steven Marshall MP - Vicki Chapman - SA Health - SA Government - Reported illegal activity

Denied investigation - directed to Stephen Wade - informed to seek legal advice from law firm supplied Slater and Gordon/ employee/ lawyer Nuygen (female lawyer) and in

Contained within the reply letter - not able to refer correspondence for action to Office of Public Integrity / Commissioner against corruption / prohibits disclosure of information that is connected to a matter that forms or is subject of a complaint under the act, except in very limited circumstances.

Broadcast of Medical Business files stored in Confidential files on my computer - Magic FM, SA - Kerrin / secretary / connection to Red Devils motorcycle gang, Port Pirie / Michael Fetherstonhaugh / SA Government / SA Health

Excessive, escalated utility bills - barcode scanned as Townsville Fines Department, Queensland - Police targeting - creating financial hardship - documented evidence

Excessive , escalated phone accounts / blocked and altered messages - phone number supplied and employees of payment plans not registered with company issuing the accounts / billing of excessive rise - i was registered with this company as the server of my phone service - documented evidence - blocked and altered messages / phone contact resulting in separation from friends and loved ones - creating emotional vulnerability and need for contact - isolation for 2 years

Increased popularity on dating sites, personal contact , Facebook (business account), being followed and approached by unknown individuals within the township of Port Pirie, constant police presence / escalating to police targeting resulting in illegal arrests and physical assault - intimidation / Deformation of Character / reputation

Police targeting of children - Refused to drop the charges against my eldest son resulting in separation from the family / court ordered to move to Melbourne to live with his father

Separating family members / destruction of family structure creating vulnerability and isolation of the mother

Sexual targeting / Police - Alleging American Police - while having contact with Paul Gardner

Zac - Police Administration - Dating site contact - phone contact only

Threatening behaviour - comments sent to phone - documented evidence of phone records contact / phone number - reason for severing contact

" If i catch you leaving Port Pirie i will stop you on the FREEWAY (American term, not HIGHWAY, Australian term) pull you out of the car and shoot you"

" You make the most money laying on your back"

Constant denials of illegal activity occurring and investigations upon reporting to government organisations / departments - documented evidence / letters, reports and replies in my possession.

Portside Tavern, Port Pirie - Police officers at the doorway - Sexual Targeting - Port Pirie Police Department

Younger male officer standing with female officer involved in .05 charge with Jake - younger male officer returned casually dressed approached me on the dance floor with resident of Port Pirie (manager of petrol station near Meadow Crescent, known associate with police department and Swingers Club of Port Pirie - last name Foster) she introduced the officer to me - said he would like to meet me

I asked the officer how old he was - answer 25 years old - i walked away - I asked this question suspiciously trying to get personal details

Portside Tavern denied me access to security footage the next day concerning this Matter - stated they don't keep footage and erase it

This officer looked familiar to me of the officer that sat in the back seat of a police vehicle with me on one occasion during an arrest and attended the 000 call reporting the threats of prostitution towards myself and my children by Paul Gardner.

All activity increased dramatically after i reported to Magic FM, SA of the broadcast of the medical business stored in Confidential files on my computer - Facebook report / my business account J Monequic to Magic FM business account - contact/ message - no reply

First incident of sexual targeting after this contact with Magic FM - Sexual targeting Man from Queensland sent me a private message containing a photograph of his exposed genitals and tried to encourage me to go to Queensland to meet him - suspicion / connection / Paul Gardner / Michael Fetherstonhaugh / SA Government / Townsville Fines Department - police targeting

Activity escalated after obtaining letters of involvement / Medical Business Plan / Roger Kirchner / Michael Fetherstonhaugh - Fraudulent activity of utility bills and phone accounts resulting in financial hardship and closure of business J Monequic

Blocked and altered phone messages resulting in separation from friends and loved ones - resulting in isolation - creating emotional vulnerability for need of contact - isolated for 2 years - sexual targeting, dating sites, personal contact, Facebook

Denied involvement by lawyer - Intellectual Property Lawyer - Johnson Lawyers

James Johnson, Adelaide denied the involvement of Roger Kirchner after supplying Roger Kirchner's letter of involvement possession of Medical Business Plan for funding

ICAC - SA Government - SA Health - Reported and supplied evidence
Reported and supplied evidence of the illegal activity and Intellectual Property Theft after my release from Glenside / 2016 - Documented evidence in my possession of this report - denied investigation / documented evidence reply letter
ICAC claims to be independent investigation of corruption yet relies upon government funding for investigation / not independent
I believe this is a government department operating to collect information on whistle blowers. This information is then given to the government who then has the knowledge of who is aware of corruption (of which they are involved in) and then know who to target, harass and condemn / deformation of character to destroy any testimony of the activity and illegally convict the victim - police targeting

Question: Are the individuals involved in being charged with corruption by the government (involved in the corruption) actually involved in corruption or whistleblowers - destroy the evidence / witness/ deformation of character / loss of employment

Question: Have the clients involved in the Robodebt claims or the individuals that took their own lives over the debts reported to authorities / government departments utility or phone companies / ICAC of any similar activity in their lives contained in this information that i have supplied and met with constant denied investigations leading to their deaths or the claims / class 4 action - suspicion connection to government targeting causing death and financial hardship - unusual to take life over one debt created?

Reported on your website of my computer being cleaned of viruses by my computer technician which resulted in a report of 134,000 malware detections which he has never seen before

I removed all files from this computer before being cleaned which contained the files of my new business developments JC INNOVATIONS and transferred them to my other computer which has never been connected to the internet in 6 years so my IP address on the internet has never been discovered and remained protected, never had a internet modem registered on it and has the internet connection disabled to protect my books which are on this computer. The next day some individual had connected to this computer via remote access / Bluetooth settings and switched on the internet connection I disabled the Bluetooth connection and remote settings

Question: How did the individuals involved know that this computer existed ?- only 4 people know i have this computer, myself, my parents and my ex partner of the Adelaide University

How did they know that i had transferred the files to that computer to remotely access it and turn on the internet connection the next day?

I reported to Telstra on their website of suspected identity theft - blocked and altered messages and connections and Paul Gardner's involvement - I have not received a reply
