Dear Ms Ann Vanstone,

I am contacting you with further information connected to my previous submission in January 2022, regarding the constructed legal Case Files of Illegal targeted activity of an Individual, submitted to Internal investigations, Reference # 2022/003090-S01 - Reference # 2022/003090, as instructed in writing by Emma Townsend, Director of OPI.

Further to the submission of the previous case file Chentelle Defoe I have continued to investigate and construct further legal case files constructed in Pattern of Targeting, case file JC Designs, which is still currently under construction but I am submitting the file as a cause of immediate attention concerning the previous advice of contacting Federal Law Enforcement to place the case under investigation. Further investigations into the targeted illegal activity have revealed that the case of the Illegal targeting of an individual is a case of Corruption and Government targeting at the highest level, Federal Government involvement, Highest level of Abuse of Power and Targeted Organised Crime against an individual, which commenced in Kadina in 1988, the targeted victim 15 years of age.

Further to the advice I provided to you regarding involving Federal Law Enforcement to conduct an investigation into the targeted illegal activity, I am advising you that I have contacted all sources of Federal Law Enforcement of which I have not received a response, I have not received any form of assistance, even with the Public announcement of Nigel Ryan, stating that he is currently involved in investigations into Organised Crime in Australia following the contact and submissions of the Legal case file construction submitted to him by myself in 2021, first contact. The refused contact, investigations into the reported activity, denied assistance and denied illegal targeted activity has been ongoing since the year of 2013, first reported occurrence of contesting Intellectual Property Theft of the Medical Business Plan and continued reporting of the targeted illegal activity between the years of 2013-2017, resulting in Extreme Targeting of the targeted victims awareness (whistle blower) and continued reporting in 2019-2022, which continues to be denied.

I am now advising you of the controlled measures of the Federal Governments Abuse of power to deny an investigation into the illegal targeted activity of an individual by the Federal Law Enforcement due to their involvement and Entrapment of the targeted victim in the targeting. I am now advising you to contact the Royal Commission for a Commonwealth Investigation into the illegal targeting of an individual and supply all constructed legal case files for an internal Royal Commission investigation into the reported illegal activity as the abuse of power and the targeting of an individual is at the highest level of abuse of power, Federal Government. I am advising you to also involve the services of Interpol to investigate, come in from all angles from all contacted sources of the Royal Commission and Interpol working together from all sides, a joint task force, and include you as over seeing of the investigations, as the source of providing the evidence of this crime being committed against an individual, which involves the highest level of Corruption and Organised Targeted Crime.

The Prime source of the commencement of the targeting of the individual at age 15, residing in the township of Kadina, which is an isolated and relatively unknown location to metropolitan members of the public and Federal Government has been revealed as John Olsen, MP, Kadina, who is connected to American Government sources and also Steven Marshall, SA Premier, and Confirms the documented evidence of the first recorded incident of the Intellectual Property Theft in 1993 from the Privacy of the targeted victims own home located on a farm house in Willamulka, SA, involving the American Government and American Academy, whose in possession of the Intellectual property of the targeted victim and has been located and documented, and contained within the submitted file of JC Designs.

All documented evidence provided in the constructed legal case files are Original documents and are of original form and have been collected between the years of 2012-2016, and during further investigations by the targeted victim collected between 2019-2022, and have not been altered. I previously provided documented evidence of altered financial records and public records, including legal records that were altered during the process of my reports between 2012-2021, as reported I am being targeted under the act of illegal surveillance of the privacy of my own home, that is still current and present in 2022, and the Individuals involved and connected are watching the construction of the Legal case files supplied to you and various sources in seeking assistance.

I advise you to advise the Royal Commission of this activity and investigations be conducted into the computer hard drives involving log in details, time, dates, name of individual logging into my details or accounts and an investigation into alterations of records that do not match the original documentation submitted and contained within the Legal Case files construction, due to the continuous efforts of the Cover up of the targeted illegal activity and the individuals involved and connected and knowledge of my intentions of prosecuting and seeking assistance.

The targeted Organised Illegal activity of an individual involves Federal Government of Australia, State Government officials of Australia, Regional Government officials of Australia, American Government, Bill Gates of America and numerous connected and involved individuals, which also include Motorcycle gang members and employees of University's.

The constructed legal case file JC Designs contains documented evidence of the above mentioned involvement and also documented evidence of the Government targeting a Government official Fraser Ellis, MP Kadina in a Government Frame up to allege his involvement in Corruption and the targeting and Cover up the truth of their involvement, pointing the finger, as contained and documented in the file submitted Chentelle Defoe, which is True and correct.

I am submitting the unfinished construction of this file JC Designs for your review and to inform you of the further evidence I have obtained and to advise you that the case is a case for a Royal Commission investigation and not Federal Law Enforcement who are being controlled by the abuse of power of the Federal Government, Scott Morrison to Cover up the illegal targeted activity of Government targeting and keep the targeted victim Entrapped in the targeting.

I have received a letter from SAPOL Internal Investigations, Joanne Sharman APM, Detective Chief Inspector, who denied the illegal targeted activity of Police Targeting involving Fraudulent charges and fines, illegal arrests, police brutality resulting in permanent injuries to the targeted victim and police sources remotely accessing servers and digital devices and utility accounts, resulting in continuous money laundering and police harassment of the targeted victim, which is documented evidence of the Government cover up of the targeted illegal activity and the abuse of power of individuals investigating the activity or are individuals involved and connected, and directly involved in the Cover up, and as a immediate attention needs to also be addressed by the Royal Commission investigation.

I have provided an Executive Summary, a brief description of the Constructed Legal case files which clearly and obviously describes the weave of the Conspired Frame up of Fraser Ellis, MP, Kadina to make it appear as if he was involved in the targeting of an individual and why the Government had targeted his family in a Frame up because of his involvement in Local politics, legal Services and media sources, which are all involved in the targeted activity of an individual, and why he remains the Only senator to offer the targeted victim assistance, and why he was

Exiled from the Liberal Party place of representation in Kadina following him offering his assistance to the targeted victim and was not supported by the Liberal party during the ICAC allegations and court proceedings.

I have every intention of submitting the completed construction of the legal Case files to you once completed, and also to be supplied to the Royal Commission for an investigation into the Abuse of Power by the Federal Government, American Government and the illegal targeted activity of Corruption and Organised targeted Crime of an individual, and all individuals involved and connected in this reported crime, that is still current and present and has placed my life in extreme endangerment and oppressive isolation from life and society for self protection, including personal and professional.

I am informing you that I am sending a copy of the incomplete file supplied File 3 JC Designs, and a copy of all completed files Stage 1, 2, 3, 4 and Character Reference to the Royal Commission and Interpol, as requested in this letter, for their review and request of an investigation into the illegal act of Government and Police Targeting of an Individual, 1988-2022.

I am requesting immediate attention and action regarding the submitted reports and documented evidence and advise you to seek the assistance of the Royal Commissioner and Interpol services to investigate this matter further, and to work in conjunction with OPI to resolve this urgent matter of targeted organised crime and corruption involving Government sources.

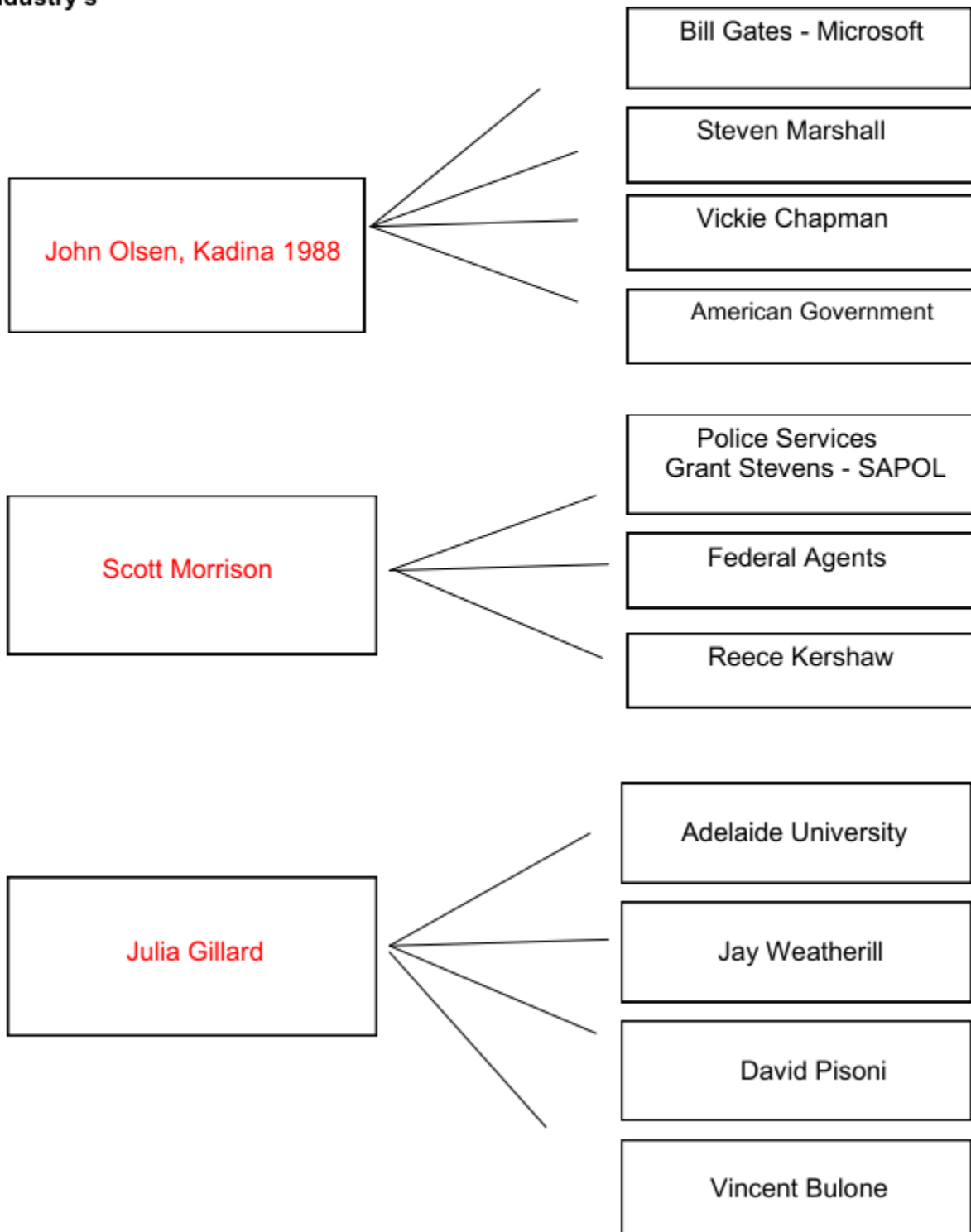
