MOTIVE FOR COMMENCEMENT OF TARGETING - REVENGE AGAINST THE MOTHER, CYNTHIA PEARCE AND THE FATHER DAVID PEARCE BY TARGETING THEIR DAUGHTER WITH THE EXACT ACT OF THE BETRAYAL AND CONSEQUENCE OF THE LIFE THE BETRAYED PARTY MAG WINTERS / CHAPMAN, KADINA LIVED FROM THAT POINT OF THE RELATIONSHIP BETRAYAL WITH THE TARGETED VICTIMS FATHER, DAVID PEARCE

SOURCE OF TARGETING OF AN INDIVIDUAL ; TARGETED VICTIM

MAG WINTERS / CHAPMAN - KADINA
FAMILY MEMBER, GOVERNMENT SOURCE ; VICKIE CHAPMAN

MOTIVE ; INTENTION ; GOAL OF THE CONSPIRED TARGETING AGAINST CYNTHIA AND DAVID PEARCE'S DAUGHTER ;

Continually abuse and groom the targeted victim, daughter of Cynthia and David Pearce, Jacqueline Pearce to result in forcing her in to Prostitution (a disreputable position) for the Sexual Abuse Ring involving Epstein and Maxwell and prominent people to result in the Humiliation and Disrespect of the reputation of the Pearce family in the community of Kadina

CYNTHIA PEARCE ; TARGETED VICTIMS MOTHER

History : Relationship

14 years old : Kadina - Cynthia Pearce - Mother of targeted victim

Cynthia Pearce, Mother of targeted victim pursued a relationship at 14 years of age with targeted victims father, David Pearce, Moonta who was 19 years of age and was friends with the father of Michael Ellis and Grandfather of Fraser Ellis, MP, Kadina and was at the time in a Relationship with Mag Winters / Chapman, Kadina.

Cynthia Pearce without remorse chased David Pearce until he betrayed his relationship with Mag Winters / Chapman and left her for Cynthia Pearce which resulted in their marriage and four children, residing permanently in Kadina.

David Pearce had described Mag Winters / Chapman as "A very nice girl"

Cynthia Pearce who was responsible for the betrayal of David Pearce's relationship with Mag Winters / Chapman was then targeted by Mag Winters / Chapman on the netball court during a netball game with physical assault

Mag Winters / Chapman's reaction to the betrayal of the relationship with David Pearce / Violent and revengeful towards Cynthia Pearce

Following the attack of violence / physical assault on the netball court of Mag Winters / Chapman against the targeted victims mother, Cynthia Pearce, the friends of Cynthia Pearce pursued Mag Winters / Chapman with a physical attack in return and in defence of their close friend Cynthia Pearce - Escalating into a Township rival of feuding

MAG WINTERS / CHAPMAN - VICKIE CHAPMAN - SOURCE OF THE TARGETING

History : Relationship

Mag Winters / Chapman following the betrayed relationship with the targeted victims father, David Pearce formed a relationship with another man resulting in marriage and became her married name Chapman

Mag Winters / Chapman's marriage with the new relationship she had formed following the betrayed relationship with the targeted victims father, David Pearce resulted in an abusive marriage of physical abuse, womanising, relationship betrayal of having sex with other women while Married and emotional neglect. Children were born to this marriage.

Mag Winters / Chapman died during this marriage of [REDACTED]

The betrayal of Cynthia and David Pearce at the age of 14 years old and 19 years old of David Pearce's relationship with Mag Winters / Chapman resulted in the abuse of Mag Winters / Chapman who formed a relationship with an abusive man following the betrayal of the relationship with David Pearce by Cynthia Pearce, the targeted victims father and mother.

Motive for the act of Criminal Targeting of the mother and fathers daughter, the individual, Jacqueline Pearce - Revengeful Hate Crime of Jealously and revenge and the betrayal of Mag Winters / Chapman's relationship at age 14 years old with the targeted victims father, David Pearce and the township rival of feuding - Payback against Cynthia and David Pearce

Jacqueline Pearce, the targeted victim, daughter of Cynthia and David Pearce suffered emotional neglect, Jealousy of the mother and betrayal of the mother in the family structure concerning the sexual abuse, [REDACTED] resulting in abandonment of the family towards the sister and daughter following the mother bad mouthing the daughter to the family and turning all family members against the daughter, which included the brothers, the father, the daughters grandmother, Cynthia Pearce's mother and the daughters aunties, Cynthia Pearce's sisters and protected the [REDACTED] the perpetrator following the sexual assault and her daughter telling the mother, Cynthia Pearce and seeking her assistance to make it stop Moral fibre and foundation of the mother, Cynthia Pearce who was responsible for the betrayal of Mag Winters / Chapman's relationship with David Pearce, the father of the targeted victim Cynthia Pearce : No moral foundation towards individuals , Relationships and acted without care, consideration, remorse or guilt - selfish and uncaring towards individuals or relationships, which also included her daughter Viewed all women as competition, including her own daughter and was jealous of other women, including her own daughter

REVENGEFUL HATE CRIME - PAYBACK - BETRAYED RELATIONSHIP OF MAG WINTERS / CHAPMAN - GOVERNMENT SOURCE / FAMILY MEMBER VICKIE CHAPMAN

PATTERN OF CONSPIRED TARGETING AND ATTACK OF THE TARGETED VICTIM, THE DAUGHTER OF CYNTHIA AND DAVID PEARCE ;
RELENTLESS CONTINUAL CONSPIRED ATTACK OF THE DAUGHTER COMMENCING AT AGE 14YEARS OLD UNTIL AGE 51 YEARS OLD INVOLVED ;

- First event of targeting - 14 years of age - Connected to a Sexual Abuse Ring involving Epstein and Maxwell - Modelling proposal in Kadina - Government source - John Olsen, Kadina connected and involved - Association Mag Winters / Chapman - Township rival and Feuding - Epstein and Maxwell / including Donald Trump involvement lending young girls from modelling agencies out to men in prominent positions fro sex demand and sexual acts
- First event of Sexual Targeting - 16 years of age - Police officer, Kadina (name unknown) involved in Sexual targeting of the targeted victim, a minor who was still a virgin and was not yet sexually involved with partners - [REDACTED] introduced to the targeted victim by Kelvin Ahrens sister, [REDACTED] who was dating the targeted victims older brother at the time, the older brother who was involved in the sexual molestation of his only sister at age 11 years old - [REDACTED] following the break down of the relationship with the targeted victims brother married [REDACTED]

- Second event of Sexual targeting - 19 years of age - Christopher McGinley, Moonta resulting in Extreme Severe Violence which included, Entrapment, Violence with a knife, strangulation, suffocation, physical brutality, violent rape, threats against family members of Murder, kidnapping, family members of Christopher McGinley involved in cohering the targeted victim into cars resulting in kidnapping and entrapment when the targeted victim Escaped resulting in the targeted victim being pulled out of the family home of Christopher McGinley out of a front window by a police officer while the targeted victim was entrapped in the house by Christopher McGinley at knife point resulting in the targeted victim developing the [REDACTED] - Police Officer, Moonta a witness to the entrapment at knife point - Christopher McGinley was never charged for this violent crime

PATTERN OF BEHAVIOUR INVOLVING BOTH FIRST RELATIONSHIPS - KELVIN AHRNS AND CHRISTOPHER MCGINLEY

KELVIN AHRNS , MOONTA ; 2 years

- Deceitful
- Disrespectful
- Physically abusive
- Psychologically abusive - and included all members of the Ahrns family being psychologically abusive towards the targeted victim - ganging up on her with verbal abuse
- Emotionally abusive
- Womanising
- Betrayal - Betraying the relationship with another woman
- Jealousy and possessiveness
- Betrayal of the relationship with another woman ending the relationship

CHRISTOPHER MCGINLEY, MOONTA ; 12 months

- Deceitful
- Disrespectful
- Extremely violent - Severe physical assault and continual attack over a 12 month period of entrapment of the targeted victim in the home of Christopher McGinley
- Extreme psychological and emotional abuse
- [REDACTED]
- Womanising
- Betrayal of the relationship with another woman - Made the targeted victim watch him have sex with another woman - watch the betrayal
- Extreme violence involving attacking and threatening the targeted victim with a divers knife
- Threatening the targeted victims life and the targeted victims family members lives
- [REDACTED] while his friends watched and clapped - humiliation of the targeted victim
- Kidnapping from the family home when escaped from the home of Christopher McGinley - Involving his sister Victoria McGinley, Moonta / Nurse of Moonta Hospital
- Segregation of the targeted victim from family and friends - isolation
- Blocked contact from family and friends - isolated from using telephone services while entrapped in the home of Christopher McGinley
- Locked in rooms of the house of Christopher McGinley or rental properties in Kadina - targeted victim forced to sit in the corner of the room while being spat on, attacked by his dog, denied food and water and shower facilities for days
- Harassed and abused while showering– Verbally abused while showering - clothing thrown over the top of the shower cubicle and forced to wear the wet clothing for the day resulting in irritated skin and rashes
- Knives held to the targeted victims throat while sleeping - upon waking nicks of the blade of the knife cutting the skin underneath the chin of the targeted victim
- Suffocation by pillows while sleeping
- Unpredictability of the perpetrator - Violent and constant mood swings

- Entrapment in the relationship and family home of Christopher McGinley for a 12 month period resulting in the victims constant escapes - resulting in being kidnapped from her families home and returned to the entrapment of the home of Christopher McGinley–
Stalking

Final entrapment following being kidnapped and escaping again resulted in Christopher McGinley contacting the targeted victims mother, Cynthia Pearce while her daughter remained hiding in her brothers home, Steven Pearce after escaping, and Cynthia Pearce, the targeted victims mother finding her following being contacted by Christopher McGinley and convincing her daughter to go back to the home of Christopher McGinley to collect her belongings she had left there when fled (escaped). The targeted victim pleaded with her mother not to take her back there and told her she did not care or want her belongings.

The targeted victim was cohered by her mother to collect her belongings from the home of Christopher McGinley, Moonta and was driven back to Moonta to the home of Christopher McGinley by her parents, David and Cynthia Pearce resulting in Christopher McGinley pulling the targeted victim back into the home at knife point while locking her in the home alone with him and threatened her with the knife held to her throat stating "Today you die"

The targeted victim broke free from the grip of Christopher McGinley resulting in her being chased by him with the knife before catching her again and placing the knife into her back leading her to his bedroom.

A police officer banged on the front door of the home and called out to Christopher McGinley and cohered him into bringing me to the front window of the house and opening the window so her could talk to him. The police officer spoke to Christopher McGinley while standing behind the targeted victim holding the knife to her back. Christopher McGinley refused to cooperate with the police officer and slammed the window shut again. The police officer quickly opened the window and reached through the window to grab the targeted victim and pulled her out of the house through the window.

Christopher McGinley was never charged with this violent crime following the Police Officer witnessing the offence and the targeted victim providing a 12 month recollection of events and the crime that was conducted against her over the 12 moth period and the statement she made to convict the perpetrator Christopher McGinely and informed the police officer she wanted to press charges. Cynthia and David Pearce were present through the violent entrapment and rescue of the police officer and present while their daughter, the targeted victim gave a statement at the Moonta Police station. A restraining order was automatically issued but now charges were ever laid for the violent crimes of Christopher McGinley, Moonta conducted against the targeted victim over a 12 month period, and including the final event of the police rescue and police witness

This violent event against the targeted victim at age 19 years old resulted in the targeted victims [REDACTED] and also included initially [REDACTED] and fear of leaving the family home for a period of 6 months following her rescue

Both relationships Conspired as an act of targeting and Sexual targeting of the targeted victim and was the commencement of the targeting.

Associations : Township rival and feuding and involvement in the Revengeful Hate Crime
Conspired involvement associations with both families : John Olsen, Kadina / Mayor of Kadina
and Government Liberal Leader, MP and Vickie Chapman / Mag Winters / Chapman

Targeted victim : 20 years of age

History ; Relationship

Met and married Darren McDiarmid, Whyalla, SA - Married for 17 years producing 4 children

No acts of Sexual targeting took place while the targeted victim was married for 17 years until 2007 with the dissolution of the marriage and the commencement of the Medical Business Plan Development while residing in Port Pirie, SA - Business Plan commenced 2006 while still in the marriage but the dissolution of the marriage in process.

1993 - First born son / twin son - [REDACTED]

First event of Intellectual Property Theft involving American Government sources - Infant Sleep Positioner from Privacy of own home - Evidence of Illegal Surveillance of the targeted victim and stalking from location to location - sitting and waiting for opportunity to target

EVIDENCE ; TARGETED VICTIM WAS A DIRECT TARGET OF A SEXUAL ABUSE RING INVOLVING EPSTEIN AND MAXWELL AND PROMINENT PEOPLE, INCLUDING GOVERNMENT SOURCES - CONNECTED TO MOTIVE AND INTENTION HUMILIATE AND DISRESPECT THE REPUTATION OF THE PEARCE FAMILY NAME

INTENTION OF TARGETING ; GROOM AND ABUSE THE TARGETED VICTIM INTO A POSITION OF PROSTITUTION FOR THE SEXUAL ABUSE RING - REVENGEFUL HATE CRIME - DISRESPECT THE REPUTATION AND HUMILIATE - HATE CRIME BASED ON BETRAYAL AND HUMILIATION OF MAG WINTERS / CHAPMAN - VICKIE CHAPMAN ASSOCIATED FAMILY MEMBER

FILE 1 ; EVIDENCE - EPSTEIN AND MAXWELL DIRECTLY TARGETING THE TARGETED VICTIM ONLINE VIA EMAIL SERVICES

Evidence ; May 21 2009 - Email - Epstein and Maxwell Directly targeting the targeted victim online via email services

Fake identity used by Epstein and Maxwell during Direct targeting of the targeted victim : ADAM GURGLY

Commencement of Epstein and Maxwell Directly targeting the targeted victim commenced first contact in 2006, the targeted victim residing at [REDACTED] while still married to Darren McDiarmid and during the commencement of the Medical Business Plan in 2006 -2009.

The targeted victims first and only presence online during her life commenced late 2006 during the final months of her marriage to Darren McDiarmid, and was a result of catching her husband on an online site involving people sharing explicit sexual photographs with one another. The targeted victims husband was on the site without her knowledge. The targeted victim does not know how long her husband was on the site or when registration of his profile commenced. Conducted on the original computer system PC System Tower Beige obtained under a NEIS program involving the married couples business McDiarmid Woodcraft. The computer was obtained from the Regional Development Board, Port Pirie in 2003.

Following the targeted victim catching her husband on the online site of sharing explicit sexual photographs her husband encouraged her to become involved in looking at the site with him. The targeted victim out of naïve curiosity and having never sighted explicit sexual material, which included photographic material or porn before agreed.

The targeted victim found the shared explicit sexual photographs embarrassing to look at and felt ashamed to look at people involved in that kind of material and felt it did not agree with her moral nature and refused to be involved and told her husband she did not mind him staying on the site. The targeted victims husband was unaware at this time that she was planning the dissolution of their marriage due to the marriage being abusive for 17 years. The dissolution of the marriage occurred March 2007 and resulted in a Restraining Order being issued against the abusive Husband

Following the targeted victim refusing to participate in being involved in the online site of sharing Explicit Sexual photographic material the husband cohered the targeted victim into being involved again b y sparking her curiosity with less graphic material and encouraged her to create a profile and talk to other men and people on the site, as he was. The targeted victim found this odd and unusual as her husband was very jealous and possessive and had isolated her from any social contact, including family for the period of their marriage of 17 years.

The targeted victim in December 2006 agreed out of coercion and curiosity to create a profile on the site, but did not publish any photographs of her self on the site and only published a written profile.

Within 5 minutes of publishing her profile the targeted victim was contacted by Maxwell, the first contact, who introduced himself as Adam, who proceeded to charm her with humour and continuous talking online through the message app on the site, which the attention and charm he was giving the targeted victim who had been in an abusive relationship which also involved emotional, physical and psychological abuse found very attractive and was easily manipulated by his charms and attention, of which she had not received during any of her previous relationships or during her marriage, and was too naïve to recognise predatory behaviour due to the isolation from society during her marriage and inexperience with men, as her husband was her third relationship.

The targeted victim continued to talk to Adam / Epstein and Maxwell on the online site every night for the next 4 months, unknowing she was being stalked and targeted by sexual predators

The targeted victim only received contact on the online site from Adam/Epstein and Maxwell and did not receive any contact from any other member on the site

March 2007 - Dissolution of the marriage to Darren McDiarmid - Continual development of the Medical Business Plan, including Market Research

The targeted victim informed Adam / Maxwell and Epstein on the online site of the dissolution of her marriage to Darren McDiarmid. Adam / Epstein and Maxwell cohered and encouraged the targeted victim to talk privately via email services and leave the site. The targeted victim agreed as they had already formed a close friendship and attraction for one another. The targeted victim informed Adam/ Epstein and Maxwell that she did not have an email address and did not know how to open one, having been ordered by her husband when married to not ever touch the computer. Adam / Maxwell and Epstein informed the targeted victim on how to open an email account and provided his email address for once she had completed opening her email address and informed her to contact him once she had.

The email address supplied by Adam/ Epstein and Maxwell was : [REDACTED]

This occurred March 2007 - The targeted victim closed her profile on the online site and never reopened it and continued to correspond with Adam/ Epstein and Maxwell via email addresses privately

The interaction between Adam / Epstein and Maxwell contained building of a deep friendship, trust and sharing of personal information once the trust and friendship was formed.

In the final months of 2007 the targeted victim informed Adam / Maxwell and Epstein that she was developing a Medical Business Plan involving specialist treatments and that she was continuously involved in study courses to achieve her goal of becoming a business woman, while remaining a single mother of 4 children. The targeted victims goal and ambition since the age of 14 years old.

2007-2008 : Sexual Encouragement and sexual experimentation encouragement

In mid 2007 Adam / Maxwell and Epstein once trust and the friendship was formed began to encourage the targeted victim to be sexual with him through sexual overtones within the correspondence of the email contact. The targeted victim had already been charmed by the attention and had a deep love of friendship with Adam / Maxwell and Epstein and did not resist the encouragement or coersion and agreed, unknowing that Adam was Epstein and Maxwell, Sexual predators due to her naivety and inexperience with men, and began to exchange sexual conduct within the email interactions, which eventually over the course of the year escalated into coersion to provide explicit sexual photographic material to Adam / Epstein and Maxwell at his request. Explicit sexual material was also provided by Adam / Epstein and Maxwell to the targeted victim via email interaction and correspondence, which included a photograph of his wives breasts and Adams / Epstein and Maxwell's genitals.

In December of 2007 the targeted victim was a victim of Conspired Sexual Targeting involving Motorcycle gang members of the Criminal Network targeting of an individual, Shaun Steele, cohered, encouraged and introduced to her by Peter Bannister, Red Devils Motorcycle Gang, Port Pirie, associated with the Hells Angels, Adelaide and Hells Angels gangs worldwide. The targeted victim informed Adam / Epstein and Maxwell of her new relationship with Shaun Steele resulting in his reply containing his admission of being jealous of the relationship but continued to encourage the targeted victim to continue their online relationship and sexual Interactions and keep it a secret from her new boyfriend. The targeted victim agreed as she believed she loved Adam / Epstein and Maxwell who had become her only close friend and social interaction.

- “Yes you have always believed in me, never doubted me at all” - Targeted victim believed she was in a deep supportive meaningful friendship with Adam / Epstein and Maxwell and was unknowing she was being targeted or targeted by sexual predatory
- Xxxxxxx - Signing off the email with affection and love - Targeted victim believed she was in a deep meaningful loving friendship with Adam / Epstein and Maxwell and was unknowing she was a victim of Sexual predatory behaviour - targeted victim had been manipulated over a 2 year period

Adam

Targeted victim is using the name ADAM when talking to whom she had been informed and believed was Adam Gurgly, London UK as informed by Epstein and Maxwell in 2006 during their first interaction on the online site

Evidence of Sexual Predatory behaviour conducted online and direct targeting of the targeted victim by Epstein and Maxwell and their use of a Fake identity to hide their real Identity from the targeted victim

May 21 2009 - Email - Evidence - Document 2

Email received by the targeted victim from Adam / Epstein and Maxwell dated May 21 2009, time 11.05pm - Subject : Re:Re - Evidence of continual email correspondence between the targeted victim and Adam/Epstein and Maxwell

Time : 11.05pm - Adam / Epstein and Maxwell had contacted the targeted victim first - Targeted victim replied to the email dated May 21 2009 at time 11.40pm / document 1

Email contains : Points of Interest ;

- Affectionate terms towards the targeted victim - baby - “you’re a lovely lady Jac” / abbreviating the targeted victims name
- “Yes of course you’ll do it baby “ “I have total faith in you because your so passionate and smart” - Displaying knowledge of her ambitions and the Medical Business Plan and acting out a supportive deep meaningful friendship with the targeted victim - Evidence of Adam / Epstein and Maxwell manipulating the targeted victim without her knowledge and portraying a deep meaningful friendship and the trust that had formed in the targeted victim regarding the friendship and interaction - Typical Sexual Predatory behaviour / Establish trust with the targeted victim
- Nikki - Adam / Epstein and Maxwell sharing personal private information with the targeted victim involving his relationships and marriage including his wife name and that she is employed in a department - Evidence Adam / Epstein and Maxwell had formed an element of trust with the targeted victim over a 2 year period and was acting out a deep meaningful friendship with the targeted victim - Evidence of Predatory manipulation
- ██████████ - Nikki - “Not telling anyone by the way” - Sharing personal private information and acting (making the targeted victim believe) that she he is sharing privileged information with her that no one else has knowledge of - Evidence of Manipulation and gaining trust of the targeted victim - Evidence of Sexual predatory manipulation behaviour Adam/Epstein and Maxwell informed the targeted victim that the ██████████ with his wife resulted in one child being born, a boy and had informed her by 2013 that him and his wife were having ██████████ again to have another child
- “May have to give me the low down on TWINS someday” - Evidence of sharing personal information involving the targeted victims children - twins born to the targeted victim in 1993—Evidence Adam / Epstein and Maxwell had knowledge of the targeted victims children and family (Personal and private information) - Evidence of manipulation to gain trust and gain personal knowledge of the targeted victim - Evidence that the targeted victim believed she was involved in a deep meaningful trusting friendship - Evidence of predatory manipulation behaviour

- "The stuff about Shaun" - "I think you guys just need more time together" - Evidence Adam/ Epstein and Maxwell had knowledge of the 2007-2009 Conspired Sexual Targeting of Shaun Steele - Evidence of Adam / Epstein and Maxwell encouraging the targeted victim to stay in the destructive deceitful Conspired attack of the 2007-2009 Conspired Sexual Targeting of motorcycle gang members of Shaun Steele - Evidence of predatory behaviour and encouraging and involvement in Conspired attacks of Conspired sexual targeting and grooming the targeted victim for Prostitution for the Sexual Abuse Ring they were involved in - Evidence of Adam / Epstein and Maxwell involvement in Intentional grooming of the targeted victim
- "Marriage" - Evidence Adam / Epstein and Maxwell had knowledge of the marriage proposal of Shaun Steele, continuous Pattern of Behaviour and conduct in all Conspired Sexual targeting perpetrators involved in Criminal network targeting of an individual / the targeted Victim


